- 1 A BILL FOR AN ACT relating to public health and welfare; to provide for
- 2 cytomegalovirus public education and prevention.
- 3 Be it enacted by the people of the State of Nebraska,

1 Section 1. (1) The Department of Health and Human Services shall

- 2 <u>develop</u> and <u>publish</u> informational materials for women who may become
- 3 pregnant, expectant parents, and parents of infants regarding:
- 4 (a) The incidence of cytomegalovirus;
- 5 <u>(b) The transmission of cytomegalovirus to pregnant women and women</u>
- 6 who may become pregnant;
- 7 (c) Birth defects caused by congenital cytomegalovirus;
- 8 (d) Methods of diagnosing congenital cytomegalovirus;
- 9 <u>(e) Available preventative measures to avoid the infection of women</u>
- 10 who are pregnant or who may become pregnant; and
- 11 (f) Early interventions, treatment, and services available for
- 12 <u>children diagnosed with congenital cytomegalovirus.</u>
- 13 (2) The department shall publish such informational materials on its
- 14 website and make the materials available to child care facilities, school
- 15 nurses, hospitals, birthing facilities as defined in section 71-4736, and
- 16 health care providers offering care to pregnant women and infants, upon
- 17 request.
- 18 Sec. 2. A health care provider offering care to pregnant women
- 19 shall provide the informational materials published under section 1 of
- 20 this act to each pregnant woman during the first trimester of pregnancy
- 21 or when a pregnant woman comes under the care of a provider after the
- 22 first trimester of pregnancy.
- 23 Sec. 3. <u>(1) If a newborn infant fails a hearing screening test as</u>
- 24 provided in section 71-4742, the birthing facility performing such
- 25 <u>screening shall provide to the parents of the newborn infant the</u>
- 26 following information in basic form:
- 27 (a) Potential birth defects caused by congenital cytomegalovirus;
- 28 (b) Testing opportunities for cytomegalovirus, including the
- 29 opportunity to test for cytomegalovirus prior to the infant's discharge
- 30 <u>from the hospital or birthing facility; and</u>
- 31 (c) Early intervention services.

1	(2) The informational material published under section 1 of this
2	act, and such additional clarifying information as required by the
3	parents, shall be provided to the parents at the newborn infant's follow-
4	up audiology appointment. Such audiology appointment shall take place
5	within twenty-one days after the newborn infant's birth.
