SUMMARY

Synopsis:	Establishes guardianship monitoring program in Office of Public Guardian for Elderly Adults.

• The Office of Legislative Services (OLS) estimates that this bill will increase annual State expenditures for the Office of the Public Guardian for Elderly Adults by between \$85,000 and \$725,000 to establish a guardianship monitoring program within the office. This estimate assumes that the office will need to hire between one and six new full-time equivalent employees, at an annual base salary range of \$53,000 to \$75,000 plus fringe benefits, to implement the provisions of the bill.

BILL DESCRIPTION

This bill establishes a guardianship monitoring program within the Office of the Public Guardian for Elderly Adults to monitor court-appointed legal guardians of elderly adults to detect abuse, neglect, or exploitation. Under the bill, the office is designated as an "interested party" that must be served with the periodic reports that court-appointed guardians of elderly adults are mandated to file with the court. The bill requires the office to review these reports and accompanying documentation and to intervene in cases in which problems or inconsistencies are identified.



FISCAL ANALYSIS

EXECUTIVE BRANCH

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that this bill will increase annual State expenditures for the Office of the Public Guardian for Elderly Adults by between \$85,000 and \$725,000 to establish a guardianship monitoring program within the office. This estimate assumes that the office will need to hire between one and six new full-time equivalent employees, at an annual base salary range of \$53,000 to \$75,000 plus fringe benefits, to implement the provisions of the bill. The office currently provides guardianship services for senior adults who have been adjudicated legally incapacitated. Services include surrogate medical decision-making, legal representation, social and clinical oversight and coordination of services, as well as financial and property management. Under the bill, the office would be additionally responsible for monitoring court-appointed guardians of elderly adults that exist outside of the office's purview.

Currently, the provisions of the bill are fulfilled via the Guardianship Monitoring Program within the Judiciary. Qualified volunteers in the Guardianship Monitoring Program track and report guardian actions using the Guardianship Monitoring System, which is a Statewide database used by all counties to track guardian activities. Volunteers review guardian reports, financial records, doctor certifications, and other documents in order to identify, and report to the court, discrepancies that could signal abuse.

Using available data, the OLS estimates that approximately 85 volunteers support this program, with each volunteer working six to 12 hours per month. Based upon this data, and assuming that between 25 percent and 75 percent of these hours are dedicated to monitoring court-appointed guardians of elderly adults, the provisions of this bill would result in the office needing to increase staff levels to perform approximately 128 to 765 hours of work each month. Assuming a 35-work week, the office would need to hire one to six new staff members to meet the requirements of this bill.
