• The Office of Legislative Services (OLS) estimates that this bill will annually increase State expenditures between \$55,000 and \$155,000 per 1,000 veteran gravesites from the implementation of the New Jersey Veteran Gravesite Maintenance Grant Program, although costs could be higher. Total costs under the program will ultimately depend on the number of veteran gravesites serviced per year, the type and frequency of services performed, and the amount of grants awarded.

BILL DESCRIPTION

This bill establishes the New Jersey Veteran Gravesite Maintenance Grant Program in the Department of Military and Veterans' Affairs. The program will provide grants to a nonprofit veterans' organization or a federally chartered Veterans' Service Organization, to provide veteran gravesite maintenance.

This bill requires the Department of Military and Veterans' Affairs to develop guidelines and procedures for the submission of applications, as well as the criteria for evaluating applications. Additionally, the department must establish the terms and conditions for the awarding of the grants and require the recipient of the grant to report their use of grant funds. The bill also requires the department to submit a request for sufficient funds to carry out the purposes and the intent of the program in their annual budget request.



FISCAL ANALYSIS

OFFICE OF LEGISLATIVE SERVICES

The OLS estimates that this bill will annually increase State expenditures in the range of \$55,000 to \$155,000 per 1,000 veteran gravesites from the implementation of the New Jersey Veteran Gravesite Maintenance Grant Program, depending on the frequency of maintenance and the services provided.

The OLS estimates maintenance costs for one gravesite at a rate between \$55 for an annual headstone cleaning and \$155 for an annual headstone cleaning with one maintenance visit. Based on these rates, the total annual maintenance cost for 1,000 gravesites is between \$55,000 and \$155,000. Costs per 1,000 gravesites could be double or triple these amounts if more frequent or additional maintenance services are provided. Total costs under the program will ultimately depend on the number of veteran gravesites serviced per year, the type and frequency of services performed, and the amount of grants awarded.
