BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 32A-3A-12 NMSA 1978 (being Laws 2019, Chapter 132, Section 1) is amended to read:

"32A-3A-12. FOSTER FAMILIES--FREE ADMISSION TO MUSEUMS
AND STATE PARKS--CAMPING PASSES--FISHING LICENSES.--

A. As provided in Subsection B of this section, foster parents and children in the custody of foster parents, .223714.2

1	youth enrolled in the fostering connections program and			
2	children who are in the custody of the children, youth and			
3	families department, who are residents of the state, shall be			
4	provided <u>for</u> free:			
5	(1) admission to state-owned museums and state			
6	parks; [provided that]			
7	(2) a camping pass for up to three consecutive			
8	nights of overnight access to a state park; and			
9	(3) a fishing license.			
10	$\underline{\mathtt{B.}}$ Eligibility for free admission shall be
