AN ACT

ESTABLISHING REPRESENTATIVE DISTRICTS; PROVIDING THE METHOD FOR ELECTING REPRESENTATIVES; PROVIDING FOR THE FILLING OF VACANCIES; SETTING PRECINCTS; FIXING THE NUMBER, RESIDENCE AND TERMS OF REPRESENTATIVES; REPEALING AND ENACTING SECTIONS OF THE NMSA 1978.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. [NEW MATERIAL] SHORT TITLE.--This act may be cited as the "2021 House Redistricting Act".

SECTION 2. [NEW MATERIAL] MEMBERSHIP.--The house of representatives is composed of seventy members to be elected from districts that are contiguous and that are as compact as is practicable.

SECTION 3. [NEW MATERIAL] RESIDENCE.--At the time of filing a declaration of candidacy for the office of

1 representative, a candidate shall reside in the district for
2 which the candidate files. Thereafter, if a representative
3 permanently removes the representative's residence from or
4 maintains no residence in the district from which the
5 representative was elected, the representative shall be deemed
6 to have resigned, and a successor shall be selected as provided
7 in Section 4 of the 2021 House Redistricting Act.

8 SECTION 4. [NEW MATERIAL] ELECTIONS--VACANCIES.--

9 A. Members of the house of representatives shall be
10 elected for terms of two years.

11 B. If a vacancy occurs in the office of
12 representative for any reason, the vacancy shall be filled as
13 follows:

14 (1) for a representative district that is
15 situated wholly within the exterior boundaries of a single
16 county, the board of county commissioners of that county shall
17 appoint the representative to fill the vacancy; and

18 (2) for a representative district situated
19 within two or more counties:

20 (a) the board of county commissioners of
21 each county in the representative district shall submit one
22 name to the governor; and

23 (b) the governor shall appoint the
24 representative to fill the vacancy from the list of names so
25 submitted.

1 C. An appointment to fill a vacancy in the house of
2 representatives shall be for a term ending on December 31 after
3 the next general election.

4 D. An appointment to fill a vacancy made before the
5 general election of 2022 shall be made from the district as it
6 was described in Section 2-7E-1 NMSA 1978, as established by
7 the court in *Egolf v. Duran*, D-101-CV-2011-02942 (1st Dist.
8 Ct., Judgment and Final Order on Remand (State House of
9 Representatives Trial) filed February 28, 2012). On or after
10 the general election of 2022, a vacancy shall be filled by
11 appointment from the district as set out in the 2021 House
12 Redistricting Act.

13 SECTION 5. [NEW MATERIAL] PRECINCTS.--

14 A. Precinct designations and boundaries used in the
15 2021 House Redistricting Act are those precinct designations
16 and boundaries established pursuant to the Precinct Boundary
17 Adjustment Act and revised and approved pursuant to that act by
18 the secretary of state as of November 30, 2021.

19 B. A board of county commissioners shall not create
20 any precinct that lies in more than one representative district
21 and shall not divide any precinct so that the divided parts of
22 the precinct are situated in two or more representative
23 districts. Votes cast in any general, primary or other
24 statewide election from precincts created or divided in
25 violation of this subsection are invalid and shall not be
