AN ACT

RELATING TO RELIGIOUS FREEDOM; AMENDING THE HUMAN RIGHTS ACT TO PROHIBIT THE APPLICATION OF ANY LAW THAT BURDENS THE FREE EXERCISE OF RELIGION; AMENDING THE NEW MEXICO RELIGIOUS FREEDOM RESTORATION ACT TO PREVENT DISCRIMINATORY ACTION BY A PERSON OR A GOVERNMENT AGENCY IN RESPONSE TO A PERSON'S FREE EXERCISE OF RELIGION; PROVIDING FOR NOTICE.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:

SECTION 1. Section 28-1-2 NMSA 1978 (being Laws 1969, Chapter 196, Section 2, as amended) is amended to read:

"28-1-2. DEFINITIONS.--As used in the Human Rights Act:

A. "person" means one or more individuals, a limited liability company, partnership, association, organization, corporation, joint venture or any legal or commercial entity, legal representative, business trust,

20 regularly undertaking with or without compensation to procure  
21 opportunities to work or to procure, recruit or refer  
22 employees;

23 [~~H-~~] I. "public accommodation" means any  
24 establishment that provides or offers its services, facilities,  
25 accommodations or goods to the public, but does not include a

4 or portion of a building that is constructed or to be

7 ~~[J.]~~ K. "real property" means lands, leaseholds or  
8 commercial or industrial buildings, whether constructed or to  
9 be constructed, offered for sale or rent, and any land rented  
10 or leased for the use, parking or storage of house trailers;

11 ~~[K.]~~ L. "secretary" means the secretary of  
12 workforce solutions;

13 ~~[L.]~~ M. "unlawful discriminatory practices" means  
14 those unlawful practices and acts specified in Section 28-1-7  
15 NMSA 1978;

16 ~~[M.]~~ N. "physical or mental handicap" means a  
17 physical or mental impairment that substantially limits one or  
18 more of a person's major life activities. A person is also  
19 considered to be physically or mentally handicapped if the  
20 person has a record of a physical or mental handicap or is  
21 regarded as having a physical or mental handicap;

23 such as caring for one's self, performing manual tasks,  
24 walking, seeing, hearing, speaking, breathing, learning and

6 perception, or perception of that person by another, of the  
7 person's identity as a male or female based upon the person's  
8 appearance, behavior or physical characteristics that are in  
9 accord with or opposed to the person's physical anatomy,  
10 chromosomal sex or sex at birth."

11           **SECTION 2.** Section 28-1-9 NMSA 1978 (being Laws 1969,  
12 Chapter 196, Section 8, as amended) is amended to read:

13           "28-1-9. EXEMPTIONS.--Nothing contained in the Human  
14 Rights Act shall:

15           A. apply to any single-family dwelling sold,  
16 leased, subleased or rented by an owner without the making of  
17 any notice, statement or advertisement with respect to the  
18 sale, lease, sublease or rental of a dwelling unit that  
19 indicates any preference, limitation or discrimination based on  
20 race, color, religion, national origin, ancestry, sex, sexual  
21 orientation or gender identity. This exemption is subject to  
22 these further reservations:

23                   (1) to qualify for the exemption, the seller  
24 must not be an owner of or own or have reserved any interest in  
25 more than three single-family dwellings; and

2 the dwelling or [he] was not the most recent occupant, the  
3 exemption granted in this section shall only apply to one sale  
4 in twenty-four months;

5 B. bar any religious or denominational institution  
6 or organization that is operated, supervised or controlled by  
7 or that is operated in connection with a religious or  
8 denominational organization from limiting admission to or  
9 giving preference to persons of the same religion or  
10 denomination or from making selections of buyers, lessees or  
11 tenants as are calculated by the organization or denomination  
12 to promote the religious or denominational principles for which  
13 it is established or maintained, unless membership in the  
14 religious or denominational organization is restricted on  
15 account of race, color, national origin or ancestry;

16 C. bar any religious or denominational institution  
17 or organization that is operated, supervised or controlled by  
18 or that is operated in connection with a religious or  
19 denominational organization from imposing discriminatory  
20 employment or renting practices that are based upon sexual  
21 orientation or gender identity; [~~provided that the provisions~~  
22 ~~of the Human Rights Act with respect to sexual orientation and~~  
23 ~~gender identity shall apply to any other:~~

12 ancestry, sex, physical or mental handicap or serious medical  
13 condition;

14 ~~[D-]~~ E. apply to rooms or units in dwellings  
15 containing living quarters occupied or intended to be occupied  
16 by no more than four families living independently of each  
17 other, if the owner actually maintains and occupies one of the  
18 living quarters as ~~[his]~~ the owner's residence;

19 ~~[E-]~~ F. apply to public restrooms, public showers,  
20 public dressing facilities or sleeping quarters in public  
21 institutions, where the preference or limitation is based on  
22 sex; and

23 ~~[F-]~~ G. prevent the mandatory retirement of an  
24 employee upon reaching the age of sixty-five years or older, if  
25 the employer is operating under a retirement plan that meets

3 SECTION 3. Section 28-22-1 NMSA 1978 (being Laws 2000  
4 (2nd S.S.), Chapter 17, Section 1) is amended to read:

5 "28-22-1. SHORT TITLE.--~~[Sections 1 through 5 of this~~  
6 ~~act]~~ Chapter 28, Article 22 NMSA 1978 may be cited as the "New  
7 Mexico Religious Freedom Restoration Act"."

8 SECTION 4. Section 28-22-2 NMSA 1978 (being Laws 2000  
9 (2nd S.S.), Chapter 17, Section 2) is amended to read:

10 "28-22-2. DEFINITIONS.--As used in the New Mexico  
11 Religious Freedom Restoration Act:

12 A. "discriminatory action" means an act by a person  
13 or a government agency in response to a person's free exercise  
14 of religion to:

15 (1) alter the tax treatment of, or cause any  
16 tax, penalty or payment to be assessed against, or to deny,  
17 delay or revoke an exemption from taxation under New Mexico  
18 laws of any person;

19 (2) withhold, reduce, exclude, terminate or  
20 otherwise deny any state grant, contract, subcontract,  
21 cooperative agreement, loan, license, certification,  
22 accreditation, employment or other status from or to a person;  
23 and

24 (3) require a person to perform an act or  
25 provide or receive a product, good or service where that act

8 authorities; and

9 D. "person" means one or more individuals, a  
10 limited liability company, partnership, association,  
11 organization, corporation, joint venture or any legal or  
12 commercial entity, legal representative, business trust,  
13 estate, trust, trustees, receivers or government agency."

14 SECTION 5. Section 28-22-3 NMSA 1978 (being Laws 2000  
15 (2nd S.S.), Chapter 17, Section 3) is amended to read:

16 "28-22-3. RELIGIOUS FREEDOM PROTECTED--EXCEPTIONS.--A  
17 [~~government agency~~] person shall not restrict a person's free  
18 exercise of religion unless:

19 A. the restriction is in the form of a rule of  
20 general applicability and does not [~~directly~~] discriminate  
21 against religion or among religions; and

22 B. the application of the restriction to the person  
23 is essential to further a compelling governmental interest and  
24 is the least restrictive means of furthering that compelling  
25 governmental interest."

1           SECTION 6. Section 28-22-4 NMSA 1978 (being Laws 2000  
2 (2nd S.S.), Chapter 17, Section 4) is amended to read:

3           "28-22-4. PRIVATE REMEDIES.--

4           A. A person whose free exercise of religion has  
5 been restricted by a violation of the New Mexico Religious  
6 Freedom Restoration Act may assert that violation as a claim or  
7 defense in a judicial proceeding and obtain appropriate relief  
8 against a [~~government agency~~] person, including:

9                   (1) injunctive or declaratory relief against a  
10 [~~government agency~~] person that violates or proposes to violate  
11 the provisions of the New Mexico Religious Freedom Restoration  
12 Act; and

13                   (2) damages pursuant to the Tort Claims Act,  
14 reasonable attorney fees and costs.

15           B. Immunity from liability of the [~~government~~  
16 ~~agency and its~~] person and the person's employees is waived for  
17 an action brought pursuant to this section."

18           SECTION 7. A new section of the New Mexico Religious  
19 Freedom Restoration Act is enacted to read:

20           "[NEW MATERIAL] NOTIFICATION OF RESTRICTION ON ACTIONS.--

21 A person offering labor, services, merchandise or goods shall  
22 take reasonable measures to ensure that persons, employees,  
23 applicants for employment, customers and potential customers  
24 are made aware of limitations on the person's ability to  
25 perform tasks, activities, services or limitations on

1 merchandise or goods on offer due to the person's sincerely  
2 held religious beliefs."

3 SECTION 8. Section 28-22-5 NMSA 1978 (being Laws 2000  
4 (2nd S.S.), Chapter 17, Section 5) is amended to read:

5 "28-22-5. CONSTRUCTION OF ACT.--Nothing in the New Mexico  
6 Religious Freedom Restoration Act authorizes a [~~government~~  
7 ~~agency~~] person to burden a person's free exercise of religion.  
8 The protection of the free exercise of religion granted in that  
9 act is in addition to the protections granted by federal law  
10 and the state and federal constitutions. The New Mexico  
11 Religious Freedom Restoration Act does not affect the grant of  
12 benefits or tax exemptions to religious organizations nor does  
13 it impair any other exemptions granted by law."

14 SECTION 9. SEVERABILITY.--If any part or application of  
15 this act is held invalid, the remainder or its application to  
16 other situations or persons shall not be affected.

17 SECTION 10. EFFECTIVE DATE.--The effective date of the  
18 provisions of this act is July 1, 2016.
