14	PROVIDED BY LAW; REPEALING THE CONSTITUTIONAL PROVISION
15	PROVIDING FOR LEGISLATIVE PER DIEM AND MILEAGE AND THE
16	PROHIBITION OF LEGISLATIVE COMPENSATION; AND AMENDING OR

20	BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF NEW MEXICO:
21	SECTION 1. It is proposed to amend Article 4 of the

of the constitution of New Mexico to read:

"There shall be a district attorney for each judicial district, who shall be learned in the law, and who shall have been a resident of New Mexico for three years next prior to [his] election, shall be the law officer of the state and of the counties within [his] the district attorney's district, shall be elected for a term of four years and shall perform such duties [and receive such salary] as may be prescribed by law.

The legislature shall have the power to provide for the election of additional district attorneys in any judicial district and to designate the counties therein for which the district attorneys shall serve; but no district attorney shall be elected for any district of which [he] the district attorney is not a resident."

SECTION 3. It is proposed to amend Article 6, Section 28 of the constitution of New Mexico to read:

"The court of appeals shall consist of not less than seven judges, who shall be chosen as provided in this constitution, whose qualifications shall be the same as those of justices of the supreme court [and whose compensation shall be as provided by law. The increased qualifications provided by this 1988 amendment shall not apply to court of appeals judges serving at the time this amendment passes or elected at the general election in 1988].

1 Three judges of the court of appeals shall constitute a 2 quorum for the transaction of business, and a majority of those participating must concur in any judgment of the court. 3 4 When necessary, the chief justice of the supreme court may 5 designate any justice of the supreme court, or any district judge of the state, to act as a judge of the court of appeals, 6 7 and the chief justice may designate any judge of the court of appeals to hold court in any district, or to act as a justice 8 of the supreme court." 9 10 SECTION 4. It is proposed to amend the constitution of New Mexico by repealing: 11 12 Α. Article 4, Section 10; Article 5, Section 12; 13 Β. Article 6, Section 11; and 14 С. Article 6, Section 17. D. 15 The amendment proposed by this resolution 16 SECTION 5. shall be submitted to the people for their approval or 17 rejection at the next general election or at any special 18 19 election prior to that date that may be called for that purpose 20 and if so approved, the provisions of: Section 1 shall take effect on January 1, 2023; 21 Α. and 22 Sections 2 through 4 shall take effect on July Β. 23 1, 2024. 24 - 5 -25 .220135.3
