AN ACT making an appropriation to Crisis Support Services of Nevada for the employment of two additional full-time staff members by Crisis Support Services of Nevada; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to Crisis Support Services of Nevada for the
3 employment of two additional full-time staff members by Crisis
4 Support Services of Nevada the following sums:

5 For the Fiscal Year 2019-2020 \$120,313
6 For the Fiscal Year 2020-2021 \$120,313

7 2. A full-time staff member employed by Crisis Support
8 Services of Nevada with the money appropriated by subsection 1
9 must hold at least a bachelor’s degree in social work or a closely
10 related field or work experience equivalent to a bachelor’s degree in
11 social work or a closely related field, as determined by the Director
12 of Crisis Support Services of Nevada or his or her designee.

13 3. A full-time staff member employed by Crisis Support
14 Services of Nevada with the money appropriated by subsection 1
15 shall provide to persons who contact Crisis Support Services of
16 Nevada case management and other related services, including,
17 without limitation, authorized follow-up communication and
18 referrals to available resources.



1 4. Upon acceptance of the money appropriated by subsection 1,
2 Crisis Support Services of Nevada agrees to:

3 (a) Prepare and transmit a report to the Interim Finance
4 Committee on or before December 18, 2020, that describes each
5 expenditure made from the money appropriated by subsection 1
6 from the date on which the money was received by Crisis Support
7 Services of Nevada through December 1, 2020;

8 (b) Prepare and transmit a final report to the Interim Finance
9 Committee on or before September 17, 2021, that describes each
10 expenditure made from the money appropriated by subsection 1
11 from the date on which the money was received by Crisis Support
12 Services of Nevada through June 30, 2021; and

13 (c) Upon request of the Legislative Commission, make available
14 to the Legislative Auditor any of the books, accounts, claims,
15 reports, vouchers or other records of information, confidential or
16 otherwise, of Crisis Support Services of Nevada, regardless of their
17 form or location, that the Legislative Auditor deems necessary to
18 conduct an audit of the use of the money appropriated pursuant to
19 subsection 1.

20 **Sec. 2.** Any balance of the sums appropriated by section 1 of
21 this act remaining at the end of the respective fiscal years must
22 not be committed for expenditure after June 30 of the respective
23 fiscal years by the entity to which the appropriation is made or any
24 entity to which money from the appropriation is granted or
25 otherwise transferred in any manner, and any portion of the
26 appropriated money remaining must not be spent for any purpose
27 after September 18, 2020, and September 17, 2021, respectively, by
28 either the entity to which the money was appropriated or the entity
29 to which the money was subsequently granted or transferred,
30 and must be reverted to the State General Fund on or before
31 September 18, 2020, and September 17, 2021, respectively.

32 **Sec. 3.** This act becomes effective on July 1, 2019.
