SUMMARY—Revises provisions relating to services to assist persons with disabilities in obtaining employment. (BDR 38-225)

AN ACT relating to persons with disabilities; revising provisions concerning the duties and employees of the Bureau of Services to Persons Who Are Blind or Visually Impaired and the Bureau of Vocational Rehabilitation of the Rehabilitation Division of the Department of Employment, Training and Rehabilitation; prohibiting, under certain circumstances, the solicitation, disclosure, receipt or use of information concerning persons receiving services from the Division; authorizing the Division to adopt, amend and repeal certain policies; authorizing the denial of services to persons who are blind under certain circumstances; removing the designation of the Division as the designated state unit for the purpose of certain federal regulations governing vocational rehabilitation; prescribing the purposes for which certain money may be used; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law establishes programs under which: (1) the Bureau of Services to
2 Persons Who Are Blind or Visually Impaired of the Rehabilitation Division of the
3 Department of Employment, Training and Rehabilitation provides services to assist
4 persons who are blind in obtaining employment; and (2) the Bureau of Vocational
5 Rehabilitation of the Division provides similar services to individuals with
6 disabilities. (NRS 426.518-426.610, chapter 615 of NRS) **Sections 2 and 24** of this
7 bill revise the purposes of those programs.

8 Existing federal law defines the term "competitive integrated employment" to
9 mean full-time or part-time work, including self-employment: (1) for which a
10 person receives certain minimum compensation; (2) that allows the employee to
11 interact with persons who are not disabled; and (3) that provides opportunities for
12 advancement similar to those provided to employees who are not disabled. (29
13 U.S.C. § 705) **Sections 3 and 21** of this bill define that term to have the same
14 meaning in state law. **Sections 5, 29 and 41** of this bill define the term "vocational
15 rehabilitation services" to mean any goods and services necessary to prepare a
16 person who is blind or an individual with a disability, as appropriate, to engage in
17 competitive integrated employment or to determine the rehabilitation potential of
18 such a person. **Sections 8 and 26-28** of this bill amend the definitions of certain
19 related terms. **Sections 9 and 33-35** of this bill revise which entities perform
20 certain duties relating to vocational rehabilitation services.

21 Federal regulations require the state unit responsible for administering
22 vocational rehabilitation services to develop and maintain written policies covering
23 the nature and scope of each such service and the criteria under which each service
24 is provided. (34 C.F.R. § 361.50) **Sections 6 and 22** of this bill authorize the
25 Division to adopt, amend and repeal such policies at a public meeting. **Section 17**
26 of this bill provides that the adoption, amendment and repeal of such policies is not
27 subject to the standard rulemaking process.

28 **Section 10** of this bill requires the Bureau of Services to Persons Who Are
29 Blind or Visually Impaired to provide vocational rehabilitation services to any
30 person who is blind, including any such person who is eligible to receive such
31 services under an agreement with the Federal Government, another state, certain
32 territories or an Indian tribe. **Sections 30-32** of this bill make similar revisions
33 concerning the duties of the Bureau of Vocational Rehabilitation.

34 Existing law requires the Division to direct the Bureau of Services to Persons
35 Who Are Blind or Visually Impaired to adopt administrative regulations to enforce
36 provisions of law concerning the provision of services for persons who are blind.
37 (NRS 426.560) **Section 11** of this bill makes slight revisions concerning those
38 regulations.

39 **Sections 12 and 23** of this bill require the Bureau of Services to Persons Who
40 Are Blind or Visually Impaired and the Bureau of Vocational Rehabilitation to
41 employ persons skilled in the vocational rehabilitation of persons who are blind or
42 individuals with disabilities, as appropriate, to allow such persons or individuals to
43 engage in competitive integrated employment.

44 **Sections 13 and 40** of this bill: (1) expressly provide that the unauthorized
45 receipt, use or disclosure of information concerning persons who apply for or
46 receive services for persons who are blind or individuals with disabilities is a
47 misdemeanor; and (2) revise the circumstances under which the receipt, use or
48 disclosure of such information is authorized.

49 **Section 14** of this bill allows the denial of services for persons who are blind to
50 persons who are ineligible to receive those services under federal law or for which
51 the person is required by federal regulations to use comparable services and
52 benefits paid for by another public or private entity. **Sections 15 and 39** of this bill
53 make nonsubstantive revisions concerning appeals of actions, determinations or
54 omissions made by the Bureau of Services to Persons Who Are Blind or Visually



55 Impaired and the Bureau of Vocational Rehabilitation. **Section 16** of this bill
56 removes the designation of the Division as the state unit for carrying out certain
57 programs for independent living prescribed in federal law.

58 **Sections 19, 32, 36, 37, 42 and 43** of this bill remove the authority of the
59 Bureau of Vocational Rehabilitation to: (1) establish or construct rehabilitation
60 facilities and workshops; and (2) provide for the establishment, supervision,
61 management and control of small business enterprises to be operated by persons
62 with severe disabilities. **Section 38** of this bill expands the purposes for which
63 money in the Rehabilitation Gift Account in the Department of Employment,
64 Training and Rehabilitation's Gift Fund may be used.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN

1 **Section 1.** Chapter 426 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 6, inclusive, of this
3 act.

4 **Sec. 2.** *The purposes of NRS 426.518 to 426.610, inclusive,*
5 *and sections 2 to 6, inclusive, of this act are to:*

6 *1. Provide vocational rehabilitation services to persons who*
7 *are blind so that they may prepare for and engage in competitive*
8 *integrated employment;*

9 *2. Promote vocational rehabilitation services and related*
10 *activities which will assist persons who are blind to reach their*
11 *fullest potential; and*

12 *3. Encourage and develop facilities and other resources*
13 *needed by persons who are blind to engage in competitive*
14 *integrated employment.*

15 **Sec. 3.** *“Competitive integrated employment” has the*
16 *meaning ascribed to it in 29 U.S.C. § 705.*

17 **Sec. 4.** *“Substantial impediment to employment” means that*
18 *a loss or impairment of eyesight, in light of attendant medical,*
19 *psychological, vocational, cultural, social or environmental*
20 *factors, hampers a person’s occupational performance by*
21 *preventing the person from obtaining, retaining or preparing for*
22 *competitive integrated employment consistent with the capabilities*
23 *and abilities of the person.*

24 **Sec. 5.** *“Vocational rehabilitation services” means any goods*
25 *and services necessary to prepare a person who is blind to engage*
26 *in competitive integrated employment or to determine the*
27 *rehabilitation potential of the person.*

28 **Sec. 6.** *1. To the extent required by 34 C.F.R. § 361.50, the*
29 *Division may adopt, amend and repeal policies concerning the*
30 *nature and scope of vocational rehabilitation services provided to*
31 *persons who are blind.*



1 **2. Any adoption, amendment or repeal of a policy pursuant to**
2 **subsection 1 must occur at a public meeting held in compliance**
3 **with the provisions set forth in chapter 241 of NRS concerning**
4 **open meetings.**

5 **Sec. 7.** NRS 426.518 is hereby amended to read as follows:

6 426.518 As used in NRS 426.518 to 426.610, inclusive, **and**
7 **sections 2 to 6, inclusive, of this act**, the words and terms defined in
8 NRS 426.519 and 426.520 **and sections 3, 4, and 5 of this act** have
9 the meanings ascribed to them in those sections.

10 **Sec. 8.** NRS 426.520 is hereby amended to read as follows:

11 426.520 "Person who is blind" means a person **who:**

12 **1. Is** described in NRS 426.082 ~~and any person who by reason~~
13 ~~of;~~ **and**

14 **2. Has a** loss or impairment of eyesight ~~is unable to provide~~
15 ~~himself or herself with the necessities of life, and who has not~~
16 ~~sufficient income of his or her own to maintain himself or herself.]~~
17 **which constitutes a substantial impediment to employment for**
18 **which vocational rehabilitation services:**

19 **(a) May reasonably be expected to prepare the person to**
20 **engage in competitive integrated employment which is consistent**
21 **with the abilities of the person; or**

22 **(b) Are necessary to determine the rehabilitation potential of**
23 **the person.**

24 **Sec. 9.** NRS 426.531 is hereby amended to read as follows:

4 3. The Bureau may:

5 (a) Provide for treatment or operations to prevent blindness or
6 restore vision to ~~{applicants for or}~~ recipients of services to persons
7 who are blind who request *and are eligible for such services under*
8 *federal law* and make written application for such treatment or
9 ~~{operation;}~~ *operations;* and

10 (b) Pay for ~~{all}~~ necessary expenses incurred in connection with
11 the diagnosis and treatment provided under paragraph (a).
12 ~~{Necessary expenses must include the costs of guide service,~~
13 ~~maintenance while the patient is away from his or her home,~~
14 ~~transportation to the eye physician or hospital and return to his or~~
15 ~~her home, and the cost of nursing home care when such care is~~
16 ~~necessary.}~~

17 4. *As used in this section, "state" includes, without limitation,*
18 *the District of Columbia, Puerto Rico, the United States Virgin*
19 *Islands and Guam.*

20 **Sec. 11.** NRS 426.560 is hereby amended to read as follows:

21 426.560 1. Subject to the approval of the Department, the
22 Division shall direct the Bureau to ~~{make}~~ *adopt* administrative
23 regulations to enforce the provisions of this chapter related to
24 services for persons who are blind, which regulations must not
25 conflict with the provisions of this chapter.

26 2. The regulations must recognize that the *vocational* needs
27 and problems of persons who are blind are ~~{special}~~ *unique* to them
28 and may differ materially from the *vocational* needs and problems
29 of other persons.
