
ASSEMBLY BILL NO. 319—ASSEMBLYMAN SPRINKLE

SUMMARY—Revises provisions governing the guardianship of minors. (BDR 13-502)

AN ACT relating to guardianships; revising provisions governing the guardianship of minors; authorizing the appointment of an advocate for the best interests of a proposed protected minor in guardianship proceedings; revising the required contents of a citation in guardianship proceedings for a protected minor; revising the procedures for requesting the appointment of a temporary guardian for certain minors; requiring the assignment of child support payments to a guardian for the support of a protected minor; authorizing the award of visitation rights between a protected minor and certain relatives; revising the factors for consideration in guardianship determinations regarding a protected minor; revising provisions for changing the residence of a protected minor to a location outside of this State; revising provisions governing obligations due to or for a protected minor; establishing certain requirements for the filing of a verified account upon the emancipation of a protected minor; providing for the extension or establishment of a guardianship of a minor after the age of majority; establishing certain required showings for certain terminations of guardianships; making various other changes pertaining to guardianships; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law sets forth the procedures for the appointment of a guardian for a
2 ward, the powers and duties of a guardian and the termination of a guardianship.
3 (Chapter 159 of NRS) **Sections 2-157** of this bill create a new chapter applicable
4 exclusively to guardianships of minors, incorporating, revising and supplementing
5 those provisions from existing law as they currently relate to minors.

6 **Section 27** authorizes the court to appoint an advocate for the best interests of a
7 proposed protected minor and sets forth the role of the advocate as an officer of the
8 court.

9 Existing law requires a citation issued pursuant to a petition for the
10 appointment of a guardian to include certain specified information concerning the
11 rights of a proposed ward. (NRS 159.048) **Section 31** adds the requirement that a
12 citation also include notice that: (1) the rights of any person having legal or
13 physical custody of a proposed protected minor may be affected as specified in
14 the petition; and (2) at any time in the proceedings, the court may appoint for the
15 proposed protected minor an attorney, a guardian ad litem and an advocate for the
16 best interests of the proposed protected minor.

17 Existing law provides that a petitioner may request the appointment of a
18 temporary guardian for a ward who is a minor and who is unable to respond to a
19 substantial and immediate risk of physical harm or to a need for immediate medical
20 attention. (NRS 159.052) **Section 36** of this bill revises the procedure by which a
21 petitioner may request the appointment of a temporary guardian for a minor who is
22 in need of immediate medical attention by eliminating the requirement that the
23 petition be supported by a letter signed by a governmental agency in this State
24 which conducts investigations or a police report indicating whether the proposed
25 ward presents a danger to himself or herself or others, or whether the proposed
26 ward is or has been subjected to abuse, neglect or exploitation.

27 **Section 37** of this bill establishes a procedure by which a petitioner may, by
28 verified petition, request the appointment of a temporary guardian for the person of
29 a proposed protected minor, for his or her estate or for both, in circumstances other
30 than when the minor is in need of immediate medical attention. **Section 37** requires
31 the petition to state facts establishing good cause for the appointment of a
32 temporary guardian and which show that: (1) the petitioner has tried in good faith
33 to give notice of the petition as required by statute; (2) the minor would be at risk of
34 immediate physical, emotional or financial harm if such notice were to be provided
35 before the court determines whether to appoint a temporary guardian; or (3) giving
36 such notice is not feasible under the circumstances. **Section 37** eliminates a
37 requirement that the court limit the powers of a temporary guardian for a protected
38 minor to those necessary to respond to the risk which threatens the minor. **Section**
39 **37** requires, in the case of an ex parte application, the petition be accompanied by an
40 affidavit which explains the emergency. **Section 37** also provides that, if no
41 parent of a proposed protected minor has had the care, custody and control of the
42 minor for the 6 months immediately preceding the petition, temporary guardianship
43 is presumed to be in the minor's best interest. Finally, **section 37** provides that the
44 court may extend a temporary guardianship beyond an initial period of 10 days for
45 not more than two successive 60-day periods unless extraordinary circumstances
46 necessitate a longer duration for the temporary guardianship.

47 **Section 41** requires the assignment of payments of court-ordered child support
48 to the guardian for the support of a protected minor.

49 **Section 42** authorizes the award of rights of visitation between a protected
50 minor and his or her parents or relatives who are within the fourth degree of
51 consanguinity.

52 Existing law states that the parents of a minor, if qualified and suitable, are
53 preferred over all others for appointment as guardian for the minor and sets forth
54 certain factors for consideration by the court in determining the qualifications and



55 suitability of any person who is proposed for appointment as guardian. (NRS
56 159.061) **Section 46** revises these provisions by establishing a presumption that a
57 parent who petitioned for guardianship of a minor is suitable to serve as guardian,
58 except when a countering presumption that a parent is unsuitable to care for the
59 proposed protected minor is created by a showing that: (1) the parent is unable to
60 provide for the basic needs of the minor; (2) the parent poses a significant risk of
61 physical or emotional danger to the minor; or (3) the minor has not been in the care,
62 custody and control of the parent for the 6 months immediately preceding the filing
63 of the petition. **Section 46** also adds to the factors for consideration by the court the
64 question of whether the parent or another person has engaged in domestic violence
65 against the proposed protected minor, a parent of the minor or any other person
66 who resides with the minor. **Section 46** provides that, in the event of competing
67 petitions, any finding of unsuitability of a parent must be supported by clear and
68 convincing evidence after a hearing on the merits or an evidentiary hearing. **Section**
69 **46** authorizes the court to award temporary guardianship, supported by findings of
70 suitability, pending a trial or evidentiary hearing. Finally, **section 46** requires the
71 court to always act in the best interests of the proposed protected minor.

72 Existing law: (1) requires a guardian to petition the court to change the
73 residence of a ward to a location outside of this State; and (2) authorizes a guardian
74 to move or place the ward in a secured residential long-term care facility without
75 filing a petition if the court has previously granted the guardian such authority or
76 the move or placement is pursuant to a written recommendation by a licensed
77 physician, a physician employed by the Department of Veterans Affairs, a licensed
78 social worker or an employee of a county or state office for protective services.
79 (NRS 159.079) **Section 61** requires a guardian to file a petition for guardianship of
80 a protected minor in the state of the minor's new residence not later than 6 months
81 after changing the residence of the minor to a location outside of this State. **Section**
82 **61** also requires a guardian to file a petition with the court for authorization to move
83 a protected minor to a secured residential long-term facility in all circumstances.

84 **Section 73** revises provisions governing obligations due to or for a protected
85 minor to provide for the payment of child support to a guardian for the support of
86 the minor and to require a guardian to give notice to the court of the entry of an
87 order for the payment of support for the minor or the approval of any public
88 assistance for the minor.

89 **Section 128** requires a guardian of the estate of a minor to make and file a
90 verified account within 90 days after the emancipation of the minor, unless the
91 court authorizes a longer period.

92 Existing law sets forth circumstances under which the guardianship of the
93 person or the estate of a ward is terminated. (NRS 159.191) **Section 144** adds a
94 requirement that a hearing be held not later than 90 days before the protected minor
95 reaches the age of majority to determine whether guardianship is needed or
96 requested beyond the age of majority and whether the guardian should be notified
97 of any requirements of the guardianship which require compliance. **Section 144**
98 also provides for the filing of a petition for guardianship pursuant to existing law
99 governing guardianships for adults if the court determines that, upon reaching the
100 age of majority, a protected minor would be deemed an incompetent adult.

101 **Section 145** sets forth certain showings that a parent of a protected minor must
102 make to terminate the guardianship of the minor.

103 **Sections 158-192** of this bill revise the provisions of existing law in chapter
104 159 of NRS governing guardianships of adults to apply exclusively to
105 guardianships of adults.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Title 13 of NRS is hereby amended by adding
2 thereto a new chapter to consist of the provisions set forth as
3 sections 2 to 157, inclusive, of this act.

4 **Sec. 2.** *As used in this chapter, unless the context otherwise*
5 *requires, the words and terms defined in sections 3 to 14,*
6 *inclusive, of this act have the meanings ascribed to them in those*
7 *sections.*

8 **Sec. 3.** *“Care provider” includes any public or private*
9 *institution located within or outside this State which provides*
10 *facilities for the care or maintenance of minors.*

11 **Sec. 4.** *“Citation” means a document issued by the clerk of*
12 *the court, as authorized by statute or ordered by the court,*
13 *requiring a person to appear, directing a person to act or conduct*
14 *himself or herself in a specified way, or notifying a person of a*
15 *hearing.*

16 **Sec. 5.** *“Court” means any court or judge having jurisdiction*
17 *of the persons and estates of minors.*

18 **Sec. 6.** *“Guardian” means any person appointed under this*
19 *chapter as guardian of the person, of the estate, or of the person*
20 *and estate for any other person, and includes an organization*
21 *under NRS 662.245 and joint appointees. The term includes,*
22 *without limitation, if the context so requires, a person appointed in*
23 *another state who serves in the same capacity as a guardian in this*
24 *State.*

25 **Sec. 7.** *“Home state” means the state in which the proposed*
26 *protected minor was physically present for at least 6 consecutive*
27 *months, including any temporary absence from the state,*
28 *immediately before the filing of a petition for the appointment of a*
29 *guardian.*

30 **Sec. 8.** *“Minor” means any person who is:*

- 31 1. *Less than 18 years of age; or*
- 32 2. *Less than 19 years of age if the guardianship is continued*
33 *until the person reaches the age of 19 years pursuant to section*
34 *144 of this act.*

35 **Sec. 9. 1.** *“Private professional guardian” means a person*
36 *who receives compensation for services as a guardian to three or*
37 *more wards who are not related to the guardian by blood or*
38 *marriage.*

39 2. *For the purposes of this chapter, the term includes:*

40 (a) *A person who serves as a private professional guardian and*
41 *who is required to have a license issued pursuant to chapter 628B*
42 *of NRS.*



1 (b) *A person who serves as a private professional guardian but*
2 *who is exempt pursuant to NRS 159.0595 or 628B.110 or section*
3 *45 of this act from the requirement to have a license issued*
4 *pursuant to chapter 628B of NRS.*

5 3. *The term does not include:*

6 (a) *A governmental agency.*

7 (b) *A public guardian appointed or designated pursuant to the*
8 *provisions of chapter 253 of NRS.*

9 **Sec. 10.** *“Proposed protected minor” means any minor for*
10 *whom proceedings for the appointment of a guardian have been*
11 *initiated in this State or, if the context so requires, for whom*
12 *similar proceedings have been initiated in another state.*

13 **Sec. 11.** *“Protected minor” means any minor for whom a*
14 *guardian has been appointed.*

15 **Sec. 12.** *“Secured residential long-term care facility” has the*
16 *meaning ascribed to it in NRS 159.0255.*

17 **Sec. 13.** *“State” has the meaning ascribed to it in*
18 *NRS 159.0265.*

19 **Sec. 14.** *“Ward” means any person for whom a guardian has*
20 *been appointed.*

21 **Sec. 15.** *As used in this chapter, unless the context otherwise*
22 *requires, when the term “writing” or “written” is used in*
23 *reference to a will or instrument, the term includes an electronic*
24 *will as defined in NRS 132.119 and an electronic trust as defined*
25 *in NRS 163.0015.*

26 **Sec. 16.** *Except as otherwise provided in this chapter, the*
27 *provisions of this chapter do not apply to guardians ad litem.*

28 **Sec. 17.** 1. *Except as otherwise provided in this section, by*
29 *specific statute or as ordered by the court, a petitioner in a*
30 *guardianship proceeding shall give notice of the time and place of*
31 *the hearing on any petition filed in the guardianship proceeding*
32 *to:*

33 (a) *Any protected minor who is 14 years of age or older.*

34 (b) *The parent or legal guardian of any protected minor who is*
35 *less than 14 years of age.*

36 (c) *All known relatives of the protected minor who are within*
37 *the second degree of consanguinity.*

38 (d) *Any other interested person or the person’s attorney who*
39 *has filed a request for notice in the guardianship proceedings and*
40 *has served a copy of the request upon the guardian. The request*
41 *for notice must state the interest of the person filing the request*
42 *and the person’s name and address, or that of his or her attorney.*

43 (e) *The guardian, if the petitioner is not the guardian.*

44 (f) *Any person or care provider who is providing care for the*
45 *protected minor, except that if the person or care provider is not*



1 *related to the protected minor, such person or care provider must*
2 *not receive copies of any inventory or accounting.*

3 *(g) The Director of the Department of Health and Human*
4 *Services if the protected minor has received or is receiving benefits*
5 *from Medicaid.*

6 *(h) Those persons entitled to notice if a proceeding were*
7 *brought in the protected minor's home state.*

8 *2. The petitioner shall give notice not later than 10 days*
9 *before the date set for the hearing:*

10 *(a) By mailing a copy of the notice by certified, registered or*
11 *ordinary first-class mail to the residence, office or post office*
12 *address of each person required to be notified pursuant to this*
13 *section;*

14 *(b) By personal service; or*

15 *(c) In any other manner ordered by the court, upon a showing*
16 *of good cause.*

17 *3. Except as otherwise provided in this subsection, if none of*
18 *the persons entitled to notice of a hearing on a petition pursuant to*
19 *this section can, after due diligence, be served by certified mail or*
20 *personal service and this fact is proven by affidavit to the*
21 *satisfaction of the court, service of the notice must be made by*
22 *publication in the manner provided by N.R.C.P. 4(e). In all such*
23 *cases, the notice must be published not later than 10 days before*
24 *the date set for the hearing. If, after the appointment of a*
25 *guardian, a search for relatives of the protected minor listed in*
26 *paragraph (c) of subsection 1 fails to find any such relative, the*
27 *court may waive the notice by publication required by this*
28 *subsection.*

29 *4. For good cause shown, the court may waive the*
30 *requirement of giving notice.*

31 *5. A person entitled to notice pursuant to this section may*
32 *wave such notice. Such a waiver must be in writing and filed with*
33 *the court.*

34 *6. On or before the date set for the hearing, the petitioner*
35 *shall file with the court proof of giving notice to each person*
36 *entitled to notice pursuant to this section.*

37 **Sec. 18.** *If publication of a notice or citation is required*
38 *pursuant to this chapter, the court may, for good cause shown:*

39 *1. Allow fewer publications to be made within the time for*
40 *publication; and*

41 *2. Extend or shorten the time in which the publications must*
42 *be made.*

43 **Sec. 19.** *If a petition, notice, objection, consent, waiver or*
44 *other paper may be filed, a true and correct facsimile of it may be*



1 *filed, if the original is filed within a reasonable time or at such*
2 *time prescribed by the court.*

3 **Sec. 20.** *All notices required to be given by this chapter may*
4 *be given by the clerk of the court without an order from the court,*
5 *and when so given, for the time and in the manner required by*
6 *law, they are legal and valid as though made upon an order from*
7 *the court. If use of a citation is authorized or required by statute,*
8 *the citation may be issued by the clerk of the court on the request*
9 *of a party or the party's attorney without a court order, unless an*
10 *order is expressly required by statute.*

11 **Sec. 21.** *1. The venue for the appointment of a guardian*
12 *when the proposed protected minor's home state is this State must*
13 *be the county where the proposed protected minor resides.*

14 *2. If the proper venue may be in two or more counties, the*
15 *county in which the proceeding is first commenced is the proper*
16 *county in which to continue the proceedings.*

17 *3. Upon the filing of a petition showing that the proper venue*
18 *is inconvenient, a venue other than that provided in subsection 1*
19 *may accept the proceeding.*

20 **Sec. 22.** *1. If proceedings for the appointment of a*
21 *guardian for the same proposed protected minor are commenced*
22 *in more than one county in this State, and the proposed protected*
23 *minor's home state is this State, the proceedings must be stayed,*
24 *except in the county where first commenced, until final*
25 *determination of venue in that county. If the court shall cause a*
26 *transcript of the proceedings and all original papers filed therein,*
27 *all certified by the clerk of the court, to be sent to the clerk of the*
28 *court of the proper county.*

29 *2. A proceeding is considered commenced by the filing of a*
30 *petition.*

31 *3. The proceedings first legally commenced for the*
32 *appointment of a guardian of the estate or of the person and estate*
33 *extend to all the property of the proposed protected minor which is*
34 *in this State.*

35 **Sec. 23.** *A court having before it any guardianship matter for*
36 *a minor whose home state is this State may transfer the matter to*
37 *another county in the interest of the minor or, if not contrary to*
38 *the interest of the minor, for the convenience of the guardian. A*
39 *petition for the transfer, setting forth the reasons therefor, may be*
40 *filed in the guardianship proceeding. If the court is satisfied that*
41 *the transfer is in the interest of the minor or, if not contrary to*
42 *the interest of the minor, for the convenience of the guardian, the*
43 *court shall make an order of transfer and cause a transcript of the*
44 *proceedings in the matter, all original papers filed in such*
45



1 *proceedings and the original bond filed by the guardian, to be*
2 *certified by the clerk of the court originally hearing the matter and*
3 *sent to the clerk of the court of the other county. Upon receipt of*
4 *the transcript, papers and bond, and the filing of them for record,*
5 *the court of the other county has complete jurisdiction of the*
6 *matter, and thereafter all proceedings must be as though they were*
7 *commenced in that court.*

8 **Sec. 24.** 1. *All petitions filed in a guardianship proceeding*
9 *pursuant to this chapter must bear the title of the court and cause.*

10 2. *The caption of all petitions and other documents filed in a*
11 *guardianship proceeding pursuant to this chapter must read, "In*
12 *The Matter of the Guardianship of (the person, the*
13 *estate, or the person and estate), (the legal name of the*
14 *person), minor."*

15 **Sec. 25.** 1. *Except as otherwise provided in NRS 127.045, a*
16 *proposed protected minor, a governmental agency, a nonprofit*
17 *corporation or any interested person may petition the court for the*
18 *appointment of a guardian.*

19 2. *To the extent the petitioner knows or reasonably may*
20 *ascertain or obtain, the petition must include, without limitation:*

21 (a) *The name and address of the petitioner.*

22 (b) *The name, date of birth and current address of the*
23 *proposed protected minor.*

24 (c) *A copy of one of the following forms of identification of the*
25 *proposed protected minor which must be placed in the records*
26 *relating to the guardianship proceeding and, except as otherwise*
27 *provided in NRS 239.0115 or as otherwise required to carry out a*
28 *specific statute, maintained in a confidential manner:*

29 (1) *A social security number;*

30 (2) *A birth certificate;*

31 (3) *A valid driver's license number;*

32 (4) *A valid identification card number; or*

33 (5) *A valid passport number.*

34 ↪ *If the information required pursuant to this paragraph is not*
35 *included with the petition, the information must be provided to the*
36 *court not later than 120 days after the appointment of a guardian*
37 *or as otherwise ordered by the court.*

38 (d) *The date on which the proposed protected minor will attain*
39 *the age of majority and:*

40 (1) *Whether there is a current order concerning custody*
41 *and, if so, the state in which the order was issued; and*

42 (2) *Whether the petitioner anticipates that the proposed*
43 *protected minor will need guardianship after attaining the age of*
44 *majority.*



1 (e) Whether the proposed protected minor is a resident or
2 nonresident of this State.

3 (f) The names and addresses of the relatives of the proposed
4 protected minor who are within the second degree of
5 consanguinity.

6 (g) The name, date of birth and current address of the
7 proposed guardian. If the proposed guardian is a private
8 professional guardian, the petition must include proof that
9 the guardian meets the requirements of section 45 of this act. If
10 the proposed guardian is not a private professional guardian, the
11 petition must include a statement that the guardian currently is
12 not receiving compensation for services as a guardian to more
13 than one ward who is not related to the person by blood or
14 marriage.

15 (h) A copy of one of the following forms of identification of the
16 proposed guardian which must be placed in the records relating to
17 the guardianship proceeding and, except as otherwise provided in
18 NRS 239.0115 or as otherwise required to carry out a specific
19 statute, maintained in a confidential manner:

- 20 (1) A social security number;
21 (2) A birth certificate;
22 (3) A valid driver's license number;
23 (4) A valid identification card number; or
24 (5) A valid passport number.

25 (i) Whether the proposed guardian has ever been convicted of
26 a felony and, if so, information concerning the crime for which
27 the proposed guardian was convicted and whether the proposed
28 guardian was placed on probation or parole.

29 (j) A summary of the reasons why a guardian is needed and
30 any available documentation demonstrating the need for a
31 guardianship, including, without limitation, any orders or other
32 information from a court concerning the custody of the proposed
33 protected minor.

34 (k) A general description and the probable value of the
35 property of the proposed protected minor and any income to which
36 the proposed protected minor is or will be entitled, if the petition is
37 for the appointment of a guardian of the estate.

38 (l) The name and address of any person or care provider
39 having the care, custody or control of the proposed protected
40 minor.

41 (m) If a petitioner is not a parent of the proposed protected
42 minor, a declaration explaining the relationship of the petitioner
43 to the proposed protected minor or to the proposed protected
44 minor's parents and the interest, if any, of that petitioner in the
45 appointment.



1 (n) *Requests for any of the specific powers set forth in sections*
2 *117 to 126, inclusive, of this act necessary to enable the guardian*
3 *to carry out the duties of the guardianship.*

4 (o) *If the guardianship is sought as the result of an*
5 *investigation of a report of abuse or neglect of the proposed*
6 *protected minor, whether the referral was from a law enforcement*
7 *agency or a state or county agency.*

8 (p) *Whether the proposed protected minor or the proposed*
9 *guardian is a party to any pending criminal or civil litigation.*

10 (q) *Whether the guardianship is sought for the purpose of*
11 *initiating litigation.*

12 (r) *Whether the proposed guardian has filed for or received*
13 *protection under the federal bankruptcy laws within the*
14 *immediately preceding 7 years.*

15 **Sec. 26. 1. On or after the date of the filing of a petition to**
16 **appoint a guardian:**

17 (a) *The court may appoint a person to represent the protected*
18 *minor or proposed protected minor as a guardian ad litem; and*

19 (b) *The guardian ad litem must represent the protected minor*
20 *or proposed protected minor as a guardian ad litem until relieved*
21 *of that duty by court order.*

22 2. *Upon the appointment of the guardian ad litem, the court*
23 *shall set forth in the order of appointment the duties of the*
24 *guardian ad litem.*

25 3. *The guardian ad litem is entitled to reasonable*
26 *compensation from the estate of the protected minor or proposed*
27 *protected minor. If the court finds that a person has unnecessarily*
28 *or unreasonably caused the appointment of a guardian ad litem,*
29 *the court may order the person to pay to the estate of the protected*
30 *minor or proposed protected minor all or part of the expenses*
31 *associated with the appointment of the guardian ad litem.*

32 **Sec. 27. 1. The court may appoint an advocate for the best**
33 **interests of a protected minor or proposed protected minor who is**
34 **the subject of guardianship proceedings conducted pursuant to**
35 **this chapter if the court believes that the minor could benefit from**
36 **that appointment.**

37 2. *The court may not appoint an attorney as an advocate for*
38 *the best interests of a protected minor or proposed protected minor*
39 *unless:*

40 (a) *The court believes that an attorney who represents a*
41 *protected minor or proposed protected minor is unable to provide*
42 *information which is required by the court to make a*
43 *determination on the best interests of the minor;*

44 (b) *No volunteer is available to serve as an advocate; or*



1 (c) *Extraordinary circumstances exist in which an attorney*
2 *may assist the court as an advocate.*

3 3. *An advocate for the best interests of a protected minor*
4 *or proposed protected minor who is appointed pursuant to*
5 *subsection 1:*

6 (a) *Is an officer of the court;*

7 (b) *Does not represent the protected minor or proposed*
8 *protected minor;*

9 (c) *Shall not offer legal advice;*

10 (d) *Is not a party to the case;*

11 (e) *Shall advocate for the best interests of the protected minor*
12 *or proposed protected minor; and*

13 (f) *Shall provide information to the court in accordance with*
14 *applicable court rule.*

15 **Sec. 28. 1.** *Upon filing of the petition, or any time*
16 *thereafter, the court may appoint one or more investigators to:*

17 (a) *Locate persons who perform services needed by the*
18 *proposed protected minor and other public and private resources*
19 *available to the proposed protected minor.*

20 (b) *Determine any competing interests in the appointment of a*
21 *guardian.*

22 (c) *Investigate allegations or claims which affect a proposed*
23 *protected minor.*

24 (d) *Investigate the suitability of a proposed guardian to provide*
25 *for the basic needs of a proposed protected minor, including,*
26 *without limitation, food, clothing, shelter, medical care and*
27 *education.*

28 (e) *Locate relatives of the proposed protected minor who are*
29 *within the second degree of consanguinity.*

30 2. *An investigator may be an employee of a social service*
31 *agency, family service officer of the court, public guardian,*
32 *physician or other qualified person.*

33 3. *An investigator shall file with the court and parties a report*
34 *concerning the scope of the appointment of the guardian and any*
35 *special powers which a guardian would need to assist the proposed*
36 *protected minor.*

37 4. *An investigator who is appointed pursuant to this section is*
38 *entitled to reasonable compensation from the estate of the*
39 *proposed protected minor. If the court finds that a person has*
40 *unnecessarily or unreasonably caused the investigation, the court*
41 *may order the person to pay to the estate of the proposed protected*
42 *minor all or part of the expenses associated with the investigation.*

43 **Sec. 29. 1.** *Except as otherwise provided in sections 30, 35,*
44 *36 and 37 of this act, upon the filing of a petition under section 25*
45 *of this act, the clerk shall issue a citation setting forth a time and*



1 *place for the hearing and directing the persons or care provider*
2 *referred to in subsection 2 to appear and show cause why a*
3 *guardian should not be appointed for the proposed protected*
4 *minor.*

5 *2. A citation issued under subsection 1 must be served upon:*

6 *(a) A proposed protected minor who is 14 years of age or*
7 *older;*

8 *(b) All known relatives of the proposed protected minor who*
9 *are:*

10 *(1) Fourteen years of age or older; and*

11 *(2) Within the second degree of consanguinity;*

12 *(c) The parents and custodian of the proposed protected*
13 *minor;*

14 *(d) Any person or officer of a care provider having the care,*
15 *custody or control of the proposed protected minor;*

16 *(e) The proposed guardian, if the petitioner is not the proposed*
17 *guardian; and*

18 *(f) The Director of the Department of Health and Human*
19 *Services if the proposed protected minor has received or is*
20 *receiving any benefits from Medicaid.*

21 **Sec. 30.** *1. A copy of the citation issued pursuant to section*
22 *29 of this act must be served by:*

23 *(a) Certified mail, with a return receipt requested, on each*
24 *person required to be served pursuant to section 29 of this act at*
25 *least 20 days before the hearing; or*

26 *(b) Personal service in the manner provided pursuant to*
27 *N.R.C.P. 4(d) at least 10 days before the date set for the hearing*
28 *on each person required to be served pursuant to section 29 of this*
29 *act.*

30 *2. If none of the persons on whom the citation is to be served*
31 *can, after due diligence, be served by certified mail or personal*
32 *service and this fact is proven, by affidavit, to the satisfaction of*
33 *the court, service of the citation must be made by publication in*
34 *the manner provided by N.R.C.P. 4(e). In all such cases, the*
35 *citation must be published at least 20 days before the date set for*
36 *the hearing.*

37 *3. A citation need not be served on a person or an officer of*
38 *the care provider who has signed the petition or a written waiver*
39 *of service of citation or who makes a general appearance.*

40 *4. The court may find that notice is sufficient if:*

41 *(a) The citation has been served by certified mail, with a return*
42 *receipt requested, or by personal service on the proposed protected*
43 *minor, care provider or public guardian required to be served*
44 *pursuant to section 29 of this act; and*



1 (b) *At least one relative of the proposed protected minor who is*
2 *required to be served pursuant to section 29 of this act has been*
3 *served, as evidenced by the return receipt or the certificate of*
4 *service. If the court finds that at least one relative of the proposed*
5 *protected minor has not received notice that is sufficient, the*
6 *court will require the citation to be published pursuant to*
7 *subsection 2.*

8 **Sec. 31.** *The citation issued pursuant to section 29 of this act*
9 *must state that:*

10 1. *A guardian may be appointed for the proposed protected*
11 *minor;*

12 2. *The rights of the proposed protected minor and of any*
13 *person having legal or physical custody of the proposed protected*
14 *minor may be affected as specified in the petition;*

15 3. *The proposed protected minor has the right to appear at*
16 *the hearing and to oppose the petition;*

17 4. *The proposed protected minor has the right to be*
18 *represented by an attorney; and*

19 5. *At any time during proceedings on the citation, the court*
20 *may appoint for the proposed protected minor:*

21 (a) *An attorney.*

22 (b) *A guardian ad litem pursuant to section 26 of this act.*

23 (c) *An advocate for the best interests of the proposed protected*
24 *minor pursuant to section 27 of this act.*

25 **Sec. 32.** *A protected minor or proposed protected minor who*
26 *is the subject of proceedings held pursuant to this chapter may be*
27 *represented by an attorney at all stages of the proceedings. If the*
28 *protected minor or proposed protected minor is represented by an*
29 *attorney, the attorney has the same authority and rights as an*
30 *attorney representing a party to the proceedings.*

31 **Sec. 33.** 1. *A court may find that a petitioner is a vexatious*
32 *litigant if a person, other than the protected minor:*

33 (a) *Files a petition which is without merit or intended to*
34 *harass or annoy the guardian; and*

35 (b) *Has previously filed pleadings in a guardianship*
36 *proceeding that were without merit or intended to harass or annoy*
37 *the guardian.*

38 2. *If a court finds a person is a vexatious litigant pursuant to*
39 *subsection 1, the court may impose sanctions on the petitioner in*
40 *an amount sufficient to reimburse the estate of the protected*
41 *minor for all or part of the expenses incurred by the estate of the*
42 *protected minor to defend the petition, to respond to the petition*
43 *and for any other pecuniary losses which are associated with the*
44 *petition.*



1 **Sec. 34.** *Any court of competent jurisdiction may appoint:*

2 1. *Guardians of the person, of the estate, or of the person and*
3 *estate for minors whose home state is this State.*

4 2. *Guardians of the person or of the person and estate for*
5 *minors who, although not residents of this State, are physically*
6 *present in this State and whose welfare requires such an*
7 *appointment.*

8 3. *Guardians of the estate for nonresident minors who have*
9 *property within this State.*

10 4. *Guardians ad litem.*

11 **Sec. 35.** *The court may, without issuing a citation, appoint a*
12 *guardian for the proposed protected minor if the petitioner is a*
13 *parent who has sole legal and physical custody of the proposed*
14 *protected minor as evidenced by a valid court order or birth*
15 *certificate and who is seeking the appointment of a guardian for*
16 *the minor child of the parent. If the proposed protected minor is a*
17 *minor who is 14 years of age or older:*

18 1. *The petition must be accompanied by the written consent*
19 *of the minor to the appointment of the guardian; or*

20 2. *The minor must consent to the appointment of the*
21 *guardian in open court.*

22 **Sec. 36.** 1. *A petitioner may request the court to appoint a*
23 *temporary guardian for a proposed protected minor who is in need*
24 *of immediate medical attention which he or she cannot obtain*
25 *without the appointment of a temporary guardian. To support the*
26 *request, the petitioner must set forth in a petition and present to*
27 *the court under oath:*

28 (a) *Documentation which shows that the proposed protected*
29 *minor needs immediate medical attention and, without the*
30 *appointment of a temporary guardian, cannot obtain that medical*
31 *attention. Such documentation must include, without limitation, a*
32 *copy of the birth certificate of the proposed protected minor or*
33 *other documentation verifying the age of the proposed protected*
34 *minor.*

35 (b) *Facts which show that:*

36 (1) *The petitioner has tried in good faith to notify the*
37 *persons entitled to notice pursuant to section 29 of this act by*
38 *telephone or in writing before the filing of the petition;*

39 (2) *The proposed protected minor would be exposed to an*
40 *immediate risk of physical harm if the petitioner were to provide*
41 *notice to the persons entitled to notice pursuant to section 29 of*
42 *this act before the court determines whether to appoint a*
43 *temporary guardian; or*

44 (3) *Giving notice to the persons entitled to notice pursuant*
45 *to section 29 of this act is not feasible under the circumstances.*



1 2. *The court may appoint a temporary guardian to serve for*
2 *10 days if the court:*

3 (a) *Finds reasonable cause to believe that the proposed*
4 *protected minor is in need of immediate medical attention which*
5 *he or she cannot obtain without the appointment of a temporary*
6 *guardian; and*

7 (b) *Is satisfied that the petitioner has tried in good faith to*
8 *notify the persons entitled to notice pursuant to section 29 of this*
9 *act or that giving notice to those persons is not feasible under the*
10 *circumstances, or determines that such notice is not required*
11 *pursuant to subparagraph (2) of paragraph (b) of subsection 1.*

12 3. *Except as otherwise provided in subsection 4, after the*
13 *appointment of a temporary guardian, the petitioner shall attempt*
14 *in good faith to notify the persons entitled to notice pursuant to*
15 *section 29 of this act, including, without limitation, notice of any*
16 *hearing to extend the temporary guardianship. If the petitioner*
17 *fails to make such an effort, the court may terminate the*
18 *temporary guardianship.*

19 4. *If, before the appointment of a temporary guardian, the*
20 *court was satisfied that giving notice to the persons entitled to*
21 *notice pursuant to section 29 of this act was not feasible under the*
22 *circumstances or determined that such notice was not required*
23 *pursuant to subparagraph (2) of paragraph (b) of subsection 1, the*
24 *petitioner shall notify the persons entitled to notice pursuant to*
25 *section 29 of this act without undue delay, but not later than 48*
26 *hours after the appointment of the temporary guardian or not later*
27 *than 48 hours after the petitioner discovers the existence, identity*
28 *and location of the persons entitled to notice pursuant to that*
29 *section. If the petitioner fails to provide such notice, the court may*
30 *terminate the temporary guardianship.*

31 5. *Not later than 10 days after the date of the appointment of*
32 *a temporary guardian pursuant to subsection 2, the court shall*
33 *hold a hearing to determine the need to extend the temporary*
34 *guardianship. Except as otherwise provided in subsection 7, if the*
35 *court finds by clear and convincing evidence that the protected*
36 *minor continues to be in need of immediate medical attention*
37 *which he or she cannot obtain without the extension of the*
38 *temporary guardianship, the court may, pursuant to subsection 8,*
39 *extend the temporary guardianship until a general guardian is*
40 *appointed.*

41 6. *If the court appoints a temporary guardian or extends a*
42 *temporary guardianship pursuant to this section, the court shall*
43 *limit the powers of the temporary guardian to those necessary to*
44 *respond to the need for immediate medical attention.*



1 7. The court may not extend a temporary guardianship
2 pursuant to subsection 5 beyond the initial period of 10 days
3 unless the petitioner demonstrates that:

4 (a) The provisions of section 30 of this act have been satisfied;
5 or

6 (b) Notice by publication pursuant to N.R.C.P. 4(e) is currently
7 being undertaken.

8 8. The court may extend the temporary guardianship, for
9 good cause shown, for not more than two successive 60-day
10 periods.

11 **Sec. 37. 1. A petitioner may request that the court appoint a**
12 **temporary guardian for the person or the estate, or both, of a**
13 **proposed protected minor by filing a verified petition.**

14 2. The petition must state facts which establish good cause
15 for the appointment of a temporary guardian and which show
16 that:

17 (a) The petitioner has tried in good faith to notify the persons
18 entitled to notice pursuant to section 29 of this act by telephone or
19 in writing before the filing of the petition;

20 (b) The proposed protected minor would be exposed to an
21 immediate risk of physical, emotional or financial harm if the
22 petitioner were to provide notice to the persons entitled to notice
23 pursuant to section 29 of this act before the court determines
24 whether to appoint a temporary guardian; or

25 (c) Giving notice to the persons entitled to notice pursuant to
26 section 29 of this act is not feasible under the circumstances.

27 3. A petition which seeks an ex parte appointment of a
28 temporary guardian must be accompanied by an affidavit which
29 explains the emergency that requires a temporary guardian to be
30 appointed before a hearing.

31 4. If no parent of the proposed protected minor has had the
32 care, custody and control of the minor for the 6 months
33 immediately preceding the petition, temporary guardianship of the
34 person of the minor is presumed to be in the best interest of the
35 minor.

36 5. The court may, upon that petition or other showing as it
37 may require, appoint a temporary guardian of the person or the
38 estate, or both, of the proposed protected minor.

39 6. Except as otherwise provided in subsection 7, after the
40 appointment of a temporary guardian, the petitioner shall attempt
41 in good faith to notify the persons entitled to notice pursuant to
42 section 29 of this act, including, without limitation, notice of any
43 hearing to extend the temporary guardianship. If the petitioner
44 fails to make such an effort, the court may terminate the
45 temporary guardianship.



1 7. *If, before the appointment of a temporary guardian, the*
2 *court was satisfied that giving notice to the persons entitled to*
3 *notice pursuant to section 29 of this act was not feasible under the*
4 *circumstances or determined that such notice was not required*
5 *pursuant to paragraph (b) or (c) of subsection 2, the petitioner*
6 *shall notify the persons entitled to notice pursuant to section 29 of*
7 *this act without undue delay, but not later than 48 hours after the*
8 *appointment of the temporary guardian or not later than 48 hours*
9 *after the petitioner discovers the existence, identity and location of*
10 *the persons entitled to notice pursuant to that section. If the*
11 *petitioner fails to provide such notice, the court may terminate the*
12 *temporary guardianship.*

13 8. *Not later than 10 days after the date of an ex parte*
14 *appointment of a temporary guardian pursuant to subsection 5,*
15 *the court shall hold a hearing to determine the need to extend the*
16 *temporary guardianship. Except as otherwise provided in*
17 *subsection 9, if the court finds by clear and convincing evidence*
18 *that the protected minor continues to be in need of a temporary*
19 *guardian, the court may, pursuant to subsection 10, extend the*
20 *temporary guardianship until a general guardian is appointed.*

21 9. *The court may not extend a temporary guardianship*
22 *pursuant to subsection 8 beyond the initial period of 10 days*
23 *unless the petitioner demonstrates that:*

24 (a) *The provisions of section 30 of this act have been satisfied;*
25 *or*

26 (b) *Notice by publication pursuant to N.R.C.P. 4(e) is currently*
27 *being undertaken.*

28 10. *The court may extend the temporary guardianship, for*
29 *good cause shown, for not more than two successive 60-day*
30 *periods, unless extraordinary circumstances necessitate a longer*
31 *duration for the temporary guardianship.*

32 11. *If for any reason a guardian who is appointed for a*
33 *protected minor cannot perform the duties of a guardian, the court*
34 *may, upon a petition filed to request temporary guardianship for*
35 *the minor, appoint a temporary guardian to exercise the powers of*
36 *a guardian until another guardian is appointed for the minor.*

37 **Sec. 38. 1.** *A proposed protected minor who is found in this*
38 *State must attend the hearing for the appointment of a guardian*
39 *unless:*

40 (a) *A certificate signed by a physician or psychiatrist who is*
41 *licensed to practice in this State specifically states the condition of*
42 *the proposed protected minor, the reasons why the proposed*
43 *protected minor is unable to appear in court and whether the*
44 *proposed protected minor's attendance at the hearing would be*



1 *detrimental to the physical or mental health of the proposed*
2 *protected minor; or*

3 *(b) A certificate signed by any other person the court finds*
4 *qualified to execute a certificate states the condition of the*
5 *proposed protected minor, the reasons why the proposed protected*
6 *minor is unable to appear in court and whether the proposed*
7 *protected minor's attendance at the hearing would be detrimental*
8 *to the physical or mental health of the proposed protected minor.*

9 *2. A proposed protected minor found in this State who cannot*
10 *attend the hearing for the appointment of a guardian as set forth*
11 *in a certificate pursuant to subsection 1 may appear by*
12 *videoconference.*

13 *3. The court may prescribe the form in which a certificate*
14 *required by this section must be filed. If the certificate consists of*
15 *separate parts, each part must be signed by the person who is*
16 *required to sign the certificate.*

17 *4. If the proposed protected minor is not in this State, the*
18 *proposed protected minor must attend the hearing only if the court*
19 *determines that the attendance of the proposed protected minor is*
20 *necessary in the interests of justice.*

21 **Sec. 39. 1. If the court finds the proposed protected minor**
22 **not in need of a guardian, the court shall dismiss the petition.**

23 *2. If the court finds that appointment of a guardian is*
24 *required, the court shall appoint a guardian of the proposed*
25 *protected minor's person, estate, or person and estate.*

26 **Sec. 40. 1. The petitioner has the burden of proving by**
27 **clear and convincing evidence that the appointment of a guardian**
28 **of the person, of the estate, or of the person and estate is**
29 **necessary.**

30 *2. If it appears to the court that the allegations of the petition*
31 *are sufficient and that a guardian should be appointed for the*
32 *proposed protected minor, the court shall enter an order*
33 *appointing a guardian. The order must:*

34 *(a) Specify whether the guardian appointed is guardian of the*
35 *person, of the estate, or of the person and estate;*

36 *(b) Specify whether the proposed protected minor is a resident*
37 *or nonresident of this State;*

38 *(c) Specify the amount of the bond to be executed and filed by*
39 *the guardian; and*

40 *(d) Designate the names and addresses, so far as may be*
41 *determined, of:*

42 *(1) The relatives of the proposed protected minor upon*
43 *whom notice must be served pursuant to section 29 of this act; and*

44 *(2) Any other interested person.*

45 *3. A notice of entry of the court order must be sent to:*



1 (a) *The relatives of the proposed protected minor upon whom*
2 *notice must be served pursuant to section 29 of this act; and*

3 (b) *Any other interested person.*

4 **Sec. 41.** *If a court order is in effect for payment for the*
5 *support of a proposed protected minor, upon entry of an order*
6 *appointing a guardian for the minor, the court shall order the*
7 *assignment of the payment to the guardian for the support of that*
8 *minor.*

9 **Sec. 42.** *In an order appointing a guardian or in any order*
10 *thereafter, the court may award rights of visitation between a*
11 *protected minor and his or her parents or relatives who are within*
12 *the fourth degree of consanguinity.*

13 **Sec. 43. 1.** *Where the appointment of a guardian is sought*
14 *for two or more proposed protected minors who are children of a*
15 *common parent, parent and child or husband and wife, it is not*
16 *necessary that separate petitions, bonds and other papers be filed*
17 *with respect to each proposed protected minor or protected minors.*

18 **2.** *If a guardian is appointed for such proposed protected*
19 *minors, the guardian:*

20 (a) *Shall keep separate accounts of the estate of each protected*
21 *minor;*

22 (b) *May make investments for each protected minor;*

23 (c) *May compromise and settle claims against one or more*
24 *protected minors; and*

25 (d) *May sell, lease, mortgage or otherwise manage the property*
26 *of one or more protected minors.*

27 **3.** *The guardianship may be terminated with respect to less*
28 *than all the protected minors in the same manner as provided by*
29 *law with respect to a guardianship of a single protected minor.*

30 **Sec. 44.** *As a condition of the appointment of a guardian, the*
31 *court may require the guardian to complete any available training*
32 *concerning guardianships that the court determines appropriate.*

33 **Sec. 45. 1.** *In order for a person to serve as a private*
34 *professional guardian, the person must be:*

35 (a) *Qualified to serve as a guardian pursuant to section 46 of*
36 *this act; and*

37 (b) *A guardian who has a license issued pursuant to chapter*
38 *628B of NRS or a certified guardian who is not required to have*
39 *such a license pursuant to subsection 3.*

40 **2.** *In order for an entity to serve as a private professional*
41 *guardian, the entity must:*

42 (a) *Have a license issued pursuant to chapter 628B of NRS*
43 *unless the entity is not required to have such a license pursuant to*
44 *subsection 3; and*



1 (b) Have a guardian who has a license issued pursuant to
2 chapter 628B of NRS or a certified guardian who is not required
3 to have such a license pursuant to subsection 3 involved in the
4 day-to-day operation or management of the entity.

5 3. For a person or entity to serve as a private professional
6 guardian, the person or entity is not required to have a license
7 issued pursuant to chapter 628B of NRS if the person or entity is
8 exempt from the requirement to have such a license pursuant to
9 NRS 628B.110 and the person or entity:

10 (a) Is a banking corporation as defined in NRS 657.016;

11 (b) Is an organization permitted to act as a fiduciary pursuant
12 to NRS 662.245;

13 (c) Is a trust company as defined in NRS 669.070;

14 (d) Is acting in the performance of his or her duties as an
15 attorney at law;

16 (e) Acts as a trustee under a deed of trust; or

17 (f) Acts as a fiduciary under a court trust.

18 4. As used in this section:

19 (a) "Certified guardian" means a person who is certified by
20 the Center for Guardianship Certification or any successor
21 organization.

22 (b) "Entity" includes, without limitation, a corporation,
23 whether or not for profit, a limited-liability company and a
24 partnership.

25 (c) "Person" means a natural person.

26 **Sec. 46. 1.** The parents of a proposed protected minor, or
27 either parent, if qualified and suitable, are preferred over all
28 others for appointment as guardian for the person or estate or
29 person and estate of the proposed protected minor. The
30 appointment of a parent as guardian for the person or estate of a
31 proposed protected minor must not conflict with a valid order for
32 custody of the proposed protected minor.

33 2. Except as otherwise provided in subsection 4, if a parent of
34 a proposed protected minor files a petition seeking appointment as
35 guardian for the proposed protected minor, the parent is presumed
36 to be suitable to serve as guardian for the proposed protected
37 minor.

38 3. In determining whether the parents of a proposed protected
39 minor, or either parent, or any other person who seeks
40 appointment as guardian for the proposed protected minor is
41 qualified and suitable, the court shall consider, if applicable and
42 without limitation:

43 (a) Which parent has physical custody of the proposed
44 protected minor;



1 ***(b) The ability of the parents, parent or other person to provide***
2 ***for the basic needs of the proposed protected minor, including,***
3 ***without limitation, food, shelter, clothing and medical care, taking***
4 ***into consideration any special needs of the proposed protected***
5 ***minor;***

6 ***(c) Whether the parents, parent or other person has engaged***
7 ***in the habitual use of alcohol or any controlled substance during***
8 ***the previous 6 months, except the use of marijuana in accordance***
9 ***with the provisions of chapter 453A of NRS;***

10 ***(d) Whether the parents, parent or other person has been***
11 ***convicted of a crime of moral turpitude, a crime involving***
12 ***domestic violence or a crime involving the abuse, neglect,***
13 ***exploitation, isolation or abandonment of a child, his or her***
14 ***spouse, his or her parent or any other adult;***

15 ***(e) Whether the parents, parent or other person has been***
16 ***convicted in this State or any other jurisdiction of a felony; and***

17 ***(f) Whether the parents, parent or other person has engaged in***
18 ***one or more acts of domestic violence against the proposed***
19 ***protected minor, a parent of the proposed protected minor or any***
20 ***other person who resides with the proposed protected minor.***

21 ***4. A parent of a proposed protected minor is presumed to be***
22 ***unsuitable to care for the proposed protected minor if:***

23 ***(a) The parent is unable to provide for any or all of the basic***
24 ***needs of the proposed protected minor, including, without***
25 ***limitation:***

26 ***(1) Food;***

27 ***(2) Shelter;***

28 ***(3) Clothing;***

29 ***(4) Medical care; and***

30 ***(5) Education;***

31 ***(b) Because of action or inaction, the parent poses a***
32 ***significant safety risk of either physical or emotional danger to the***
33 ***proposed protected minor; or***

34 ***(c) The proposed protected minor has not been in the care,***
35 ***custody and control of the parent for the 6 months immediately***
36 ***preceding the filing of the petition. The presumption created by***
37 ***this paragraph is a rebuttable presumption.***

38 ***5. Subject to the preference set forth in subsection 1 and***
39 ***except as otherwise provided in subsection 7, the court shall***
40 ***appoint as guardian the qualified person who is most suitable and***
41 ***is willing to serve.***

42 ***6. In determining which qualified person is most suitable, the***
43 ***court shall, in addition to considering any applicable factors set***
44 ***forth in subsections 2, 3 and 4, give consideration, among other***
45 ***factors, to:***



1 (a) Any nomination of a guardian for the proposed protected
2 minor contained in a will or other written instrument executed by
3 a parent of the proposed protected minor.

4 (b) Any request made by the proposed protected minor, if he or
5 she is 14 years of age or older, for the appointment of a person as
6 guardian for the proposed protected minor.

7 (c) The relationship by blood or adoption of the proposed
8 guardian to the proposed protected minor. In considering
9 preferences of appointment, the court may consider relatives of the
10 half blood equally with those of the whole blood. The court may
11 consider relatives in the following order of preference:

12 (1) Parent.

13 (2) Adult sibling.

14 (3) Grandparent.

15 (4) Uncle or aunt.

16 (d) Any recommendation made by a master of the court or
17 special master pursuant to section 47 of this act.

18 (e) Any recommendation made by:

19 (1) An agency which provides child welfare services, an
20 agency which provides child protective services or a similar
21 agency; or

22 (2) A guardian ad litem or court appointed special advocate
23 who represents the proposed protected minor.

24 (f) Any request for the appointment of any other interested
25 person that the court deems appropriate.

26 7. The court may award temporary guardianship pursuant to
27 this section, supported by findings of suitability, pending a trial or
28 evidentiary hearing if that appointment is supported by findings.

29 8. Notwithstanding the presumption set forth in subsection 4,
30 in the event of competing petitions for the appointment of
31 guardianship of a proposed protected minor, any finding of
32 unsuitability of a parent of the proposed protected minor must be
33 found by clear and convincing evidence after a hearing on the
34 merits or an evidentiary hearing.

35 9. In determining whether to appoint a guardian of the
36 person or estate of a proposed protected minor and who should be
37 appointed, the court must always act in the best interests of the
38 proposed protected minor.

39 10. As used in this section, "agency which provides child
40 welfare services" has the meaning ascribed to it in NRS 432B.030.

41 **Sec. 47. 1.** If the court determines that a minor may be in
42 need of a guardian, the court may order the appointment of a
43 master of the court or a special master from among the members
44 of the State Bar of Nevada to conduct a hearing to identify the



1 *person most qualified and suitable to serve as guardian for the*
2 *proposed protected minor.*

3 *2. Not later than 5 calendar days after the date of the*
4 *hearing, the master of the court or special master shall prepare*
5 *and submit to the court a recommendation regarding which*
6 *person is most qualified and suitable to serve as guardian for the*
7 *proposed protected minor.*

8 **Sec. 48.** *If the court or a master of the court or special*
9 *master appointed pursuant to section 47 of this act finds that a*
10 *parent or other relative, teacher, friend or neighbor of a proposed*

12 *1. Has a personal interest in the well-being of the proposed*
13 *protected minor; or*

14 *2. Possesses information that is relevant to the determination*

16 *↳ the court or a master of the court or special master appointed*
17 *pursuant to section 47 of this act may allow the person to testify at*

21 **Sec. 49.** *A parent of a minor may by will nominate a*
22 *guardian. The person nominated must file a petition and obtain an*
23 *appointment from the court before exercising the powers of a*
24 *guardian.*

25 **Sec. 50.** *1. Except as otherwise provided by law, every*
26 *guardian shall, before entering upon his or her duties as*
27 *guardian, execute and file in the guardianship proceeding a bond,*
28 *with sufficient surety or sureties, in such amount as the court*
29 *determines necessary for the protection of the protected minor and*
30 *the estate of the protected minor, and conditioned upon the*
31 *faithful discharge by the guardian of his or her authority and*
32 *duties according to law. The bond must be approved by the clerk.*
33 *Sureties must be jointly and severally liable with the guardian and*

43 *5. If a person has been nominated to be guardian in a will,*
44 *power of attorney or other written instrument that has been*
45 *acknowledged before two disinterested witnesses or acknowledged*



1 before a notary public and the will, power of attorney or other
2 written instrument provides that no bond is to be required of the
3 guardian, the court may direct letters of guardianship to issue to
4 the guardian after the guardian:

5 (a) Takes and subscribes the oath of office; and

6 (b) Files the appropriate documents which contain the full
7 legal name and address of the guardian.

8 6. In lieu of executing and filing a bond, the guardian may
9 request that access to certain assets be blocked. The court may
10 grant the request and order letters of guardianship to issue to the
11 guardian if sufficient evidence is filed with the court to establish
12 that such assets are being held in a manner that prevents the
13 guardian from accessing the assets without a specific court order.

15 after notice to the guardian, increase or decrease the amount of

29 estate, and such bond is not void on the first recovery. If the action
30 on the bond is in behalf of one protected minor on a bond given to
31 more than one protected minor, the other protected minors
32 mentioned in the bond need not be united in or made parties to
33 such action.

34 **Sec. 53.** No action may be maintained against the sureties on
35 any bond given by a guardian unless it is commenced within 3
36 years after the time the guardian is discharged, unless at the time
37 of such discharge the person entitled to bring the action is under
38 any legal disability to sue, in which case the action may be
39 brought at any time within 3 years after the disability is removed.

40 **Sec. 54.** 1. Every guardian, before entering upon his or her
41 duties as guardian and before letters of guardianship may issue,
42 shall:

43 (a) Take and subscribe the official oath which must:

44 (1) Be endorsed on the letters of guardianship; and



1 (2) *State that the guardian will well and faithfully perform*
2 *the duties of guardian according to law.*

3 (b) *File in the proceeding the appropriate documents which*
4 *include, without limitation, the full legal name of the guardian*
5 *and the residence and post office addresses of the guardian.*

6 (c) *Except as otherwise provided in subsection 2, make and file*
7 *in the proceeding a verified acknowledgment of the duties and*
8 *responsibilities of a guardian. The acknowledgment must set*
9 *forth:*

10 (1) *A summary of the duties, functions and responsibilities*

18 (III) *Protect, preserve and manage the income, assets*
19 *and estate of the protected minor and utilize the income, assets*
20 *and estate of the protected minor solely for the benefit of the*

22 (IV) *Maintain the assets of the protected minor in the*
23 *name of the protected minor or the name of the guardianship. The*
24 *assets of the protected minor must not be commingled with the*
25 *assets of any third party.*

26 (V) *Notify the court, all interested parties, the trustee,*
27 *and named executor or appointed personal representative of the*
28 *estate of the protected minor of the death of the protected minor*
29 *within 30 days after the death.*

30 (2) *A summary of the statutes, regulations, rules and*
31 *standards governing the duties of a guardian.*

32 (3) *A list of actions regarding the protected minor that*
33 *require the prior approval of the court.*

34 (4) *A statement of the need for accurate recordkeeping and*
35 *the filing of annual reports with the court regarding the finances*
36 *and well-being of the protected minor.*

37 2. *The court may exempt a public guardian or private*
38 *professional guardian from filing an acknowledgment in each*
39 *case and, in lieu thereof, require the public guardian or private*
40 *professional guardian to file a general acknowledgment covering*
41 *all guardianships to which the guardian may be appointed by the*
42 *court.*

43 **Sec. 55. 1.** *A copy of the order appointing the guardian*
44 *must be served personally or by mail upon the protected minor not*
45 *later than 5 days after the date of the appointment of the guardian.*



1 2. The order must contain the names, addresses and
2 telephone numbers of the guardian, the protected minor's
3 attorney, if any, and the investigator.

4 3. A notice of entry of the order must be filed with the court.

5 **Sec. 56.** When a guardian has taken the official oath and
6 filed a bond as provided in this chapter, the court shall order
7 letters of guardianship to issue to the guardian. Letters of
8 guardianship may be in the following form:

34 **Sec. 57.** If, at the time of the appointment of the guardian or
35 thereafter, the estate of a protected minor consists of personal
36 property having a value not exceeding by more than \$10,000 the
37 aggregate amount of unpaid expenses of administration of the
38 guardianship estate and claims against the estate, the guardian of
39 the estate, with prior approval of the court by order, may pay those
40 expenses and claims from the estate and deliver all the remaining
41 personal property to such person as the court may designate in the
42 order, to be held, invested or used as ordered by the court. The
43 recipient of the property so delivered shall give a receipt therefor
44 to the guardian. The receipt is a release and acquittance to the
45 guardian as to the property so delivered. The guardian shall file in



1 *the proceeding proper receipts or other evidence satisfactory to the*
2 *court showing the delivery, and the guardian is released from his*
3 *or her trust and the bond of the guardian is exonerated.*

4 **Sec. 58.** 1. *The court may grant a summary administration*

38 *guardian shall petition the court for an order authorizing the*
39 *guardian to:*

40 (a) *Except as otherwise provided in this paragraph, make or*

42 *policy, bank account or any other type of asset of the protected*

12 (a) *"Exploitation" means any act taken by a person who has*
13 *the trust and confidence of a protected minor to:*

14 (1) *Obtain control, through deception, intimidation or*
15 *undue influence, over the money, assets or property of the*
16 *protected minor with the intention of permanently depriving*
17 *the protected minor of the ownership, use, benefit or possession of*
18 *the protected minor's money, assets or property.*

19 (2) *Convert money, assets or property of the protected*
20 *minor with the intention of permanently depriving the protected*
21 *minor of the ownership, use, benefit or possession of the*
22 *protected minor's money, assets or property.*

23 ↪ *As used in this paragraph, "undue influence" does not include*
24 *the normal influence that one member of a family has over*
25 *another.*

26 (b) *"Fraud" means an intentional misrepresentation,*
27 *deception or concealment of a material fact known to the person*
28 *with the intent to deprive the protected minor of the protected*
29 *minor's rights or property or to otherwise injure the protected*
30 *minor.*

31 (c) *"Interested person" has the meaning ascribed to it in NRS*
32 *132.185 and also includes a named beneficiary under a trust or*
33 *other instrument if the validity of the trust or other instrument*
34 *may be in question.*

35 **Sec. 61.** 1. *Except as otherwise ordered by the court, a*
36 *guardian of the person has the care, custody and control of the*
37 *person of the protected minor, and has the authority and, subject*
38 *to subsection 2, shall perform the duties necessary for the proper*
39 *care, maintenance, education and support of the protected minor,*
40 *including, without limitation, the following:*

41 (a) *Supplying the protected minor with food, clothing, shelter*

9 *(c) The participation of a protected minor in any biomedical or*

1 (a) *Revoke the letters of guardianship and the guardian is*
2 *liable on the bond for any loss or injury to the estate caused by the*
3 *neglect of the guardian; or*

4 (b) *Enter a judgment for any loss or injury to the estate caused*
5 *by the neglect of the guardian.*

6 **Sec. 66.** 1. *Except as otherwise provided in subsection 2,*
7 *the guardian of an estate shall cause an appraisal or valuation of*
8 *any asset of a guardianship estate to be conducted by a*
9 *disinterested appraiser, certified public accountant or expert in*
10 *valuation and file the appraisal or valuation with the court.*

11 2. *In lieu of an appraisal, the guardian may file:*

12 (a) *A verified record of value of an asset where the value of the*
13 *asset can be determined with reasonable certainty, including,*

25 *guardianship estate, each appraiser, certified public accountant or*
26 *expert in valuation shall certify that the appraiser, accountant or*
27 *expert will truthfully, honestly and impartially appraise or value*
28 *the property according to the best of his or her knowledge and*
29 *ability. The certification must be included in the appraisal or*
30 *valuation and filed with the court.*

31 2. *The appraisal or valuation must list each asset that has a*
32 *value of more than \$100 separately with a statement of the value*

38 *estate at any time after the appraisal or valuation is completed.*

39 4. *An appraiser, certified public accountant or expert in*
40 *valuation who directly or indirectly purchases any asset of an*
41 *estate without full disclosure to and approval by the court is guilty*
42 *of a misdemeanor. A sale made in violation of the provisions of*
43 *this subsection is void, and the asset sold may be recovered by the*
44 *guardian, protected minor or proposed protected minor.*



1 **Sec. 68. 1.** *Not later than 60 days after the date of the*
2 *appointment of a guardian of the estate, the guardian shall record,*
3 *or cause to be recorded, in the office of the recorder of each*
4 *county in which real property of the protected minor is located, a*
5 *copy, certified by the clerk of the court, of the letters of*
6 *guardianship.*

7 2. *The guardian shall attach, or cause to be attached, to the*
8 *copy of the letters of guardianship recorded pursuant to*
9 *subsection 1 a cover sheet containing:*

10 (a) *The name, address and telephone number of the guardian;*

11 (b) *The assessor's parcel number and the address of the real*
12 *property of the protected minor; and*

13 (c) *If the estate of the protected minor includes a*
14 *manufactured home or mobile home, the location and serial*
15 *number of the manufactured home or mobile home.*

16 3. *As used in this section:*

17 (a) *"Manufactured home" has the meaning ascribed to it in*
18 *NRS 489.113.*

19 (b) *"Mobile home" has the meaning ascribed to it in*
20 *NRS 489.120.*

21 **Sec. 69. 1.** *A guardian of the estate shall take possession*
22 *of:*

23 (a) *All of the property of substantial value of the protected*
24 *minor;*

25 (b) *Rents, income, issues and profits from the property,*
26 *whether accruing before or after the appointment of the guardian;*
27 *and*

28 (c) *The proceeds from the sale, mortgage, lease or other*
29 *disposition of the property.*

30 2. *The guardian may allow the protected minor to have*
31 *possession and control of the personal property and funds as are*
32 *appropriate to the needs and capacities of the protected minor.*

33 3. *The title to all property of the protected minor is in the*
34 *protected minor and not in the guardian.*

35 4. *A guardian shall secure originals, when available, or*
36 *copies of any:*

37 (a) *Contract executed by the protected minor;*

38 (b) *Revocable or irrevocable trust in which the protected minor*
39 *has a vested interest as a beneficiary; and*

40 (c) *Writing evidencing a present or future vested interest in*
41 *any real or intangible property.*

42 **Sec. 70. 1.** *A guardian shall present a copy of the court*
43 *order appointing the guardian and letters of guardianship to a*
44 *bank or other financial institution that holds any account or other*



1 *assets of the protected minor before the guardian may access the*
2 *account or other assets.*

3 2. *The bank or other financial institution shall accept the*
4 *copy of the court order appointing the guardian and letters of*
5 *guardianship as proof of guardianship and allow the guardian*
6 *access to the account or other assets of the protected minor,*
7 *subject to any limitations set forth in the court order.*

8 3. *Unless the bank or other financial institution is a party to*
9 *the guardianship proceeding, the bank or other financial*
10 *institution is not entitled to a copy of any:*

11 (a) *Competency evaluation of the protected minor or any other*
12 *confidential information concerning the medical condition or the*
13 *placement of the protected minor; or*

14 (b) *Inventory or accounting of the estate of the protected*
15 *minor.*

16 **Sec. 71.** 1. *The guardian may retain assets for the*
17 *anticipated expense of the protected minor's funeral and the*
18 *disposal of his or her remains. Of the amount so retained, \$3,000*
19 *is exempt from all claims, including those of this State.*

20 2. *The guardian may place assets so retained in a pooled*
21 *account or trust. If the assets are invested in a savings account or*
22 *other financial account, the assets are not subject to disposition as*
23 *unclaimed property during the lifetime of the protected minor.*

24 3. *Assets so retained may be disbursed for the protected*
25 *minor's funeral or the disposal of his or her remains without prior*
26 *authorization of the court. An amount not so disbursed becomes*
27 *part of the protected minor's estate.*

28 **Sec. 72.** *Upon the filing of a petition in the guardianship*
29 *proceeding by the guardian, the protected minor or any other*
30 *interested person, alleging that any person is indebted to the*
31 *protected minor, has or is suspected of having concealed,*
32 *embezzled, converted or disposed of any property of the protected*
33 *minor or has possession or knowledge of any such property or of*
34 *any writing relating to such property, the court may require the*
35 *person to appear and answer under oath concerning the matter.*

36 **Sec. 73.** 1. *A guardian of the estate:*

37 (a) *Shall demand all debts and other choses in action due to*
38 *the protected minor; and*

39 (b) *With prior approval of the court, may sue for and receive*
40 *all debts and other choses in action due to the protected minor.*

41 2. *A guardian of the estate, with prior approval of the court*
42 *by order, may compound or compromise any debt or other chose*
43 *in action due to the protected minor and give a release and*
44 *discharge to the debtor or other obligor.*

45 3. *A guardian of the person:*



1 (a) May obtain an order which requires one or both parents of
2 the protected minor to pay the guardian an amount established
3 pursuant to NRS 125B.070 and 125B.080 for the support of the
4 protected minor.

5 (b) Shall give notice to the court of the entry of an order for
6 the payment of the support of the protected minor or the approval
7 of any public assistance for the protected minor not later than 30
8 days after the entry of the order or the approval of public
9 assistance. The guardian shall file a copy of the order of support
10 or document which evidences approval of public assistance with
11 the notice which is filed with the court.

12 **Sec. 74. 1.** A guardian of the estate shall appear for and
13 represent the protected minor in all actions, suits or proceedings to
14 which the protected minor is a party, unless the court finds that
15 the interests of the guardian conflict with the interests of the
16 protected minor or it is otherwise appropriate to appoint a
17 guardian ad litem in the action, suit or proceeding.

18 2. Upon final resolution of the action, suit or proceeding, the
19 guardian of the estate or the guardian ad litem shall notify the
20 court of the outcome of the action, suit or proceeding.

21 3. If the person of the protected minor would be affected by
22 the outcome of any action, suit or proceeding, the guardian of the
23 person, if any, should be joined to represent the protected minor in
24 the action, suit or proceeding.

25 **Sec. 75.** Any contract, except to the extent of the reasonable
26 value of necessities, and any transaction with respect to the
27 property of a protected minor made by the protected minor are
28 voidable by the guardian of the estate.

29 **Sec. 76.** A guardian of the estate is not personally liable on
30 any written or oral contract entered into for or on behalf of the
31 protected minor where the guardian is acting within his or her
32 authority as such guardian. Any action, suit or proceeding on any
33 such contract must be brought against the guardian in his or her
34 fiduciary capacity only, and any judgment or decree obtained in
35 such action, suit or proceeding must be satisfied only from
36 property of the protected minor.

37 **Sec. 77.** A guardian of the estate shall pay from the
38 guardianship estate pursuant to sections 78, 79 and 80 of this act
39 all just claims against the protected minor, the estate or the
40 guardian as such, whether accruing before or after the
41 appointment of the guardian and whether arising in contract, in
42 tort or otherwise.

43 **Sec. 78. 1.** Other than claims for attorney's fees that are
44 subject to the provisions of subsection 3, a guardian of the estate
45 may pay from the guardianship estate the following claims without



1 *complying with the provisions of this section and sections 79 and*
2 *80 of this act:*

3 *(a) The guardian's claims against the protected minor or the*
4 *estate; and*

5 *(b) Any claims accruing after the appointment of the guardian*
6 *which arise from contracts entered into by the guardian on behalf*
7 *of the protected minor.*

8 *2. The guardian shall report all claims and the payment of*
9 *claims made pursuant to subsection 1 in the account that the*
10 *guardian makes and files in the guardianship proceeding*
11 *following each payment.*

12 *3. Claims for attorney's fees which are associated with the*
13 *commencement and administration of the guardianship of the*
14 *estate:*

15 *(a) May be made at the time of the appointment of the*
16 *guardian of the estate or any time thereafter; and*

17 *(b) May not be paid from the guardianship estate unless the*
18 *payment is made in compliance with the provisions of this section*
19 *and sections 79 and 80 of this act.*

20 **Sec. 79.** *Except as otherwise provided in section 78 of this*
21 *act, all claims against the protected minor, the guardianship estate*
22 *or the guardian of the estate as such must be presented to the*
23 *guardian of the estate. Each such claim must be in writing, must*
24 *describe the nature and the amount of the claim, if ascertainable,*
25 *and must be accompanied by the affidavit of the claimant, or*
26 *someone on behalf of the claimant, who has personal knowledge*
27 *of the fact. The affidavit must state that within the knowledge of*
28 *the affiant the amount claimed is justly due, no payments have*
29 *been made thereon which are not credited and there is no*
30 *counterclaim thereto, except as stated in the affidavit. If such*
31 *claim is founded on a written instrument, the original or a copy*
32 *thereof with all endorsements must be attached to the claim. The*
33 *original instrument must be exhibited to the guardian or the court,*
34 *upon demand, unless it is lost or destroyed, in which case the fact*
35 *of its loss or destruction must be stated in the claim.*

36 **Sec. 80.** *1. A guardian of the estate shall examine each*
37 *claim presented to the guardian for payment. If the guardian is*
38 *satisfied that the claim is appropriate and just, the guardian shall:*

39 *(a) Endorse upon the claim the words "examined and*
40 *allowed" and the date;*

41 *(b) Officially subscribe the notation; and*

42 *(c) Pay the claim from the guardianship estate.*

43 *2. If the guardian is not satisfied that the claim is just, the*
44 *guardian shall:*



1 (a) Endorse upon the claim the words “examined and
2 rejected” and the date;

3 (b) Officially subscribe the notation; and

4 (c) Not later than 60 days after the date the claim was
5 presented to the guardian, notify the claimant by personal service
6 or by mailing a notice by registered or certified mail that the claim
7 was rejected.

8 **Sec. 81. 1.** *If, not later than 60 days after the date the claim*
9 *was presented to the guardian, a rejected claim is returned to the*
10 *claimant or the guardian of the estate fails to approve or reject*
11 *and return a claim, the claimant, before the claim is barred by the*
12 *statute of limitations, may:*

13 (a) *File a petition for approval of the rejected claim in the*
14 *guardianship proceeding for summary determination by the court;*
15 *or*

16 (b) *Commence an action or suit on the claim against the*
17 *guardian in the guardian’s fiduciary capacity and any judgment*
18 *or decree obtained must be satisfied only from property of the*
19 *protected minor.*

20 2. *If a claimant files a request for approval of a rejected*
21 *claim or a like claim in the guardianship proceeding for summary*
22 *determination, the claimant shall serve notice that he or she has*
23 *filed such a request on the guardian.*

24 3. *Not later than 20 days after the date of service, the*
25 *guardian may serve notice of objection to summary determination*
26 *on the claimant. If the guardian serves the claimant with notice*
27 *and files a copy of the notice with the court, the court shall not*
28 *enter a summary determination and the claimant may commence*
29 *an action or suit on the claim against the guardian in the*
30 *guardian’s fiduciary capacity as provided in subsection 1.*

31 4. *If the guardian fails to serve the claimant with notice of*
32 *objection to summary determination or file a copy of the notice*
33 *with the court, the court shall:*

34 (a) *Hear the matter and determine the claim or like claim in a*
35 *summary manner; and*

36 (b) *Enter an order allowing or rejecting the claim, either in*
37 *whole or in part. No appeal may be taken from the order.*

38 **Sec. 82. 1.** *Before taking any of the following actions, the*
39 *guardian of the estate shall petition the court for an order*
40 *authorizing the guardian to:*

41 (a) *Invest the property of the protected minor pursuant to*
42 *section 84 of this act.*

43 (b) *Borrow money for the protected minor pursuant to section*
44 *85 of this act.*



1 (c) Except as otherwise provided in section 61 of this act, enter
2 into contracts for the protected minor or complete the
3 performance of contracts of the protected minor pursuant to
4 section 86 of this act.

5 (d) Make gifts from the protected minor's estate pursuant to
6 section 87 of this act.

7 (e) Sell, lease or place in trust any property of the protected
8 minor pursuant to section 88 of this act.

9 (f) Exchange or partition the protected minor's property
10 pursuant to section 126 of this act.

11 (g) Exercise or release the power of the protected minor as a
12 donee of a power of appointment.

13 (h) Exercise the right of the protected minor to take under or
14 against a will.

15 (i) Transfer to a trust created by the protected minor any
16 property unintentionally omitted from the trust.

17 (j) Submit a revocable trust to the jurisdiction of the court if:

18 (1) The protected minor is the grantor and sole beneficiary
19 of the income of the trust; or

20 (2) The trust was created by the court.

21 (k) Pay any claim by the Department of Health and Human
22 Services to recover benefits for Medicaid correctly paid to or on
23 behalf of the protected minor.

24 (l) Transfer money in a protected minor's blocked account to
25 the Nevada Higher Education Prepaid Tuition Trust Fund created
26 pursuant to NRS 353B.140.

27 2. Before taking any of the following actions, unless the
28 guardian has been otherwise ordered by the court to petition the
29 court for permission to take specified actions or make specified
30 decisions in addition to those described in subsection 1, the
31 guardian may petition the court for an order authorizing the
32 guardian to:

33 (a) Obtain advice, instructions and approval of any other
34 proposed act of the guardian relating to the protected minor's
35 property.

36 (b) Take any other action which the guardian deems would be
37 in the best interests of the protected minor.

38 3. The petition must be signed by the guardian and contain:

39 (a) The name, age, residence and address of the protected
40 minor.

41 (b) A concise statement as to the condition of the protected
42 minor's estate.

43 (c) A concise statement as to the advantage to the protected
44 minor of or the necessity for the proposed action.



1 (d) *The terms and conditions of any proposed sale, lease,*
2 *partition, trust, exchange or investment, and a specific description*
3 *of any property involved.*

4 4. *Any of the matters set forth in subsection 1 may be*
5 *consolidated in one petition, and the court may enter one order*
6 *authorizing or directing the guardian to do one or more of those*
7 *acts.*

8 5. *A petition filed pursuant to paragraphs (b) and (d) of*
9 *subsection 1 may be consolidated in and filed with the petition for*
10 *the appointment of the guardian, and if the guardian is appointed,*
11 *the court may enter additional orders authorizing the guardian to*
12 *continue the business of the protected minor, enter contracts for*
13 *the protected minor or complete contracts of the protected minor.*

14 **Sec. 83.** 1. *Upon the filing of any petition under section 60*
15 *or 82 of this act, or any account, notice must be given in the*
16 *manner prescribed by section 17 of this act.*

17 2. *The notice must:*

18 (a) *Give the name of the protected minor.*

19 (b) *Give the name of the petitioner.*

20 (c) *Give the date, time and place of the hearing.*

21 (d) *State the nature of the petition.*

22 (e) *Refer to the petition for further particulars, and notify all*
23 *persons interested to appear at the time and place mentioned in*
24 *the notice and show cause why the court order should not be*
25 *made.*

26 **Sec. 84.** 1. *Upon approval of the court by order, a guardian*
27 *of the estate may:*

28 (a) *Invest the property of the protected minor, make loans and*
29 *accept security therefor, in the manner and to the extent*
30 *authorized by the court.*

31 (b) *Exercise options of the protected minor to purchase or*
32 *exchange securities or other property.*

33 2. *A guardian of the estate may, without securing the prior*
34 *approval of the court, invest the property of the protected minor in*
35 *the following:*

36 (a) *Savings accounts in any bank, credit union or savings and*
37 *loan association in this State, to the extent that the deposits are*
38 *insured by the Federal Deposit Insurance Corporation, the*
39 *National Credit Union Share Insurance Fund or a private insurer*
40 *approved pursuant to NRS 678.755.*

41 (b) *Interest-bearing obligations of or fully guaranteed by the*
42 *United States.*

43 (c) *Interest-bearing obligations of the United States Postal*
44 *Service.*



1 (d) *Interest-bearing obligations of the Federal National*
2 *Mortgage Association.*

3 (e) *Interest-bearing general obligations of this State.*

4 (f) *Interest-bearing general obligations of any county, city or*
5 *school district of this State.*

6 (g) *Money market mutual funds which are invested only in*
7 *those instruments listed in paragraphs (a) to (f), inclusive.*

8 3. *A guardian of the estate for two or more wards may invest*
9 *the property of two or more of the wards in property in which each*
10 *ward whose property is so invested has an undivided interest. The*
11 *guardian shall keep a separate record showing the interest of each*
12 *ward in the investment and in the income, profits or proceeds*
13 *therefrom.*

14 4. *A guardian of the estate may access or manage a*
15 *guardianship account via the Internet on a secured website*
16 *established by the bank, credit union or broker holding the*
17 *account.*

18 **Sec. 85.** 1. *A guardian of the estate, with prior approval of*
19 *the court by order, may borrow money for the account of the*
20 *protected minor when necessary:*

21 (a) *To pay claims against the protected minor, the*
22 *guardianship estate or the guardian of the estate as such.*

23 (b) *To provide for the proper care, maintenance, education*
24 *and support of the protected minor.*

25 (c) *For any other purpose that is in the best interests of the*
26 *protected minor.*

27 2. *If the court determines that the borrowing is necessary or*
28 *proper, the court shall make an order approving the borrowing*
29 *and may authorize one or more separate loans. The order must*
30 *prescribe the maximum amount of each loan, the maximum rate*
31 *of interest and the date of final maturity of each loan, and may*
32 *authorize the guardian to secure any loan by mortgage, deed of*
33 *trust, pledge or other security transaction authorized by the laws*
34 *of this State. The order must describe the property, if any, to be*
35 *given as security for each loan.*

36 **Sec. 86.** *If a protected minor for whom a guardian of the*
37 *estate is appointed was, at the time of the appointment, a party to a*
38 *contract which has not been fully performed, and which was made*
39 *by the minor while not under any legal disability other than being*
40 *under the age of majority, the guardian of the estate, with prior*
41 *approval of the court by order, may complete the performance of*
42 *such contract. If such contract requires the conveyance of any*
43 *real or personal property, or any interest in such property, the*
44 *court may authorize the guardian to convey the interest and estate*
45 *of the protected minor in the property, and the effect of such*



1 conveyance is the same as though made by the protected minor
2 while not under legal disability. If the contract requires a sale, no
3 notice of sale is required under this section unless otherwise
4 ordered by the court.

5 **Sec. 87.** 1. A guardian of the estate, with prior approval of
6 the court by order, may, from the estate of the protected minor
7 which is not necessary for the proper care, maintenance,
8 education and support of the protected minor, make reasonable
9 gifts directly, or into a trust, on behalf of the protected minor.

10 2. Any petition filed by a guardian pursuant to this section
11 must state whether:

12 (a) The purpose of the guardian in seeking approval to make
13 the gift is to dispose of assets to make the ward eligible for
14 Medicaid; and

15 (b) Making the gift will cause the ward to become eligible for
16 Medicaid.

17 **Sec. 88.** A guardian of the estate, with prior approval of the
18 court by order, may sell, lease or place in trust any of the property
19 of the protected minor:

20 1. For the purpose of paying claims against the protected
21 minor, the guardianship estate or the guardian of the estate.

22 2. For the purpose of providing for the proper care,
23 maintenance, education and support of the protected minor.

24 3. For the purpose of investing the proceeds.

25 4. To obtain income through rentals or royalties.

26 5. For any other purpose that is in the best interests of the
27 protected minor.

28 **Sec. 89.** Any interest of a protected minor in real or personal
29 property, including interests in contracts and choses in action,
30 may be sold pursuant to this chapter.

31 **Sec. 90.** 1. All sales of real property of a protected minor
32 must be:

33 (a) Reported to the court; and

34 (b) Confirmed by the court before the title to the real property
35 passes to the purchaser.

36 2. The report and a petition for confirmation of the sale must
37 be filed with the court not later than 30 days after the date of each
38 sale.

39 3. The court shall set the date of the hearing and give notice
40 of the hearing in the manner required pursuant to section 83 of
41 this act or as the court may order.

42 4. An interested person may file written objections to the
43 confirmation of the sale. If such objections are filed, the court
44 shall conduct a hearing regarding those objections during which



1 *the interested person may offer witnesses in support of the*
2 *objections.*

3 *5. Before the court confirms a sale, the court must find that*
4 *notice of the sale was given in the manner required pursuant to*
5 *sections 98, 99 and 100 of this act, unless the sale was exempt*
6 *from notice pursuant to section 86 of this act.*

7 **Sec. 91.** *If the guardian neglects or refuses to sell any real*
8 *property of the estate when it is necessary or in the best interests of*
9 *the protected minor, an interested person may petition the court*
10 *for an order requiring the guardian to sell the property. The court*
11 *shall set the petition for a hearing, and the petitioner shall serve*
12 *notice on the guardian at least 10 days before the hearing.*

13 **Sec. 92.** *If real property of the estate of a protected minor is*
14 *sold that is subject to a mortgage or other lien which is a valid*
15 *claim against the estate, the money from the sale must be applied*
16 *in the following order:*

17 *1. To pay the necessary expenses of the sale.*

18 *2. To satisfy the mortgage or other lien, including, without*
19 *limitation, payment of interest and any other lawful costs and*
20 *charges. If the mortgagee or other lienholder cannot be found, the*
21 *money from the sale may be paid as ordered by the court and the*
22 *mortgage or other lien shall be deemed to be satisfied.*

23 *3. To the estate of the protected minor, unless the court*
24 *orders otherwise.*

25 **Sec. 93.** *At a sale of real property that is subject to a*
26 *mortgage or lien, the holder of the mortgage or lien may become*
27 *the purchaser. The receipt for the amount owed to the holder from*
28 *the proceeds of the sale is a payment pro tanto.*

29 **Sec. 94.** *1. In the manner required by this chapter for the*
30 *sale of like property, a guardian may sell:*

31 *(a) The equity of the estate in any real property that is subject*
32 *to a mortgage or lien; and*

33 *(b) The property that is subject to the mortgage or lien.*

34 *2. If a claim has been filed upon the debt secured by the*
35 *mortgage or lien, the court shall not confirm the sale unless the*
36 *holder of the claim files a signed and acknowledged document*
37 *which releases the estate from all liability upon the claim.*

38 **Sec. 95.** *1. A guardian may enter into a written contract*
39 *with any bona fide agent, broker or multiple agents or brokers to*
40 *secure a purchaser for any real property of the estate. Such a*
41 *contract may grant an exclusive right to sell the property to the*
42 *agent, broker or multiple agents or brokers.*

43 *2. The guardian shall provide for the payment of a*
44 *commission upon the sale of the real property which:*

45 *(a) Must be paid from the proceeds of the sale;*



1 (b) *Must be fixed in an amount not to exceed:*

2 (1) *Ten percent for unimproved real property; or*

3 (2) *Seven percent for improved real property; and*

4 (c) *Must be authorized by the court by confirmation of the*
5 *sale.*

6 3. *Upon confirmation of the sale by the court, the contract for*
7 *the sale becomes binding and enforceable against the estate.*

8 4. *A guardian may not be held personally liable and the estate*
9 *is not liable for the payment of any commission set forth in a*
10 *contract entered into with an agent or broker pursuant to this*
11 *section until the sale is confirmed by the court, and then is liable*
12 *only for the amount set forth in the contract.*

13 **Sec. 96.** 1. *When an offer to purchase real property of a*
14 *guardianship estate is presented to the court for confirmation:*

15 (a) *Other persons may submit higher bids to the court; and*

16 (b) *The court may confirm the highest bid.*

17 2. *Upon confirmation of a sale of real property by the court,*
18 *the commission for the sale must be divided between the listing*
19 *agent or broker and the agent or broker who secured the*
20 *purchaser to whom the sale was confirmed, if any, in accordance*
21 *with the contract with the listing agent or broker.*

22 **Sec. 97.** 1. *If a protected minor owns real property jointly*
23 *with one or more other persons, the interest owned by the*
24 *protected minor may be sold to one or more joint owners of the*
25 *property only if:*

26 (a) *The guardian files a petition with the court to confirm the*
27 *sale pursuant to section 90 of this act; and*

28 (b) *The court confirms the sale.*

29 2. *The court shall confirm the sale only if:*

30 (a) *The net amount of the proceeds from the sale to the estate*
31 *of the protected minor is not less than 90 percent of the fair*
32 *market value of the portion of the property to be sold; and*

33 (b) *Upon confirmation, the estate of the protected minor will*
34 *be released from all liability for any mortgage or lien on the*
35 *property.*

36 **Sec. 98.** 1. *Except as otherwise provided in this section and*
37 *except for a sale pursuant to section 86 or 97 of this act, a*
38 *guardian may sell the real property of a protected minor only after*
39 *notice of the sale is published in:*

40 (a) *A newspaper that is published in the county in which the*
41 *property, or some portion of the property, is located; or*

42 (b) *If a newspaper is not published in that county:*

44 (2) *In such other newspaper as the court orders.*



1 2. *Except as otherwise provided in this section and except for*
2 *a sale of real property pursuant to section 86 or 97 of this act:*

3 (a) *The notice of a public auction for the sale of real property*
4 *must be published not less than three times before the date of the*
5 *sale, over a period of 14 days and 7 days apart.*

6 (b) *The notice of a private sale must be published not less than*
7 *three times before the date on which offers will be accepted, over a*
8 *period of 14 days and 7 days apart.*

9 3. *For good cause shown, the court may order fewer*
10 *publications and shorten the time of notice, but must not shorten*
11 *the time of notice to less than 8 days.*

12 4. *The court may waive the requirement of publication*
13 *pursuant to this section if:*

14 (a) *The guardian is the sole devisee or heir of the estate; or*

15 (b) *All devisees or heirs of the estate consent to the waiver in*
16 *writing.*

17 5. *Publication for the sale of real property is not required*
18 *pursuant to this section if the property to be sold is reasonably*
19 *believed to have a value of \$10,000 or less. In lieu of publication,*
20 *the guardian shall post notice of the sale in three of the most*
21 *public places in the county in which the property, or some portion*
22 *of the property, is located for at least 14 days before:*

23 (a) *The date of the sale at public auction; or*

24 (b) *The date on which offers will be accepted for a private sale.*

25 6. *Any notice published or posted pursuant to this section*
26 *must include, without limitation:*

27 (a) *For a public auction:*

28 (1) *A description of the real property which reasonably*
29 *identifies the property to be sold; and*

30 (2) *The date, time and location of the auction.*

31 (b) *For a private sale:*

32 (1) *A description of the real property which reasonably*
33 *identifies the property to be sold; and*

34 (2) *The date, time and location that offers will be accepted.*

35 **Sec. 99.** 1. *Except for a sale pursuant to section 86 or 97 of*
36 *this act, a public auction for the sale of real property must be held:*

37 (a) *In the county in which the property is located or, if the real*
38 *property is located in two or more counties, in either county;*

39 (b) *Between the hours of 9 a.m. and 5 p.m.; and*

40 (c) *On the date specified in the notice, unless the sale is*
41 *postponed.*

42 2. *If, on or before the date and time set for the public auction,*
43 *the guardian determines that the auction should be postponed:*

44 (a) *The auction may be postponed for not more than 3 months*
45 *after the date first set for the auction; and*



1 **(b) Notice of the postponement must be given by a public**
2 **declaration at the place first set for the sale on the date and time**
3 **that was set for the sale.**

4 **Sec. 100. 1. Except for the sale of real property pursuant to**
5 **section 86 or 97 of this act, a sale of real property of a**
6 **guardianship estate at a private sale:**

7 **(a) Must not occur before the date stated in the notice.**

8 **(b) Except as otherwise provided in this paragraph, must not**
9 **occur sooner than 14 days after the date of the first publication or**
10 **posting of the notice. For good cause shown, the court may**
11 **shorten the time in which the sale may occur to not sooner than 8**
12 **days after the date of the first publication or posting of the notice.**
13 **If the court so orders, the notice of the sale and the sale may be**
14 **made to correspond with the court order.**

15 **(c) Must occur not later than 1 year after the date stated in the**
16 **notice.**

17 **2. The offers made in a private sale:**

18 **(a) Must be in writing; and**

19 **(b) May be delivered to the place designated in the notice or to**
20 **the guardian at any time:**

21 **(1) After the date of the first publication or posting of the**
22 **notice; and**

23 **(2) Before the date on which the sale is to occur.**

24 **Sec. 101. 1. Except as otherwise provided in subsection 2,**
25 **the court shall not confirm a sale of real property of a**
26 **guardianship estate at a private sale unless:**

27 **(a) The court is satisfied that the amount offered represents**
28 **the fair market value of the property to be sold; and**

29 **(b) Except for a sale of real property pursuant to section 86 of**
30 **this act, the real property has been appraised within 1 year before**
31 **the date of the sale. If the real property has not been appraised**
32 **within this period, a new appraisal must be conducted pursuant to**
33 **sections 66 and 67 of this act at any time before the sale or**
34 **confirmation by the court of the sale.**

35 **2. The court may waive the requirement of an appraisal and**
36 **allow the guardian to rely on the assessed value of the real**
37 **property for purposes of taxation in obtaining confirmation by the**
38 **court of the sale.**

39 **Sec. 102. 1. At the hearing to confirm the sale of real**
40 **property, the court shall:**

41 **(a) Consider whether the sale is necessary or in the best**
42 **interest of the estate of the protected minor; and**

43 **(b) Examine the return on the investment and the evidence**
44 **submitted in relation to the sale.**



1 2. *The court shall confirm the sale and order conveyances to*
2 *be executed if it appears to the court that:*

3 (a) *Good reason existed for the sale;*

4 (b) *The sale was conducted in a legal and fair manner;*

5 (c) *The amount of the offer or bid is not disproportionate to*
6 *the value of the property; and*

7 (d) *It is unlikely that an offer or bid would be made which*
8 *exceeds the original offer or bid:*

9 (1) *By at least 5 percent if the offer or bid is less than*
10 *\$100,000; or*

11 (2) *By at least \$5,000 if the offer or bid is \$100,000 or*
12 *more.*

13 3. *The court shall not confirm the sale if the conditions in*
14 *this section are not satisfied.*

15 4. *If the court does not confirm the sale, the court:*

16 (a) *May order a new sale;*

17 (b) *May conduct a public auction in open court; or*

18 (c) *May accept a written offer or bid from a responsible person*
19 *and confirm the sale to the person if the written offer complies*
20 *with the laws of this State and exceeds the original bid:*

21 (1) *By at least 5 percent if the bid is less than \$100,000; or*

22 (2) *By at least \$5,000 if the bid is \$100,000 or more.*

23 5. *If the court does not confirm the sale and orders a new*
24 *sale:*

25 (a) *Notice must be given in the manner set forth in section 98*
26 *of this act; and*

27 (b) *The sale must be conducted in all other respects as though*
28 *no previous sale has taken place.*

29 6. *If a higher offer or bid is received by the court during the*
30 *hearing to confirm the sale, the court may continue the hearing*
31 *rather than accept the offer or bid as set forth in paragraph (c) of*
32 *subsection 4 if the court determines that the person who made the*
33 *original offer or bid was not notified of the hearing and that the*
34 *person who made the original offer or bid may wish to increase his*
35 *or her bid. This subsection does not grant a right to a person to*
36 *have a continuance granted and may not be used as a ground to*
37 *set aside an order confirming a sale.*

38 7. *Except as otherwise provided in this subsection, if a higher*
39 *offer or bid is received by the court during the hearing to confirm*

42 (a) *An additional \$5,000, if the original offer is for \$100,000*
43 *or more; or*

44 (b) *An additional \$250 if the original offer is less than*
45 *\$100,000.*



1 ↪ Upon the request of the guardian during the hearing to confirm
2 the sale, the court may set other incremental bid amounts.

3 **Sec. 103.** 1. If the court confirms a sale of real property of
4 a guardianship estate, the guardian shall execute a conveyance of
5 the property to the purchaser.

6 2. The conveyance must include a reference to the court
7 order confirming the sale, and a certified copy of the court order
8 must be recorded in the office of the recorder of the county in
9 which the property, or any portion of the property, is located.

10 3. A conveyance conveys all the right, title and interest of the
11 protected minor in the property on the date of the sale, and if,
12 before the date of the sale, by operation of law or otherwise, the
13 protected minor has acquired any right, title or interest in the
14 property other than or in addition to that of the protected minor at
15 the time of the sale, that right, title or interest also passes by the
16 conveyance.

17 **Sec. 104.** 1. If a sale of real property is made upon credit,
18 the guardian shall take:

19 (a) The note or notes of the purchaser for the unpaid portion
20 of the sale; and

21 (b) A mortgage on the property to secure the payment of the
22 notes.

23 2. The mortgage may contain a provision for release of any
24 part of the property if the court approves the provision.

25 **Sec. 105.** 1. After confirmation of the sale of real property,
26 if the purchaser neglects or refuses to comply with the terms of the
27 sale, the court may set aside the order of confirmation and order
28 the property to be resold:

29 (a) On motion of the guardian; and

30 (b) After notice is given to the purchaser.

31 2. If the amount realized on the resale of the property is
32 insufficient to cover the bid and the expenses of the previous sale,
33 the original purchaser is liable to the estate of the protected minor
34 for the deficiency.

35 **Sec. 106.** A guardian who fraudulently sells any real
36 property of a protected minor in a manner inconsistent with the
37 provisions of this chapter is liable for double the value of the
38 property sold, as liquidated damages, to be recovered in an action
39 by or on behalf of the protected minor.

40 **Sec. 107.** The periods of limitation prescribed in NRS 11.260
41 apply to all actions:

42 1. For the recovery of real property sold by a guardian in
43 accordance with the provisions of this chapter; and

44 2. To set aside a sale of real property.



1 **Sec. 108. 1.** *A guardian may sell perishable property and*
2 *other personal property of the protected minor without notice, and*
3 *title to the property passes without confirmation by the court if the*
4 *property:*

5 (a) *Will depreciate in value if not disposed of promptly; or*

6 (b) *Will incur loss or expense by being kept.*

7 **2.** *The guardian is responsible for the actual value of the*
8 *personal property unless the guardian obtains confirmation by the*
9 *court of the sale.*

10 **Sec. 109.** *A guardian may sell any security of the protected*
11 *minor if:*

12 **1.** *The guardian petitions the court for confirmation of the*
13 *sale;*

14 **2.** *The clerk sets the date of the hearing;*

15 **3.** *The guardian gives notice in the manner required*
16 *pursuant to section 17 of this act unless, for good cause shown,*
17 *the court shortens the period within which notice must be given or*
18 *dispenses with notice; and*

19 **4.** *The court confirms the sale.*

20 **Sec. 110. 1.** *Except as otherwise provided in sections 108*
21 *and 109 of this act, a guardian may sell the personal property of*
22 *the protected minor only after notice of the sale is published in:*

23 (a) *A newspaper that is published in the county in which the*
24 *property, or some portion of the property, is located; or*

25 (b) *If a newspaper is not published in that county:*

26 (1) *In a newspaper of general circulation in the county; or*

27 (2) *In such other newspaper as the court orders.*

28 **2.** *Except as otherwise provided in this section:*

29 (a) *The notice of a public sale must be published not less than*
30 *three times before the date of the sale, over a period of 14 days and*
31 *7 days apart.*

32 (b) *The notice of a private sale must be published not less than*
33 *three times before the date on which offers will be accepted, over a*
34 *period of 14 days and 7 days apart.*

35 **3.** *For good cause shown, the court may order fewer*
36 *publications and shorten the time of notice, but must not shorten*
37 *the time of notice to less than 8 days.*

38 **4.** *The notice must include, without limitation:*

39 (a) *For a public sale:*

40 (1) *A description of the personal property to be sold; and*

41 (2) *The date, time and location of the sale.*

42 (b) *For a private sale:*

43 (1) *A description of the personal property to be sold; and*

44 (2) *The date, time and location that offers will be accepted.*



1 (c) For a sale on an appropriate auction website on the
2 Internet:

- 3 (1) A description of the personal property to be sold;
4 (2) The date the personal property will be listed; and
5 (3) The Internet address of the website on which the sale
6 will be posted.

7 **Sec. 111.** 1. The guardian may sell the personal property of
8 a protected minor by public sale at:

- 9 (a) The residence of the protected minor; or
10 (b) Any other location designated by the guardian.

11 2. The guardian may sell the personal property by public sale
12 only if the property is made available for inspection at the time of
13 the sale or photographs of the personal property are posted on an
14 appropriate auction website on the Internet.

15 3. Personal property may be sold at a public or private sale
16 for cash or upon credit.

17 **Sec. 112.** The following interests of the estate of the
18 protected minor may be sold in the same manner as other personal
19 property:

20 1. An interest in personal property that has been pledged to
21 the protected minor; and

22 2. Choses in action.

23 **Sec. 113.** A guardian of the estate may lease any real
24 property of the protected minor or any interest in real property:

25 1. Without securing prior court approval, where the tenancy
26 is from month to month or for a term not to exceed 1 year and the
27 reasonable fixed rental for the property or the protected minor's
28 proportionate interest in such rental does not exceed \$250 per
29 month.

30 2. With prior approval of the court by order, for such period
31 of time as may be authorized by the court, not exceeding any time
32 limitation prescribed by law, and upon such terms and conditions
33 as the court may approve. Such lease may extend beyond the
34 period of minority of a protected minor.

35 **Sec. 114.** The court may authorize the guardian to enter into
36 a written contract with one or more licensed real estate brokers to
37 secure a lessee of the protected minor's property, which contract
38 may provide for the payment of a commission, not exceeding 5
39 percent of the fixed rental for the first 2 years, to be paid out of the
40 proceeds of any such lease.

41 **Sec. 115.** 1. Petitions to secure court approval of any lease:

42 (a) Must include the parcel number assigned to the property to
43 be leased and the physical address of the property, if any; and



1 **(b) Must set forth the proposed fixed rental, the duration of the**
2 **lease and a brief description of the duties of the proposed lessor**
3 **and lessee.**

4 **2. Upon the hearing of a petition pursuant to subsection 1, if**
5 **the court is satisfied that the lease is for the best interests of the**
6 **protected minor and the estate of the protected minor, the court**
7 **shall enter an order authorizing the guardian to enter into the**
8 **lease.**

9 **Sec. 116. A guardian of the estate, with prior approval of the**
10 **court by order, may enter into agreements providing for the rental**
11 **or bailment of the protected minor's personal property. All**
12 **proceedings to obtain such a court order must be the same as**
13 **required for the lease of real property.**

14 **Sec. 117. 1. If the property to be leased consists of mining**
15 **claims, an interest in the mining claims, property worked as a**
16 **mine or lands containing oil, gas, steam, gravel or any minerals,**
17 **the court may authorize the guardian to enter into a lease which**
18 **provides for payment by the lessee of a royalty, in money or in**
19 **kind, in lieu of a fixed rental. The court may also authorize the**
20 **guardian to enter into a lease which provides for a pooling**
21 **agreement or authorizes the lessee to enter into pooling or other**
22 **cooperative agreements with lessees, operators or owners of other**
23 **lands and minerals for the purpose of bringing about the**
24 **cooperative development and operation of any mine, oil field or**

26 **2. If the proposed lease contains an option to purchase, and**
27 **the property to be sold under the option consists of mining claims,**
28 **property worked as a mine, or interests in oil, gas, steam, gravel or**
29 **any mineral, which has a speculative or undefined market value,**
30 **the court may authorize the guardian to enter into such a lease**
31 **and sales agreement or give an option to purchase without**
32 **requiring the property to be sold at public auction or by private**
33 **sale in the manner required by this chapter for sales of other real**
34 **property.**

35 **3. If the petition filed pursuant to this section requests**
36 **authority to enter into a lease with an option to purchase, in**
37 **addition to the notice required by section 17 of this act, the**
38 **guardian shall publish a copy of the notice at least twice, the first**
39 **publication to be at least 10 days before the date set for the**
40 **hearing and the second publication to be not earlier than 7 days**
41 **after the date of the first publication. The notice must be published**
42 **in:**

43 **(a) A newspaper that is published in the county where the**
44 **property is located; or**



1 (b) *If no newspaper is published in the county where the*
2 *property is located, a newspaper of general circulation in that*
3 *county which is designated by the court.*

4 **Sec. 118.** 1. *To enter into an agreement to sell or to give an*
5 *option to purchase a mining claim or real property worked as a*
6 *mine which belongs to the estate of the protected minor, the*
7 *guardian or an interested person shall file a petition with the court*
8 *that:*

9 (a) *Describes the property or claim;*

10 (b) *States the terms and general conditions of the agreement;*

11 (c) *Shows any advantage that may accrue to the estate of the*
12 *protected minor from entering into the agreement; and*

13 (d) *Requests confirmation by the court of the agreement.*

14 2. *The court shall set the date of the hearing on the petition.*

15 3. *The petitioner shall give notice in the manner provided in*
16 *section 17 of this act.*

17 **Sec. 119.** 1. *At the time appointed and if the court finds*
18 *that due notice of the hearing concerning an agreement has been*
19 *given, the court shall hear a petition filed pursuant to section 118*
20 *of this act and any objection to the petition that is filed or*
21 *presented.*

22 2. *After the hearing, if the court is satisfied that the*
23 *agreement will be to the advantage of the estate of the protected*
24 *minor, the court:*

25 (a) *Shall order the guardian to enter into the agreement; and*

26 (b) *May prescribe in the order the terms and conditions of the*
27 *agreement.*

28 3. *A certified copy of the court order must be recorded in the*
29 *office of the county recorder of each county in which the property*
30 *affected by the agreement, or any portion of the property, is*
31 *located.*

32 **Sec. 120.** 1. *If the court orders the guardian to enter into*
33 *the agreement pursuant to section 119 of this act, the court shall*
34 *order the guardian to provide an additional bond and specify the*
35 *amount of the bond in the court order.*

36 2. *The guardian is not entitled to receive any of the proceeds*
37 *from the agreement until the guardian provides the bond and the*
38 *court approves the bond.*

39 3. *When the court order is entered, the guardian shall*
40 *execute, acknowledge and deliver an agreement which:*

41 (a) *Contains the conditions specified in the court order;*

42 (b) *States that the agreement or option is approved by court*
43 *order; and*

44 (c) *Provides the date of the court order.*



1 **Sec. 121.** *1. If the purchaser or option holder neglects or*
2 *refuses to comply with the terms of the agreement approved by the*
3 *court pursuant to section 119 of this act, the guardian may petition*
4 *the court to cancel the agreement. The court shall cancel the*
5 *agreement after notice is given to the purchaser or option holder.*

6 *2. The cancellation of an agreement pursuant to this section*
7 *does not affect any liability created by the agreement.*

8 **Sec. 122.** *1. If the purchaser or option holder complies with*
9 *the terms of an agreement approved by the court pursuant to*
10 *section 119 of this act and has made all payments according to the*
11 *terms of the agreement, the guardian shall:*

12 *(a) Make a return to the court of the proceedings; and*

13 *(b) Petition the court for confirmation of the proceedings.*

14 *2. Notice must be given to the purchaser or option holder*
15 *regarding the petition for confirmation.*

16 *3. The court:*

17 *(a) Shall hold a hearing regarding the petition for*
18 *confirmation; and*

19 *(b) May order or deny confirmation of the proceedings and*
20 *execution of the conveyances in the same manner and with the*
21 *same effect as when the court orders or denies a confirmation of a*
22 *sale of real property.*

23 **Sec. 123.** *1. A guardian of the estate, with prior approval of*
24 *the court, may accept an offer for the purchase of the interest or*
25 *estate of the protected minor, in real or personal property or both*
26 *real and personal property, where it appears from the petition and*
27 *the court determines that:*

28 *(a) The interest or estate of the protected minor in such*
29 *property is an interest in a partnership, joint venture or closely*
30 *held corporation, in which the offeror or offerors own the*
31 *remaining interests in the partnership, joint venture or closely*
32 *held corporation, or are offering to purchase such remaining*
33 *interests.*

34 *(b) The interest or estate of the protected minor in such*
35 *property is an undivided interest in property in which the offeror*
36 *or offerors own the remaining interests in such property or are*
37 *offering to purchase such remaining interests.*

38 *(c) The interest or estate of the protected minor to be sold or*
39 *granted is an easement in or creates a servitude upon the protected*
40 *minor's property.*

41 *2. A guardian of the estate, with prior approval of the court,*
42 *may accept an offer to surrender the interest or estate of the*
43 *protected minor in real or personal property or both real and*
44 *personal property, where it appears from the petition and the court*
45 *determines that:*



1 (a) *The interest or estate of the protected minor is contingent*
2 *or dubious.*

3 (b) *The interest or estate of the protected minor in such*
4 *property is a servitude upon the property of another.*

5 **Sec. 124. 1.** *A guardian of the estate may petition the court*
6 *for advice and instructions in any matter concerning:*

7 (a) *The administration of the protected minor's estate;*

8 (b) *The priority of paying claims;*

9 (c) *The propriety of making any proposed disbursement of*
10 *funds;*

11 (d) *Exercising for or on behalf of the protected minor:*

12 (1) *Any options or other rights under any policy of*
13 *insurance or annuity; and*

14 (2) *The right to take under a will, trust or other devise;*

15 (e) *The propriety of exercising any right exercisable by owners*
16 *of property; and*

17 (f) *Matters of a similar nature.*

18 2. *Any act done by a guardian of the estate after securing*
19 *court approval or instructions with reference to the matters set*
20 *forth in subsection 1 is binding upon the protected minor or those*
21 *claiming through the protected minor, and the guardian is not*
22 *personally liable for performing any such act.*

23 3. *If any interested person may be adversely affected by the*
24 *proposed act of the guardian, the court shall direct the issuance of*
25 *a citation to that interested person, to be served upon the person at*
26 *least 20 days before the hearing on the petition. The citation must*
27 *be served in the same manner that summons is served in a civil*
28 *action and must direct the interested person to appear and show*
29 *cause why the proposed act of the guardian should not be*
30 *authorized or approved. All interested persons so served are bound*
31 *by the order of the court which is final and conclusive, subject to*
32 *any right of appeal.*

33 **Sec. 125. 1.** *A guardian of the estate shall record a certified*
34 *copy of any court order authorizing the sale, mortgage, lease,*
35 *surrender or conveyance of real property in the office of the*
36 *county recorder of the county in which any portion of the land is*

38 2. *To carry out effectively any transaction affecting the*
39 *protected minor's property as authorized by this chapter, the court*
40 *may authorize the guardian to execute any promissory note,*
41 *mortgage, deed of trust, deed, lease, security agreement or other*

43 *carry out such transaction.*

44 **Sec. 126. 1.** *A guardian of the estate, with prior approval of*
45 *the court by order, where it appears from the petition and the*



1 *court determines that the best interests of the protected minor are*
2 *served by such action, may:*

3 *(a) Accept an offer to exchange all or any interest of the*
4 *protected minor in real or personal property or both real and*
5 *personal property for real or personal property or both real and*
6 *personal property of another, and pay or receive any cash or other*
7 *consideration to equalize the values on such exchange; or*

8 *(b) Effect a voluntary partition of real or personal property or*
9 *both real and personal property in which the protected owner*
10 *owns an undivided interest.*

11 *2. Upon hearing the petition, the court shall inquire into the*
12 *value of the property to be exchanged or partitioned, the rental or*
13 *income therefrom, and the use for which the property is best*
14 *suited.*

15 **Sec. 127.** *Every guardianship established pursuant to this*
16 *chapter must be reviewed by the court annually.*

17 **Sec. 128.** *A guardian of the estate shall make and file a*
18 *verified account in the guardianship proceeding:*

19 *1. Annually, not later than 60 days after the anniversary date*
20 *of the appointment of the guardian, unless the court orders such*
21 *an account to be made and filed at a different interval upon a*
22 *showing of good cause and with the appropriate protection of the*
23 *interests of the protected minor.*

24 *2. Upon filing a petition to resign and before the resignation*
25 *is accepted by the court.*

26 *3. Within 30 days after the date of his or her removal, unless*
27 *the court authorizes a longer period.*

28 *4. Within 90 days after the date of termination of the*
29 *guardianship or the emancipation or death of the protected minor,*
30 *unless the court authorizes a longer period.*

31 *5. At any other time as required by law or as the court may*
32 *order.*

33 **Sec. 129.** *1. An account made and filed by a guardian of*
34 *the estate must include, without limitation, the following*
35 *information:*

36 *(a) The period covered by the account.*

37 *(b) All cash receipts and disbursements during the period*
38 *covered by the account.*

39 *(c) All claims filed and the action taken regarding the account.*

40 *(d) Any changes in the protected minor's property due to sales,*
41 *exchanges, investments, acquisitions, gifts, mortgages or other*
42 *transactions which have increased, decreased or altered the*
43 *protected minor's property holdings as reported in the original*
44 *inventory or the preceding account.*



1 (e) Any other information the guardian considers necessary to
2 show the condition of the affairs of the protected minor.

3 2. If the account is for the estates of two or more wards, it
4 must show the interest of each ward in the receipts, disbursements
5 and property.

6 3. Receipts or vouchers for all expenditures must be retained
7 by the guardian for examination by the court or an interested
8 person. Unless ordered by the court, the guardian is not required
9 to file such receipts or vouchers with the court.

10 4. On the court's own motion or on ex parte application by an
11 interested person which demonstrates good cause, the court may:

12 (a) Order production of the receipts or vouchers that support
13 the account; and

14 (b) Examine or audit the receipts or vouchers that support the
15 account.

16 5. If a receipt or voucher is lost or for good reason cannot be
17 produced on settlement of an account, payment may be proved by
18 the oath of at least one competent witness. The guardian must be
19 allowed expenditures if it is proven that:

20 (a) The receipt or voucher for any disbursement has been lost
21 or destroyed so that it is impossible to obtain a duplicate of the
22 receipt or voucher; and

23 (b) Expenses were paid in good faith and were valid charges
24 against the estate.

25 **Sec. 130.** 1. Any interested person may appear at the
26 hearing and object to the account or file written objections to the
27 account before the hearing.

28 2. If there are no objections to the account or if the court
29 overrules any objections, the court may enter an order allowing
30 and confirming the account.

31 3. Except as otherwise provided in this subsection, the order
32 settling and allowing the account is a final order and is conclusive
33 against all persons interested in the guardianship proceeding,
34 including, without limitation, heirs and assigns. The order is not
35 final against a protected minor who requests an examination of
36 any account after the protected minor's legal disability is removed.

37 4. If the court finds that an interested person who objected to
38 the account did not object in good faith or in furtherance of the
39 best interests of the protected minor, the court may order the
40 interested person to pay to the estate of the protected minor all or
41 part of the expenses associated with the objection.

42 **Sec. 131.** 1. Subject to the discretion and approval of the
43 court and except as otherwise provided in subsection 4, a guardian
44 must be allowed:

45 (a) Reasonable compensation for the guardian's services;



1 (b) *Necessary and reasonable expenses incurred in exercising*
2 *the authority and performing the duties of a guardian; and*

3 (c) *Reasonable expenses incurred in retaining accountants,*
4 *attorneys, appraisers or other professional services.*

5 2. *Reasonable compensation and services must be based upon*
6 *similar services performed for persons who are not under a legal*
7 *disability. In determining whether compensation is reasonable, the*
8 *court may consider:*

9 (a) *The nature of the guardianship;*

10 (b) *The type, duration and complexity of the services required;*
11 *and*

12 (c) *Any other relevant factors.*

13 3. *In the absence of an order of the court pursuant to this*
14 *chapter shifting the responsibility of the payment of compensation*
15 *and expenses, the payment of compensation and expenses must be*
16 *paid from the estate of the protected minor. In evaluating the*
17 *ability of a protected minor to pay such compensation and*
18 *expenses, the court may consider:*

19 (a) *The nature, extent and liquidity of the protected minor's*
20 *assets;*

21 (b) *The disposable net income of the protected minor;*

22 (c) *Any foreseeable expenses; and*

23 (d) *Any other factors that are relevant to the duties of the*
24 *guardian pursuant to section 61 or 64 of this act.*

25 4. *A private professional guardian is not allowed*
26 *compensation or expenses for services incurred by the private*
27 *professional guardian as a result of a petition to have him or her*
28 *removed as guardian if the court removes the private professional*
29 *guardian pursuant to the provisions of paragraph (b), (d), (e), (f)*
30 *or (h) of subsection 1 of section 133 of this act.*

31 **Sec. 132.** *If a protected minor resides with a care provider*
32 *that is an institution or facility, the care provider shall furnish to*
33 *the guardian an itemized accounting of all financial activity*
34 *pertaining to the protected minor:*

35 1. *On a quarterly basis; and*

36 2. *At any other time, upon the request of the guardian.*

37 **Sec. 133.** 1. *The court may remove a guardian if the court*
38 *determines that:*

39 (a) *The guardian has become mentally incompetent,*
40 *unsuitable or otherwise incapable of exercising the authority and*
41 *performing the duties of a guardian as provided by law;*

42 (b) *The guardian is no longer qualified to act as a guardian*
43 *pursuant to section 46 of this act;*

44 (c) *The guardian has filed for bankruptcy within the previous*
45 *5 years;*



1 (d) *The guardian of the estate has mismanaged the estate of*
2 *the protected minor;*

3 (e) *The guardian has negligently failed to perform any duty as*
4 *provided by law or by any order of the court and:*

5 (1) *The negligence resulted in injury to the protected minor*
6 *or the estate of the protected minor; or*

7 (2) *There was a substantial likelihood that the negligence*
8 *would result in injury to the protected minor or the estate of the*
9 *protected minor;*

10 (f) *The guardian has intentionally failed to perform any duty*
11 *as provided by law or by any lawful order of the court, regardless*
12 *of injury;*

13 (g) *The best interests of the protected minor will be served by*
14 *the appointment of another person as guardian; or*

15 (h) *The guardian is a private professional guardian who is no*
16 *longer qualified as a private professional guardian pursuant to*
17 *section 45 of this act.*

18 2. *A guardian may not be removed if the sole reason for*
19 *removal is the lack of money to pay the compensation and*
20 *expenses of the guardian.*

21 **Sec. 134.** *A guardian who, after appointment:*

22 1. *Is convicted of a gross misdemeanor or felony in any state;*

23 2. *Files for or receives protection as an individual or as a*
24 *principal of any entity under the federal bankruptcy laws;*

25 3. *Has a driver's license suspended, revoked or cancelled for*
26 *nonpayment of child support;*

27 4. *Is suspended for misconduct or disbarred from:*

28 (a) *The practice of law;*

29 (b) *The practice of accounting; or*

30 (c) *Any other profession which:*

31 (1) *Involves or may involve the management or sale of*
32 *money, investments, securities or real property; or*

33 (2) *Requires licensure in this State or any other state; or*

34 5. *Has a judgment entered against him or her for*
35 *misappropriation of funds or assets from any person or entity in*
36 *any state,*

37 *↪ shall immediately inform the court of the circumstances of*
38 *those events. The court may remove the guardian and appoint a*
39 *successor guardian, unless the court finds that it is in the best*
40 *interest of the protected minor to allow the guardian to continue in*
41 *his or her appointment.*

42 **Sec. 135.** 1. *The following persons may petition the court to*
43 *have a guardian removed:*

44 (a) *The protected minor;*



1 (b) Any relative who is within the second degree of
2 consanguinity to the protected minor;

3 (c) A public guardian; or

4 (d) Any other interested person.

5 2. The petition must:

6 (a) State with particularity the reasons for removing the
7 guardian; and

8 (b) Show cause for the removal.

9 3. If the court denies the petition for removal, the petitioner
10 shall not file a subsequent petition unless a material change of
11 circumstances warrants a subsequent petition.

12 4. If the court finds that the petitioner did not file a petition
13 for removal in good faith or in furtherance of the best interests of
14 the protected minor, the court may:

15 (a) Disallow the petitioner from petitioning the court for
16 attorney's fees from the estate of the protected minor; and

17 (b) Impose sanctions on the petitioner in an amount sufficient
18 to reimburse the estate of the protected minor for all or part of the
19 expenses incurred by the estate of the protected minor in
20 responding to the petition and for any other pecuniary losses
21 which are associated with the petition.

22 **Sec. 136.** 1. If a petition to have a guardian removed is
23 filed with the court, the court shall issue and serve a citation on
24 the guardian and on all other interested persons.

25 2. The citation must require the guardian to appear and show
26 cause why the court should not remove the guardian.

27 3. If it appears that the protected minor or estate may suffer
28 loss or injury during the time required for service of the citation
29 on the guardian, on the court's own motion or on petition, the
30 court may:

31 (a) Suspend the powers of the guardian by issuing a 30-day
32 temporary restraining order or an injunction;

33 (b) Compel the guardian to surrender the protected minor to a
34 temporary guardian for not more than 30 days; and

35 (c) Compel the guardian to surrender the assets of the estate to
36 a temporary guardian or to the public guardian until the date set
37 for the hearing.

38 **Sec. 137.** If a petition to remove a guardian is deemed
39 sufficient and the guardian fails to appear before the court, the
40 court may take any or all of the following actions:

41 1. Hold the guardian in contempt of court.

42 2. Require the guardian to appear at a date and time set by
43 the court.

44 3. Issue a bench warrant for the arrest and appearance of the
45 guardian.



1 4. Find that the guardian caused harm to the protected minor
2 or the estate of the protected minor and issue an order
3 accordingly.

4 **Sec. 138.** 1. Notwithstanding any other provision of law,
5 except as otherwise provided in subsection 3, the court shall not
6 remove the guardian or appoint another person as guardian
7 unless the court finds that removal of the guardian or appointment
8 of another person as guardian is in the best interests of the
9 protected minor.

10 2. For the purposes of this section in determining the best
11 interests of the protected minor, the court shall consider, without
12 limitation:

13 (a) The ability of the present guardian to provide for the basic
14 needs of the protected minor, including, without limitation, food,
15 shelter, clothing and medical care;

16 (b) The safety of the home in which the protected minor is
17 residing;

18 (c) The length of time that the protected minor has been in the
19 care of the present guardian;

20 (d) The current well-being of the protected minor, including
21 whether the protected minor is prospering in the environment
22 being provided by the present guardian;

23 (e) The emotional bond existing between the present guardian
24 and the protected minor;

25 (f) If the person petitioning the court to replace the present
26 guardian was previously removed from the care, custody or
27 guardianship of the protected minor:

28 (1) The level of participation before the petition was filed by
29 the petitioner in the welfare of the protected minor; and

30 (2) If applicable, whether the petitioner has received
31 instruction in parenting, participated in a program of
32 rehabilitation or undergone counseling for any problem or
33 conduct that the court, in appointing the present guardian,
34 considered as an indication of the previous unfitness of the
35 petitioner; and

36 (g) The mental and physical health of the present guardian.

37 3. The court may remove the guardian of a protected minor
38 or appoint another person as guardian if the guardian files a
39 petition to resign his or her position as guardian.

40 **Sec. 139.** 1. When a guardian dies or is removed by order
41 of the court, the court, upon the court's own motion or upon a
42 petition filed by any interested person, may appoint another
43 guardian in the same manner and subject to the same
44 requirements as are provided by law for an original appointment
45 of a guardian.



1 2. *If a guardian of the person is appointed for a protected*
2 *minor pursuant to this section, the protected minor must be served*
3 *with the petition. If the protected minor does not object to the*
4 *appointment, the protected minor is not required to attend the*
5 *hearing.*

6 **Sec. 140.** *1. A guardian of the person, of the estate, or of*
7 *the person and the estate, may file with the court a petition*
8 *tendering the resignation of the guardian.*

9 2. *If the guardian files a petition to resign, the court shall*
10 *serve notice upon any person entitled to notice pursuant to section*
11 *29 of this act.*

12 **Sec. 141.** *1. Before the court approves the resignation of a*
13 *guardian of the person and discharges the guardian, the court*
14 *shall appoint a successor guardian.*

15 2. *If a protected minor has more than one guardian, the court*
16 *may approve the resignation of one of the guardians if the*
17 *remaining guardian or guardians are qualified to act alone.*

18 **Sec. 142.** *1. Before the court approves the resignation of a*
19 *guardian of the estate and discharges the guardian, the court shall*
20 *require the guardian to submit, on the date set for the hearing, an*
21 *accounting of the estate through the end of the term.*

22 2. *If the guardian fails to file such an accounting, the court*
23 *may impose sanctions upon the guardian.*

24 3. *If an estate has more than one guardian, the court may*
25 *accept the resignation of one of the guardians if the remaining*
26 *guardian or guardians are qualified to act alone. The court may*
27 *waive the requirement of filing the accounting if the remaining*
28 *guardian or guardians are:*

29 (a) *Required to file the annual accounting, if applicable; and*

30 (b) *Responsible for any discrepancies in the accounting.*

31 4. *Upon approval of the accounting, if any is required, and*
32 *appointment of a successor guardian, the court may approve the*
33 *resignation of a guardian and order the discharge of his or her*
34 *duties.*

35 **Sec. 143.** *1. A protected minor, the guardian or another*
36 *person may petition the court for the termination or modification*
37 *of a guardianship. The petition must state or contain:*

38 (a) *The name and address of the petitioner.*

39 (b) *The relationship of the petitioner to the protected minor.*

40 (c) *The name, age and address of the protected minor, if the*
41 *protected minor is not the petitioner, or the date of death of the*
42 *protected minor if the protected minor is deceased.*

43 (d) *The name and address of the guardian, if the guardian is*
44 *not the petitioner.*

45 (e) *The reason for termination or modification.*



1 (f) Whether the termination or modification is sought for a
2 guardianship of the person, of the estate, or of the person and
3 estate.

4 (g) A general description and the value of the remaining
5 property of the protected minor and the proposed disposition of
6 that property.

7 2. Upon the filing of the petition, the court may appoint an
8 attorney to represent the protected minor if:

9 (a) The protected minor is unable to retain an attorney; and

10 (b) The court determines that the appointment is necessary to
11 protect the interests of the protected minor.

12 3. The petitioner has the burden of proof to show by clear
13 and convincing evidence that the termination or modification of
14 the guardianship of the person, of the estate, or of the person and
15 estate is in the best interests of the protected minor.

16 4. The court shall issue a citation to the guardian and all
17 interested persons requiring them to appear and show cause why
18 termination or modification of the guardianship should not be
19 granted.

20 5. If the court finds that the petitioner did not file a petition
21 for termination or modification in good faith or in furtherance of
22 the best interests of the protected minor, the court may:

23 (a) Disallow the petitioner from petitioning the court for
24 attorney's fees from the estate of the protected minor; and

25 (b) Impose sanctions on the petitioner in an amount sufficient
26 to reimburse the estate of the protected minor for all or part of the
27 expenses and for any other pecuniary losses which are incurred by
28 the estate of the protected minor and associated with the petition.

29 **Sec. 144. 1.** A guardianship of the person, of the estate, or
30 of the person and estate is terminated:

31 (a) By the death of the protected minor;

32 (b) Upon the protected minor's change of domicile to a place
33 outside this State and the transfer of jurisdiction to the court
34 having jurisdiction in the new domicile;

35 (c) Upon order of the court, if the court determines that the
36 guardianship no longer is necessary;

37 (d) On the date on which the protected minor reaches 18 years
38 of age; or

39 (e) On the date on which the protected minor graduates from
40 high school or becomes 19 years of age, whichever occurs sooner,
41 if:

42 (1) The protected minor will be older than 18 years of age
43 upon graduation from high school; and

44 (2) The protected minor and the guardian consent to
45 continue the guardianship and the consent is filed with the court



1 *at least 14 days before the date on which the protected minor will*
2 *become 18 years of age.*

3 *2. A guardianship of the estate is terminated:*

4 *(a) If the court removes the guardian or accepts the*
5 *resignation of the guardian and does not appoint a successor*
6 *guardian;*

7 *(b) If the court determines that the guardianship is not*
8 *necessary and orders the guardianship terminated; or*

9 *(c) By the death of the protected minor, subject to the*
10 *provisions of section 147 of this act.*

11 *3. If the guardianship is of the person and estate, the court*
12 *may order the guardianship terminated as to the person, the estate,*
13 *or the person and estate.*

14 *4. The guardian shall notify the court, all interested parties,*
15 *the trustee, and the named executor or appointed personal*
16 *representative of the estate of the protected minor of the death of*
17 *the protected minor within 30 days after the death.*

18 *5. Immediately upon the death or emancipation of the*
19 *protected minor:*

20 *(a) The guardian of the estate shall have no authority to act*
21 *for the protected minor except to wind up the affairs of the*
22 *guardianship pursuant to section 147 of this act, and to distribute*
23 *the property of the protected minor as provided in sections 148 and*
24 *149 of this act; and*

25 *(b) No person has standing to file a petition pursuant to*
26 *section 60 of this act.*

27 *6. A hearing must be held not later than 90 days before a*
28 *protected minor reaches the age of majority to determine whether:*

29 *(a) Guardianship is needed beyond the age of majority;*

30 *(b) The protected minor desires an additional year of*
31 *guardianship beyond the age of majority; and*

32 *(c) The guardian should be notified of any requirements of the*
33 *guardianship which require compliance before termination of the*
34 *guardianship.*

35 *7. If, at a hearing conducted pursuant to subsection 6, a court*
36 *makes a determination that, upon reaching the age of majority, a*
37 *protected minor would be deemed incompetent, as defined in NRS*
38 *159.019, a petition may be filed in accordance with the provisions*
39 *of chapter 159 of NRS to seek guardianship for the protected*
40 *minor pursuant to that chapter to take effect when the protected*
41 *minor reaches the age of majority. The protected minor has the*
42 *right to be represented by counsel if guardianship is sought*
43 *pursuant to this subsection.*

44 **Sec. 145. 1. If, before a protected minor is emancipated, a**
45 **parent of the protected minor petitions the court for the**



1 *termination of a guardianship of the protected minor, the parent*
2 *has the burden of proof to show by clear and convincing evidence*
3 *that:*

4 (a) *There has been a material change of circumstances since*
5 *the time the guardianship was created. The parent must show that,*
6 *as part of the change of circumstances, the parent has been*
7 *restored to suitability as described in section 46 of this act.*

8 (b) *Except as otherwise provided in subsection 2, the welfare*
9 *of the protected minor would be substantially enhanced by the*
10 *termination of the guardianship and the placement of the*
11 *protected minor with the parent.*

12 2. *If the parent consented to the guardianship when it was*
13 *created, the parent is required to make only that showing set forth*
14 *in paragraph (a) of subsection 1.*

15 **Sec. 146.** 1. *If a temporary guardianship is terminated and*
16 *a petition for a general guardianship has not been filed:*

17 (a) *The temporary guardian shall immediately turn over all of*
18 *the protected minor's property to the protected minor; or*

19 (b) *If the temporary guardian is awaiting certification from the*
20 *appropriate authority acknowledging that the guardian has no*
21 *further liability for taxes on the estate, the temporary guardian*
22 *shall seek approval from the court to maintain possession of all or*
23 *a portion of the protected minor's property.*

24 2. *If a temporary guardianship is terminated and a petition*
25 *for general guardianship has been filed, the temporary guardian*
26 *of the estate may:*

27 (a) *Continue possessing the protected minor's property; and*

28 (b) *Perform the duties of guardian for not more than 90 days*
29 *after the temporary guardianship is terminated or until the court*
30 *appoints another temporary or general guardian.*

31 3. *If the death of a protected minor causes the termination of*
32 *a temporary guardianship before the hearing on a general*
33 *guardianship:*

34 (a) *The temporary guardian of the estate may:*

35 (1) *Continue possessing the protected minor's property;*
36 *and*

37 (2) *Except as otherwise provided in this paragraph, perform*
38 *the duties of guardian for not more than 90 days after the date of*
39 *the termination of the temporary guardianship or until the court*
40 *appoints a personal representative of the estate, if any. If the*
41 *temporary guardian is awaiting certification from the appropriate*
42 *authority acknowledging that the guardian has no further liability*
43 *for taxes on the estate and it will take longer than 90 days after the*
44 *date of the termination of the temporary guardianship to receive*
45 *such certification, the temporary guardian must seek approval*



1 *from the court to maintain possession of all or a portion of the*
2 *protected minor's property until certification is received.*

3 *(b) If no personal representative has been appointed pursuant*
4 *to chapter 138 or 139 of NRS, the temporary guardian shall pay*
5 *all of the final expenses and outstanding debts of the protected*
6 *minor to the extent possible using the assets in the possession of*
7 *the temporary guardian.*

8 **Sec. 147.** *1. The guardian of the estate is entitled to retain*
9 *possession of the protected minor's property already in the control*
10 *of the guardian and is authorized to perform the duties of the*
11 *guardian to wind up the affairs of the guardianship:*

12 *(a) Except as otherwise provided in paragraph (b), (c) or (d),*
13 *for not more than 180 days or a period that is reasonable and*
14 *necessary as determined by the court after the termination of the*
15 *guardianship;*

16 *(b) Except as otherwise provided in paragraph (d), for not*
17 *more than 90 days after the date of the appointment of a personal*
18 *representative of the estate of a deceased protected minor;*

19 *(c) Except as otherwise provided in paragraph (d), for not*
20 *more than 90 days after the date of the appointment of a successor*
21 *trustee of a trust of the deceased protected minor and upon request*
22 *by the trustee; or*

23 *(d) Upon approval of the court, for more than 180 days or 90*
24 *days, as applicable, if the guardian is awaiting certification from*
25 *the appropriate authority acknowledging that the guardian has no*
26 *further liability for taxes on the estate.*

27 *2. To wind up the affairs of the guardianship, the guardian*
28 *shall:*

29 *(a) Pay all expenses of administration of the guardianship*
30 *estate, including those incurred in winding up the affairs of the*
31 *guardianship.*

32 *(b) Complete the performance of any contractual obligations*
33 *incurred by the guardianship estate.*

34 *(c) With prior approval of the court, continue any activity that:*

35 *(1) The guardian believes is appropriate and necessary; or*

36 *(2) Was commenced before the termination of the*
37 *guardianship.*

38 *(d) If the guardianship is terminated for a reason other than*
39 *the death of the protected minor, examine and allow and pay, or*
40 *reject, all claims presented to the guardian before the termination*
41 *of the guardianship for obligations incurred before the*
42 *termination.*

43 *3. If the assets are transferred to a personal representative or*
44 *a successor trustee as provided for in paragraphs (b) and (c) of*
45 *subsection 1, the court may authorize the guardian to retain*



1 *sufficient assets to pay any anticipated expenses and taxes of the*
2 *guardianship estate.*

3 **Sec. 148. 1.** *If the guardianship is terminated by reason of*
4 *the death of the protected minor:*

5 *(a) Except as otherwise provided in section 149 of this act, the*
6 *guardian shall report to the personal representative claims which*
7 *are presented to the guardian, or which have been presented to the*
8 *guardian but have not been paid, except those incurred in paying*
9 *the expenses of administration of the guardianship estate and in*
10 *winding up the affairs of the guardianship estate.*

11 *(b) Claims which have been allowed by the guardian, but not*
12 *paid, must be paid by the personal representative in the course of*
13 *probate in the priority provided by law for payment of claims*
14 *against a decedent, and shall have the same effect and priority as*
15 *a judgment against a decedent.*

16 *(c) Claims which have been presented and not allowed or*
17 *rejected must be acted upon by the personal representative in the*
18 *same manner as other claims against a decedent.*

19 **2.** *The personal representative must be substituted as the*
20 *party in interest for the guardian in any action commenced or*
21 *which may be commenced by the creditor pursuant to section 79 of*
22 *this act, including summary determination, on any claim rejected*
23 *by the guardian.*

24 **Sec. 149. 1.** *After the winding up of the affairs of the*
25 *guardianship, the guardian shall deliver physical possession of all*
26 *of the protected minor's property to the protected minor, the*
27 *personal representative or the successor guardian, as the case may*
28 *be, and obtain a receipt of the delivery of the property.*

29 **2.** *Before the guardian delivers physical possession of the*
30 *protected minor's property to the personal representative and upon*
31 *sufficient evidence of prior title, the guardian may petition the*
32 *court to have the title to the property modified, on a pro rata basis,*
33 *to reflect the manner in which title was held before the*
34 *guardianship was established so that the property is distributed to*
35 *the intended beneficiary or former joint owner of the property.*

36 **3.** *If the guardianship has terminated by reason of the death*
37 *of the protected minor, the court, by order, may authorize the*
38 *guardian to handle the deceased protected minor's property in*
39 *the same manner as authorized by NRS 146.070 or 146.080, if the*
40 *gross value of the property, less encumbrances, and less fees, costs*
41 *and expenses that are approved by the court, remaining in the*
42 *hands of the guardian does not exceed the amount authorized*
43 *pursuant to NRS 146.070 or 146.080.*

44 **Sec. 150. 1.** *Upon the filing of receipts and vouchers*
45 *showing compliance with the orders of the court in winding up the*



1 *affairs of the guardianship, the court shall enter an order*
2 *discharging the guardian and exonerating the bond of the*
3 *guardian.*

4 *2. A guardian is not relieved of liability for his or her term as*
5 *guardian until an order of discharge is entered and filed with the*
6 *court.*

7 **Sec. 151.** *A guardian shall maintain all records and*
8 *documents for each protected minor whom the guardian has*
9 *authority over for a period of not less than 7 years after the court*
10 *terminates the guardianship and shall maintain all financial*
11 *records related to the guardianship for a period of not less than 7*
12 *years after the date of the last financial transaction.*

13 **Sec. 152.** *1. Where a guardian of the estate for a*
14 *nonresident has not been appointed in this State, but the*
15 *nonresident has a foreign guardian and a person within this State*
16 *is indebted to such nonresident or such nonresident has property*
17 *within this State that is capable of being removed and which is on*
18 *deposit with or in the possession of a resident of this State, and*
19 *such property is not subject to a mortgage, pledge, lien or other*
20 *encumbrance restricting removal of the property from this State,*
21 *the person in possession of the property may deliver such property*
22 *or the person indebted may pay such debt, to the foreign guardian.*
23 *The delivery of such property or the payment of such debt is, to the*

23 abuse or neglect of the child; or

24 (2) Any recording made by the agency of any statement

26 member or director and officer of the corporation and person acting
27 in a managerial or case manager capacity indicates fiscal
28 responsibility consistent with his or her position.

29 (c) That the name of the proposed business complies with all
30 applicable statutes.

31 (d) That, except as otherwise provided in NRS 628B.540, the
32 initial surety bond is not less than the amount required by NRS
33 159.065 **H** *or section 50 of this act, as applicable.*

34 2. In rendering a decision on an application for a license, the
35 Commissioner shall consider, without limitation:

36 (a) The proposed markets to be served and, if they extend
37 outside this State, any exceptional risk, examination or supervision
38 concerns associated with those markets;

39 (b) Whether the proposed organizational and equity structure
40 and the amount of initial equity or fidelity and surety bonds of the
41 applicant appear adequate in relation to the proposed business and
42 markets, including, without limitation, the average level of assets
43 under guardianship projected for each of the first 3 years of
44 operation; and



1 (c) Whether the applicant has planned suitable annual audits
2 conducted by qualified outside auditors of its books and records and
3 its fiduciary activities under applicable accounting rules and
4 standards as well as suitable internal audits.

5 **Sec. 216.** NRS 628B.540 is hereby amended to read as
6 follows:

7 628B.540 1. The Commissioner may require a private
8 professional guardian company to maintain equity, fidelity and
9 surety bonds in amounts that are more than the minimum required
10 initially or at any subsequent time based on the Commissioner's
11 assessment of the risks associated with the business plan of the
12 private professional guardian or other information contained in the
13 application, the Commissioner's investigation of the application or
14 any examination of or filing by the private professional guardian
15 company thereafter, including, without limitation, any examination
16 before the opening of the business. In making such a determination,
17 the Commissioner may consider, without limitation:

18 (a) The nature and type of business to be conducted by the
19 private professional guardian company;

20 (b) The nature and liquidity of assets proposed to be held in the
21 account of the private professional guardian company;

22 (c) The amount of fiduciary assets projected to be under the
23 management or administration of the private professional guardian
24 company;

25 (d) The type of fiduciary assets proposed to be held and any
26 proposed depository of such assets;

27 (e) The complexity of the fiduciary duties and degree of
28 discretion proposed to be undertaken by the private professional
29 guardian company;

30 (f) The competence and experience of the proposed management
31 of the private professional guardian company;

32 (g) The extent and adequacy of proposed internal controls;

33 (h) The proposed presence of annual audits by an independent
34 certified public accountant, and the scope and frequency of such
35 audits, whether they result in an opinion of the accountant and any
36 qualifications to the opinion;

37 (i) The reasonableness of business plans for retaining or
38 acquiring additional equity capital;

39 (j) The adequacy of fidelity and surety bonds and any additional
40 insurance proposed to be obtained by the private professional
41 guardian company for the purpose of protecting its fiduciary assets;

42 (k) The success of the private professional guardian company in
43 achieving the financial projections submitted with its application for
44 a license; and



1 (l) The fulfillment by the private professional guardian company
2 of its representations and its descriptions of its business structures
3 and methods and management set forth in its application for a
4 license.

5 2. The director or manager of a private professional guardian
6 company shall require fidelity bonds in the amount of at least
7 \$25,000 on the sole proprietor or each active officer, manager,
8 member acting in a managerial or case manager capacity and
9 employee, regardless of whether the person receives a salary or
10 other compensation from the private professional guardian
11 company, to indemnify the company against loss due to any
12 dishonest, fraudulent or criminal act or omission by a person upon
13 whom a bond is required pursuant to this section who acts alone or
14 in combination with any other person. A bond required pursuant to
15 this section may be in any form and may be paid for by the private
16 professional guardian company.

17 3. A private professional guardian company shall obtain
18 suitable insurance against burglary, robbery, theft and other hazards
19 to which it may be exposed in the operation of its business.

20 4. A private professional guardian company shall obtain
21 suitable surety bonds in accordance with NRS 159.065 ~~§~~ *or section*
22 *50 of this act*, as applicable.

23 5. The surety bond obtained pursuant to subsection 4 must be
24 in a form approved by a court of competent jurisdiction and the
25 Division and conditioned that the applicant conduct his or her
26 business in accordance with the requirements of this chapter. The
27 bond must be made and executed by the principal and a surety
28 company authorized to write bonds in this State.

29 6. A private professional guardian company shall at least
30 annually prescribe the amount or penal sum of the bonds or policies
31 of the company and designate the sureties and underwriters thereof,
32 after considering all known elements and factors constituting a risk
33 or hazard. The action must be recorded in the minutes kept by the
34 private professional guardian company and reported to the
35 Commissioner.

36 7. The bond must cover all matters placed with the private
37 professional guardian company during the term of the license or a
38 renewal thereof.

39 8. An action may not be brought upon any bond after 2 years
40 from the revocation or expiration of the license.

41 9. After 2 years, all liability of the surety or sureties upon the
42 bond ceases if no action is commenced upon the bond.



1 **Sec. 217.** NRS 628B.550 is hereby amended to read as
2 follows:

3 628B.550 1. The fiduciary relationship which exists between
4 a private professional guardian and the ward of the private
5 professional guardian may not be used for the private gain of the
6 guardian other than the remuneration for fees and expenses. A
7 private professional guardian may not incur any obligation on behalf
8 of the guardianship that conflicts with the discharge of the duties of
9 the private professional guardian.

10 2. Unless prior approval is obtained from a court of competent
11 jurisdiction, a private professional guardian shall not:

12 (a) Have any interest, financial or otherwise, direct or indirect,
13 in any business transaction or activity with the guardianship.

14 (b) Acquire an ownership, possessory, security or other
15 pecuniary interest adverse to the ward.

16 (c) Be knowingly designated as a beneficiary on any life
17 insurance policy or pension or benefit plan of the ward unless such
18 designation was validly made by the ward before the adjudication of
19 the person's incapacity.

20 (d) Directly or indirectly purchase, rent, lease or sell any
21 property or services from or to any business entity in which the
22 private professional guardian, or the spouse or relative of the
23 guardian, is an officer, partner, director, shareholder or proprietor or
24 in which such a person has any financial interest.

25 3. Any action taken by a private professional guardian which is
26 prohibited by this section may be voided during the term of the
27 guardianship or by the personal representative of the ward's estate.
28 The private professional guardian is subject to removal and to
29 imposition of personal liability through a proceeding for discharge,
30 in addition to any other remedies otherwise available.

31 4. A court shall not appoint a private professional guardian that
32 is not licensed pursuant to this chapter as the guardian of a person or
33 estate. The court must review each guardianship involving a private
34 professional guardian on the anniversary date of the appointment of
35 the private professional guardian. If a private professional guardian
36 does not hold a current license, the court must replace the guardian
37 until such time as the private professional guardian obtains the
38 necessary license.

40 regarding summary administration do not apply to a private

42 6. A licensee shall file any report required by the court in a
43 timely manner.

2 follows:

3 628B.560 1. Except as otherwise provided in NRS 159.076
4 **† and section 58 of this act**, a licensee shall maintain a separate
5 guardianship account for each ward into which all money received
6 for the benefit of the ward must be deposited. Each guardianship
7 account must be maintained in an insured bank or credit union
8 located in this State, be held in a name which is sufficient to
9 distinguish it from the personal or general checking account of the
10 licensee and be designated as a guardianship account. Each
11 guardianship account must at all times account for all money
12 received for the benefit of the ward and account for all money
13 dispersed for the benefit of the ward, and no disbursement may be
14 made from the account except as authorized under chapter 159 of
15 NRS **or sections 2 to 157, inclusive, of this act** or as authorized by
16 court order.

17 2. Each licensee shall keep a record of all money deposited in
18 each guardianship account maintained for a ward, which must
19 clearly indicate the date and from whom the money was received,
20 the date the money was deposited, the dates of withdrawals of
21 money and other pertinent information concerning the transactions.
22 Records kept pursuant to this subsection must be maintained for at
23 least 6 years after the completion of the last transaction concerning
24 the account. The records must be maintained at the premises in this
25 State at which the licensee is authorized to conduct business.

26 3. The Commissioner or his or her designee may conduct an
27 examination of the guardianship accounts and records relating to
28 wards of each private professional guardian company licensed
29 pursuant to this chapter at any time to ensure compliance with the
30 provisions of this chapter.

31 4. During the first year a private professional guardian is
32 licensed in this State, the Commissioner or his or her designee may
33 conduct any examinations deemed necessary to ensure compliance
34 with the provisions of this chapter.

35 5. If there is evidence that a private professional guardian
36 company has violated a provision of this chapter, the Commissioner
37 or his or her designee may conduct additional examinations to
38 determine whether a violation has occurred.

39 6. Each licensee shall authorize the Commissioner or his or her
40 designee to examine all books, records, papers and effects of the
41 private professional guardian company.

42 7. If the Commissioner determines that the records of a
43 licensee are not maintained in accordance with subsections 1 and 2,
44 the Commissioner may require the licensee to submit, within 60
45 days, an audited financial statement prepared from the records of the



1 licensee by a certified public accountant who holds a certificate to
2 engage in the practice of public accounting in this State. The
3 Commissioner may grant a reasonable extension of time for the
4 submission of the financial statement if an extension is requested
5 before the statement is due.

6 8. Upon the request of the Division, a licensee must provide to
7 the Division copies of any documents reviewed during an
8 examination conducted by the Commissioner or his or her designee
9 pursuant to subsection 4, 5 or 6. If the copies are not provided, the
10 Commissioner may subpoena the documents.

11 9. For each examination of the books, papers, records and
12 effects of a private professional guardian company that is required
13 or authorized pursuant to this chapter, the Commissioner shall
14 charge and collect from the private professional guardian company a
15 fee for conducting the examination and preparing a report of the
16 examination based upon the rate established by regulation pursuant
17 to NRS 658.101. Failure to pay the fee within 30 days after receipt
18 of the bill is grounds for revoking the license of the private
19 professional guardian company.

20 10. All money collected under this section must be deposited in
21 the State Treasury pursuant to the provisions of NRS 658.091.
