SUMMARY—Revises provisions governing the regional training programs for the professional development of teachers and administrators. (BDR 34-272)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to education; abolishing the Statewide Council for the Coordination of the Regional Training Programs and the governing body of each regional training program; transferring the powers and duties of the Council and governing bodies concerning the regional training programs to the Department of Education; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law creates three regional training programs for the professional  
2 development of teachers and administrators and designates each of the 17 county  
3 school districts within the jurisdiction of one of the regional training programs.  
4 (NRS 391.500-391.556) Existing law also creates: (1) a Statewide Council for the  
5 Coordination of the Regional Training Programs; and (2) a governing body of each  
6 regional training program. This bill abolishes the Statewide Council and each  
7 governing body and transfers their powers and duties concerning the regional  
8 training programs to the Department of Education.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 385.34691 is hereby amended to read as  
2 follows:

3 385.34691 1. The State Board shall prepare a plan to improve  
4 the achievement of pupils enrolled in the public schools in this  
5 State. The plan:

- 1 (a) Must be prepared in consultation with:  
2 (1) Employees of the Department;  
3 (2) At least one employee of a school district in a county  
4 whose population is 100,000 or more, appointed by the Nevada  
5 Association of School Boards; *and*  
6 (3) At least one employee of a school district in a county  
7 whose population is less than 100,000, appointed by the Nevada  
8 Association of School Boards; and  
9 ~~(4) At least one representative of the Statewide Council for~~  
10 ~~the Coordination of the Regional Training Programs created by NRS~~  
11 ~~391.516, appointed by the Council; and~~

- 12 (b) May be prepared in consultation with:  
13 (1) Representatives of institutions of higher education;  
14 (2) Representatives of regional educational laboratories;  
15 (3) Representatives of outside consultant groups;  
16 (4) Representatives of the regional training programs for the  
17 professional development of teachers and administrators created by  
18 NRS 391.512;  
19 (5) The Bureau; and  
20 (6) Other persons who the State Board determines are  
21 appropriate.

22 2. A plan to improve the achievement of pupils enrolled in  
23 public schools in this State must include:

24 (a) A review and analysis of the data upon which the report  
25 required pursuant to NRS 385.3469 is based and a review and  
26 analysis of any data that is more recent than the data upon which the  
27 report is based.

28 (b) The identification of any problems or factors common  
29 among the school districts or charter schools in this State, as  
30 revealed by the review and analysis.

31 (c) Strategies based upon scientifically based research, as  
32 defined in 20 U.S.C. § 7801(37), that will strengthen the core  
33 academic subjects, as set forth in NRS 389.018.

34 (d) Strategies to improve the academic achievement of pupils  
35 enrolled in public schools in this State, including, without limitation,  
36 strategies to:

37 (1) Instruct pupils who are not achieving to their fullest  
38 potential, including, without limitation:

39 (I) The curriculum appropriate to improve achievement;  
40 (II) The manner by which the instruction will improve the  
41 achievement and proficiency of pupils on the examinations  
42 administered pursuant to NRS 389.015 and 389.550; and

43 (III) An identification of the instruction and curriculum  
44 that is specifically designed to improve the achievement and



1 proficiency of pupils in each group identified in paragraph (b) of  
2 subsection 1 of NRS 385.361;

3 (2) Increase the rate of attendance of pupils and reduce the  
4 number of pupils who drop out of school;

5 (3) Integrate technology into the instructional and  
6 administrative programs of the school districts;

7 (4) Manage effectively the discipline of pupils; and

8 (5) Enhance the professional development offered for the  
9 teachers and administrators employed at public schools in this State  
10 to include the activities set forth in 20 U.S.C. § 7801(34) and to  
11 address the specific needs of the pupils enrolled in public schools in  
12 this State, as deemed appropriate by the State Board.

13 (e) Strategies designed to provide to the pupils enrolled in  
14 middle school, junior high school and high school, the teachers and  
15 counselors who provide instruction to those pupils, and the parents  
16 and guardians of those pupils information concerning:

17 (1) The requirements for admission to an institution of higher  
18 education and the opportunities for financial aid;

19 (2) The availability of Governor Guinn Millennium  
20 Scholarships pursuant to NRS 396.911 to 396.945, inclusive; and

21 (3) The need for a pupil to make informed decisions about  
22 his or her curriculum in middle school, junior high school and high  
23 school in preparation for success after graduation.

24 (f) An identification, by category, of the employees of the  
25 Department who are responsible for ensuring that each provision of  
26 the plan is carried out effectively.

27 (g) A timeline for carrying out the plan, including, without  
28 limitation:

29 (1) The rate of improvement and progress which must be  
30 attained annually in meeting the goals and benchmarks established  
31 by the State Board pursuant to subsection 3; and

32 (2) For each provision of the plan, a timeline for carrying out  
33 that provision, including, without limitation, a timeline for  
34 monitoring whether the provision is carried out effectively.

35 (h) For each provision of the plan, measurable criteria for  
36 determining whether the provision has contributed toward  
37 improving the academic achievement of pupils, increasing the rate  
38 of attendance of pupils and reducing the number of pupils who drop  
39 out of school.

40 (i) Strategies to improve the allocation of resources from this  
41 State, by program and by school district, in a manner that will  
42 improve the academic achievement of pupils. If this State has a  
43 financial analysis program that is designed to track educational  
44 expenditures and revenues to individual schools, the State Board  
45 shall use that statewide program in complying with this paragraph.



1 If a statewide program is not available, the State Board shall use the  
2 Department's own financial analysis program in complying with  
3 this paragraph.

4 (j) Based upon the reallocation of resources set forth in  
5 paragraph (i), the resources available to the State Board and the  
6 Department to carry out the plan, including, without limitation, a  
7 budget for the overall cost of carrying out the plan.

8 (k) A summary of the effectiveness of appropriations made by  
9 the Legislature to improve the academic achievement of pupils and  
10 programs approved by the Legislature to improve the academic  
11 achievement of pupils.

12 (l) A 5-year strategic plan which identifies the recurring issues  
13 in improving the achievement and proficiency of pupils in this State  
14 and which establishes strategic goals to address those issues. The  
15 5-year strategic plan must be:

16 (1) Based upon the data from previous years which is  
17 collected by the Department for the plan developed pursuant to this  
18 section; and

19 (2) Designed to track the progress made in achieving the  
20 strategic goals established by the Department.

21 (m) Any additional plans addressing the achievement and  
22 proficiency of pupils adopted by the Department.

23 3. The State Board shall:

24 (a) In developing the plan to improve the achievement of pupils  
25 enrolled in public schools, establish clearly defined goals and  
26 benchmarks for improving the achievement of pupils, including,  
27 without limitation, goals for:

28 (1) Improving proficiency results in core academic subjects;

29 (2) Increasing the number of pupils enrolled in public middle  
30 schools and junior high schools, including, without limitation,  
31 charter schools, who enter public high schools with the skills  
32 necessary to succeed in high school;

33 (3) Improving the percentage of pupils who enroll in grade 9  
34 and who graduate from a public high school, including, without  
35 limitation, a charter school, with a standard or higher diploma upon  
36 completion;

37 (4) Improving the performance of pupils on standardized  
38 college entrance examinations;

39 (5) Increasing the percentage of pupils enrolled in high  
40 schools who enter postsecondary educational institutions or who are  
41 career and workforce ready; and

42 (6) Reengaging disengaged youth who have dropped out of  
43 high school or who are at risk of dropping out of high school,  
44 including, without limitation, a mechanism for tracking and



1 maintaining communication with those youth who have dropped out  
2 of school or who are at risk of doing so;

3 (b) Review the plan annually to evaluate the effectiveness of the  
4 plan;

5 (c) Examine the timeline for implementing the plan and each  
6 provision of the plan to determine whether the annual goals and  
7 benchmarks have been attained; and

8 (d) Based upon the evaluation of the plan, make revisions, as  
9 necessary, to ensure that:

10 (1) The goals and benchmarks set forth in the plan are being  
11 attained in a timely manner; and

12 (2) The plan is designed to improve the academic  
13 achievement of pupils enrolled in public schools in this State.

14 4. On or before January 31 of each year, the State Board shall  
15 submit the plan or the revised plan, as applicable, to the:

16 (a) Governor;

17 (b) Committee;

18 (c) Bureau;

19 (d) Board of Regents of the University of Nevada;

20 (e) Council to Establish Academic Standards for Public Schools  
21 created by NRS 389.510;

22 (f) Board of trustees of each school district; and

23 (g) Governing body of each charter school.

24 **Sec. 2.** NRS 385.3784 is hereby amended to read as follows:

25 385.3784 1. The Commission on Educational Excellence,  
26 consisting of nine members is hereby created. The Superintendent of  
27 Public Instruction shall serve as an ex officio voting member of the  
28 Commission. The Governor shall appoint the following members to  
29 the Commission:

30 (a) Three teachers, two of whom have experience in providing  
31 instruction at public elementary schools and who have been  
32 successful in school improvement efforts and one of whom has  
33 experience in providing instruction at secondary schools and who  
34 has been successful in school improvement efforts;

35 (b) Two principals, one of whom has experience in  
36 administering successful school improvement efforts at an  
37 elementary school and one of whom has experience in administering  
38 successful school improvement efforts at a secondary school;

39 (c) Two school district administrators, one of whom is employed  
40 by a school district in a county whose population is less than  
41 100,000 and one of whom is employed by a school district in a  
42 county whose population is 100,000 or more; and

43 (d) One parent or legal guardian of a pupil enrolled in a public  
44 school in this State. The parent must not be employed by the board



1 of trustees of a school district or the governing body of a charter  
2 school.

3 ↪ One or more of the members appointed pursuant to this  
4 subsection may be retired from employment, but those retired  
5 members that are appointed must have been employed with a public  
6 school in this State in the immediately preceding 5 years.

7 2. The Governor may solicit recommendations for  
8 appointments pursuant to this section from the Nevada State  
9 Education Association, the Nevada Association of School  
10 Administrators, a statewide organization for parents of pupils ~~†, the~~  
11 ~~Statewide Council for the Coordination of the Regional Training~~  
12 ~~Programs†~~ and other organizations and entities related to education  
13 in this State. The Governor may consider the recommendations  
14 submitted and may make appointments from those  
15 recommendations. The Governor shall appoint a Chair from among  
16 the members appointed by the Governor.

17 3. After the initial terms, the term of each appointed member of  
18 the Commission is 2 years, commencing on January 1 of the year in  
19 which the member is appointed and expiring on December 31 of the  
20 immediately following year. A member shall continue to serve on  
21 the Commission until his or her successor is appointed. Upon the  
22 expiration of a term of a member, the member may be reappointed if  
23 he or she still possesses any requisite qualifications for appointment.  
24 There is no limit on the number of terms that a member may serve.

25 4. The Commission shall hold at least four regular meetings  
26 each year and may hold special meetings at the call of the Chair.

27 5. Members of the Commission serve without compensation,  
28 except that for each day or portion of a day during which a member  
29 of the Commission attends a meeting of the Commission or is  
30 otherwise engaged in the business of the Commission, the member  
31 is entitled to receive the per diem allowance and travel expenses  
32 provided for state officers and employees generally. Except as  
33 limited by paragraph (a) of subsection 3 of NRS 385.379, the per  
34 diem allowances and travel expenses must be paid from the Account  
35 and accounted for separately in that Account. In addition, money in  
36 the Account may be used to pay compensation necessary for the  
37 employment of substitute teachers who are hired on those days  
38 when a member of the Commission attends a meeting of the  
39 Commission or is otherwise engaged in the business of the  
40 Commission.

41 6. The Department shall provide:

- 42 (a) Administrative support;
- 43 (b) Equipment; and
- 44 (c) Office space,

45 ↪ as is necessary for the Commission to carry out its duties.



1 7. The Legislative Counsel Bureau:

2 (a) Must be provided with adequate notice of each meeting of  
3 the Commission; and

4 (b) Shall provide, as requested by the Committee, technical  
5 expertise and assistance to the Commission.

6 **Sec. 3.** NRS 385.635 is hereby amended to read as follows:

7 385.635 1. The Office of Parental Involvement and Family  
8 Engagement created by NRS 385.630 shall:

9 (a) Review and evaluate the programs implemented by the  
10 school districts and public schools, including, without limitation,  
11 programs which are supported in part with money received from the  
12 Federal Government, for carrying out and increasing parental  
13 involvement and family engagement in the public schools. The  
14 review and evaluation must include an identification of current  
15 strategies and practices for effective parental involvement and  
16 family engagement.

17 (b) Develop a list of practices which have been proven effective  
18 in increasing the involvement of parents and the engagement of  
19 families in the education of their children, including, without  
20 limitation, practices that increase the ability of school districts and  
21 public schools to effectively reengage parents and families and  
22 provide those parents and families with the skills and resources  
23 necessary to support the academic achievement of their children.

24 (c) ~~Work~~ *Under the direction and supervision of the*  
25 *Department, work* in cooperation with the ~~Statewide Council for~~  
26 ~~the Coordination of the Regional Training Programs~~ *regional*  
27 *training programs for the professional development of teachers*  
28 *and administrators* to establish a statewide training program  
29 concerning parental involvement and family engagement required  
30 pursuant to NRS 391.520.

31 (d) Provide information to the school districts and public  
32 schools on the availability of competitive grants for programs which  
33 offer:

34 (1) Professional development for educational personnel on  
35 practices to reengage disengaged parents and families in the  
36 education of their children;

37 (2) Training for parents and families in skills of leadership  
38 and volunteerism;

39 (3) Family literacy training;

40 (4) Home visitation programs to encourage the involvement  
41 of parents and the engagement of families in the education of their  
42 children; and

43 (5) Other innovative programs that are designed to increase  
44 the involvement of parents and the engagement of families in the  
45 academic achievement of their children.



1 (e) Provide support to those school districts which have  
2 established an advisory council on parental involvement and family  
3 engagement pursuant to NRS 385.625 and encourage those school  
4 districts which have not established such an advisory council to  
5 consider creating an advisory council for the school district.

6 (f) Build the capacity of public schools to work in collaboration  
7 with parents to establish policies for the involvement of parents and  
8 the engagement of families, including, without limitation, policies  
9 that focus on partnerships between public schools and the parents  
10 and families of children enrolled in public schools and the  
11 empowerment of parents and families in support of the education of  
12 their children.

13 (g) Work in cooperation with the Commission on Professional  
14 Standards in Education in developing the regulations required by  
15 paragraph (k) of subsection 1 of NRS 391.019 and monitoring the  
16 implementation of those regulations.

17 (h) Establish, in collaboration with the State Board, guidelines  
18 to assist parents and families in helping their children achieve the  
19 standards of content and performance adopted by the State Board  
20 pursuant to NRS 389.520.

21 (i) Collaborate with the Nevada State Parent Information and  
22 Resource Center, the Parent Training and Information Centers, the  
23 Nevada Parent Teacher Association, the Advisory Council and the  
24 teachers who are trained to serve as liaisons to parents and legal  
25 guardians of pupils enrolled in public schools to plan and implement  
26 a statewide summit on parental involvement and family  
27 engagement, which must be held at least biennially. After each  
28 summit, the Office of Parental Involvement and Family Engagement  
29 shall evaluate the success of the summit in consultation with the  
30 entities identified in this paragraph.

31 (j) Assist each school district and the public schools within the  
32 school district with incorporating strategies and practices for  
33 effective parental involvement and family engagement into the plans  
34 to improve the achievement of pupils prepared by the public schools  
35 pursuant to NRS 385.357.

36 (k) Work in partnership with the Advisory Council to:

37 (1) Review and evaluate the annual reports of accountability  
38 prepared by the board of trustees of each school district pursuant to  
39 NRS 385.347 relating to parental involvement and family  
40 engagement in the school districts and public schools;

41 (2) Review and evaluate the plans to improve the  
42 achievement of pupils prepared by each public school pursuant to  
43 NRS 385.357 relating to the strategies and practices for effective  
44 parental involvement and family engagement incorporated into the  
45 plans; and





1 (3) Review the status of the implementation of the provisions  
2 of this section and the effectiveness of the Office in carrying out the  
3 duties prescribed in this section.

4 2. On or before August 1 of each year, the Office of Parental  
5 Involvement and Family Engagement shall prepare a report which  
6 includes a summary of the:

7 (a) Status of the progress made by the school districts and public  
8 schools in effectively involving parents and engaging families in the  
9 education of their children and an identification of any areas where  
10 further improvement is needed; and

11 (b) Activities of the Office during the immediately preceding  
12 school year, including the progress made by the Office, in  
13 consultation with the Advisory Council, in assisting the school  
14 districts and public schools with increasing the effectiveness of  
15 involving parents and engaging families in the education of their  
16 children.

17 3. The Department shall post on its Internet website:

18 (a) The list of practices developed by the Office of Parental  
19 Involvement and Family Engagement pursuant to paragraph (b) of  
20 subsection 1;

21 (b) The report prepared by the Office pursuant to subsection 2;  
22 and

23 (c) Any other information that the Office finds useful for the  
24 school districts, public schools, parents, families and general public  
25 relating to effective parental involvement and family engagement.
