SUMMARY—Revises provisions relating to uniforms and equipment of peace officers. (BDR 23-405)

AN ACT relating to peace officers; requiring certain state agencies to reimburse certain persons who possess some or all of the powers of peace officers for the cost to repair or replace their required uniforms and other clothing, accessories and safety equipment under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law authorizes, under certain circumstances, a state agency that
2 employs certain persons who possess some or all of the powers of peace officers to
3 reimburse the persons for the cost to repair or replace their required uniforms or
4 other clothing, accessories or safety equipment if they are damaged or destroyed by
5 means other than ordinary wear and tear while the persons perform duties for the
6 State as peace officers. (NRS 289.800) This bill requires a state agency which
7 employs a person who possesses some or all of the powers of a peace officer and
8 which requires the person to purchase and wear a uniform in performing the
9 person’s duties for the State as a peace officer to reimburse the person for the cost
10 to repair or replace the required uniform and any other required clothing,
11 accessories and safety equipment that is damaged or destroyed by ordinary wear
12 and tear while the person performs duties for the State as a peace officer.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 289.800 is hereby amended to read as follows:
2 289.800 **1.** *In addition to the compensation required by*
3 *NRS 281.121, a state agency that employs a person:*

4 **(a)** *Upon whom some or all of the powers of a peace officer*
5 *are conferred pursuant to NRS 289.150 to 289.360, inclusive; and*

6 **(b)** *Who is required to purchase and wear a uniform while*
7 *performing the person's duties for the State as a peace officer,*
8 *↪ shall reimburse that person for the cost to repair or replace the*
9 *person's required uniform and any other required clothing,*
10 *accessories or safety equipment if it is damaged or destroyed by*
11 *ordinary wear and tear while the person is performing his or her*
12 *duties.*

13 **2.** In addition to the compensation required by NRS 281.121, a
14 state agency that employs a person:
