AN ACT relating to wildlife; revising the process by which the Board of Wildlife Commissioners establishes certain policies and adopts certain regulations; revising provisions governing programs for the management and control of predatory wildlife; revising provisions relating to the fees charged to an applicant for an elk tag; revising certain provisions governing county advisory boards to manage wildlife; revising the membership of the State Predatory Animal and Rodent Committee; making various other changes relating to wildlife; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

Existing law requires the Board of Wildlife Commissioners to establish policies for the management of wildlife in this State and to establish policies and adopt regulations necessary to the preservation, protection, management and restoration of wildlife and its habitat. (NRS 501.105, 501.181) **Sections 1 and 1.2** of this bill require the Commission, in establishing such policies and adopting such regulations, to first consider the recommendations of the Department of Wildlife, the county advisory boards to manage wildlife and other persons who present their views at an open meeting of the Commission.

Existing law establishes a county advisory board to manage wildlife in each of the counties of this State. (NRS 501.260) **Sections 1.4-1.6** of this bill make various changes relating to those boards.

12 Existing law sets forth the fees to be charged by the Department of Wildlife to a  
13 hunter who applies for an elk tag. In addition to a fee for the tag itself, the  
14 Department is required to charge a fee for processing the application of not more  
15 than \$15, of which \$5 must be used for the prevention and mitigation of damage  
16 caused by elk or game mammals not native to this State. (NRS 502.250) **Section 3**  
17 of this bill revises those provisions so that the fee for processing the application is  
18 fixed at \$10 and the fee to cover costs of prevention and mitigation is increased to  
19 not more than \$10, as provided by regulation of the Board of Wildlife  
20 Commissioners. **Sections 1.2 and 2** of this bill make conforming changes.

21 Existing law also provides that in addition to any fee charged and collected for  
22 a game tag, a fee of \$3 must be charged for processing each application for a game  
23 tag, the revenue from which must be deposited with the State Treasurer for credit to  
24 the Wildlife Fund Account in the State General Fund and used by the Department  
25 for costs related to certain programs, management activities and research relating to  
26 wildlife. (NRS 502.253) **Section 4** of this bill revises the provisions governing the  
27 use of this money. **Section 4** also requires the Commission to consider the  
28 recommendations of the State Predatory Animal and Rodent Committee, the county  
29 advisory boards to manage wildlife and other persons who present their views at an  
30 open meeting before approving certain programs, activities and research.

31 Existing law creates and governs the State Predatory Animal and Rodent  
32 Committee. (NRS 567.010-567.090) **Section 5** of this bill adds two new members  
33 to the Committee and establishes their qualifications. **Section 8** of this bill requires  
34 the Chair to designate the two additional members described in **section 5** of this bill  
35 as soon as practicable after the effective date of this bill. **Sections 6 and 7** of this  
36 bill make various changes relating to the meetings of the Committee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 501.105 is hereby amended to read as follows:  
2 501.105 The Commission shall establish policies and adopt  
3 regulations necessary to the preservation, protection, management  
4 and restoration of wildlife and its habitat. *In establishing such*  
5 *policies and adopting such regulations, the Commission must first*  
6 *consider the recommendations of the Department, the county*  
7 *advisory boards to manage wildlife and other persons who present*  
8 *their views at an open meeting of the Commission.*

9 **Sec. 1.2.** NRS 501.181 is hereby amended to read as follows:

10 501.181 The Commission shall:

11 1. Establish broad policies for:

12 (a) The protection, propagation, restoration, transplanting,  
13 introduction and management of wildlife in this State.

14 (b) The promotion of the safety of persons using or property  
15 used in the operation of vessels on the waters of this State.

16 (c) The promotion of uniformity of laws relating to policy  
17 matters.

18 2. Guide the Department in its administration and enforcement  
19 of the provisions of this title and of chapter 488 of NRS by the  
20 establishment of such policies.



1 3. Establish policies for areas of interest including:

2 (a) The management of big and small game mammals, upland  
3 and migratory game birds, fur-bearing mammals, game fish, and  
4 protected and unprotected mammals, birds, fish, reptiles and  
5 amphibians.

6 (b) The *management and control of predatory wildlife .*  
7 ~~depredations.~~

8 (c) The acquisition of lands, water rights and easements and  
9 other property for the management, propagation, protection and  
10 restoration of wildlife.

11 (d) The entry, access to, and occupancy and use of such  
12 property, including leases of grazing rights, sales of agricultural  
13 products and requests by the Director to the State Land Registrar for  
14 the sale of timber if the sale does not interfere with the use of the  
15 property on which the timber is located for wildlife management or  
16 for hunting or fishing thereon.

17 (e) The control of nonresident hunters.

18 (f) The introduction, transplanting or exporting of wildlife.

19 (g) Cooperation with federal, state and local agencies on wildlife  
20 and boating programs.

21 (h) The revocation of licenses issued pursuant to this title to any  
22 person who is convicted of a violation of any provision of this title  
23 or any regulation adopted pursuant thereto.

24 4. Establish regulations necessary to carry out the provisions of  
25 this title and of chapter 488 of NRS, including:

26 (a) Seasons for hunting game mammals and game birds, for  
27 hunting or trapping fur-bearing mammals and for fishing, the daily  
28 and possession limits, the manner and means of taking wildlife,  
29 including, but not limited to, the sex, size or other physical  
30 differentiation for each species, and, when necessary for  
31 management purposes, the emergency closing or extending of a  
32 season, reducing or increasing of the bag or possession limits on a  
33 species, or the closing of any area to hunting, fishing or trapping.

34 ~~The~~ *If, in establishing any regulations* ~~must be established after~~  
35 ~~first considering~~ *pursuant to this subsection, the Commission*  
36 *rejects the recommendations of* ~~the Department, the~~ *a county*  
37 *advisory* ~~boards~~ *board* *to manage wildlife* ~~and others who wish to~~  
38 ~~present their views at an open meeting.~~ *with regard to the length of*  
39 *seasons for fishing, hunting and trapping or the bag or possession*  
40 *limits applicable within the respective county, the Commission*

5 (c) The delineation of game management units embracing  
6 contiguous territory located in more than one county, irrespective of  
7 county boundary lines.

8 (d) The number of licenses issued for big game and, if  
9 necessary, other game species.

10 5. Adopt regulations requiring the Department to make public,  
11 before official delivery, its proposed responses to any requests by  
12 federal agencies for its comment on drafts of statements concerning  
13 the environmental effect of proposed actions or regulations affecting  
14 public lands.

15 6. Adopt regulations:

16 (a) Governing the provisions of the permit required by NRS  
17 502.390 and for the issuance, renewal and revocation of such a  
18 permit.

19 (b) Establishing the method for determining the amount of an  
20 assessment, and the time and manner of payment, necessary for the  
21 collection of the assessment required by NRS 502.390.

22 7. Designate those portions of wildlife management areas for  
23 big game mammals that are of special concern for the regulation of  
24 the importation, possession and propagation of alternative livestock  
25 pursuant to NRS 576.129.

26 8. Adopt regulations governing the trapping of fur-bearing  
27 mammals in a residential area of a county whose population is  
28 100,000 or more.

29 *9. In establishing any policy or adopting any regulations  
30 pursuant to this section, first consider the recommendations of the  
31 Department, the county advisory boards to manage wildlife and  
32 other persons who present their views at an open meeting of the  
33 Commission.*

34 **Sec. 1.4.** NRS 501.290 is hereby amended to read as follows:

35 501.290 The board shall meet before ~~those meetings~~ *each*  
36 *meeting* of the Commission ~~at which seasons, bag limits or hours~~  
37 ~~are to be established~~ and at such other times as the chair may call or  
38 the Commission may request.

39 **Sec. 1.5.** NRS 501.297 is hereby amended to read as follows:

40 501.297 The boards shall solicit and evaluate local opinion and  
41 advise the Commission on matters relating to the management of  
42 wildlife. ~~within their respective counties.~~

43 **Sec. 1.6.** NRS 501.303 is hereby amended to read as follows:

44 501.303 1. The boards shall submit recommendations for *the*  
45 *management of wildlife and* setting seasons for fishing, hunting and



1 trapping, which must be considered by the Commission in its  
2 deliberation on and establishment of regulations . ~~covering open or~~  
3 ~~closed seasons, bag limits, hours and other regulations or policies.~~

4 2. The chair or vice chair, or members of the board appointed  
5 by them:

6 (a) Shall attend the meetings of the Commission ; ~~at which~~  
7 ~~seasons are set or bag limits, hours or other regulations and policies~~  
8 ~~are established;~~ and

9 (b) Are entitled to receive such travel and per diem expenses as  
10 are allowed by law.

19 (e) All other sources, including, without limitation, the Federal  
20 Government, except money derived from the forfeiture of any

7 (a) Set forth the application and annual review processes for the  
8 issuance of special incentive elk tags.

9 (b) Require that an application for a special incentive elk tag  
10 must be accompanied by:

11 (1) The fee charged for an elk tag pursuant to *subsection 1 of*  
12 *NRS 502.250*; and

13 (2) Any administrative fee charged in connection with the  
14 issuance of an elk tag pursuant to this chapter ~~H~~, *including,*  
15 *without limitation, the fees charged pursuant to subsections 4 and*  
16 *6 of NRS 502.250.*

17 (c) Provide for the issuance of a special incentive elk tag only to  
18 a person who:

19 (1) Lawfully owns, leases or manages private land within an

21 (2) If that private land blocks reasonable access to adjacent

23 allow a person or hunting party possessing a valid elk tag to hunt elk  
24 on the adjacent public land.

25 (d) Establish criteria for the issuance of special incentive elk  
26 tags based upon:

27 (1) The number of elk using private land controlled by the  
28 applicant;

29 (2) The number of days the elk use private lands of the  
30 applicant in a calendar year;

31 (3) The total number of elk; and

32 (4) Limiting the number of special incentive elk tags issued  
33 in each calendar year to not more than one-half of the bull elk tags  
34 issued in that calendar year,

35 ➔ within the actual elk use area in the unit or units of the  
36 management area or areas in which the private land is located.

37 (e) Provide that special incentive elk tags are valid for both  
38 sexes of elk.

39 (f) Prohibit a person who has, within a particular calendar year,  
40 applied for or received compensation pursuant to NRS 504.165 as  
41 reimbursement for damage caused by elk to private land from  
42 applying, within the same calendar year, for a special incentive elk  
43 tag for the same private land.



1 (g) Allow a group of owners, lessees and managers of private  
2 land to qualify for a special incentive elk tag for their combined  
3 lands.

4 (h) Ensure that the issuance of special incentive elk tags will not  
5 result in the number of bull elk tags issued in any year being  
6 reduced to a number below the quota for bull elk tags established by  
7 the Commission for 1997.

8 (i) Provide that a person to whom a special incentive elk tag is  
9 issued by the Commission pursuant to this section may:

10 (1) If the person holds a valid hunting license issued by this  
11 State, use the special incentive elk tag himself or herself; or

12 (2) Sell the special incentive elk tag to another person who  
13 holds a valid hunting license issued by this State at any price upon  
14 which the parties mutually agree.

15 (j) Require that a person who is issued a special incentive elk tag  
16 must hunt:

17 (1) During the open season for elk.

18 (2) In the unit or units within the management area or areas  
19 in which the private land is located.

20 (k) Provide for the appointment of an arbitration panel to resolve  
21 disputes between persons who apply for special incentive elk tags  
22 and the Department regarding the issuance of such tags.

23 2. As used in this section, "actual elk use area" means an area  
24 in which elk live, as identified and designated by the Department.

43 2. The amount of the fee for other resident or nonresident big  
44 game tags must not exceed the highest fee for a resident or  
45 nonresident big game tag established pursuant to this section.



1 3. The amount of the fee for a tag determined to be necessary  
2 by the Commission for other species pursuant to NRS 502.130 must  
3 not exceed the highest fee for a resident or nonresident tag  
4 established pursuant to this section.

5 4. A fee not to exceed \$10 may be charged for processing an  
6 application for a game species or permit other than an application  
7 for ~~an elk. A fee of not less than \$5 but not more than \$15 must be~~  
8 ~~charged for processing an application for an elk, \$5 of which~~ *a*  
9 *Silver State Tag. Any fee collected pursuant to this subsection*  
10 must be deposited with the State Treasurer for credit to the Wildlife  
11 Fund Account in the State General Fund . ~~and used for the~~  
12 ~~prevention and mitigation of damage caused by elk or game~~  
13 ~~mammals not native to this State.~~

14 5. A fee of not less than \$15 and not more than \$50 must be  
15 charged for processing an application for a Silver State Tag.

17 *deposited with the State Treasurer for credit to the Wildlife*  
18 *Heritage Trust Account in the State General Fund.*

19 6. *If an application is for an elk, in addition to the fee for the*  
20 *elk tag required by subsection 1 and the fee for processing an*  
21 *application required by subsection 4 or 5, a fee of not less than \$5*  
22 *and not more than \$10, as provided by regulation of the*  
23 *Commission, must be charged. Any fee collected pursuant to this*  
24 *subsection must be deposited with the State Treasurer for credit to*  
25 *the Wildlife Fund Account in the State General Fund and used*  
26 *pursuant to NRS 504.155 for the prevention and mitigation of*  
27 *damage caused by elk or game mammals not native to this State.*

28 7. The Commission may accept sealed bids for, or award  
29 through an auction or a Silver State Tag Drawing, or any  
30 combination thereof, not more than 15 big game tags and not more  
31 than 5 wild turkey tags each year. To reimburse the Department for  
32 the cost of managing wildlife and administering and conducting the  
33 bid, auction or Silver State Tag Drawing, not more than 18 percent  
34 of the total amount of money received from the bid, auction or  
35 Silver State Tag Drawing may be deposited with the State Treasurer  
36 for credit to the Wildlife Fund Account in the State General Fund.  
37 Any amount of money received from the bid, auction or Silver State  
38 Tag Drawing that is not so deposited must be deposited with the  
39 State Treasurer for credit to the Wildlife Heritage Trust Account in  
40 the State General Fund in accordance with the provisions of

42 ~~6.~~ 8. The Commission may by regulation establish an  
43 additional drawing for big game tags, which may be entitled the  
44 Partnership in Wildlife Drawing. To reimburse the Department for  
45 the cost of managing wildlife and administering and conducting the





1 drawing, not more than 18 percent of the total amount of money  
2 received from the drawing may be deposited with the State  
3 Treasurer for credit to the Wildlife Fund Account in the State  
4 General Fund. Except as otherwise provided by regulations adopted  
5 by the Commission pursuant to subsection ~~{7,}~~ 9, the money  
6 received by the Department from applicants in the drawing who are  
7 not awarded big game tags must be deposited with the State  
8 Treasurer for credit to the Wildlife Heritage Trust Account in  
9 accordance with the provisions of NRS 501.3575.

10 ~~{7,}~~ 9. The Commission may adopt regulations which  
11 authorize the return of all or a portion of any fee collected from a  
12 person pursuant to the provisions of this section.

14 502.253 1. In addition to any fee charged and collected  
15 pursuant to NRS 502.250, a fee of \$3 must be charged for  
16 processing each application for a game tag, the revenue from which  
17 must be accounted for separately, deposited with the State Treasurer  
18 for credit to the Wildlife Fund Account in the State General Fund  
19 and used by the Department for costs related to:

20 (a) ~~{Programs}~~ *Developing and implementing an annual*  
21 *program* for the management and control of ~~{injurious}~~ predatory  
22 wildlife;

23 (b) Wildlife management activities relating to the protection of

11 5. The money in the Wildlife Fund Account remains in the  
12 Account and does not revert to the State General Fund at the end of  
13 any fiscal year.

43 *(b) Must not have been convicted of any violation of the*  
44 *provisions of this title or any regulations adopted pursuant thereto*  
45 *or any federal law or regulation or any law or regulation of any*



1 *other state relating to hunting, trapping or fishing in the 5 years*  
2 *immediately preceding the date on which he or she is designated*  
3 *as a member.*

4 **Sec. 6.** NRS 567.040 is hereby amended to read as follows:

7 *and Vice Chair from among its members. A member may not serve*  
8 *as the Chair or Vice Chair for more than two consecutive terms.*

9 2. *Upon the selection of the Chair at the first meeting of each*  
10 *year, the Chair shall designate the members described in*  
11 *subsections 5 and 6 of NRS 567.030.*

12 3. The Secretary of the State Board of Agriculture shall serve  
13 as Secretary of the Committee.

24 section 5 of this act, each to serve a term that expires on the date of  
25 the first meeting of the Committee that occurs on or after January 1,  
26 2017.

27 **Sec. 9.** This act becomes effective upon passage and approval.
