SENATE BILL NO. 172–SENATORS FARLEY, HARDY AND WOODHOUSE

FEBRUARY 18, 2015

Referred to Committee on Health and Human Services

SUMMARY—Makes various changes relating to the authorized activities of medical students. (BDR 40-797)

FISCAL NOTE: Effect on Local Government: No. Effect on the State: No.

EXPLANATION - Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to public health; prohibiting a medical facility or physician from allowing a person who is not enrolled in good standing at an accredited medical school or school of osteopathic medicine from performing or participating in any activity for credit towards a medical degree; requiring a medical student to attend an accredited medical school in order to possess and administer a controlled substance or dangerous drug; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

Sections 1, 8 and 10 of this bill prohibit a medical facility or a physician from allowing a person to perform or participate in activities for credit toward a medical degree unless the person is enrolled in good standing at an accredited medical school. **Sections 3-5, 9, 11 and 12** of this bill give the Division of Public and Behavioral Health of the Department of Health and Human Services, the Board of Medical Examiners, the State Board of Osteopathic Medicine and the Board of Examiners for Long-term Care Administrators the authority to enforce this prohibition with respect to their licensees.

9 Under existing law, a student at an approved medical school is authorized to 10 possess and administer a controlled substance or dangerous drug at the direction of 11 a physician. (NRS 453.375, 454.213) **Sections 6 and 7** of this bill instead allow a 12 medical student who attends an accredited medical school to possess and administer 13 such drugs.





THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

Chapter 449 of NRS is hereby amended by adding Section 1. 1 2 thereto a new section to read as follows:

A medical facility shall not allow a person to perform or 3 4 participate in any activity at the facility for the purpose of receiving credit toward a degree of doctor of medicine, osteopathy 5 or osteopathic medicine, including, without limitation, clinical 6 7 observation and contact with patients, unless the person is 8 enrolled in good standing at:

9 1. A medical school that is accredited by the Liaison Committee on Medical Education of the American Medical 10 Association and the Association of American Medical Colleges or 11 12 their successor organizations; or

2. A school of osteopathic medicine, as defined in 13 14 NRS 633.121.

Sec. 2. NRS 449.0301 is hereby amended to read as follows:

449.0301 The provisions of NRS 449.030 to 449.2428, 16 17 inclusive, *and section 1 of this act* do not apply to:

(c) Is marijuana being used for medical purposes in accordance 3 4 with chapter 453A of NRS.

5 13. Attempting, directly or indirectly, by intimidation, coercion 6 or deception, to obtain or retain a patient or to discourage the use of 7 a second opinion.

8 Terminating the medical care of a patient without adequate 14. 9 notice or without making other arrangements for the continued care 10 of the patient.

15. In addition to the provisions of subsection 3 of NRS 11 633.524, making or filing a report which the licensee knows to be 12 13 false, failing to file a record or report that is required by law or 14 willfully obstructing or inducing another to obstruct the making or 15 filing of such a record or report.

16 16. Failure to report any person the licensee knows, or has reason to know, is in violation of the provisions of this chapter or 17 18 the regulations of the Board within 30 days after the date the 19 licensee knows or has reason to know of the violation.

Failure by a licensee or applicant to report in writing, 20 17. 21 within 30 days, any criminal action taken or conviction obtained 22 against the licensee or applicant, other than a minor traffic violation, 23 in this State or any other state or by the Federal Government, a branch of the Armed Forces of the United States or any local or 24 25 federal jurisdiction of a foreign country.

26 18. Engaging in any act that is unsafe in accordance with 27 regulations adopted by the Board.

19. Failure to comply with the provisions of NRS 633.165.

29 20. Failure to supervise adequately a medical assistant pursuant 30 to the regulations of the Board.

31 *21*. Failure to comply with the provisions of section 10 of this 32 act.

Sec. 12. NRS 654.190 is hereby amended to read as follows:

The Board may, after notice and an opportunity 34 654.190 1. for a hearing as required by law, impose an administrative fine of 35 not more than \$10,000 for each violation on, recover reasonable 36 37 investigative fees and costs incurred from, suspend, revoke, deny 38 the issuance or renewal of or place conditions on the license of, and 39 place on probation or impose any combination of the foregoing on any nursing facility administrator or administrator of a residential 40 41 facility for groups who:

42 (a) Is convicted of a felony relating to the practice of 43 administering a nursing facility or residential facility or of any 44 offense involving moral turpitude. 45

(b) Has obtained his or her license by the use of fraud or deceit.





(c) Violates any of the provisions of this chapter.

2 (d) Aids or abets any person in the violation of any of the 3 provisions of NRS 449.030 to 449.2428, inclusive, *and section 1 of* 4 *this act*, as those provisions pertain to a facility for skilled nursing, 5 facility for intermediate care or residential facility for groups.

6 (e) Violates any regulation of the Board prescribing additional 7 standards of conduct for nursing facility administrators or 8 administrators of residential facilities for groups, including, without 9 limitation, a code of ethics.

10 (f) Engages in conduct that violates the trust of a patient or 11 resident or exploits the relationship between the nursing facility 12 administrator or administrator of a residential facility for groups and 13 the patient or resident for the financial or other gain of the licensee.

14 2. If a licensee requests a hearing pursuant to subsection 1, the 15 Board shall give the licensee written notice of a hearing pursuant to 16 NRS 233B.121 and 241.034. A licensee may waive, in writing, his 17 or her right to attend the hearing.

3. The Board may compel the attendance of witnesses or the production of documents or objects by subpoena. The Board may adopt regulations that set forth a procedure pursuant to which the Chair of the Board may issue subpoenas on behalf of the Board. Any person who is subpoenaed pursuant to this subsection may request the Board to modify the terms of the subpoena or grant additional time for compliance.

4. An order that imposes discipline and the findings of fact and conclusions of law supporting that order are public records.

5. The expiration of a license by operation of law or by order or decision of the Board or a court, or the voluntary surrender of a license, does not deprive the Board of jurisdiction to proceed with any investigation of, or action or disciplinary proceeding against, the licensee or to render a decision suspending or revoking the license.
