SUMMARY—Revises provisions relating to the pilot diversion program for certain probation violators. (BDR S-744)

AN ACT relating to criminal offenders; increasing the maximum number of probation violators who may be remanded to the pilot diversion program for certain probation violators; extending by 2 years the sunset date for the pilot diversion program; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Assembly Bill No. 93 of the 2011 Legislative Session requires the Department
2 of Corrections to establish a pilot diversion program for certain probation violators.
3 (Chapter 433, Statutes of Nevada 2011, p. 2628) **Section 1** of this bill increases
4 from 50 to 100 the maximum number of probation violators for whom the
5 Department is required to provide housing under the pilot diversion program.
6 **Section 2** of this bill extends the sunset date of the pilot diversion program from
7 July 1, 2015, to July 1, 2017.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Section 1 of chapter 433, Statutes of Nevada 2011,
2 at page 2628, is hereby amended to read as follows:

3 Section 1. 1. The Department of Corrections shall
4 establish a pilot diversion program within the correctional
5 institutions or other facilities maintained by the Department.

6 2. The Department of Corrections shall ensure that
7 facilities of adequate capacity for the pilot diversion program
8 are available in one or more suitable locations within the
9 State. The Department shall not be required to provide
10 housing for more than ~~150~~ 100 probation violators at one
11 time.

12 3. The Department of Corrections shall provide a
13 healthful diet and appropriate, secure and sanitary housing
14 and necessary emergency medical services for the probation
15 violators who are placed in the pilot diversion program, but
16 the Department is not responsible for providing treatment to
17 the probation violators remanded to the pilot diversion
18 program pursuant to section 3 of this act.

19 4. As a condition of participation in the program, a
20 probationer must release in writing the Department from
21 liability and agree to abide by the applicable rules and
22 regulations of the Department.

23 **Sec. 2.** Section 11 of chapter 433, Statutes of Nevada 2011, at
24 page 2629, is hereby amended to read as follows:

25 Sec. 11. This act becomes effective upon passage and
26 approval and expires by limitation on July 1, ~~2015~~ 2017.
