SUMMARY—Revises provisions relating to pharmacists.
(BDR 54-869)

AN ACT relating to pharmacists; authorizing a registered pharmacist or registered intern pharmacist to administer a drug to the body of a patient by certain means; authorizing a registered pharmacist to administer a vaccine under certain circumstances and to furnish certain drugs to a patient without a prescription; authorizing the State Board of Pharmacy to issue an endorsement as an advanced practice pharmacist to a registered pharmacist under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law provides for the licensing and regulation of pharmacists in this
2 State. (Chapter 639 of NRS) Existing regulations permit a pharmacist to administer
3 immunizations pursuant to a physician's authorization. (NAC 639.2971) **Section 3**
4 of this bill allows a registered pharmacist to administer certain vaccines without the
5 authorization of a physician. **Section 2** of this bill authorizes a registered
6 pharmacist to administer a drug to the body of a patient by certain means. Existing
7 law requires that a dangerous drug may only be dispensed pursuant to a prescription
8 issued by a practitioner. (NRS 454.215) **Section 4** of this bill allows a registered
9 pharmacist to furnish those drugs to a patient without a prescription under certain
10 circumstances. Existing law allows a pharmacist, under a written protocol and in
11 collaboration with a physician, to order and interpret certain laboratory tests and
12 examinations of a patient to monitor a drug therapy. Additionally, existing law
13 allows a pharmacist to administer a blood glucose test to a patient. (NRS 639.2808,



14 639.2809) **Section 5** of this bill authorizes the State Board of Pharmacy to endorse
15 as an advanced practice pharmacist a registered pharmacist who has met certain
16 training or experience requirements. **Section 5** allows an advanced practice
17 pharmacist to perform physical assessments of a patient, independently order and
18 interpret lab tests and refer patients to other health care providers.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 639 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 to 5, inclusive, of this
3 act.

4 **Sec. 2.** *In addition to the administration of any drug or*
5 *medicine pursuant to NRS 454.213, a registered pharmacist or a*
6 *registered intern pharmacist may administer a drug to the body of*
7 *a patient by injection, inhalation, ingestion or any other means.*

8 **Sec. 3. 1.** *A registered pharmacist who is qualified*
9 *pursuant to this section may administer a vaccine recommended*
10 *by the Advisory Committee on Immunization Practices of the*
11 *Centers for Disease Control and Prevention, or its successor.*

12 **2.** *Before administering a vaccine pursuant to subsection 1, a*
13 *registered pharmacist must:*

14 *(a) Complete a program of immunization training endorsed by*
15 *the Accreditation Council for Pharmacy Education, or its*
16 *successor; and*

17 *(b) Be certified in basic life support by the American Heart*
18 *Association.*

19 **3.** *A registered pharmacist who administers a vaccine*
20 *pursuant to this section shall, as soon as practicable after*
21 *administering the vaccine:*

22 *(a) Provide documentation of immunization to the patient's*
23 *primary care provider, if any; and*

24 *(b) Provide documentation of immunization to the Division of*
25 *Public and Behavioral Health of the Department of Health and*
26 *Human Services.*

27 **4.** *A registered pharmacist who administers a vaccine*
28 *pursuant to this section may also administer epinephrine or*
29 *diphenhydramine by injection to treat a severe allergic reaction to*
30 *the vaccine.*

31 **Sec. 4. 1.** *A registered pharmacist may furnish the*
32 *following drugs to a patient without a prescription:*

33 *(a) Prescription drugs not requiring a diagnosis that are*
34 *recommended by the Centers for Disease Control and Prevention*
35 *for persons traveling outside the United States, in accordance with*
36 *the provisions of subsection 2;*



1 (b) Prescription drugs and devices related to tobacco cessation,
2 in accordance with the provisions of subsection 3; and

3 (c) Drugs for emergency contraception and self-administered
4 hormonal contraceptives, in accordance with the provisions of
5 subsection 4.

6 2. Before furnishing any drug pursuant to paragraph (a) of
7 subsection 1, a registered pharmacist shall complete a course in
8 pharmacy-based travel health services endorsed by the
9 Accreditation Council for Pharmacy Education, or its successor.

10 3. A registered pharmacist who furnishes a drug to a patient
11 pursuant to paragraph (b) of subsection 1 shall:

12 (a) Maintain a record of each drug furnished for at least 3
13 years after furnishing the drug;

14 (b) Notify the patient's primary care physician, if any. If the
15 patient does not have a primary care provider, the registered
16 pharmacist shall advise the patient to consult a physician; and

17 (c) Complete a course in tobacco cessation therapy specified by
18 the Board.

19 4. A registered pharmacist who furnishes a drug or
20 contraceptive to a patient pursuant to paragraph (c) of subsection
21 1 shall:

22 (a) Require the patient to complete a self-screening tool, which
23 must be developed by the State Board of Pharmacy in consultation
24 with the Board of Medical Examiners and based on the United
25 States Medical Eligibility Criteria for Contraceptive Use developed
26 by the Centers for Disease Control and Prevention;

27 (b) Comply with any regulation adopted by the Board; and

28 (c) Complete any training required by the Board.

29 5. This section does not authorize a pharmacist to furnish a
30 controlled substance without a prescription.

31 6. The Board shall adopt regulations to carry out the
32 provisions of this section.

33 **Sec. 5.** 1. The Board may issue an endorsement as an
34 advanced practice pharmacist to any registered pharmacist in
35 good standing with the Board who has:

36 (a) Completed a 1-year postgraduate residency in pharmacy
37 which included significant direct patient care as part of an
38 interdisciplinary team;

39 (b) Had at least 1 year of experience managing patients under
40 a collaborative agreement or protocol with a practitioner pursuant
41 to NRS 639.2809; or

42 (c) Completed an accredited certification program in a
43 relevant area of practice approved by the Board.

44 2. An advanced practice pharmacist may:

45 (a) Perform a physical assessment of a patient;



1 ***(b) Order and interpret laboratory tests for the purpose of***
2 ***monitoring the toxicity and efficacy of a drug therapy on a***
3 ***patient; and***

4 ***(c) Refer a patient to other providers of health care.***

5 **3. The Board shall adopt regulations:**

6 ***(a) Specifying the required education, training or experience***
7 ***for the issuance of an endorsement as an advanced practice***
8 ***pharmacist pursuant to subsection 1 and any continuing***
9 ***education requirements for the renewal of the endorsement.***

10 ***(b) Defining the scope of practice for an advanced practice***
11 ***pharmacist in collaboration with the Board of Medical Examiners.***

12 ***(c) Establishing the manner in which a registered pharmacist***
13 ***may apply for an endorsement as an advanced practice pharmacist***
14 ***and setting any application fee, which must not exceed the cost of***
15 ***issuing the endorsement.***

16 **Sec. 6.** NRS 639.0124 is hereby amended to read as follows:

17 639.0124 "Practice of pharmacy" includes, but is not limited
18 to, the:

19 1. Performance or supervision of activities associated with
20 manufacturing, compounding, labeling, dispensing and distributing
21 of a drug, including the receipt, handling and storage of
22 prescriptions and other confidential information relating to patients.

23 2. ***Administering of a drug that has been prescribed by a***
24 ***practitioner.***

25 3. ***Administering of a vaccine pursuant to section 3 of this***
26 ***act.***

27 4. Interpretation and evaluation of prescriptions or orders for
28 medicine.

29 ~~3-~~ 5. Participation in drug evaluation and drug research.

30 ~~4-~~ 6. Advising of the therapeutic value, reaction, drug
31 interaction, hazard and use of a drug.

32 ~~5-~~ 7. ***Provision of information concerning the management***
33 ***and prevention of disease.***

34 8. Selection of the source, storage and distribution of a drug.

35 ~~6-~~ 9. Maintenance of proper documentation of the source,
36 storage and distribution of a drug.

37 ~~7-~~ 10. Interpretation of clinical data contained in a person's
38 record of medication.

39 ~~8-~~ 11. Development of written guidelines and protocols in
40 collaboration with a practitioner which are intended for a patient in a
41 licensed medical facility or in a setting that is affiliated with a
42 medical facility where the patient is receiving care and which
43 authorize the implementation, monitoring and modification of drug
44 therapy. The written guidelines and protocols must comply with
45 NRS 639.2809.



~~19~~ 12. Implementation and modification of drug therapy in accordance with the authorization of the prescribing practitioner for a patient in a pharmacy in which drugs, controlled substances, poisons, medicines or chemicals are sold at retail.

↳ The term does not include the changing of a prescription by a pharmacist or practitioner without the consent of the prescribing practitioner, except as otherwise provided in NRS 639.2583.

Sec. 7. NRS 639.170 is hereby amended to read as follows:

639.170 1. The Board shall charge and collect not more than the following fees for the following services:

For the examination of an applicant for registration as a pharmacist.....	Actual cost of the examination
For the investigation or registration of an applicant as a registered pharmacist.....	\$200
For the investigation, examination or registration of an applicant as a registered pharmacist by reciprocity	300
For the investigation or issuance of an original license to conduct a retail pharmacy	600
For the biennial renewal of a license to conduct a retail pharmacy	500
For the investigation or issuance of an original license to conduct an institutional pharmacy.....	600
For the biennial renewal of a license to conduct an institutional pharmacy.....	500
For the issuance of an original or duplicate certificate of registration as a registered pharmacist	50
For the biennial renewal of registration as a registered pharmacist	200
For the reinstatement of a lapsed registration (in addition to the fees for renewal for the period of lapse).....	100
For the initial registration of a pharmaceutical technician or pharmaceutical technician in training	50
For the biennial renewal of registration of a pharmaceutical technician or pharmaceutical technician in training	50
For the investigation or registration of an intern pharmacist.....	50



1 For the biennial renewal of registration as an

21 2. If a person requests a special service from the Board or
 22 requests the Board to convene a special meeting, the person must
 23 pay the actual costs to the Board as a condition precedent to the
 24 rendition of the special service or the convening of the special
 25 meeting.

26 3. All fees are payable in advance and are not refundable.

27 4. The Board may, by regulation, set the penalty for failure to
 28 pay the fee for renewal for any license, permit, authorization or
 29 certificate within the statutory period, at an amount not to exceed
 30 100 percent of the fee for renewal for each year of delinquency in
 31 addition to the fees for renewal for each year of delinquency.

32 **Sec. 8.** NRS 454.215 is hereby amended to read as follows:

33 454.215 A dangerous drug may be dispensed by:

- 34 1. A registered pharmacist ~~upon~~ :
 35 (a) *Upon* the legal prescription from a practitioner ~~for to~~ ;
 36 (b) *To* a pharmacy in a correctional institution upon the written
 37 order of the prescribing practitioner in charge; *or*
 38 (c) *Pursuant to section 4 of this act;*

39 2. A pharmacy in a correctional institution, in case of
 40 emergency, upon a written order signed by the chief medical officer;

41 3. A practitioner, or a physician assistant licensed pursuant to
 42 chapter 630 or 633 of NRS if authorized by the Board;

43 4. A registered nurse, when the nurse is engaged in the
 44 performance of any public health program approved by the Board;

45 5. A medical intern in the course of his or her internship;



1 6. An advanced practice registered nurse who holds a
2 certificate from the State Board of Pharmacy permitting him or her
3 to dispense dangerous drugs;

4 7. A registered nurse employed at an institution of the
5 Department of Corrections to an offender in that institution;

6 8. A registered pharmacist from an institutional pharmacy
7 pursuant to regulations adopted by the Board; or

8 9. A registered nurse to a patient at a rural clinic that is
9 designated as such pursuant to NRS 433.233 and that is operated by
10 the Division of Public and Behavioral Health of the Department of
11 Health and Human Services if the nurse is providing mental health
12 services at the rural clinic,

13 ↪ except that no person may dispense a dangerous drug in violation
14 of a regulation adopted by the Board.

15 **Sec. 9.** NRS 454.221 is hereby amended to read as follows:

16 454.221 1. A person who furnishes any dangerous drug
17 except upon the prescription of a practitioner is guilty of a category
18 D felony and shall be punished as provided in NRS 193.130, unless
19 the dangerous drug was obtained originally by a legal prescription.

20 2. The provisions of this section do not apply to the furnishing
21 of any dangerous drug by:

22 (a) A practitioner to his or her patients;

23 (b) A physician assistant licensed pursuant to chapter 630 or 633
24 of NRS if authorized by the Board;

25 (c) A registered nurse while participating in a public health
26 program approved by the Board, or an advanced practice registered
27 nurse who holds a certificate from the State Board of Pharmacy
28 permitting him or her to dispense dangerous drugs;

29 (d) A manufacturer or wholesaler or pharmacy to each other or
30 to a practitioner or to a laboratory under records of sales and
31 purchases that correctly give the date, the names and addresses of
32 the supplier and the buyer, the drug and its quantity;

33 (e) A hospital pharmacy or a pharmacy so designated by a
34 county health officer in a county whose population is 100,000 or
35 more, or by a district health officer in any county within its
36 jurisdiction or, in the absence of either, by the Chief Medical Officer
37 or the Chief Medical Officer's designated Medical Director of
38 Emergency Medical Services, to a person or agency described in
39 subsection 3 of NRS 639.268 to stock ambulances or other
40 authorized vehicles or replenish the stock; ~~for~~

41 (f) A pharmacy in a correctional institution to a person
42 designated by the Director of the Department of Corrections to
43 administer a lethal injection to a person who has been sentenced to
44 death ~~for~~; or

45 (g) *A registered pharmacist pursuant to section 4 of this act.*



- 1 **Sec. 10.** This act becomes effective:
2 1. Upon passage and approval for the purposes of adopting any
3 regulations and performing any preparatory administrative tasks
4 necessary to carry out the provisions of this act; and
5 2. On January 1, 2016, for all other purposes.
