SUMMARY—Provides a charter for the City of Mesquite.

AN ACT providing a charter for the City of Mesquite, in Clark County, Nevada; authorizing the City Council of the City of Mesquite to establish certain fees and impose certain taxes; requiring the City Council to levy a tax upon the assessed value of real and personal property; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 The Nevada Constitution authorizes the Legislature to provide for the
2 incorporation of a city by a special act. (Nev. Const. Art. 8, § 8) **Section 1** of this
3 bill provides a charter for the City of Mesquite in Clark County, Nevada. Article I
4 of the Charter provides that the elective officers of the City consist of a Mayor, five
5 members of the City Council and such other officers as provided in the Charter.
6 (Section 1.050) Article I also requires the City Council to establish a Charter
7 Committee, which is required to prepare recommendations to be presented to the
8 Legislature on behalf of the City concerning all necessary amendments to the
9 Charter. (Section 1.110)

10 Articles II, III and IV of the Charter establish provisions relating to the
11 legislative, executive and judicial departments of the City, respectively. Article II
12 provides for the qualifications, election, term of office and salary of the members of
13 the City Council and establishes the various powers of the City Council, including
14 the power to fix, impose and collect a license tax for revenue upon all businesses,
15 trades and professions. (Sections 2.010, 2.080, 2.110-2.280) Article II also
16 authorizes the City Council to establish and impose various fees. (Sections 2.170,
17 2.210, 2.270) Article II further establishes several provisions concerning the sale or
18 lease of real property owned by the City and the redevelopment of communities.
19 (Sections 2.300-2.370) Article III provides for the qualifications, duties, election,
20 term of office and salary of the Mayor and the election by the City Council of one

21 of its members to be Mayor pro tempore. (Section 3.010) Article III also establishes
22 provisions relating to the City Manager, City Clerk, City Attorney and City
23 Assessor. (Sections 3.020-3.070) Article IV provides for a Municipal Court and
24 establishes provisions relating to the departments of the Municipal Court and the
25 Municipal Court Judges. (Sections 4.010-4.030)

26 Article V of the Charter establishes provisions concerning elections, including
27 certain procedures relating to the election of members of the City Council.
28 (Sections 5.010, 5.020) Article VI of the Charter pertains to local improvements
29 and generally authorizes the City Council to acquire, improve, equip, operate and
30 maintain, convert to or authorize certain improvements. (Section 6.010) Article VII
31 of the Charter: (1) prohibits the City from incurring any indebtedness in excess of a
32 certain amount; (2) authorizes the City to grant franchises and acquire any public
33 utility; and (3) authorizes the City to borrow money for any corporate purpose.
34 (Sections 7.010-7.030)

35 Article VIII of the Charter authorizes express trusts to be created in real or
36 personal property, with the City as the beneficiary thereof, for the furtherance, or
37 the providing of funds for the furtherance, of any authorized or proper function of
38 the City. (Section 8.010) Article IX of the Charter authorizes the City Council to
39 levy an annual tax at a rate allowable under state law upon the assessed value of all
40 applicable real and personal property within the City. (Section 9.010) Article X of
41 the Charter establishes certain miscellaneous provisions concerning the Charter.
42 (Sections 10.010, 10.020)

43 **Section 2** of this bill provides that the effective date of incorporation of the
44 City of Mesquite is July 1, 2017.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** The Charter of the City of Mesquite is as follows.
2 Each section of the Charter shall be deemed to be a section of this
3 act for the purpose of any subsequent amendment.

5 *ARTICLE I*

7 *INCORPORATION OF CITY; GENERAL POWERS; BOUNDARIES;*
8 *ANNEXATIONS; CITY OFFICES; CHARTER COMMITTEE*
9

10 *Section 1.010 Preamble: Legislative intent.*

11 *1. In order to provide for the orderly government of the City*
12 *of Mesquite and the general welfare of its citizens, the Legislature*
13 *hereby establishes this Charter for the government of the City of*
14 *Mesquite. It is expressly declared as the intent of the Legislature*
15 *that all provisions of this Charter be liberally construed to carry*
16 *out the express purposes of the Charter and that the specific*
17 *mention of particular powers must not be construed as limiting in*
18 *any way the general powers necessary to carry out the purposes of*
19 *the Charter.*

20 *2. Any powers expressly granted by this Charter are in*
21 *addition to any powers granted to a city by the general law of this*



1 *State. All provisions of the Nevada Revised Statutes which are*
2 *applicable generally to cities, not including, unless otherwise*
3 *expressly mentioned in this Charter, chapter 265, 266 or 267 of*
4 *NRS, which are not in conflict with the provisions of this Charter*
5 *apply to the City of Mesquite.*

6 *3. Except as otherwise expressly provided in a particular*
7 *section or required by the context:*

8 *(a) The masculine gender includes the feminine and neuter*
9 *genders.*

10 *(b) The singular number includes the plural number and the*
11 *plural includes the singular.*

12 *(c) The present tense includes the future tense.*

13 *↪ The use of a masculine noun or pronoun in conferring a*
14 *benefit or imposing a duty does not exclude a female person from*
15 *that benefit or duty. The use of a feminine noun or pronoun in*
16 *conferring a benefit or imposing a duty does not exclude a male*
17 *person from that benefit or duty.*

18 *Sec. 1.020 Incorporation of City.*

19 *1. All persons who are inhabitants of that portion of the State*
20 *of Nevada embraced within the limits set forth in section 1.030*
21 *constitute a political and corporate body by the name of "City of*
22 *Mesquite" and by that name they and their successors must be*
23 *known in law, have perpetual succession and may sue or be sued*
24 *in all courts.*

25 *2. Whenever used throughout this Charter, "City" means the*
26 *City of Mesquite.*

27 *Sec. 1.030 Description of territory. The territory embraced*
28 *in the City is that certain land described in the official plat*
29 *required by NRS 234.250 to be filed with the County Recorder and*
30 *the County Assessor of Clark County, as such plat is revised from*
31 *time to time.*

32 *Sec. 1.040 Annexations. The City may annex territory by*
33 *following the procedure provided for the annexation of cities in*
34 *those sections of chapter 268 of NRS, as amended from time to*
35 *time, which apply to a county whose population is 700,000 or*
36 *more.*

37 *Sec. 1.050 Elective offices. The elective officers of the City*
38 *consist of:*

39 *1. A Mayor;*

40 *2. Five Council members; and*

41 *3. Such other officers as provided by this Charter.*

42 *Sec. 1.060 Elective offices: Vacancies.*

43 *1. A vacancy in the City Council or in the office of Mayor*
44 *must be filled for the remainder of the unexpired term by a*
45 *majority vote of the members of the City Council, or the remaining*



1 *members in the case of a vacancy in the City Council, within 45*
2 *days after the occurrence of the vacancy.*

3 *2. A person appointed to fill a vacancy:*

4 *(a) Must have the same qualifications as are required of the*
5 *elective official; and*

6 *(b) Shall enter upon the discharge of his or her respective*
7 *duties at the first meeting of the City Council held after the vote to*
8 *fill the vacancy.*

9 *Sec. 1.070 Mayor and Council members not to hold other*
10 *office; authorization to run for other office.*

11 *1. The Mayor and Council members:*

12 *(a) Shall not hold any other elective office with the State of*
13 *Nevada or any of its political subdivisions or any other*
14 *employment with the City.*

15 *(b) Must not be elected or appointed to any office created by or*
16 *the compensation for which was increased or fixed by the City*
17 *Council until 1 year after the expiration of the term for which he*
18 *or she was elected.*

19 *2. Any person holding any office proscribed by subsection 1*
20 *automatically forfeits his or her office as Mayor or Council*
21 *member.*

22 *3. Subject to the provisions of subsections 1 and 2, the Mayor*
23 *and any Council member may run for an elective office with the*
24 *State or any political subdivision thereof while still serving in his*
25 *or her capacity as Mayor or Council member.*

26 *Sec. 1.080 Executive officers.*

27 *1. The following positions are executive officers within the*
28 *City:*

29 *(a) City Manager.*

30 *(b) City Attorney.*

31 *(c) Assistant City Manager or Deputy City Manager.*

32 *(d) City Clerk.*

33 *(e) Director of Finance.*

34 *(f) Chief of Police.*

35 *(g) Fire Chief.*

36 *2. The City Council may combine any positions for executive*
37 *officers by ordinance.*

38 *3. The appointments of the City Manager and City Attorney*
39 *must be made by the Mayor, subject to the advice and consent of*
40 *the City Council.*

41 *4. The appointments and termination of all other executive*
42 *officers must be made by the City Manager and are subject to*
43 *ratification by the City Council.*



1 *Sec. 1.090 Executive officers: Duties; salary.*

2 1. *All executive officers other than the City Attorney shall*
3 *perform such duties as may be designated by the City Manager.*

4 2. *Any executive officer who becomes aware of any supposed*
5 *nonfeasance, misfeasance or malfeasance shall report such*
6 *behavior in accordance with the proper chain of command. If the*
7 *person who has allegedly committed the nonfeasance, misfeasance*
8 *or malfeasance is ranked higher than the executive officer in the*
9 *proper chain of command, the executive officer shall report the*
10 *behavior to the appropriate legal authorities.*

11 3. *The City Manager shall set the salary for all executive*
12 *officers other than the City Attorney.*

13 *Sec. 1.100 Oath of office. Every person elected or*
14 *appointed to fill any elective office shall subscribe to the official*
15 *oath as provided by the City Council. Every such person shall*
16 *swear or affirm that he or she is not under any direct or indirect*
17 *obligation to vote for, appoint or elect any person to any office,*
18 *position or employment in the City.*

19 *Sec. 1.110 Charter Committee: Creation; appointment;*
20 *qualifications; terms; compensation.*

21 1. *The City Council shall establish a Charter Committee*
22 *which shall meet as required to prepare recommendations to be*
23 *presented to the Legislature on behalf of the City concerning all*
24 *necessary amendments to the City Charter.*

25 2. *The Charter Committee must be appointed as follows:*

26 (a) *The Mayor and each member of the City Council shall*
27 *appoint one member;*

28 (b) *Each member of the Senate and Assembly delegation*
29 *representing the residents of the City shall appoint one member;*
30 *and*

31 (c) *Before the conclusion of the second meeting of the Charter*
32 *Committee, the Committee shall appoint one member.*

33 3. *Each member of the Charter Committee:*

34 (a) *Must be a registered voter of the City;*

35 (b) *If appointed pursuant to:*

36 (1) *Paragraph (a) or (b) of subsection 2, serves a term*
37 *concurrent to the term of the public officer by whom he or she was*
38 *appointed; or*

39 (2) *Paragraph (c) of subsection 2, serves a term of 2 years;*

40 (c) *Must reside in the City during his or her term of office; and*

41 (d) *Serves without compensation.*

42 *Sec. 1.120 Charter Committee: Officers; meetings; duties;*
43 *legislative measures.*

44 1. *The Charter Committee shall:*



1 (a) Elect from among its members a Chair and Vice Chair,
2 who each serve a term of 2 years unless he or she resigns or is
3 removed from the Committee pursuant to section 1.130;

4 (b) Meet at least once every 2 years before the beginning of
5 each regular session of the Legislature and when requested by the
6 City Council or the Chair of the Committee;

7 (c) Meet jointly with the City Council on a date to be set after
8 the final biennial meeting of the Committee is conducted pursuant
9 to paragraph (b) and before the beginning of the next regular
10 session of the Legislature to advise the City Council with regard to
11 the recommendations of the Committee concerning necessary
12 amendments to this Charter;

13 (d) If the City Council elects to submit the Committee's
14 recommended amendments to the Legislature as one of the City's
15 legislative measures, assist the City Council in the timely
16 preparation of such amendments for presentation to the
17 Legislature on behalf of the City; and

18 (e) Perform all functions and do all things necessary to
19 accomplish the purposes for which it is established, including,
20 without limitation, holding meetings and public hearings and
21 obtaining assistance from officers of the City to ensure the
22 Committee's compliance with any law applicable to a public body.

23 2. If the City Council elects not to submit the Committee's
24 recommended amendments to the Legislature as one of the City's
25 legislative measures, the Committee may vote to authorize a
26 member of the Committee to seek sponsorship of a legislative
27 measure by a member of the Senate or Assembly delegation
28 representing the residents of the City and to assist the Senator,
29 Assemblyman or Assemblywoman, as applicable, in the timely
30 preparation of such amendments for presentation to the
31 Legislature. The member of the Committee shall not represent that
32 any such legislative measure is approved or supported by the City
33 Council and shall disclose to the Senator, Assemblyman or
34 Assemblywoman, as applicable, that the legislative measure is not
35 approved or supported by the City Council.

36 Sec. 1.130 Charter Committee: Removal of member;
37 vacancies.

38 1. Any member of the Charter Committee may be removed by
39 a majority of the remaining members of the Charter Committee
40 for any of the following reasons:

41 (a) Failure or refusal to perform the duties of office;

42 (b) Absence from three consecutive regular meetings;

43 (c) Ceasing to meet any qualification for appointment to the
44 Charter Committee; or



1 (d) Any conduct deemed inappropriate by a majority vote of
2 the members of the Charter Committee.

3 2. A vote for removal of a member of the Charter Committee
4 pursuant to paragraph (d) of subsection 1 must be ratified by a
5 majority vote of the City Council.

6 3. If a vacancy occurs on the Charter Committee, the vacancy
7 must be filled in the same manner as the original appointment for
8 the remainder of the unexpired term.

10 **ARTICLE II**

11
12 **LEGISLATIVE DEPARTMENT**

13
14 **Sec. 2.010 City Council: Qualifications; election; term of**
15 **office; salary.**

16 1. The legislative power of the City is vested in a City Council
17 consisting of five Council members.

18 2. Each Council member must be elected at large and without
19 respect to the location of his or her residence, as long as the
20 residence is within the city limits of the City of Mesquite.

21 3. Each Council member must be:

22 (a) A bona fide resident of the territory which is established by
23 the boundaries of the City for the 12 months immediately
24 preceding the last day for filing a declaration of candidacy for the
25 office.

26 (b) A qualified elector within the City.

27 4. All Council members must be voted upon by the registered
28 voters of the City at large and shall serve for terms of 4 years.

29 5. The Council members are entitled to receive a salary in an
30 amount fixed by the City Council. The City Council shall not
31 adopt an ordinance which increases or decreases the salary of the
32 Council members and becomes effective during the term for which
33 they have been elected or appointed.

34 **Sec. 2.020 City Council: Contracts. Members of the City**
35 **Council may vote on any lease, contract or other agreement which**
36 **extends beyond their terms of office.**

37 **Sec. 2.030 City Council: Discipline of members and other**
38 **persons; subpoena power.**

39 1. The City Council may:

40 (a) Provide for the punishment of any member for disorderly
41 conduct committed in its presence.

42 (b) Order the attendance of witnesses and the production of all
43 documents and data relating to any business before the City
44 Council.



1 2. *If any person ordered to appear before the City Council or*
2 *to produce documents or data fails to obey such order:*

3 (a) *The City Council or any member thereof may direct the*
4 *City Attorney to apply to the Municipal Court for a subpoena*
5 *commanding the attendance of the person before the City Council*
6 *or production of the documents or data to the City Council.*

7 (b) *A Municipal Court Judge may issue the subpoena, and any*
8 *peace officer may serve it.*

9 (c) *If the person upon whom the subpoena is served fails to*
10 *obey it, the Municipal Court may issue an order to show cause*
11 *why such person should not be held in contempt of the Municipal*
12 *Court and upon hearing of the matter may adjudge such person*
13 *guilty of contempt and punish him or her accordingly.*

14 *Sec. 2.040 Meetings: Quorum.*

15 1. *Unless the Mayor or a majority of Council members decide*
16 *otherwise, the City Council shall hold at least two regular*
17 *meetings each month. In no case may the City Council not hold a*
18 *regular meeting during any given month.*

19 2. *Before each regular meeting, but after the previous*
20 *meeting, the City Council shall hold a work session to discuss the*
21 *contents of the upcoming meeting.*

22 3. *Except as otherwise provided in NRS 241.0355, a majority*
23 *of all members of the City Council constitutes a quorum to do*
24 *business, but a lesser number may meet and recess from time to*
25 *time, and compel the attendance of the absent members.*

26 4. *Except as otherwise provided by law, all sessions and all*
27 *proceedings of the City Council must be public.*

28 *Sec. 2.050 Meetings: Special.*

29 1. *Special meetings may be held on call of the Mayor or by a*
30 *majority of the City Council, by giving notice of the special*
31 *meeting pursuant to NRS 241.020.*

32 2. *At a special meeting, no contract involving the expenditure*
33 *of money may be made or claim allowed unless notice of the*
34 *meeting called to consider the action is given pursuant to the*
35 *provisions of NRS 241.020.*

36 *Sec. 2.060 Meetings: Time and place; rules. The City*
37 *Council may:*

38 1. *Fix the time and place of its meetings.*

39 2. *Adopt rules for the government of its members and*
40 *proceedings.*

41 *Sec. 2.070 Oaths and affirmations. The Mayor, the Mayor*
42 *pro tempore while acting for the Mayor and the City Clerk may*
43 *administer oaths and affirmations relating to any business*
44 *pertaining to the City before the City Council or to be considered*
45 *by the City Council.*



1 *Sec. 2.080 Powers of City Council: Ordinances, resolutions*
2 *and orders.*

3 *1. The City Council may make and pass all ordinances,*
4 *resolutions and orders not repugnant to the Constitution of the*
5 *United States or the State of Nevada, or to the provisions of*
6 *the Nevada Revised Statutes or of this Charter, necessary for the*
7 *municipal government and the management of the affairs of the*
8 *City, and for the execution of all the powers vested in the City.*

9 *2. When power is conferred upon the City Council to do and*
10 *perform anything, and the manner of exercising such power is not*
11 *specifically provided for, the City Council may provide by*
12 *ordinance the manner and details necessary for the full exercise of*
13 *such power.*

14 *3. The City Council may enforce ordinances by providing*
15 *penalties not to exceed those established by the Legislature for*
16 *misdemeanors.*

17 *4. The City Council has such powers, not in conflict with the*
18 *express or implied provisions of this Charter, as are conferred*
19 *generally by statute upon the governing bodies of cities organized*
20 *under a special charter.*

21 *Sec. 2.090 Ordinances: Passage by bill; amendments; subject*
22 *matter; title requirements.*

23 *1. No ordinance may be passed except by bill and by a*
24 *majority vote of the whole City Council. The style of all ordinances*
25 *must be as follows: "The City Council of the City of Mesquite does*
26 *ordain:".*

27 *2. No ordinance may contain more than one subject, which*
28 *must be briefly indicated in the title. If the subject of the ordinance*
29 *is not so expressed in the title, the ordinance is void as to the*
30 *matter not expressed in the title.*

31 *3. Any ordinance which amends an existing ordinance must*
32 *set out in full the ordinance or sections thereof to be amended,*
33 *must indicate matter to be omitted by enclosing it in brackets or by*
34 *using another similar conspicuous marking, and must indicate*
35 *new matter by underscoring, by italics or by another similar*
36 *conspicuous marking.*

37 *Sec. 2.100 Ordinances: Enactment procedure; emergency*
38 *ordinances.*

39 *1. All proposed ordinances when first proposed must be read*
40 *to the City Council by title and referred to a committee for*
41 *consideration, if such a committee has been established, after*
42 *which an adequate number of copies of the proposed ordinance*
43 *must be filed with the City Clerk for public distribution. Except as*
44 *otherwise provided in subsection 3, notice of the filing must be*
45 *published once in a newspaper qualified pursuant to the*



1 *provisions of chapter 238 of NRS, and published in the City at*
2 *least 10 days before the adoption of the ordinance. The City*
3 *Council shall adopt or reject the ordinance or an amendment*
4 *thereto within 30 days after the date of publication.*

5 *2. At the next regular meeting or special meeting of the City*
6 *Council following the proposal of an ordinance and its reference*
7 *to a committee, if such a committee has been established, any such*
8 *committee shall report the ordinance back to the City Council.*
9 *Before the City Council considers the action to be taken on the*
10 *proposed ordinance, a public hearing on the proposed ordinance*
11 *must be held. Upon the conclusion of the public hearing, the*
12 *proposed ordinance must be finally voted upon or action thereon*
13 *postponed.*

14 *3. In cases of emergency or where the ordinance is of a kind*
15 *specified in section 7.030, by unanimous consent of the City*
16 *Council, final action may be taken immediately or at a special*
17 *meeting called for that purpose, and no notice of the filing of the*
18 *copies of the proposed ordinance with the City Clerk need be*
19 *published.*

20 *4. All ordinances must be signed by the Mayor, attested by the*
21 *City Clerk and published at least once by title, together with the*
22 *names of the Council members voting for or against passage, in a*
23 *newspaper qualified pursuant to the provisions of chapter 238 of*
24 *NRS and published in the City, before the ordinance becomes*
25 *effective. The City Council may, by majority vote, order the*
26 *publication of the ordinance in full in lieu of publication by title*
27 *only.*

28 *5. The City Clerk shall keep a record of all ordinances*
29 *together with the affidavits of publication.*

30 *Sec. 2.110 Powers of City Council: Public property,*
31 *buildings. The City Council may:*

32 *1. Control the property of the City.*

33 *2. Erect and maintain all buildings necessary for the use of*
34 *the City.*

35 *3. Purchase, receive, hold, sell, lease, convey and dispose of*
36 *property, wherever situated, for the benefit of the City, improve*
37 *and protect such property, and do all other things in relation*
38 *thereto which natural persons might do.*

39 *Sec. 2.120 Powers of City Council: Eminent domain. The*
40 *City Council may condemn property for the public use in the*
41 *manner prescribed by chapter 37 of NRS, as amended from time to*
42 *time.*

43 *Sec. 2.130 Powers of City Council: Licensing, regulation and*
44 *prohibition of businesses, trades and professions.*

45 *1. The City Council may:*



1 (a) Except as otherwise provided in NRS 598D.150 and
2 640C.100, regulate all businesses, trades and professions.

3 (b) Fix, impose and collect a license tax for revenue upon all
4 businesses, trades and professions.

5 2. The City Council may establish by ordinance or resolution
6 any equitable standard to be used in fixing license taxes required
7 to be collected pursuant to this section.

8 Sec. 2.140 Powers of City Council: Police ordinances.

9 1. The City Council may enact and enforce such local police
10 ordinances as are not in conflict with the general laws of the State
11 of Nevada.

12 2. Any offense made a misdemeanor by the laws of the State
13 of Nevada shall also be deemed to be a misdemeanor in the City
14 whenever such offense is committed within the City.

15 Sec. 2.150 Powers of City Council: Fire protection;
16 regulation of explosives, inflammable materials; fire codes and
17 regulations. The City Council may:

18 1. Organize, regulate and maintain a fire department.

19 2. Regulate or prohibit the storage of any explosive,
20 combustible or inflammable material in or transported through
21 the City, and prescribe the distance from any residential or
22 commercial area where it may be kept. Any ordinance adopted
23 pursuant to this subsection that regulates places of employment
24 where explosives are stored must be at least as stringent as the
25 standards and procedures adopted by the Division of Industrial
26 Relations of the Department of Business and Industry pursuant to
27 NRS 618.890.

28 3. Establish, by ordinance, a fire code and other regulations
29 necessary to carry out the purposes of this section.

30 Sec. 2.160 Powers of City Council: Public health; Southern
31 Nevada Health District; regulations. The City Council may:

32 1. Provide for safeguarding public health in the City.

33 2. Provide for the enforcement of all regulations and
34 quarantines established by the Southern Nevada Health District or
35 its successor by imposing adequate penalties for violations thereof.

36 3. Provide by ordinance any rules and regulations specific to
37 the health and welfare of the City of Mesquite and its residents
38 and, in accordance with subsection 3 of section 2.080, provide that
39 the penalty for any violation thereof is equivalent to the penalty
40 established by the Legislature for a misdemeanor.

41 Sec. 2.170 Powers of City Council: Buildings; construction
42 and maintenance regulations; building and safety codes. The
43 City Council may:



1 *1. Regulate all matters relating to the construction,*

35 3. A real estate agency or real estate professional that
36 provides services pursuant to this section shall present all offers to

38 does not accept an offer and enter into a purchase and sale

7 **EXECUTIVE DEPARTMENT**

10 **Sec. 3.010 Mayor: Qualifications; duties; election; term of**
11 **office; salary; Mayor pro tempore.**

12 1. The Mayor must be:

13 (a) A bona fide resident of the territory which is established by
14 the boundaries of the City for the 12 months immediately
15 preceding the last day for filing a declaration of candidacy for the
16 office.

17 (b) A qualified elector within the City.

18 2. The Mayor:

19 (a) Shall preside over the meetings of the City Council, but
20 may not vote except in the case of breaking a tie vote. While
21 presiding over a meeting, the Mayor shall preserve order and
22 decorum among the members and enforce the rules of the City
23 Council and determine the order of business, subject to those rules
24 and appeal to the City Council, or as provided by ordinance.

25 (b) Must be recognized as the official head of the City
26 Government for all ceremonial purposes and for the performance
27 of all duties lawfully delegated to the Mayor by this Charter, by
28 action of the City Council or by any law.

29 (c) Has the authority to declare emergencies as necessary to
30 protect the general health, welfare and safety of the City. Any such
31 declaration of emergency:

32 (1) May include a provision authorizing the Mayor to act as
33 the chief executive officer of all affairs of the City during the
34 emergency; and

35 (2) Must be reviewed by the City Council at its next
36 meeting.

37 (d) Shall provide an annual address to the City Council during
38 the first quarter of each year relating to the state of the City, and
39 recommend such measures as the Mayor may deem beneficial to
40 the City.

41 (e) Shall take all proper measures for the preservation of
42 public peace and order, and the suppression of riots, tumults and
43 all forms of public disturbances, for which purpose the Mayor
44 may, if the City is not participating in a metropolitan police
45 department, appoint extra police officers temporarily and use and



1 *command the police force. If the City is participating in a*
2 *metropolitan police department, the Mayor may request law*
3 *enforcement assistance from the sheriff. In either case, if local law*
4 *enforcement forces are inadequate, the Mayor shall call upon the*
5 *Governor for military aid in the manner provided by law.*

6 *(f) Shall sign all licenses and warrants and claims against the*
7 *City.*

8 *(g) May, subject to ratification by the City Council:*

9 *(1) Appoint himself or herself or any member of the City*
10 *Council to, or remove himself or herself or any member of the City*
11 *Council from, any board, commission or advisory agency if the*
12 *Mayor or Council member is granted a seat on the board,*
13 *commission or advisory agency because of his or her elective*
14 *office; or*

15 *(2) Appoint a person whom the City Council determines to*
16 *be qualified to fill the seat of any person granted a seat pursuant*
17 *to subparagraph (1) or remove such a qualified person from that*
18 *seat.*

19 *(h) Shall, with the advice and consent of the City Council,*
20 *appoint the City Manager and City Attorney.*

21 *(i) May propose ordinances, resolutions and proclamations*
22 *that the City Council shall consider.*

23 *(j) Shall perform such other duties as the City Council*
24 *prescribes by ordinance.*

25 *3. The Mayor may exercise the right of veto upon all matters*
26 *passed by the City Council, but has no power to exercise a line-*
27 *item veto. To pass any matter receiving the Mayor's veto requires*
28 *a four-fifths vote of the City Council.*

29 *4. No resolution or contract requiring the payment of money*
30 *approved by the City Council or any ordinance may go into force*
31 *or have any effect until approved in writing by the Mayor or his or*
32 *her authorized designee, unless passed over the Mayor's veto. If*
33 *the Mayor does not approve the resolution, contract or ordinance*
34 *so submitted, the Mayor shall, within 5 days after the receipt*
35 *thereof, return it to the City Clerk with his or her reasons in*
36 *writing for not approving it. If the Mayor does not so return it, the*
37 *resolution or contract thereupon goes into effect and the*
38 *ordinance becomes a law, in like manner and with the same effect*

17 ***the office of Mayor becomes vacant.***

18 ***Sec. 3.020 City Manager: Duties.***

19 ***1. Except as otherwise provided in paragraph (b) of***
20 ***subsection 2 of section 3.010, the City Manager is the chief***
21 ***executive officer of the City and is responsible for the effective***
22 ***administration of the City Government.***

23 ***2. The City Manager shall:***

24 ***(a) Ensure that all the general laws and ordinances of the City***
25 ***are enforced.***

26 ***(b) Administer and exercise supervision and control over all***
27 ***offices, departments and services of the City under the jurisdiction***
28 ***and control of the City Manager.***

29 ***(c) Except as otherwise provided in this Charter, appoint all***
30 ***heads or directors of departments of the City and all subordinate***
31 ***officers and employees, and may discipline and remove any such***
32 ***appointed officer or employee.***

33 ***(d) Make such recommendations to the Mayor and City***
34 ***Council as he or she deems appropriate concerning the operation,***
35 ***affairs and future needs of the City.***

36 ***(e) Attend all regular and special meetings of the City Council***
37 ***and may participate in the discussion of any matters pending***
38 ***before the City Council, but may not vote on any such matter.***

39 ***(f) Ensure that all terms or conditions imposed in favor of the***
40 ***City or the residents of the City in any contract, franchise, lease or***
41 ***permit are faithfully kept and performed, and upon obtaining***
42 ***knowledge of any violation thereof, shall notify the City Council of***
43 ***such a violation.***

44 ***(g) If authorized by the provisions of this Charter or an***
45 ***ordinance or resolution, sign all contracts, franchises, leases,***



1 *permits or other documents that do not require approval of the*
2 *City Council and execute on behalf of the City all contracts,*
3 *franchises, leases, permits or other documents required to be*
4 *executed by an officer of the City.*

5 *(h) Keep the Mayor and City Council fully advised as to the*
6 *operations, financial conditions and needs of the City.*

7 *(i) Prepare and present an annual budget pursuant to the laws*
8 *of this State.*

9 *(j) Perform such other duties as may be prescribed by the City*
10 *Council.*

11 *3. The salary of the City Manager must be set by the City*
12 *Council.*

13 *4. The City Manager may appoint such clerical and*
14 *administrative assistants as he or she may deem necessary.*

15 *5. The Mayor or a Council member may not be appointed as*
16 *City Manager during the term for which he or she was elected or*
17 *within 1 year after the expiration of his or her term.*

18 *Sec. 3.030 City Manager: Removal. The Mayor and City*
19 *Council may vote to determine whether to remove the City*
20 *Manager. The City Manager may be removed for any reason,*
21 *subject to any employment agreement, upon receiving four votes*
22 *for removal. Such removal is not subject to the ability of the*
23 *Mayor to exercise the right of veto or the ability of the City*
24 *Council to override any veto.*

25 *Sec. 3.040 City Clerk: Duties. The City Clerk shall:*

26 *1. Keep the corporate seal and all books, records and*
27 *historical papers belonging to the City.*

28 *2. Attend all meetings of the City Council and keep an*
29 *accurate journal of its proceedings, including a record of all*
30 *ordinances, bylaws and resolutions passed or adopted by it. After*
31 *approval at each meeting of the City Council, the City Clerk shall*
32 *attest the journal after it has been signed by the Mayor.*

33 *3. Enter upon the journal the result of the vote of the City*
34 *Council upon the passage of all ordinances and resolutions.*

35 *4. Perform such other duties as may be required by the City*
36 *Manager.*

37 *Sec. 3.050 City Attorney: Qualifications; duties.*

38 *1. The City Attorney must be a duly licensed member of the*
39 *State Bar of Nevada.*

40 *2. The City Attorney is the chief legal officer of the City and*
41 *shall:*

42 *(a) Advise the City Council and all of the offices, departments*
43 *and divisions of the City in all matters with respect to the affairs of*
44 *the City;*



1 ***(b) Prosecute any violation of law occurring within the City of***
2 ***Mesquite that the Nevada Revised Statutes authorize a city to***
3 ***prosecute;***

4 ***(c) Determine whether the City should initiate any judicial or***
5 ***administrative proceedings; and***

6 ***(d) Perform such other duties as may be designated by the City***
7 ***Council or prescribed by ordinance.***

8 ***3. The City Attorney may employ legal counsel on a contract***
9 ***or full-time basis as needed by the City.***

10 ***Sec. 3.060 City Attorney: Removal. The Mayor and City***
11 ***Council may vote to determine whether to remove the City***
12 ***Attorney. The City Attorney may be removed for any reason,***
13 ***subject to any employment agreement, upon receiving four votes***
14 ***for removal. Such removal is not subject to the ability of the***
15 ***Mayor to exercise the right of veto or the ability of the City***
16 ***Council to override any veto.***

17 ***Sec. 3.070 County Assessor to be ex officio City Assessor;***
18 ***duties.***

19 ***1. The County Assessor of Clark County is ex officio City***
20 ***Assessor of the City. The County Assessor shall perform such***
21 ***duties for the City without additional compensation.***

22 ***2. Upon request of the ex officio City Assessor, the City***
23 ***Council may appoint and set the salary of a Deputy City Assessor***
24 ***to perform such duties relative to city assessments as may be***
25 ***deemed necessary.***

26 ***Sec. 3.080 Collection and disposition of money.***

27 ***1. All fines, forfeitures or other money, except taxes collected***
28 ***or recovered by any employee of the City or other person pursuant***
29 ***to the provisions of this Charter or of any valid ordinance of the***
30 ***City, must be paid by the employee or person collecting or***
31 ***receiving them to the Director of Finance, who shall dispose of***
32 ***them in accordance with the ordinances, regulations and***
33 ***procedures established by the City Council.***

34 ***2. The City Council, City Manager or City Attorney may by***
35 ***proper legal action collect all money, including taxes, which are***
36 ***due and unpaid to the City or any office thereof, and the City***
37 ***Council may pay from the General Fund all fees and expenses***
38 ***necessarily incurred by it in connection with the collection of such***
39 ***money.***

40 ***Sec. 3.090 Interference by City Council. Except for the***
41 ***purpose of inquiry, the City Council and its members shall deal***
42 ***with employees solely through the City Manager or City Attorney,***
43 ***as applicable, or their designees. Neither the City Council nor any***
44 ***member thereof may give orders to any subordinate of the City***
45 ***Manager or City Attorney, either publicly or privately.***



ARTICLE IV

JUDICIAL DEPARTMENT

Sec. 4.010 Municipal Court.

1. There is a Municipal Court of the City which consists of at least one department. Each department must be presided over by a Municipal Court Judge and has such power and jurisdiction as is prescribed in, and is, in all respects which are not inconsistent with this Charter, governed by, the provisions of chapter 5 of NRS.

2. The City Council may from time to time establish additional departments of the Municipal Court.

3. The respective departments of the Municipal Court must be numbered 1 through the appropriate Arabic number, as additional departments are approved by the City Council. A Municipal Court Judge must be appointed or elected, as applicable, for each department by number.

4. The Senior Municipal Court Judge is selected by a majority of the sitting judges for a term of 2 years. If no Municipal Court Judge receives a majority of the votes, the Senior Municipal Court Judge is the Municipal Court Judge who has continuously served as a Municipal Court Judge for the longest period.

Sec. 4.020 Municipal Court: Appointment or election; terms of office; removal of Municipal Court Judge.

1. If the Municipal Court consists of only one department:

(a) The Justice of the Peace for the Township of Mesquite shall be ex officio Municipal Court Judge unless the Mayor, with the advice and consent of the City Council, appoints a different person to serve as the Municipal Court Judge presiding over the department. No provision of this Charter or an ordinance may preclude the Justice of the Peace for the Township of Mesquite from also serving as the Municipal Court Judge presiding over the department.

(b) The Mayor and City Council may vote to determine whether to remove the Municipal Court Judge. The Municipal Court Judge may be removed for any reason, subject to any employment agreement, upon receiving four votes for removal. Such removal is not subject to the ability of the Mayor to exercise the right of veto or the ability of the City Council to override any veto.

2. If the Municipal Court consists of more than one department:

(a) Each Municipal Court Judge presiding over a department must be elected.



1 (b) *The term of office of each Municipal Court Judge must be*
2 *staggered, with each judge serving a term of 6 years. Except as*
3 *otherwise provided by law, there is no limit on the number of*
4 *terms a Municipal Court Judge may serve.*

5 *Sec. 4.030 Municipal Court: Qualifications of Municipal*
6 *Court Judge; salary.*

7 1. *Each Municipal Court Judge must have been a resident of*
8 *the territory which is established by the boundaries of the City for*
9 *the 12 months immediately preceding the last day for seeking*
10 *appointment for the office.*

11 2. *If the Municipal Court consists of only one department:*

12 (a) *Unless the City Council passes an ordinance to the*
13 *contrary, the Municipal Court Judge will serve on an as-needed*
14 *basis.*

15 (b) *The Municipal Court Judge must not be required to be a*
16 *licensed member of the State Bar of Nevada or have any previous*
17 *legal training.*

18 3. *If the City Council establishes a second or subsequent*
19 *department of the Municipal Court pursuant to subsection 2 of*
20 *section 4.010, each Municipal Court Judge shall devote his or her*
21 *full time to the duties of his or her office and must be a duly*
22 *licensed member, in good standing, of the State Bar of Nevada.*

23 4. *The salary of each Municipal Court Judge must be fixed*
24 *by the City Council and be uniform for all departments in the*
25 *Municipal Court. The salary may be increased during the terms*
26 *for which the Judges are appointed or elected, applicable.*

27 5. *If the City Council establishes a second or subsequent*
28 *department of the Municipal Court pursuant to subsection 2 of*
29 *section 4.010, the department must not begin operating as a*
30 *department of the Municipal Court until a qualified candidate is*
31 *elected as the Municipal Court Judge who will preside over the*
32 *department. Such a Municipal Court Judge must be elected during*
33 *the next general municipal election following the establishment of*
34 *such a department.*

35 *Sec. 4.040 Disposition of fines. All fines and forfeitures for*
36 *the violation of ordinances must be paid to the Director of*
37 *Finance.*

39 **ARTICLE V**

40
41 **ELECTIONS**

42
43 *Sec. 5.010 Election for City Council.*

44 1. *Candidates for City Council must be elected at large and by*
45 *seat. Each Council seat must be consecutively numbered 1*



1 *through 5. The number of each Council seat is for informational*
2 *purposes only and the sequencing of such seats does not grant or*
3 *denote any special authority or ability.*

4 *2. Upon passage and approval of this Charter, the incumbent*
5 *Council members shall draw a number by lot to determine the*
6 *number assigned to each Council seat. The number assigned to*
7 *each Council seat will remain until such time as this Charter is*
8 *amended to provide otherwise.*

9 *3. The term of office for each Council seat must be consistent*
10 *with the term of office of the incumbent Council member assigned*
11 *to that seat.*

12 *4. After each Council seat has been assigned a number, any*
13 *candidate for City Council shall file by seat number.*

14 *5. If:*

15 *(a) Not more than two candidates file for a seat, the names of*
16 *the candidates must not be listed on the ballot for the primary*
17 *municipal election and the candidates must advance directly to the*
18 *general municipal election.*

19 *(b) Three or more candidates file for a seat, the names of the*
20 *candidates must be listed on the ballot for the primary municipal*
21 *election.*

22 *Sec. 5.020 Primary municipal election.*

23 *1. A primary municipal election must be held on the second*
24 *Tuesday in June in each even-numbered year pursuant to NRS*
25 *293.175, as amended from time to time.*

26 *2. In a primary municipal election, if the number of votes a*
27 *candidate receives is:*

28 *(a) Equal to or greater than a majority of the number of voters*
29 *participating in the primary election for that seat, that candidate*
30 *must be declared elected and the name of the candidate must not*
31 *be placed on the ballot for the general municipal election.*

32 *(b) Less than a majority of the number of voters participating*
33 *in the primary election for that seat, the names of the two*
34 *candidates receiving the highest number of votes must be placed*
35 *on the ballot for the general municipal election.*

36 *3. For the purposes of this section, a majority of the number*
37 *of voters participating in a primary municipal election for a seat is*
38 *determined as follows:*

39 *(a) If there is an even number of voters participating in the*
40 *primary election for a seat, a majority of those voters is determined*
41 *by dividing the number of voters in half and adding one.*

42 *(b) If there is an odd number of voters participating in the*
43 *primary election for a seat, a majority of those voters is determined*
44 *by dividing the number of voters in half and rounding up to the*
45 *nearest whole number.*



1 *Sec. 5.030 General municipal election. A general*
2 *municipal election must be held in the City on the first Tuesday*
3 *after the first Monday of November in each even-numbered year*
4 *pursuant to NRS 293.12755, as amended from time to time.*

5 *Sec. 5.040 Applicability of state election laws; elections*
6 *under City Council control.*

7 1. *All elections held under this Charter are governed by the*
8 *provisions of the election laws of this State, so far as those laws*
9 *can be made applicable and are not inconsistent herewith.*

10 2. *The conduct of all municipal elections is under the control*
11 *of the City Council.*

12 3. *The City Council shall by ordinance provide for the*
13 *holding of a municipal election, appoint the necessary officers*
14 *thereof and do all the things required to carry the election into*
15 *effect as it considers desirable and consistent with law and this*
16 *Charter.*

17 4. *Notwithstanding any other provision of this Charter, the*
18 *City Council may enter into an interlocal agreement with another*
19 *public entity to conduct municipal elections or any portion thereof.*

20 *Sec. 5.050 Qualifications. Every person who resides within*
21 *the City and who is a legally registered voter of the City is entitled*
22 *to vote at each municipal election, including, without limitation,*
23 *primary, general or special elections.*

24 *Sec. 5.060 Names on ballots.*

25 1. *The full names of all candidates, except those who have*
26 *withdrawn, died or become ineligible, must be printed on the*
27 *official ballots without party designation or symbol.*

28 2. *If two or more candidates have the same surname or*
29 *surnames so similar as to be likely to cause confusion and:*

30 (a) *None of the candidates is an incumbent, the middle names*
31 *or middle initials, if any, of both candidates must be included in*
32 *their names as printed on the ballot; or*

33 (b) *One of the candidates is an incumbent, the name of the*
34 *incumbent must be listed first and must be printed in bold type.*

35 *Sec. 5.070 Ballots for ordinance and Charter amendments.*
36 *An ordinance or Charter amendment to be voted on in the City*
37 *must be presented for voting by ballot title. The ballot title of a*
38 *measure may differ from its legal title and must be a clear, concise*
39 *statement describing the substance of the measure without*
40 *argument or prejudice. Below the ballot title must appear the*
41 *following question: "Shall the above described (ordinance)*
42 *(amendment) be adopted?" The ballot or voting machine or device*
43 *must be so marked as to indicate clearly in what manner the voter*
44 *may cast his or her vote, either for or against the ordinance or*
45 *amendment.*



1 *Sec. 5.080 Availability of lists of registered voters. Any*
2 *person who desires a copy of a list of registered voters in the City*
3 *may obtain a copy pursuant to the provisions of NRS 293.440.*

4 *Sec. 5.090 Voting machines. The City Council may provide*
5 *for the use of mechanical or other devices for voting or counting*
6 *the votes not inconsistent with law or regulations of the Secretary*
7 *of State.*

8 *Sec. 5.100 Election returns; canvass; certificates of election;*
9 *entry of officers upon duties; tie vote procedure.*

10 1. *The election returns from any special, primary or general*
11 *municipal election must be filed with the City Clerk, who shall*
12 *immediately place the returns in a safe or vault, and no person*
13 *may handle, inspect or in any manner interfere with the returns*
14 *until canvassed by the City Council.*

15 2. *The City Council shall meet at any time within 10 days*
16 *after any election and canvass the returns and declare the result.*
17 *The election returns must then be sealed and kept by the City*
18 *Clerk for 6 months. No person may have access to the returns*
19 *except on order of a court of competent jurisdiction or by order of*
20 *the City Council.*

21 3. *The City Clerk, under his or her hand and official seal,*
22 *shall issue to each person elected a certificate of election. Except*
23 *as otherwise provided in section 1.060, the officers so elected shall*
24 *qualify and enter upon the discharge of their respective duties at*
25 *the first meeting of the City Council held in December of the year*
26 *of the general municipal election.*

27 4. *If any election results in a tie, the City Council shall*
28 *summon the candidates who received the tie vote and determine*
29 *the tie by lot. The City Clerk shall then issue to the winner a*
30 *certificate of election.*

31 *Sec. 5.110 Contest of election. A contested election for any*
32 *municipal office must be determined according to the law of the*
33 *State regulating proceedings in contested elections in political*
34 *subdivisions.*

36 **ARTICLE VI**

38 **LOCAL IMPROVEMENTS**

39
40 *Sec. 6.010 Local improvement law. Except as otherwise*
41 *provided in subsection 3 of section 2.280 and section 2.290, the*
42 *City Council, on behalf of the City and in its name, without any*
43 *election, may from time to time acquire, improve, equip, operate*
44 *and maintain, convert to or authorize:*

45 1. *Curb and gutter projects;*



- 1 2. *Drainage projects;*
- 2 3. *Off-street parking projects;*
- 3 4. *Overpass projects;*
- 4 5. *Park or recreation projects;*
- 5 6. *Sanitary sewer projects;*
- 6 7. *Security walls;*
- 7 8. *Sidewalk projects;*
- 8 9. *Storm sewer projects;*
- 9 10. *Street projects;*
- 10 11. *Telephone projects;*
- 11 12. *Transportation projects;*
- 12 13. *Underground and aboveground electric and*
- 13 *communication facilities;*
- 14 14. *Underpass projects;*
- 15 15. *Water projects;*
- 16 16. *Such other utility projects as are deemed necessary by the*
- 17 *City Council; and*
- 18 17. *Any combination thereof.*

19 *Sec. 6.020 Local improvement law: Collateral powers. The*
20 *City Council on behalf of the City for the purpose of defraying all*
21 *the costs of acquiring, improving or converting to any project*
22 *authorized by section 6.010, or any portion of the cost thereof not*
23 *to be defrayed with money otherwise available therefor, is vested*
24 *with the powers granted to municipalities by chapters 271 and*
25 *704A of NRS, as amended from time to time.*

27 **ARTICLE VII**

28
29 **LOCAL BONDS AND FRANCHISES**

30
31 *Sec. 7.010 Debt limit.*

32 1. *The City shall not incur an indebtedness in excess of 25*
33 *percent of the total assessed valuation of the taxable property*
34 *within the boundaries of the City.*

35 2. *In determining any debt limitation under this section, the*
36 *following must be counted as indebtedness:*

37 (a) *Any liabilities of the City that are due in more than 1 year,*
38 *including, without limitation, revenue bonds, general obligation*
39 *bonds and short-term securities.*

40 (b) *Any outstanding personnel-related liabilities.*

41 (c) *Any special assessment bonds, if the full faith and credit of*
42 *the City is pledged to the payment thereof.*

43 (d) *Any other liabilities that are identified as part of the*
44 *annual audit of the City and determined by the Director of*
45 *Finance to be appropriate to include as indebtedness.*



1 3. *In determining any debt limitation under this section, the*
2 *following must not be counted as indebtedness:*

3 (a) *Any special assessment bonds if the full faith and credit of*
4 *the City is not pledged to the payment thereof.*

5 (b) *Any liabilities of the City due within 1 year that are*
6 *accounted for within the budget for the current fiscal year.*

7 *Sec. 7.020 Acquisition, operation of municipal utilities.*
8 *Except as otherwise provided in subsection 3 of section 2.280 and*
9 *section 2.290, the City may, in the manner and for the purposes*
10 *provided in this Charter and the Nevada Revised Statutes as they*
11 *apply to cities, grant franchises and acquire in any manner any*
12 *public utility, and hold, manage and operate it either alone or*
13 *jointly, with any level of government or instrumentality or*
14 *subdivision thereof.*

15 *Sec. 7.030 Borrowing money.*

16 1. *Subject to the limitations imposed by this article, the City*
17 *may borrow money for any corporate purpose, including, without*
18 *limitation, any purpose authorized by this Charter or by the*
19 *Nevada Revised Statutes for a city, and for such purpose may issue*
20 *bonds or other securities. The Local Government Securities Law,*
21 *as amended from time to time, applies to all securities so issued*
22 *except for securities issued under section 6.020.*

23 2. *Any property tax levied to pay the principal of or interest*
24 *on such indebtedness must be levied upon all taxable property*
25 *within the City as provided in NRS 350.590 to 350.602, inclusive.*

26 3. *Any ordinance pertaining to the sale or issuance of bonds*
27 *or other securities, including, without limitation, securities issued*
28 *under section 6.020, may be adopted in the same manner as is*
29 *provided for cases of emergency. A declaration by the City Council*
30 *in any ordinance that it is of this kind is conclusive in the absence*
31 *of fraud or gross abuse of discretion.*

35 **TRUSTS FOR FURTHERANCE OF PUBLIC FUNCTIONS**

36
37 *Sec. 8.010. Trusts for furtherance of public functions:*
38 *Authorization to create; purposes; eligible beneficiaries; power of*
39 *beneficiary to lease trust property.*

40 1. *Express trusts may be created in real or personal property,*
41 *or either or both, or in any estate or interest in either or both, with*
42 *the City as the beneficiary thereof, and the purpose thereof may be*
43 *the furtherance, or the providing of funds for the furtherance, of*
44 *any authorized or proper function of the beneficiary, but no funds*
45 *of the beneficiary derived from sources other than the trust*



1 *property, or the operation thereof, may be charged with or*
2 *expended for the execution of the trust, except by express action of*
3 *the legislative authority of the beneficiary first had.*

4 *2. The officers or any other governmental agencies or*
5 *authorities having the custody, management or control of any*
6 *property, real or personal or both, of the beneficiary of such trust,*
7 *or of such a proposed trust, which property is necessary for the*
8 *execution of the trust purposes, are hereby authorized and*
9 *empowered to lease such property for such purposes, after the*
10 *acceptance of the beneficial interest therein by the beneficiary as*
11 *provided in this article, or conditioned upon such acceptance.*

12 *Sec. 8.020 Creation by written instrument; execution,*
13 *recording of trust instrument; acceptance by beneficiary creates*
14 *contract between State, grantor; duration of trust.*

15 *1. Such trusts may be created by written instruments, or by*
16 *will. A written instrument must be subscribed by the grantor or*
17 *grantors and duly acknowledged as conveyances of real property*
18 *are acknowledged. Before the same becomes effective, the*
19 *beneficial interest therein must be accepted by the governing body*
20 *of the beneficiary, which power and authority of acceptance is*
21 *hereby conferred upon the City Council. Thereupon the*
22 *instrument or will, together with the written acceptance of*
23 *the beneficial interest endorsed thereon, must be recorded in the*
24 *Office of the County Recorder of each county in which is situated*
25 *any real property, or any interest therein, belonging to the trust, as*
26 *well as in the county where the trust property is located or its*
27 *principal operations are conducted.*

28 *2. Upon the acceptance of the beneficial interest by the*
29 *beneficiary as authorized in subsection 1, the same must be and*
30 *constitute a binding contract between the State of Nevada and the*
31 *grantor or grantors, or the executor of the estate of the testator,*
32 *for the acceptance of the beneficial interest in the trust property by*
33 *the designated beneficiary and the application of the proceeds of*
34 *the trust property and its operation for the purposes and in*
35 *accordance with the stipulations specified by the trustor or*
36 *trustors.*

37 *3. Such trusts have duration for the term of duration of the*
38 *beneficiary, or such shorter length of time as is specified in the*
39 *instrument or will creating the trust.*

40 *Sec. 8.030 Trustees: Appointment; succession, powers;*
41 *duties, terms, compensation controlled by trust instrument.*

42 *1. The instrument or will creating such trust may provide for*
43 *the appointment, succession, powers, duties, term and*
44 *compensation of the trustee or trustees, and in all such respects*
45 *the terms of the instrument or will are controlling, except as*



1 otherwise provided in subsections 2 and 3. If the instrument or will
2 makes no provision in regard to any of the foregoing, then the
3 general laws of the State control as to such omission or omissions.

4 2. All meetings of the trustees must be open to the public to
5 the same extent as required by chapter 241 of NRS for state and
6 local agencies. If the trustee is a partnership, corporation or
7 banking association, this requirement applies to that part of every
8 meeting of the partners or directors at which trust affairs are
9 discussed.

10 3. All records of the trust are public records and must be kept
11 in a place which is identified by documents recorded in the Office
12 of the County Recorder of each county in which the instrument
13 creating the trust is recorded.

14 **Sec. 8.040 Trustees: Eligibility and status; standard of care;
15 exemption from personal liability.**

16 1. The trustee or trustees under such an instrument or will
17 may be two or more natural persons or a partnership, corporation,
18 community foundation, national banking association or state
19 banking association selected by the City Council, and such trustee
20 or trustees must be an agency of the State and the regularly
21 constituted authority of the beneficiary for the performance of the
22 functions for which the trust has been created.

23 2. The provisions of NRS 164.700 to 164.775, inclusive,
24 relating to the standard of care for a trustee in investing and
25 managing trust property apply to the trustee or trustees of a trust
26 created by a written instrument or will pursuant to this article.

27 3. No trustee or beneficiary may be charged personally with
28 any liability whatsoever by reason of any act or omission
29 committed or suffered in the performance of such trust or in the
30 operation of the trust property, but any act, liability for any
31 omission or obligation of a trustee or trustees, in the execution of
32 such trust, or in the operation of the trust property, extends to the
33 whole of the trust estate, or so much thereof as may be necessary
34 to discharge such liability or obligation, and not otherwise.

35 **Sec. 8.050 Annual audit of trust funds, accounts, fiscal
36 affairs: Requirements; distribution of copies; expenses.**

37 1. The trustee or trustees of every trust created for the benefit
38 and furtherance of any public function with the City as the
39 beneficiary thereof shall cause an audit to be made of the funds,
40 accounts and fiscal affairs of such trust, such audit to be ordered
41 within 30 days after the close of each fiscal year of the trust.

42 2. The audits required by subsection 1 must be certified with
43 the unqualified opinion of a certified public accountant or a
44 public accountant notwithstanding any lesser requirement by any
45 instrument under which the trust may have covenanted for an



1 *audit to be made or furnished. One copy of the annual audit must*
2 *be filed with the Legislative Auditor of the Legislative Counsel*
3 *Bureau and one copy with each beneficiary of the trust not later*
4 *than 90 days following the close of each fiscal year of the trust.*

5 *3. If a copy of the required audit is not filed with the*
6 *Legislative Auditor of the Legislative Counsel Bureau within the*
7 *time provided, the Legislative Auditor is authorized to employ, at*
8 *the cost and expense of the trust, a certified public accountant or a*
9 *public accountant to make the required audit.*

10 *4. The necessary expense of such audits, including the cost of*
11 *typing, printing and binding, must be paid from funds of the trust.*

12 *Sec. 8.060 Franchise not required for acquisition, ownership*
13 *or operation of trust property. No franchise is required for the*
14 *acquisition, ownership or operation of any properties of a trust*
15 *created for the benefit and furtherance of any public function.*

16 *Sec. 8.070 Approval of certain contracts and resolutions*
17 *required. The trustees shall not enter into contracts for the*
18 *acquisition or construction of buildings or public improvements or*
19 *for the acquisition or disposal of trust properties by purchase,*
20 *lease, gift, bequest or devise or any other lawful means until such*
21 *contract is first approved by the City Council by ordinance. The*
22 *City Council shall so approve the resolution providing for the*
23 *issuance of bonds or other securities to be issued by the trustees*
24 *and proposed terms of sale thereof, but is not required to approve*
25 *the award of such bonds to the purchaser thereof if such bonds*
26 *are sold in compliance with the resolution of issuance and terms*
27 *of sale.*

28 *Sec. 8.080 Approval of financing method, underwriters by*
29 *State Board of Finance. The State Board of Finance shall first*
30 *review and approve the method of finance proposed by any trust*
31 *created pursuant to the former provisions of NRS 242B.010 to*
32 *242B.100, inclusive, or the provisions of this article, and must*
33 *approve the underwriter or financial institution preparing and*
34 *offering the proposed issue for sale, as to the financial*
35 *responsibility of such underwriter or financial institution, before*
36 *such issue may be offered or sold.*

37 *Sec. 8.090 Exemption from securities laws.*

38 *1. The provisions of the State Securities Law, the Local*
39 *Government Securities Law, the University Securities Law, or any*
40 *other general, special or local statute relating to the issuance of*
41 *public securities or other debt obligations do not apply to a trust*
42 *created for the benefit and furtherance of any public function.*

43 *2. All bonds issued by any trust created for the benefit and*
44 *furtherance of any public function must:*

1 (a) *Be sold at public or private sale, as determined by the*
2 *trustees and approved by the City Council. If the bonds are offered*
3 *at public sale, but no satisfactory bids are received from*
4 *responsible bidders at the public sale, the bonds may be sold at*
5 *private sale.*

6 (b) *Be secured:*

7 (1) *By property, real or personal or both, having a market*
8 *value equal to at least twice the principal amount of the bonds*
9 *sold; or*

10 (2) *By gross revenues from an existing revenue producing*
11 *facility equal to at least one and one-half times the average annual*
12 *debt service payable on the bonds.*

13 *Sec. 8.100 Competitive bidding not required. Except as*
14 *otherwise provided in section 8.090, no statute, general, special or*
15 *local, requiring competitive bidding applies to a trust created for*
16 *the benefit and furtherance of a public function.*

17 *Sec. 8.110 Rejection of contribution to trust. A trustee may*
18 *reject any contribution to a trust created for the benefit and*
19 *furtherance of a public function that the trustee deems not to be in*
20 *the best interest of the trust. If the trustee rejects any contribution,*
21 *the trustee shall provide notice of the rejection in writing.*

22 *Sec. 8.120 Termination of trust. Any trust created for the*
23 *benefit and furtherance of a public function may be terminated by*
24 *agreement of the trustee, or if there is more than one, then all of*
25 *the trustees, and the governing body of the beneficiary, with the*
26 *approval of the Governor of the State of Nevada, but such trust*
27 *must not be terminated while there exists outstanding any*
28 *contractual obligations chargeable against the trust property,*
29 *which, by reason of such termination, might become an obligation*
30 *of the beneficiary of such trust.*

32 **ARTICLE IX**

33
34 **Revenue**

35
36 *Sec. 9.010 Municipal taxes.*

37 1. *The City Council shall annually, at the time prescribed by*
38 *law for levying taxes for State and county purposes, levy a tax at a*
39 *rate allowable under applicable provisions of the Nevada Revised*
40 *Statutes upon the assessed value of all real and personal property*
41 *within the City except as provided in the Local Government*
42 *Securities Law and the Consolidated Local Improvements Law, as*
43 *amended from time to time. The taxes so levied must be collected*
44 *at the same time and in the same manner and by the same officers,*
45 *exercising the same functions, as prescribed in the laws of the*



1 *State of Nevada for collection of state and county taxes. The*
2 *revenue laws of the State, in every respect not inconsistent with the*
3 *provisions of this Charter, are applicable to the levying, assessing*
4 *and collecting of the municipal taxes.*

5 *2. In the matter of equalization of assessments, the rights of*
6 *the City and the inhabitants thereof must be protected in the same*
7 *manner and to the same extent by the action of the county board*
8 *of equalization as are the State and county.*

9 *3. All forms and blanks used in levying, assessing and*
10 *collecting the revenues of the State and counties must, with such*
11 *alterations or additions as may be necessary, be used in levying,*
12 *assessing and collecting the revenues of the City. The City Council*
13 *shall enact all such ordinances as it may deem necessary and not*
14 *inconsistent with this Charter and the laws of the State for the*
15 *prompt, convenient and economical collecting of the revenue.*

16 *Sec. 9.020 Revenue ordinances. The City Council may pass*
17 *and enact all ordinances necessary to carry into effect the revenue*
18 *laws in the City and to enlarge, fix and determine the powers and*
19 *duties of all officers in relation thereto.*

21 **ARTICLE X**

22
23 **MISCELLANEOUS PROVISIONS**

24
25 *Sec. 10.010 Severability of provisions. If any portion of this*
26 *Charter is held to be unconstitutional or invalid for any reason by*
27 *the decision of any court of competent jurisdiction, such decision*
28 *does not affect the validity of the remaining portion of this*
29 *Charter. The Legislature hereby declares that it would have passed*
30 *this Charter and each portion thereof, irrespective of the portion*
31 *which may be deemed unconstitutional or otherwise invalid.*

32 *Sec. 10.020 Effect of enactment of Charter.*

33 *1. All rights and property of every kind and description which*
34 *were vested in the City before the enactment of this Charter are*
35 *vested in the City on July 1, 2017. No right or liability, either in*
36 *favor of or against the City existing at the time of becoming*
37 *incorporated under this Charter, and no action or prosecution is*
38 *affected by such change, but it stands and progresses as if no*
39 *change had been made.*

40 *2. Whenever a different remedy is given by this Charter,*
41 *which may properly be made applicable to any right existing at the*
42 *time of the City so becoming incorporated under this Charter,*
43 *such remedy is cumulative to the remedy before provided, and*
44 *used accordingly.*



1 3. *All ordinances and resolutions in effect in the City before*
2 *July 1, 2017, unless in conflict with the provisions of this Charter,*
3 *continue in full force and effect until amended or repealed.*

4 4. *The enactment of this Charter does not effect any change*
5 *in the legal identity of the City.*

6 5. *The enactment of this Charter must not be construed to*
7 *repeal or in any way affect or modify:*

8 (a) *Any special, local or temporary law.*

9 (b) *Any law or ordinance making an appropriation.*

10 (c) *Any ordinance affecting any bond issue or by which any*
11 *bond issue may have been authorized.*

12 (d) *The running of the statute of limitations in force at the*
13 *time this Charter becomes effective.*

14 (e) *Any bond of any public officer.*

15 **Sec. 2.** This act becomes effective:

16 1. Upon passage and approval for the purpose of performing
17 any preparatory administrative tasks that are necessary to carry out
18 the provisions of this act; and

19 2. On July 1, 2017, for all other purposes.
