SUMMARY—Makes an appropriation to the Department of Motor Vehicles for the creation and maintenance of branch offices in the City of West Wendover and the City of Caliente. (BDR S-444)

AN ACT making an appropriation from the State Highway Fund to the Department of Motor Vehicles for the creation and maintenance of branch offices in the City of West Wendover and the City of Caliente; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** 1. There is hereby appropriated from the State
2 Highway Fund to the Department of Motor Vehicles for the creation
3 and maintenance of a branch office of the Department within or near
4 the City of West Wendover the following sums:
5 For the Fiscal Year 2019-2020 \$330,000
6 For the Fiscal Year 2020-2021 \$330,000
7 2. There is hereby appropriated from the State Highway Fund
8 to the Department of Motor Vehicles for the creation and
9 maintenance of a branch office of the Department within or near the
10 City of Caliente the following sums:
11 For the Fiscal Year 2019-2020 \$330,000
12 For the Fiscal Year 2020-2021 \$330,000



1 **Sec. 2.** Any balance of the sums appropriated by section 1 of
2 this act remaining at the end of the respective fiscal years must not
3 be committed for expenditure after June 30 of the respective fiscal
4 years by the entity to which the appropriation is made or any entity
5 to which money from the appropriation is granted or otherwise
6 transferred in any manner, and any portion of the appropriated
7 money remaining must not be spent for any purpose after
8 September 18, 2020, and September 17, 2021, respectively, by
9 either the entity to which the money was appropriated or the entity
10 to which the money was subsequently granted or transferred, and
11 must be reverted to the State Highway Fund on or before
12 September 18, 2020, and September 17, 2021, respectively.

13 **Sec. 3.** The appropriations made by the provisions of this act
14 are not intended to finance ongoing expenditures of state agencies,
15 and the expenditures financed with those appropriations must be
16 included as base budget expenditures in the proposed budget for the
17 Executive Branch of State Government for the 2021-2023 biennium.

18 **Sec. 4.** This act becomes effective upon passage and approval
19 for the purposes of performing any preparatory administrative tasks
20 that are necessary to carry out the provisions of this act, and on
21 July 1, 2019, for all other purposes.
