2 to serve as the Parliamentarian and Chief Administrative Officer of
3 the Senate; and

4 WHEREAS, The Senate of the 82nd Session of the Nevada
5 Legislature elected Brendan Bucy to serve as Secretary of the
6 Senate for the first time; and

7 WHEREAS, The Secretary of the Senate is responsible for
8 employing all of the staff of the Senate, including the Sergeants at
9 Arms, Front Desk Clerks, Administrative Services Staff, Leadership
10 Officers, Legislative Assistants, Committee Managers, Committee
11 Secretaries and Proofreaders; and

14 retired from other governmental service, bringing a vast amount of
15 knowledge and experience, while others bring talent and expertise
