**A BILL**

To enact section 1546.31 of the Revised Code to 1  
change the name of "Mosquito Lake State Park" to 2  
"Donald J. Trump State Park" and to make an 3  
appropriation. 4

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 1546.31 of the Revised Code be 5  
enacted to read as follows: 6

**Sec. 1546.31.** The chief of the division of parks and 7  
watercraft shall change the name of "Mosquito Lake State Park" 8  
to "Donald J. Trump State Park." The chief shall erect suitable 9  
markers in the state park indicating its new name. 10

**Section 2.** All items in this act are hereby appropriated 11  
as designated out of any moneys in the state treasury to the 12  
credit of the designated fund. For all operating appropriations 13  
made in this act, those in the first column are for fiscal year 14  
2022 and those in the second column are for fiscal year 2023. 15  
The operating appropriations made in this act are in addition to 16  
any other operating appropriations made for the FY 2022-FY 2023 17  
biennium. 18

SPECIAL PURPOSE PROJECTS 21

The foregoing appropriation item 725521, Special Purpose 22  
Projects, shall be used by the Chief of the Division of Parks 23  
and Watercraft to erect suitable markers pursuant to section 24  
1546.31 of the Revised Code. 25

**Section 3.** Within the limits set forth in this act, the 26  
Director of Budget and Management shall establish accounts 27  
indicating the source and amount of funds for each appropriation 28  
made in this act, and shall determine the form and manner in 29  
which appropriation accounts shall be maintained. Expenditures 30  
from operating appropriations contained in this act shall be 31  
accounted for as though made in the main operating 32  
appropriations act of the 134th General Assembly. The operating 33  
appropriations made in this act are subject to all provisions of 34  
the main operating appropriations act of the 134th General 35  
Assembly that are generally applicable to such appropriations. 36
