A BILL

To amend sections 5101.63 and 5101.99 of the Revised Code to make failure to make a mandatory report of adult abuse, neglect, or exploitation a fourth degree misdemeanor.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 5101.63 and 5101.99 of the Revised Code be amended to read as follows:

Sec. 5101.63. (A) (1) ~~Any individual~~ No person listed in division (A) (2) of this section having reasonable cause to believe that an adult is being abused, neglected, or exploited, or is in a condition which is the result of abuse, neglect, or exploitation shall knowingly fail to immediately report such belief to the county department of job and family services.

(2) All of the following are subject to division (A) (1) of this section:

(B) Any person having reasonable cause to believe that an adult has suffered abuse, neglect, or exploitation may report, or cause a report to be made of such belief to the county department of job and family services.	92 93 94 95

(C) The reports made under this section shall be made	99
orally or in writing except that oral reports shall be followed	100
by a written report if a written report is requested by the	101
department. Written reports shall include:	102
(1) The name, address, and approximate age of the adult	103
who is the subject of the report;	104
(2) The name and address of the individual responsible for	105
the adult's care, if any individual is, and if the individual is	106
known;	107
(3) The nature and extent of the alleged abuse, neglect,	108
or exploitation of the adult;	109
(4) The basis of the reporter's belief that the adult has	110
been abused, neglected, or exploited.	111
(D) Any person with reasonable cause to believe that an	112
adult is suffering abuse, neglect, or exploitation who makes a	113
report pursuant to this section or who testifies in any	114
administrative or judicial proceeding arising from such a	115
report, or any employee of the state or any of its subdivisions	116
who is discharging responsibilities under section 5101.65 of the	117
Revised Code shall be immune from civil or criminal liability on	118
account of such investigation, report, or testimony, except	119
liability for perjury, unless the person has acted in bad faith	120
or with malicious purpose.	121
(E) No employer or any other person with the authority to	122
do so shall do any of the following as a result of an employee's	123
having filed a report under this section:	124

(1) Discharge, demote, transfer, or prepare a negative work performance evaluation;	125 126
(2) Reduce benefits, pay, or work privileges;	127
(3) Take any other action detrimental to an employee or in any way retaliate against the employee.	128 129
(F) The written or oral report provided for in this section and the investigatory report provided for in section 5101.65 of the Revised Code are confidential and are not public records, as defined in section 149.43 of the Revised Code. In accordance with rules adopted by the department of job and family services, information contained in the report shall upon request be made available to the adult who is the subject of the report and to legal counsel for the adult. If it determines that there is a risk of harm to a person who makes a report under this section or to the adult who is the subject of the report, the county department of job and family services may redact the name and identifying information related to the person who made the report.	130 131 132 133 134 135 136 137 138 139 140 141 142
(G) The county department of job and family services shall be available to receive the written or oral report provided for in this section twenty-four hours a day and seven days a week.	143 144 145
Sec. 5101.99. (A) Whoever violates division (A) of section 5101.63 of the Revised Code shall be fined not more than five hundred dollars.	146 147 148
(B) Whoever violates division (A) of section 5101.27 of the Revised Code is guilty of a misdemeanor of the first degree.	149 150
(C) <u>(B) Whoever violates section 5101.133, division (A) of section 5101.63, or division (C) (2) of section 5101.631 of the Revised Code is guilty of a misdemeanor of the fourth degree.</u>	151 152 153
