A BILL

To require the State Board of Education to 1
establish criteria and procedures for the 2
awarding of school safety funds to school 3
districts and to make an appropriation. 4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. Money may be distributed to a school district 5
under Section 2 of this act only upon the approval of an 6
application submitted by the district. The State Board of 7
Education shall prescribe an application form and establish 8
criteria for the awarding of funds and procedures for the 9
consideration and approval of applications. 10

Section 2. All items in this section are hereby 11
appropriated as designated out of any moneys in the state 12
treasury to the credit of the designated fund. For all 13
appropriations made in this act, those in the first column are 14
for fiscal year 2018 and those in the second column are for 15
fiscal year 2019. The appropriations made in this act are in 16
addition to any other appropriations made for the FY 2018-FY 17
2019 biennium. 18

SCHOOL SAFETY 25

The foregoing appropriation item 200591, School Safety, 26
shall be distributed to school districts to be used for school 27
safety purposes. Upon approval of an application, the funds 28
shall be distributed based on school district enrollment as 29
follows: (1) up to \$25,000 per year to a district with fewer 30
than 1,000 enrolled students, (2) up to \$50,000 per year to a 31
district with between 1,000 and 2,000 enrolled students, (3) up 32
to \$75,000 per year to a district with greater than 2,000 but 33
fewer than 10,000 enrolled students, and (4) up to \$100,000 per 34
year to a district with 10,000 or more enrolled students. 35

Section 3. Within the limits set forth in this act, the 36
Director of Budget and Management shall establish accounts 37
indicating the source and amount of funds for each appropriation 38
made in this act, and shall determine the form and manner in 39
which appropriation accounts shall be maintained. Expenditures 40
from appropriations contained in this act shall be accounted for 41
as though made in the main operating appropriations act of the 42
132nd General Assembly. 43

The appropriations made in this act are subject to all 44
provisions of the main operating appropriations act of the 132nd 45
General Assembly that are generally applicable to such 46

appropriations.
