BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Billion Three Hundred Twelve Million One Hundred Thirty-nine Thousand One Hundred Fifty-seven Dollars (\$1,312,139,157.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created by Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of One Billion Thirty-six Million Seven Hundred One Thousand Three Hundred Sixty-six Dollars (\$1,036,701,366.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Common Education Technology Revolving Fund, the sum of Forty-seven Million Twenty-five Thousand Seven Hundred One Dollars (\$47,025,701.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Twenty-seven Million

Seven Hundred Eighty-seven Thousand Five Hundred Dollars

(\$27,787,500.00) or so much thereof as may be necessary for the

financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2022, the sum of Nine Million Two Hundred Eighty-six Thousand Eight Hundred Twenty Dollars (\$9,286,820.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30 2024, the sum of Four Million Seven Hundred Seventy-one Thousand Fifteen Dollars (\$4,771,015.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Hundred Twenty-one Million Three Hundred Nineteen Thousand Twenty-six Dollars (\$121,319,026.00) or so much thereof as may be necessary for the support of public school activities.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Three Hundred Fifty-nine Million One Hundred Ninety-three Thousand Four Hundred Seventy Dollars (\$359,193,470.00) or so much thereof as may be necessary for the Certified Employee Health Benefit Allowance.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of One Hundred Ninety-four Million Two Hundred Eleven Thousand Three Hundred Fifty-nine Dollars (\$194,211,359.00) or so much thereof as may be necessary for the Support Personnel Health Benefit Allowance.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Nineteen Million One Hundred Forty-five Thousand Three Hundred Sixty-six Dollars (\$19,145,366.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2022, the sum of Forty-five Million One Hundred

Ninety Thousand Dollars (\$45,190,000.00) or so much thereof as may

be necessary for the purchase of textbooks and instructional

materials.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Three Million Eightyseven Thousand Five Hundred Dollars (\$3,087,500.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2022, the sum of One Million Thirty-one Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Three Million Eighty-seven Thousand Five Hundred Dollars (\$3,087,500.00) or so much thereof as

may be necessary for transfer to the Teachers' Retirement System

Dedicated Revenue Revolving Fund.

SECTION 15. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2022, the sum of One Million Thirty-one Thousand Eight Hundred Sixty-nine Dollars (\$1,031,869.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 16. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2021, the sum of Eighty-seven Million Seven Hundred Thousand Dollars (\$87,700,000.00) to be transferred to the Ad Valorem Reimbursement Fund, created pursuant to Section 193 of Title 62 of the Oklahoma Statutes, for the purpose of reimbursing counties for school districts that claim a loss of revenue due to a tax exemption granted pursuant to the provisions of Section 6B of Article X of the Oklahoma Constitution.

SECTION 17. There is hereby appropriated to the State Board of Education for deposit in the State Public Common School Building Equalization Fund created by Section 32 of Article X of the Oklahoma Constitution, from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year

ending June 30, 2022, Forty-four Million Dollars (\$44,000,000.00) to

be distributed as redbud school grants as provided in Section 3-104

of Title 70 of the Oklahoma Statutes.

SECTION 18. For the fiscal year ending June 30, 2024, the State Board of Education is hereby authorized to transfer from the Teachers' Retirement System Dedicated Revenue Revolving Fund to the Teachers' Retirement System of Oklahoma the sum of Four Hundred Sixty Million One Hundred Fifty-two Thousand Two Hundred Ten Dollars (\$460,152,210.00) and from appropriations provided in Sections 14 and 15 of this act, in the amounts provided in those sections for the purposes prescribed in Section 34.93 of Title 62 of the Oklahoma Statutes.

SECTION 19. FINANCE

SECTION 41. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2024, the sum of Thirty-seven Million One Hundred Seventy-four Thousand Four Hundred Seventeen Dollars (\$37,174,417.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission by law. Of those funds appropriated, the Oklahoma Tax Commission shall pay an amount not to exceed Two Hundred Fifty Thousand Dollars (\$250,000.00) for the personal services and other operating expenses of the Office of the State Auditor and Inspector in performing audits of the Oklahoma Tax Commission and licensed operators as required by law.
