11 PROPOSED COMMITTEE SUBSTITUTE

12 An Act relating to the Oklahoma Capitol Improvement
13 Authority; providing for allocation of funds from the
14 Legacy Capital Financing Fund; authorizing
15 utilization of certain amount for the purpose of
16 benefitting the University of Oklahoma; requiring
17 certain recapitalization payments; authorizing
18 certain distributions; authorizing and limiting
19 utilization of memoranda of understanding; providing
20 for codification; providing an effective date; and
21 declaring an emergency.

22 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

23 SECTION 1. NEW LAW A new section of law to be codified
24 in the Oklahoma Statutes as Section 187A-8 of Title 73, unless there
is created a duplication in numbering, reads as follows:

1 A. In addition to any other authorization provided by law, the
2 Oklahoma Capitol Improvement Authority is authorized to utilize
3 available funds from the Legacy Capital Financing Fund created by
4 Section 187B of Title 73 of the Oklahoma Statutes, in the amount of
5 Eighty Million Dollars (\$80,000,000.00) for the benefit of the
6 University of Oklahoma to construct or expand facilities utilized in
7 the instruction of engineering curriculum to increase capacity for
8 research, experiential learning, and engineering collaboration
9 spaces.

10 B. LCF Recapitalization Payments shall be made by the
11 University of Oklahoma related to the distribution of proceeds
12 provided in subsection A of this section, in accordance with the
13 provisions of the Legacy Capital Financing Act.

14 C. The Authority may distribute funds authorized pursuant to
15 subsection A of this section in one or more tranches.

16 D. The Authority may enter memoranda of understanding with
17 agencies, departments, and subdivisions of the state as needed, to
18 facilitate the provisions of this act, provided that such memoranda
19 of understanding do not constitute a legal obligation of the State
20 of Oklahoma or impede the administration of the provisions of the
21 Legacy Capital Financing Act.

22 SECTION 2. This act shall become effective July 1, 2024.

23 SECTION 3. It being immediately necessary for the preservation
24 of the public peace, health or safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
