be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies received by the Oklahoma Water Resources Board from legislative appropriations provided for the purpose of providing levee improvements and matching funds for levee projects along the Arkansas River. All monies accruing to the credit of the fund are hereby appropriated and may be budgeted and expended by the Oklahoma Water Resources Board for the purpose provided for in this section. Expenditures from the fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.

- B. Notwithstanding any other provision of law, income and earnings on the fund shall accrue to the fund and may be used for the purposes provided for in this section.
- SECTION 2. There is hereby appropriated to the Oklahoma Water Resources Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2023, the sum of Fifty Million Dollars (\$50,000,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Board by law.
- 21 SECTION 3. This act shall become effective July 1, 2024.
- SECTION 4. It being immediately necessary for the preservation of the public peace, health or safety, an emergency is hereby
