Supp. 2023, 11 Section 1137.1), which relates to used dealer license and registration; modifying required components of 12 temporary license plates; providing exception; modifying period of validity of temporary license 13 plate; requiring certain documentation be submitted; amending 47 O.S. 2021, Section 1137.2, as amended by 14 Section 171, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2023, Section 1137.2), which relates to authority to 15 issue dealer license plates; authorizing Oklahoma New Motor Vehicle Commission and the Oklahoma Used Motor 16 Vehicle, Dismantler, and Manufactured Housing Commission to designate certain vendor; amending 47 17 O.S. 2021, Section 1137.3, as last amended by Section 2, Chapter 262, O.S.L. 2023 (47 O.S. Supp. 2023, 18 Section 1137.3), which relates to registration and licensing after purchase; modifying certain 19 purchasers required to register vehicle or trailer; modifying required components of temporary license 20 plates; providing exception; requiring dealer to submit certain documentation and information to 21 Service Oklahoma or licensed operator; amending 47 O.S. 2021, Section 1141.1, as last amended by Section 22 13, Chapter 47, 1st Extraordinary Session, O.S.L. 2023 (47 O.S. Supp. 2023, Section 1141.1), which 23 relates to retention of taxes and fees by licensed operator; authorizing Service Oklahoma to set 24

licensed operator compensation for certain documentation processing and license plate and decal issuance; updating statutory language; updating statutory reference; providing for codification; and providing an effective date.

6 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 1137.4 of Title 47, unless there
is created a duplication in numbering, reads as follows:

A. The Oklahoma New Motor Vehicle Commission and the Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing Commission shall have the power and duty to promulgate rules and procedures to designate and register authorized temporary license plate vendors in this state. The Commissions may impose a vendor registration fee not to exceed Six Hundred Dollars (\$600.00) and a subsequent annual renewal fee not to exceed Six Hundred Dollars (\$600.00).

B. Oklahoma New Motor Vehicle Commission and the Oklahoma Used
Motor Vehicle, Dismantler, and Manufactured Housing Commission
selected vendors shall:

Provide pre-printed temporary license plates, or software
 services or the equipment and supplies necessary to print temporary
 license plates to dealers licensed by the Oklahoma New Motor Vehicle
 Commission and the Oklahoma Used Motor Vehicle, Dismantler, and
 Manufactured Housing Commission;

2. Provide a method for such dealers to electronically enter
 required purchaser information for each vehicle purchase; and

3 3. Electronically submit such required purchaser information to
4 Service Oklahoma in a manner that protects and meets security
5 requirements promulgated by the Commissions every twenty-four (24)
6 hours in a format that is readily accessible by Service Oklahoma.

7 4. The Commissions shall also be granted the power to revoke 8 the designation and registration of and administer fines and 9 penalties, not to exceed Ten Thousand Dollars (\$10,000.00) per 10 occurrence, to designated and registered temporary license plate 11 vendors that fail to comply with the provisions of this section.

12 5. The Commissions shall also be granted the power to require13 the selected vendors to do the following:

a. obtain a Fifty thousand Dollar (\$50,000.00) bond, and
b. obtain commercial liability insurance with a minimum
coverage amount of One Million Dollars

17 (\$1,000,000.00).

B. Temporary license plates issued by authorized temporarylicense plate vendors shall be required to include:

A sequential three-character prefix, unique to the
 individual authorized temporary license plate vendor, followed by a
 five-digit tag number;

23 2. The name of this state;

24 3. The name of the vehicle purchaser;

- 4. The date of expiration;

5. The name of the dealer and the dealer license number; and 6. The year, make, and model of the vehicle. Provided, the name of the vehicle purchaser shall not be required to be included on the temporary license plate if the vendor holds a record of the name of the vehicle purchaser and the bill of sale is carried in the vehicle.

8 SECTION 2. AMENDATORY 47 O.S. 2021, Section 563, as 9 amended by Section 4, Chapter 29, O.S.L. 2023 (47 O.S. Supp. 2023, 10 Section 563), is amended to read as follows:

Section 563. A. There is hereby created the Oklahoma New Motor 11 12 Vehicle Commission, to be composed of nine (9) members. Seven of 13 the members shall have been engaged in the manufacture, distribution, or sale of new motor vehicles and two members shall be 14 lay members, all to be appointed by the Governor of the State of 15 Oklahoma this state, with the advice and consent of the Senate. 16 Appointments shall be made within thirty (30) days after November 1, 17 1985. Each of the Commissioners thus appointed shall, at the time 18 of the appointment, be a resident in good faith of this state, shall 19 be of good moral character, and each of the industry related 20 industry-related Commissioners shall have been actually engaged in 21 the manufacture, distribution, or sale of new motor vehicles for not 22 less than ten (10) years preceding the appointment. The members of 23 the Commission shall serve at the pleasure of the Governor. 24

B. 1. The Commissioners shall elect a chair from amongst them
 whose term shall be for one (1) year with the right to succeed
 himself or herself.

2. There shall be three at large <u>at-large</u> members of the
Commission. Six members of the Commission shall be appointed from
the following geographical areas with at least one member from each
area:

a. four areas of the state shall be the northwest,
northeast, southwest, and southeast sections
designated by Interstate 35 dividing the state east
and west and Interstate 40 dividing the state north
and south, excluding Oklahoma County and Tulsa County,
and

b. two additional areas shall be Oklahoma County andTulsa County.

16 There shall not be more than two members of the Commission from any 17 one area.

18 C. The terms of office of the members first appointed to the 19 Commission shall be as follows:

The members appointed from the northwest, northeast, and
 southwest areas shall serve until June 30, 1987;

The members appointed from the southeast area and Oklahoma
 County and Tulsa County shall serve until June 30, 1989; and

3. The members appointed at large shall serve until June 30,
 1991.

Each member shall serve until a successor is appointed and 3 Thereafter, the term of office of each member of the 4 qualifies. 5 Commission shall be for six (6) years. The term of office of any member will automatically expire if the member moves out of the 6 geographical area from which the member was appointed. In event of 7 death, resignation, removal, or term automatically expiring of any 8 9 person serving on the Commission, the vacancy shall be filled by appointment as provided for the unexpired portion of the term. The 10 Commission shall meet at in Oklahoma City and complete its 11 organization immediately after the membership has been appointed and 12 has qualified. The chair and each member of the Commission shall 13 take and subscribe to the oath of office required of public 14 officers. 15

D. The members of the Commission shall receive reimbursement for subsistence and traveling expenses necessarily incurred in the performance of their duties as provided by the State Travel Reimbursement Act.

E. The Commission shall appoint a qualified person to serve as
Executive Director thereof, which person shall have had not less
than ten (10) years of experience in the motor vehicle industry.
The Executive Director shall be appointed for a term of six (6)
years, and shall not be subject to dismissal or removal without

The Commission shall fix the salary and prescribe the duties 1 cause. of the Executive Director. The Executive Director shall devote such 2 time as necessary to fulfill the duties thereof, and before entering 3 upon such duties shall take and subscribe to the oath of office. 4 5 The Executive Director may employ such clerical, technical, and other help and legal services and incur such expenses as may be 6 necessary for the proper discharge of the duties of the Executive 7 Director under Section 561 et seq. of this title. The Commission 8 shall maintain its office and transact its business in Oklahoma 9 City, and it is authorized to adopt and use a seal. The Executive 10 Director is hereby authorized to hire, retain, or otherwise acquire 11 12 the services of an attorney to represent the Commission in any and 13 all state and federal courts, and assist the Commission in any and all business or legal matters that may come before it. The attorney 14 so representing the Commission shall discharge the duties under the 15 direction of the Executive Director. 16

F. The Commission is hereby vested with the powers necessary to 17 enable it to fully and effectively carry out the provisions and 18 objects of Section 561 et seq. of this title and Section 1 of this 19 act, and is hereby authorized and empowered to make and enforce all 20 reasonable rules and to adopt and prescribe all forms necessary to 21 accomplish such purpose. All forms used by a new motor vehicle 22 dealer to facilitate the delivery of a vehicle pending approval of 23 financing shall be approved by the Commission. Spot delivery 24

agreement forms shall be required for all new motor vehicle
 deliveries subject to dealers finding lending institutions to
 purchase the retail installment contracts executed by the purchasing
 and selling parties.

5 G. All fees, charges, and fines collected under the provisions of Section 561 et seq. of this title and Section 1 of this act shall 6 be deposited by the Executive Director in the State Treasury in 7 accordance with the depository laws of this state in a special fund 8 to be known as the "Oklahoma New Motor Vehicle Commission Fund", 9 which is hereby created, and except as hereinafter provided the 10 monies in the fund shall be used by the Commission for the purpose 11 of carrying out and enforcing the provisions of Section 561 et seq. 12 of this title and Section 1 of this act. Expenditures from the fund 13 shall be made upon vouchers approved by the Commission or its 14 authorized officers. 15

At the close of each fiscal year, the Commission shall file with the Governor and the State Auditor and Inspector a true and correct report of all fees, fines, and charges collected and received by it during the preceding fiscal year and shall at the same time pay into the General Revenue Fund of the state a sum equal to ten percent (10%) of the fees, fines, and charges collected and received.

All expenses incurred by the Commission in carrying out the provisions of Section 561 et seq. of this title <u>and Section 1 of</u> this act, including but not limited to per diem, wages, salaries, 1 rent, postage, advertising, supplies, bond premiums, travel, and subsistence for the Commissioners, the Executive Director, 2 employees, and legal counsel, and printing and utilities, shall be a 3 proper charge against such fund, exclusive of the portion thereof to 4 5 be paid into the General Revenue Fund as above set out. In no event shall liability ever accrue hereunder against this state in any sum 6 whatsoever, or against the Oklahoma New Motor Vehicle Commission 7 Fund, in excess of the ninety percent (90%) of the fees, fines, and 8 9 charges deposited therein.

10 SECTION 3. AMENDATORY 47 O.S. 2021, Section 582, as 11 amended by Section 2, Chapter 107, O.S.L. 2022 (47 O.S. Supp. 2023, 12 Section 582), is amended to read as follows:

Section 582. A. There is hereby created the Oklahoma Used Motor Vehicle, Dismantler, and Manufactured Housing Commission, to be composed of ten (10) members who shall be selected as follows:

1. One member shall be appointed from each congressional 16 district and any remaining members, including the chair, shall be 17 appointed from the state at large. However, when congressional 18 districts are redrawn, each member appointed prior to July 1 of the 19 year in which such modification becomes effective shall complete the 20 current term of office and appointments made after July 1 of the 21 year in which such modification becomes effective shall be based on 22 the redrawn districts. Appointments made after July 1 of the year 23 in which such modification becomes effective shall be from any 24

redrawn districts which are not represented by a board member until such time as each of the modified congressional districts are represented by a board member; provided, the chair shall be appointed at large without regard to congressional district representation on the board;

6 2. All members shall be appointed by the Governor, by and with7 the advice and consent of the Senate;

3. each Each of the members appointed from a 8 a. 9 congressional district shall, at the time of appointment, be a resident in good faith of the 10 congressional district from which appointed, and 11 each Each of the members appointed from the state at 12 b. large shall, at the time of appointment and during the 13 period of service, be residents in good faith of the 14 15 state;

Each member shall be of good moral character and, for the 16 4. ten-year period immediately preceding appointment, each of the used 17 motor vehicle dealer representatives shall have been licensed for 18 and actually engaged in the distribution or sale of used motor 19 20 vehicles; each of the dismantler representatives shall have actually been licensed for and engaged in the principal business of 21 dismantling or disassembling motor vehicles for the purpose of 22 selling the parts thereof; and the manufactured housing 23

representative shall have been licensed for and actually engaged in
 the principal business of selling manufactured homes; and

Eight members plus the chair shall be engaged in the used 3 5. motor vehicle industry or the automotive dismantler industry. 4 There 5 shall not be fewer than five members engaged in the principal business of the sale of used motor vehicles and there shall not be 6 fewer than two members engaged in the principal business of 7 dismantling or disassembling motor vehicles for the purpose of 8 9 selling the parts thereof. One of the at-large members shall be engaged in the principal business of selling manufactured homes as a 10 licensed manufactured home dealer. Being engaged in one or more of 11 such pursuits shall not disqualify a person otherwise qualified from 12 13 serving on the Commission.

B. 1. The term of the chair shall be coterminous with that of the Governor making the appointment, and until a successor is appointed and is qualified.

17 2. The terms of office of each member of the Commission shall18 be subject to the following:

19a.the Commission shall determine and certify the trade20associations of manufactured home dealers that21represent ten percent (10%) or more of the number of22licensed manufactured home dealers in the state and23shall certify each such association to the Governor.24The Governor shall request a minimum of ten names from

- each such association and shall select one member from
 the manufactured home industry from the names
 provided,
- b. each member actively serving July 1, 2000, who was
 appointed on or before June 30, 2000, shall remain and
 fulfill the term of his or her membership as set forth
 at the appointment,
- except for the chair, the term of office of each 8 с. 9 member of the Commission shall be for six (6) years, d. except for the chair and the at-large members, the 10 term of office of any member will automatically expire 11 if the member moves out of the congressional district 12 from which appointed; however, if the congressional 13 districts are modified each member shall complete the 14 current term of office as provided in this section, 15 in event of death, resignation, or removal of any 16 e. person serving on the Commission, the vacancy shall be 17 filled by appointment as aforesaid for the unexpired 18 portion of the term, and 19
- f. except for the chair, when the term of a member automatically expires, the vacancy shall be filled by appointment of a qualified successor for a term of six (6) years as aforesaid, except that the member shall serve until a successor is appointed and qualified.

3. The chair and each member of the Commission shall take and
 subscribe to the oath of office required of public officers.

С. The chair and members of the Commission shall receive Thirty 3 Dollars (\$30.00) for each and every day actually and necessarily 4 5 spent in attending the meetings of the Commission, and shall be reimbursed for subsistence and traveling expenses incurred in the 6 performance of their duties hereunder as provided by the State 7 Travel Reimbursement Act; provided that such meeting payments shall 8 9 not exceed the sum of Six Hundred Dollars (\$600.00) per annum to any 10 one person.

- D. 1. a. The Commission shall appoint a qualified person to serve as Executive Director who shall have had sufficient management and organizational experience in the automotive industry to direct the functions of the Commission.
- b. The Executive Director shall be appointed for a term
 of six (6) years, and shall not be subject to
 dismissal or removal without cause.
- C. The Commission shall fix the salary and define and
 prescribe the duties of the Executive Director.
- d. The Executive Director shall be in charge of the
 Commission's office, shall devote such time as
 necessary to fulfill the duties thereof, and, before
- 24

entering upon these duties, shall take and subscribe to the oath of office.

2. The Commission may employ such clerical, technical, legal, 4 and other help and incur such expenses as may be necessary for the 5 proper discharge of its duties under Section 581 et seq. of this 6 title and Section 1 of this act.

7 3. The Commission shall maintain its office and transact its
8 business in Oklahoma City, and is authorized to adopt and use a
9 seal.

E. 1. a. The Commission is hereby vested with the powers and 10 duties necessary and proper to enable it to fully and 11 12 effectively carry out the provisions and objectives of Section 581 et seq. of this title and Section 1 of 13 this act, and is hereby authorized and empowered, 14 pursuant to the Administrative Procedures Act, to make 15 and enforce all reasonable rules and to adopt and 16 prescribe all forms necessary to accomplish said such 17 18 purpose.

b. The Commission shall promulgate rules for the
licensing of manufactured home installers and the
installation, which is the blocking, anchoring, and
leveling of mobile and manufactured homes that meet
the standards of the manufacturer's manual or the
Commission.

- c. The Commission shall promulgate rules to prescribe the
 contents of manufactured home sales agreements and to
 require that each manufactured home manufacturer issue
 with each new manufactured home a warranty comparable
 to warranties generally in use in the industry
 warranting the manufactured home to be free from
 material defects.
- 8 d. The enumeration of any power or authority herein shall 9 not be construed to deny, impair, disparage, or limit 10 any others necessary to the attainment thereof.
- e. A copy of all rules adopted by the Commission shall be
 filed and recorded in the office Office of the
 Secretary of State and the State Librarian and <u>State</u>
 Archivist, and same may be amended, modified, or
 repealed from time to time.
- 16 2. The Commission's powers and duties shall include, but not be 17 limited to, the following:
- a. to license used motor vehicle dealers, wholesale used
 motor vehicle dealers, dismantlers, manufactured home
 dealers, manufactured home manufacturers, and
 manufactured home installers,
- b. to inspect used motor vehicle dealer, dismantler and
 manufactured home dealer locations, and manufactured
 home manufacturers' factories or assembly sites to

ensure that they are in an approved location, meet local zoning or other municipal requirements, and have sufficient facilities which shall include, but not be limited to, for retail businesses, a business sign, a listed and usable telephone number, a restroom, and a sales office,

- to inspect wholesale used motor vehicle dealer 7 с. locations to ensure that they are in an approved 8 9 location, meet local zoning or other municipal requirements, and have sufficient facilities which 10 shall include, but not be limited to, a listed and 11 12 usable telephone number in the dealer's name and a business office where records of the business are 13 kept, 14
- d. to require all dealer sales to have a condition of
 sale such as a warranty disclaimer, implied or written
 warranty, or a service contract approved by the
 Commission,
- e. to work with consumers and dealers to hear complaints
 on used vehicles and manufactured homes, including
 installation, and
- f. to serve as a dispute resolution panel for binding
 arbitration in accordance with Section 1851 et seq. of
 Title 12 of the Oklahoma Statutes in contract

controversies between licensed used motor vehicle dealers, dismantlers, and manufactured housing dealers, manufactured home dealers, installers, and manufacturers and their consumers when, by mutual written agreement executed after the dispute between the parties has arisen, both parties have agreed to use the Commission as their arbitration panel for contract disputes.

9 F. 1. All fees and charges collected under the provisions of 10 Section 581 et seq. of this title and Section 1 of this act shall be deposited by the Executive Director in the State Treasury in 11 12 accordance with the depository laws of this state in a special fund to be known as the "Oklahoma Used Motor Vehicle, Dismantler, and 13 Manufactured Housing Commission Fund", which fund is hereby created. 14 Except as hereinafter provided, the monies in the fund shall be used 15 by the Commission for the purpose of carrying out and enforcing the 16 provisions of Section 581 et seq. of this title and Section 1 of 17 Expenditures from the fund shall be warrants issued by 18 this act. the State Treasurer against claims submitted by the Commission to 19 the Director of the Office of Management and Enterprise Services for 20 approval. 21

22 2. At the close of each fiscal year, the Commission shall file 23 with the Governor and the State Auditor and Inspector a true and 24 correct report of all fees and charges collected and received by it

All expenses incurred by the Commission in carrying out the 4 5 provisions of Section 581 et seq. of this title and Section 1 of this act including, but not limited to, per diem, wages, salaries, 6 rent, postage, advertising, supplies, bond premiums, travel, and 7 subsistence for the Commissioners, the Executive Director, 8 9 employees, and legal counsel, and printing and utilities, shall be a proper charge against the fund, exclusive of the portion thereof to 10 be paid into the General Revenue Fund as above set out; provided, 11 12 that in no event shall liability ever accrue hereunder against the state in any sum whatsoever, or against the Oklahoma Used Motor 13 Vehicle, Dismantler, and Manufactured Housing Commission Fund, in 14 excess of the ninety percent (90%) of the fees and charges deposited 15 therein. 16

SECTION 4. AMENDATORY 47 O.S. 2021, Section 1102, as last amended by Section 106, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 2023, Section 1102), is amended to read as follows:

20 Section 1102. As used in the Oklahoma Vehicle License and 21 Registration Act:

22 1. "All-terrain vehicle" means a vehicle manufactured and used
 23 exclusively for off-highway use traveling on four or more non 24 highway tires, and being fifty (50) inches or less in width;

2. "Carrying capacity" means the carrying capacity of a vehicle
 as determined or declared in tons of cargo or payload by the owner;
 provided, that such declared capacity shall not be less than the
 minimum tonnage capacity fixed, listed or advertised by the
 manufacturer of any vehicle;

3. "Certificate of title" means a document which is proof of
legal ownership of a motor vehicle as described and provided for in
8 Section 1105 of this title;

9 4. "Chips and oil" or the term "road oil and crushed rock" means, with respect to materials authorized for use in the surfacing 10 of roads or highways as provided for in this title or in any 11 12 equivalent statute pertaining to road or highway surfacing in the State of Oklahoma this state, any asphaltic materials. 

1 issue to the owner of the vehicle a certificate of 2 registration, one license plate and a yearly decal. For each subsequent registration year, Service 3 Oklahoma shall issue a yearly decal to be affixed to 4 5 the license plate. The initial decal for a streetlegal utility vehicle shall be attached to the front 6 of the vehicle and shall be in clear view. 7 The yearly decal shall have an identification number and the last 8 9 two numbers of the registration year for which it 10 shall expire. Except as provided by Section 1113A of this title, the license plate shall be affixed to the 11 12 exterior of the vehicle until a replacement license plate is issued. If the owner applies for a 13 replacement license plate, Service Oklahoma shall 14 charge the fee provided for in Section 1114 of this 15 title. The yearly decal will validate the license 16 plate for each registration period other than the year 17 the license plate is issued. The license plate and 18 decal shall be of such size, color, design, and 19 numbering as Service Oklahoma may direct. However, 20 yearly decals issued to the owner of a vehicle who has 21 filed an affidavit with the appropriate licensed 22 operator in accordance with Section 7-607 of this 23

title shall be a separate and distinct color from all other decals issued under this section.

Service Oklahoma shall design and issue a temporary 3 b. tag to out-of-state owners of street-legal utility 4 5 vehicles. The temporary tag shall be recognized in lieu of registration in this state. The temporary tag 6 shall clearly indicate the date of issuance and the 7 date of expiration, which shall be five (5) days, 8 9 including the day of issuance. Upon application for a temporary tag, the out-of-state owner shall show proof 10 of insurance coverage that satisfies the requirements 11 12 of the Compulsory Insurance Law pursuant to Section 7-600 et seq. of this title. Service Oklahoma is 13 authorized to promulgate rules and procedures to 14 implement the provisions of this paragraph. 15

The license plate shall be securely attached to the rear of 16 3. the vehicle, except truck-tractor plates which shall be attached to 17 the front of the vehicle. Service Oklahoma may, with the 18 concurrence of the Department of Public Safety, by Joint Rule, 19 change and direct the manner, place, and location of display of any 20 vehicle license plate when such action is deemed in the public 21 interest. The license plate, decal and all letters and numbers 22 shall be clearly visible at all times. The operation of a vehicle 23 in this state, regardless of where such vehicle is registered, upon 24

which the license plate is covered, overlaid, or otherwise screened
 with any material, whether such material be clear, translucent,
 tinted or opaque, shall be a violation of this paragraph.

4. Upon payment of the annual registration fee provided in 4 5 Section 1133 of this title, Service Oklahoma or the Corporation Commission, as applicable, or a licensed operator may issue a 6 permanent nonexpiring license plate to an owner of one hundred or 7 more commercial motor vehicles and for vehicles registered under the 8 9 provisions of Section 1120 of this title. Upon payment of the annual registration fee, Service Oklahoma or the Corporation 10 Commission shall issue a certificate of registration that shall be 11 carried at all times in the vehicle for which it is issued. 12 13 Provided, if the registrant submits its application through electronic means, such qualified owners of one hundred or more 14 commercial motor vehicles, properly registered pursuant to the 15 provisions of Section 1133 of this title, may elect to receive a 16 permanent certificate of registration that shall be carried at all 17 times in the vehicle for which it is issued. 18

Every vehicle owned by an agency of this state shall be
 exempt from the payment of registration fees required by this title.
 Provided, such vehicle shall be registered and shall otherwise
 comply with the provisions of the Oklahoma Vehicle License and
 Registration Act.

B. The license plates required under the provisions of this title shall conform to the requirements and specifications listed hereinafter:

Each license plate shall have a space for the placement of
 the yearly decals for each succeeding year of registration after the
 initial issue;

7 2. The provisions of the Oklahoma Vehicle License and
8 Registration Act regarding the issuance of yearly decals shall not
9 apply to the issuance of apportioned license plates, including
10 license plates for state vehicles, and exempt plates for
11 governmental entities and fire departments organized pursuant to
12 Section 592 of Title 18 of the Oklahoma Statutes;

3. All license plates and decals shall be made with reflectorized material as a background to the letters, numbers and characters displayed thereon. The reflectorized material shall be of such a nature as to provide effective and dependable brightness during the service period for which the license plate or decal is issued;

4. Except as otherwise provided in this subsection, Service Oklahoma shall design appropriate official license plates for all state vehicles. Such license plates shall be permanent in nature and designed in such manner as to remain with the vehicle for the duration of the vehicle's life span or until the title is transferred to a nongovernmental owner;

5. Within the limits prescribed in this section, Service
 Oklahoma shall design appropriate official license plates for
 vehicles of the Oklahoma Highway Patrol. The license plates shall
 have the legend "Oklahoma OK" and shall contain the letters "OHP"
 followed by the state seal and the badge number of the Highway
 Patrol officer to whom the vehicle is assigned. The words "Oklahoma
 Highway Patrol" shall also be included on such license plates;

6. Within the limits prescribed in this section, Service 8 9 Oklahoma shall design appropriate official license plates for 10 vehicles of the Oklahoma Military Department of the State of Such license plates shall have the legend "Oklahoma OK" 11 Oklahoma. and shall contain the letters "OMD" followed by the state seal and 12 three numbers or letters as designated by the Adjutant General. 13 The words "Oklahoma Military Department" shall also be included on such 14 license plates; 15

7. Within the limits prescribed in this section, Service 16 Oklahoma shall design appropriate official license plates for 17 vehicles of the Oklahoma Department of Corrections. Such license 18 plates shall contain the letters "DOC" followed by the Department of 19 Corrections badge and three numbers or letters or combination of 20 both as designated by the Director of the agency. The words 21 "Department of Corrections" shall also be included on such license 22 plates; and 23

1 8. Within the limits prescribed in this section, the Oklahoma 2 Tourism and Recreation Department shall design any license plates required by the initiation of a license plate reissuance by Service 3 Oklahoma at the request of the Department of Public Safety pursuant 4 5 to the provisions of Section 1113.2 of this title. Any such new designs shall be submitted by the Oklahoma Tourism and Recreation 6 Department to the Department of Public Safety for its approval prior 7 to being issued by Service Oklahoma. 8

9 C. Where the applicant has satisfactorily shown that the applicant owns the vehicle sought to be registered but is unable to 10 produce documentary evidence of the ownership, a license plate may 11 12 be issued upon approval by Service Oklahoma or the Corporation 13 Commission, as applicable. In such instances the reason for not issuing a certificate of title shall be indicated on the receipt 14 given to the applicant. It shall still be the duty of the applicant 15 to immediately take all necessary steps to obtain the Oklahoma 16 17 certificate of title and it shall be unlawful for the applicant to sell the vehicle until the certificate has been obtained in the 18 applicant's name. 19

D. The certificate of registration provided for in this section shall be in convenient form, and the certificate of registration, or a certified copy or photostatic copy thereof, duly authenticated by Service Oklahoma or the Corporation Commission, as applicable, shall be carried at all times in or upon all vehicles so registered, in

1 such manner as to permit a ready examination thereof upon demand by 2 any peace officer of the state or duly authorized employee of the Department of Public Safety. Any such officer or agent may seize 3 and hold such vehicle when the operator of the same does not have 4 5 the registration certificate in the operator's possession or when any such officer or agent determines that the registration 6 certificate has been obtained by misrepresentation of any essential 7 or material fact or when any number or identifying information 8 9 appearing on such certificate has been changed, altered, obliterated or concealed in any way, until the proper registration or 10 identification of such vehicle has been made or produced by the 11 12 owner thereof.

Ε. The purchaser of a new or used manufactured home shall, 13 within thirty (30) days of the date of purchase, register the home 14 with Service Oklahoma or a licensed operator pursuant to the 15 provisions of Section 1117 of this title. For a new manufactured 16 home, it shall be the responsibility of the dealer selling the home 17 to place a temporary license plate on the home in the same manner as 18 provided in Section 1128 of this title for other new motor vehicles. 19 For the first year that any manufactured home is registered in this 20 state, Service Oklahoma shall issue a metal license plate which 21 shall be affixed to the manufactured home. The temporary dealer 22 license plate or the metal license plate shall be displayed on the 23 manufactured home at all times when upon a public roadway; provided, 24

1 a repossession affidavit issued pursuant to Sections 1110 and 1126 of this title shall be permissible in lieu of a current license 2 plate and decal for the purposes of removing a repossessed 3 manufactured home to a secure location. Manufactured homes 4 5 previously registered and subject to ad valorem taxation as provided by law shall have a decal affixed at the time ad valorem taxes are 6 paid for such manufactured home; provided, for a manufactured home 7 permanently affixed to real estate, no decal or license plate shall 8 9 be required to be affixed and the owner thereof shall be given a 10 receipt upon payment of ad valorem taxes due on the home. Service Oklahoma shall make sufficient plates and decals available to the 11 12 various licensed operators of the state in order for an owner of a 13 manufactured home to acquire the plate or decal. A one-dollar fee shall be charged for issuance of any plate or decal. The fee shall 14 be apportioned each month to the General Revenue Fund of the State 15 Treasury. 16

F. The decal shall be easily visible for purposes of 17 verification by a county assessor that the manufactured home is 18 properly assessed for ad valorem taxation. In the first year of 19 registration, a decal shall be issued for placement on the license 20 plate indicating payment of applicable registration fees and excise 21 taxes. A duplicate manufactured home registration decal shall be 22 affixed inside the window nearest the front door of the manufactured 23 In the second and all subsequent years for which the 24 home.

1 manufactured home is subject to ad valorem taxation, an annual decal 2 shall be affixed inside the window nearest the front door as 3 evidence of payment of ad valorem taxes. Service Oklahoma shall 4 issue decals to the various county treasurers of the state in order 5 for a manufactured home owner to obtain such decal each year. Upon 6 presentation of a valid ad valorem tax receipt, the manufactured 7 home owner shall be issued the annual decal.

G. Upon the registration of a manufactured home in this state
for the first time or upon discovery of a manufactured home
previously registered within this state for which the information
required by this subsection is not known, Service Oklahoma shall
obtain:

13 1. The name of the owner of the manufactured home;

14 2. The serial number or identification number of the15 manufactured home;

3. A legal description or address of the location for the home;
4. The actual retail selling price of the manufactured home
excluding Oklahoma taxes;

19 5. The certificate of title number for the home; and

Any other information which Service Oklahoma deems to be
 necessary.

The application for registration shall also include the school district in which the manufactured home is located or is to be located. The information shall be entered into a computer data

1 system which shall be used by Service Oklahoma to provide 2 information to county assessors upon request by the assessor. The assessor may request any information from the system in order to 3 properly assess a manufactured home for ad valorem taxation. 4 5 SECTION 8. AMENDATORY 47 O.S. 2021, Section 1113A, as amended by Section 128, Chapter 282, O.S.L. 2022 (47 O.S. Supp. 6 2023, Section 1113A), is amended to read as follows: 7 Section 1113A. A. As used in this section: 8 "First vehicle" means the vehicle from which a license plate 9 1. is removed and transferred to a second vehicle; 10 "Second vehicle" means the vehicle to which a license plate 11 2. is transferred after removal from a first vehicle; and 12 3. In the event a person fails to obtain a replacement license plate as provided for in this section within the time prescribed for the registration of the new or used second vehicle, a penalty of twenty-five cents (\$0.25) per day shall be assessed from the day following the period prescribed for registration to the date of acquisition of the replacement license plate, such penalty to accrue

1 for no more than thirty (30) days, at the end of which time the penalty shall be twice the registration cost of such vehicle. 2 SECTION 9. 47 O.S. 2021, Section 1132, as 3 AMENDATORY last amended by Section 146, Chapter 282, O.S.L. 2022 (47 O.S. The registration fee provided for in this subsection shall be in

On and after January 1, 2022, if a physically disabled license 4 5 plate is issued pursuant to paragraph 3 of subsection B of Section 1135.1 of this title, any registration fee required for such license 6 plate and the fee required pursuant to this subsection shall be 7 remitted at the same time and subject to a single registration 8 9 period. Upon receipt of a physically disabled license plate, the standard issue standard-issue license plate must be surrendered to 10 Service Oklahoma or the licensed operator. C. For utility vehicles used exclusively for use off roads or 12 highways purchased on or after July 1, 2008, and for utility 13 vehicles used exclusively for use off roads or highways purchased 14 prior to July 1, 2008, which the owner chooses to register pursuant 15 to the provisions of Section 1115.3 of this title, an initial and 16 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be 17 assessed at the time of initial registration by the owner. 18 Nine Dollars (\$9.00) of the registration fee shall be deposited in the 19 Oklahoma Tax Commission Reimbursement Fund through December 31, 20 2022, and beginning January 1, 2023, this fee shall be deposited in 21 the Service Oklahoma Reimbursement Fund. Two Dollars (\$2.00) of the 22 registration fee shall be retained by the licensed operator. The 23

fees required by subsection A of this section shall not be required

3 D. There shall be a credit allowed with respect to the fee for4 registration of a new vehicle which is a replacement for:

9 2. A defective new original vehicle returned by the 10 purchaser/registrant to the seller within six (6) months of the date 11 of purchase of the defective new original vehicle as certified by 12 the manufacturer.

The credit shall be in the amount of the fee for registration which was paid for the new original vehicle and shall be applied to the registration fee for the replacement vehicle. In no event will the credit be refunded.

Upon every transfer or change of ownership of a vehicle, the 17 Ε. new owner shall obtain title for and, except in the case of salvage 18 vehicles and manufactured homes, register the vehicle within thirty 19 (30) days two (2) months of change of ownership and pay a transfer 20 fee of Fifteen Dollars (\$15.00) in addition to any other fees 21 provided for in the Oklahoma Vehicle License and Registration Act. 22 Additionally, within two (2) business days of the date of the sale 23 or transfer of the motor vehicle, the parties must submit the 24

No new decal shall be issued to the registrant for an existing license plate. Thereafter, the owner shall register the 6 vehicle annually on the anniversary date of its initial registration 7 in this state and shall pay the fees provided in subsection A of 8 9 this section and receive a decal evidencing such payment. Provided, used motor vehicle dealers shall be exempt from the provisions of 10 this section. 11

In the event a new or used vehicle is not registered, titled, and tagged within thirty (30) days two (2) months from the 13 date of transfer of ownership, the penalty for the failure of the 14 owner of the vehicle to register the vehicle within thirty (30) days 15 two (2) months shall be One Dollar (\$1.00) per day, provided that in 16 no event shall the penalty exceed One Hundred Dollars (\$100.00). No 17 penalty shall be waived by Service Oklahoma or any licensed operator 18 except as provided in subsection C of Section 1127 of this title. 19 Of each dollar one-dollar penalty collected pursuant to this 20 subsection: 21

Twenty-one cents (\$0.21) shall be apportioned as provided in

Except for vehicles, travel trailers or 8 9 commercial trailers which display a current Oklahoma license tag, 10 upon the purchase or transfer of ownership of a used motor vehicle, travel trailer or commercial trailer, including an out-of-state 11 purchase or transfer of the same, to a licensed used motor vehicle 12 dealer, wholesale used motor vehicle dealer, used travel trailer 13 dealer or used commercial trailer dealer, subsequently referred to 14 in this section as "dealer", the dealer shall affix a used dealer's 15 plate visible from the rear of the vehicle, travel trailer or 16 commercial trailer. Such license plate shall expire on December 31 17 of each year. When the vehicle, travel trailer or commercial 18 trailer is parked on the dealer's licensed place of business, it 19 shall not be required to have a license plate of any kind affixed. 20 A dealer shall obtain from Service Oklahoma at a cost of Ten Dollars 21 (\$10.00) a dealer license plate for demonstrating, transporting or 22 any other normal business of a dealer including use by an individual 23 holding a valid salesperson's license issued by the Oklahoma Used 24

1 Motor Vehicle and Parts, Dismantler, and Manufactured Housing 2 Commission. Any dealer who operates a wrecker or towing service licensed pursuant to Sections 951 through 957 of this title shall 3 register each wrecker vehicle and display a wrecker license plate on 4 5 each vehicle as required by Section 1134.3 of this title. A dealer may obtain as many additional license plates as may be desired upon 6 the payment of Ten Dollars (\$10.00) for each additional license 7 plate. Use of the used dealer license plate by a licensed dealer 8 9 for other than the purposes as set forth herein shall constitute grounds for revocation of the dealer's license. Service Oklahoma 10 shall design the official used dealer license plate to include the 11 12 used dealer's license number issued to him or her each year by 13 Service Oklahoma or the Oklahoma Used Motor Vehicle and Parts, Dismantler, and Manufactured Housing Commission. 14

B. Upon the purchase or transfer of ownership of an out-of-15 state used motor vehicle, travel trailer or commercial trailer to a 16 17 licensed dealer, the dealer shall make application for an Oklahoma certificate of title pursuant to the Oklahoma Vehicle License and 18 Registration Act, Section 1101 et seq. of this title. Upon receipt 19 of the Oklahoma certificate of title, the dealer shall follow the 20 procedure as set forth in subsection A of this section. Provided, 21 nothing in this title shall be construed as requiring a dealer to 22 register a used motor vehicle, travel trailer or commercial trailer 23

1 purchased in another state which will not be operated or sold in 2 this state.

C. Upon sale or transfer of ownership of the used motor vehicle 3 or travel trailer, the dealer shall place upon the reassignment 4 5 portion of the certificate of title a tax stamp issued by the county treasurer of the county in which the dealer has his or her primary 6 place of business. The tax stamp shall be issued upon payment of a 7 fee of Three Dollars and fifty cents (\$3.50) and shall be in lieu of 8 9 the dealer's ad valorem tax on the inventories of used motor vehicles or travel trailers but shall not relieve any other property 10 of the dealer from ad valorem taxation. 11

12 D. Upon sale of a used motor vehicle or travel trailer to another licensed dealer, the selling dealer shall place the tax 13 stamp required in subsection C of this section upon the certificate 14 of title. The used dealer license plate or wholesale dealer license 15 plate shall be removed by the selling dealer. The purchasing dealer 16 shall, at time of purchase, place his or her dealer license plate on 17 the used motor vehicle, travel trailer or commercial trailer as 18 provided in subsection A of this section; provided, for vehicles, 19 travel trailers or commercial trailers purchased by a licensed used 20 dealer at an auction, in lieu of such placement of the dealer 21 license plate, the auction may provide temporary documentation as 22 approved by the Director of the Motor Vehicle Division of Service 23 Oklahoma for the purpose of transporting such vehicle to the 24

purchaser's point of destination. Such temporary documentation
 shall be valid for two (2) days following the date of sale.

E. 1. The purchaser of every used motor vehicle, travel 3 trailer, or commercial trailer, except as otherwise provided by law, 4 5 shall obtain registration and title for the vehicle or trailer within two (2) months from the date of purchase of same. It shall 6 be the responsibility of the selling dealer to place a temporary 7 license plate, in size similar to the permanent Oklahoma license 8 9 plate but of a weatherproof plastic-impregnated substance ten-mil 10 weatherproof plastic-impregnated paper approved by the Oklahoma Used Motor Vehicle and Parts, Dismantler, and Manufactured Housing 11 12 Commission, upon a used motor vehicle, travel trailer or commercial trailer when a transaction is completed for the sale of said such 13 vehicle. Provided, upon a determination by the Commission that 14 there exists a national shortage of ten-mil weatherproof plastic-15 impregnated paper, eight-mil weatherproof plastic-impregnated paper 16 may be approved by the Commission until it has been determined by 17 the Commission the shortage has ended. The temporary license plate 18 under this subsection shall be placed at the location provided for 19 the permanent motor vehicle license plate. The temporary license 20 plate shall show the license number which is issued to the dealer 21 each year by Service Oklahoma or the Oklahoma Used Motor Vehicle and 22 Parts, Dismantler, and Manufactured Housing Commission, the date the 23

1 used motor vehicle, travel trailer or commercial trailer was 2 purchased of expiration, and the company name of the selling dealer. 2. The Oklahoma Used Motor Vehicle and Parts, Dismantler, and 3 Manufactured Housing Commission is hereby directed to develop the 4 5 temporary license plate design to incorporate these requirements in a manner that will permit law enforcement personnel to readily 6 identify the dealer license number and date of the vehicle purchase 7 expiration. The Oklahoma Used Motor Vehicle and Parts, Dismantler, 8 9 and Manufactured Housing Commission is hereby authorized to develop additional requirements and parameters as deemed appropriate to 10 discourage or prevent illegal duplication and use of the temporary 11 license plate. Such temporary license plate shall be valid for a 12 period of two (2) months ten (10) days from the date of purchase. 13 Use of the temporary license by a dealer for other than the purposes 14 set forth herein shall constitute grounds for revocation of the 15 dealer's license to conduct business. Purchasers of a commercial 16 trailer shall affix the temporary license plate to the rear of the 17 commercial trailer. The purchaser shall display the temporary 18 license plate for a period not to exceed $\frac{1}{100}$ months ten (10) 19 days or until registration and title are obtained as provided in 20 this section. 21

3. The provisions of this subsection on temporary licenses
shall apply to nonresidents who purchase a used motor vehicle,
travel trailer, or commercial trailer within this state that is to

The nonresident purchaser shall be allowed to operate the vehicle or trailer within the state with a 2 temporary license plate for a period not to exceed two (2) months 3 ten (10) days from date of purchase. Any nonresident purchaser 4 5 found to be operating a used motor vehicle, travel trailer, or commercial trailer within this state after two (2) months shall be 6 subject to the registration fees of this state upon the same terms 7 and conditions applying to residents of this state. Additionally, 8 9 within two (2) business days of the date of the sale or transfer of 10 the vehicle or trailer, the parties shall submit the requisite 11 documentation to Service Oklahoma or licensed operator identifying 12 the vehicle or trailer subject to the sale or transfer, purchaser information, and any associated license plate on the vehicle, 13 pursuant to the requirements of Section 1112.2 of this title. 14

F. It shall be unlawful for any dealer to procure the registration and licensing of any used motor vehicle, travel trailer or commercial trailer sold by the dealer or to act as the agent for the purchaser in the procurement of the registration and licensing of the purchaser's used vehicle, travel trailer, or commercial trailer. A license of any dealer violating the provision of this section may be revoked.

G. Dealers following the procedure set forth herein shall not be required to register vehicles, travel trailers, or commercial trailers to which this section applies, nor will the registration 1 fee otherwise required be assessed. Provided, dealers shall not 2 purchase or trade for a used motor vehicle, travel trailer, or 3 commercial trailer on which the registration therefor has been 4 expired for a period exceeding two (2) months without obtaining 5 current registration therefor.

A nonprofit charitable organization which is exempt from 6 н. taxation pursuant to the provisions of the Internal Revenue Code, 26 7 U.S.C., Section 501(c)(3), and which accepts donations of used motor 8 9 vehicles previously titled in Oklahoma to be subsequently transferred to another owner, upon the qualifying organization 10 providing sufficient documentation of its tax-exempt status, may 11 12 obtain from Service Oklahoma charitable nonprofit organization license plates for demonstrating, transporting, or test-driving 13 donated vehicles, provided that no organization shall possess or use 14 at any one time more than eight such plates. Service Oklahoma shall 15 design distinctive license plates for that purpose. The cost for 16 said such plates shall be the same as provided in subsection A of 17 this section for dealer plates. 18

I. The transfer of ownership from the vehicle donor to the
 qualifying nonprofit organization described in subsection H of this
 section shall be made without the payment of motor vehicle excise
 tax levied pursuant to Section 2103 of Title 68 of the Oklahoma
 Statutes.
