2. The Lieutenant Governor shall receive a salary of One

- 3. The Attorney General shall receive a salary of One Hundred Thirty-two Thousand Eight Hundred Twenty-five Dollars (\$132,825.00);
- 4. The State Superintendent of Public Instruction shall receive a salary of One Hundred Twenty-four Thousand Three Hundred Seventy-three Dollars (\$124,373.00);
- 5. Each member of the Corporation Commission shall receive a salary of One Hundred Fourteen Thousand Seven Hundred Thirteen

  Dollars (\$114,713.00);
  - 6. The State Treasurer shall receive a salary of One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00);
- 7. The State Auditor and Inspector shall receive a salary of
  One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
  (\$114,713.00);
- 8. The State Insurance Commissioner shall receive a salary of
  One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
  (\$114,713.00); and
  - 9. The Commissioner of Labor shall receive a salary of One Hundred Five Thousand Fifty-three Dollars (\$105,053.00).
- B. Pursuant to provisions of the Constitution of the State of

  Oklahoma, from and after the beginning date of a term of office

  which commences in, or after, January 2025, the following officers

1	of the State of Oklahoma shall be annually compensated for their
2	services, payable monthly, as follows:
3	1. The Governor shall receive a salary equal to the salary
4	received by the Chief Justice of the Oklahoma Supreme Court;
5	2. The Attorney General shall receive a salary equal to the
6	salary received by the Presiding Judge of the Court of Criminal
7	Appeals;
8	3. The following shall receive a salary equal to the salary
9	received by a district judge:
10	a. the Lieutenant Governor,
11	b. the State Superintendent of Public Instruction,
12	c. the State Treasurer,
13	d. the State Auditor and Inspector,
14	e. the State Insurance Commissioner,
15	f. the Commissioner of Labor, and
16	g. each member of the Oklahoma Corporation Commission.
17	SECTION 2. This act shall become effective November 1, 2023.
