8 An Act relating to state government; amending 74 O.S.
9 2021, Section 250.4, which relates to the salaries of
10 statewide elected officers; limiting certain salary
11 amounts to certain time period; and providing an
12 effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 74 O.S. 2021, Section 250.4, is
15 amended to read as follows:

16 Section 250.4 A. Pursuant to provisions of the Constitution of
17 the State of Oklahoma from and after the beginning date of a term of
18 office which commences ~~in, or after,~~ during the period from January
19 2016 through December 2024, the following officers of the State of
20 Oklahoma shall be annually compensated for their services, payable
21 monthly, as follows:

22 1. The Governor shall receive a salary of One Hundred Forty-
23 seven Thousand Dollars (\$147,000.00);

1 2. The Lieutenant Governor shall receive a salary of One
2 Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
3 (\$114,713.00);

4 3. The Attorney General shall receive a salary of One Hundred
5 Thirty-two Thousand Eight Hundred Twenty-five Dollars (\$132,825.00);

6 4. The State Superintendent of Public Instruction shall receive
7 a salary of One Hundred Twenty-four Thousand Three Hundred Seventy-
8 three Dollars (\$124,373.00);

9 5. Each member of the Corporation Commission shall receive a
10 salary of One Hundred Fourteen Thousand Seven Hundred Thirteen
11 Dollars (\$114,713.00);

12 6. The State Treasurer shall receive a salary of One Hundred
13 Fourteen Thousand Seven Hundred Thirteen Dollars (\$114,713.00);

14 7. The State Auditor and Inspector shall receive a salary of
15 One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
16 (\$114,713.00);

17 8. The State Insurance Commissioner shall receive a salary of
18 One Hundred Fourteen Thousand Seven Hundred Thirteen Dollars
19 (\$114,713.00); and

20 9. The Commissioner of Labor shall receive a salary of One
21 Hundred Five Thousand Fifty-three Dollars (\$105,053.00).

22 B. Pursuant to provisions of the Constitution of the State of
23 Oklahoma, from and after the beginning date of a term of office
24 which commences in, or after, January 2025, the following officers

1 of the State of Oklahoma shall be annually compensated for their
2 services, payable monthly, as follows:

3 1. The Governor shall receive a salary equal to the salary
4 received by the Chief Justice of the Oklahoma Supreme Court;

5 2. The Attorney General shall receive a salary equal to the
6 salary received by the Presiding Judge of the Court of Criminal
7 Appeals;

8 3. The following shall receive a salary equal to the salary
9 received by a district judge:

10 a. the Lieutenant Governor,

11 b. the State Superintendent of Public Instruction,

12 c. the State Treasurer,

13 d. the State Auditor and Inspector,

14 e. the State Insurance Commissioner,

15 f. the Commissioner of Labor, and

16 g. each member of the Oklahoma Corporation Commission.

17 SECTION 2. This act shall become effective November 1, 2023.
