19	SECTION 1. There is hereby appropriated to the Oklahoma

22	the fiscal year ending June 30, 2018, the sum of

Receipt and expenditure of unanticipated federal funds awarded the Oklahoma Department of Rehabilitation Services after July 1, 2017, shall be exempt from expenditure limitations, provided that any such funds used for operations shall be included in the agency's budget work program.

SECTION 3. The duties and compensation of employees, not otherwise prescribed by law, necessary to perform the duties imposed upon the Oklahoma Department of Rehabilitation Services by law shall be set by the Executive Director of the Oklahoma Department of Rehabilitation Services. The Oklahoma Department of Rehabilitation Services for the fiscal year ending June 30, 2018, shall be subject

to the following budgetary limitations on full-time-equivalent employees and expenditures excluding expenditures for capital and special projects, except as may be authorized pursuant to the provisions of Section 3603 of Title 74 of the Oklahoma Statutes:

SECTION 4. Any employees of the Disability Determination

Division in the Oklahoma Department of Rehabilitation Services whose salaries are funded in whole by federal funds shall be exempted from the agency FTE limit.
