10 An Act relating to state government; amending 74 O.S.
11 2011, Section 3601.2, as last amended by Section 1,
12 Chapter 351, O.S.L. 2013 (74 O.S. Supp. 2017, Section
13 3601.2), which relates to salaries of chief executive
14 officers; modifying establishment of certain
15 salaries; prohibiting processing of payroll in excess
16 of certain limits; and declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 74 O.S. 2011, Section 3601.2, as
19 last amended by Section 1, Chapter 351, O.S.L. 2013 (74 O.S. Supp.
20 2017, Section 3601.2), is amended to read as follows:

21 Section 3601.2 A. ~~Beginning July 1, 2013, each agency, board,~~
22 ~~commission, department or program in the executive branch of state~~
23 ~~government shall establish the~~ Except as otherwise provided by law,
24 the salary of each of the chief executive officers for which they
~~have appointing authority~~ state agencies and departments shall be

1 determined by the appointing authority of the chief executive
2 officer. Such salary shall be set between the minimum and maximum
3 of the range specified in the annual compensation reports required
4 by paragraph 5 of Section 840-1.6A of this title, for full-time
5 employees only.

6 B. All increases require certification of the appointing
7 authority that said action can be implemented for the current fiscal
8 year and subsequent fiscal year without the need for additional
9 funding. The agency, board, commission, department or program shall
10 report increases granted under this section to the Office of
11 Management and Enterprise Services on an annual basis by August 1 of
12 each year. The Office of Management and Enterprise Services shall
13 forward a report of such increases to the Governor, President Pro
14 Tempore of the Senate, and Speaker of the House of Representatives
15 no later than September 1 of each year.

16 C. Every three (3) years beginning with fiscal year 2013, the
17 Office of Management and Enterprise Services shall review these
18 salary ranges and report on and make recommendations on proposed
19 salary ranges in its annual compensation reports mandated by
20 paragraph 5 of Section 840-1.6A of this title. Such recommendations
21 shall be made no later than February 1 for chief executive officers
22 in all state agencies, boards, commissions, departments or programs
23 in the executive branch of state government, including but not
24 limited to those specified in Section 3601.1 of this title. The

1 Office of Management and Enterprise Services shall not process
2 payroll in excess of the salary limits recommended in the annual
3 compensation reports.

4 SECTION 2. It being immediately necessary for the preservation
5 of the public peace, health or safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
