12 An Act relating to license plates; amending 47 O.S.
13 2011, Sections 1116, 1132, as amended by Section 2,
14 Chapter 337, O.S.L. 2012 and 1135.1, as amended by
15 Section 1, Chapter 26, O.S.L. 2016 (47 O.S. Supp.
16 2020, Sections 1132 and 1135.1), which relate to
17 issuance of license plates; after specified date,
18 authorizing single registration period when
19 physically disabled license plate and standard
20 license plate are issued; requiring certain
21 rulemaking by Oklahoma Tax Commission; after
22 specified date, providing for single fee,
23 registration period and plate issue for physically
24 disabled license plate; requiring surrender of
standard issue plate under specified circumstances;
construing provision with respect to apportionment;
updating statutory reference; amending 47 O.S. 2011,
Sections 1135.2, 1135.3 and 1135.5, as last amended
by Sections 1, 2 and 3, Chapter 434, O.S.L. 2019 (47
O.S. Supp. 2020, Sections 1135.2, 1135.3 and 1135.5),
which relate to specialty license plates; modifying
the Killed in Action License Plate; modifying name of

14 which relates to the design and issuance of special
15 license plates; authorizing Tax Commission to enter
16 into certain licensing agreements; providing for
17 transfer of funds for certain licensing fees;
18 providing certain exception; amending Section 4,
19 Chapter 434, O.S.L. 2019 (68 O.S. Supp. 2020, Section
20 2368.32), which relates to the Historic Greenwood
21 District/Juneteenth Festival Revolving Fund;
22 requiring the transfer of certain monies; requiring
23 monitoring of certain fund; requiring transfer of
24 certain funds upon accrual; requiring certain fund
cease to exist upon certain date; repealing Section
4, Chapter 434, O.S.L. 2019 (68 O.S. Supp. 2020,
Section 2368.32), as last amended by Section 8 of
this act, which relates to the Historic Greenwood
District/Juneteenth Festival Revolving Fund;
providing effective dates; and declaring an
emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1116, is
21 amended to read as follows:

22 Section 1116. A. Twelve registration periods shall be
23 established for vehicles required to be registered on a staggered
24 basis. The registration periods shall start on the first day of

1 each calendar month and shall end on the last day of that month.
2 Unless otherwise provided, all such vehicles where the date of
3 execution of transfer of ownership occurs in this state at any time
4 during a calendar month shall be subject to registration and payment
5 of the fee for the registration period commencing the first day of
6 the month of such date of execution of transfer.

7 B. A person who registers more than one vehicle may have all of
8 such vehicles initially registered at the same time or at separate
9 times. Any person who obtains a vehicle may, upon registration,
10 have the registration period adjusted to allow future registration
11 of all such vehicles at the same period or at a different period.

12 C. On and after January 1, 2022, if a physically disabled
13 license plate is issued pursuant to paragraph 3 of subsection B of
14 Section 1135.1 of this title for a vehicle which is subject to the
15 requirements of Section 1132 of this title, the registration periods
16 for the vehicle may be combined into a single registration period.
17 The Oklahoma Tax Commission shall determine, by rule, a method for
18 adjusting the twelve-month period.

19 SECTION 2. AMENDATORY 47 O.S. 2011, Section 1132, as
20 amended by Section 2, Chapter 337, O.S.L. 2012 (47 O.S. Supp. 2020,
21 Section 1132), is amended to read as follows:

22 Section 1132. A. For all vehicles, unless otherwise
23 specifically provided by the Oklahoma Vehicle License and
24 Registration Act, a registration fee shall be assessed at the time

1 of initial registration by the owner and annually thereafter, for
2 the use of the avenues of public access within this state in the
3 following amounts:

4 1. For the first through the fourth year of registration in
5 this state or any other state, Eighty-five Dollars (\$85.00);

6 2. For the fifth through the eighth year of registration in
7 this state or any other state, Seventy-five Dollars (\$75.00);

8 3. For the ninth through the twelfth year of registration in
9 this state or any other state, Fifty-five Dollars (\$55.00);

10 4. For the thirteenth through the sixteenth year of
11 registration in this state or any other state, Thirty-five Dollars
12 (\$35.00); and

13 5. For the seventeenth and any following year of registration
14 in this state or any other state, Fifteen Dollars (\$15.00).

15 The registration fee provided for in this subsection shall be in
16 lieu of all other taxes, general or local, unless otherwise
17 specifically provided.

18 On and after January 1, 2022, if a physically disabled license
19 plate is issued pursuant to paragraph 3 of subsection B of Section
20 1135.1 of this title, any registration fee required for such license
21 plate and the fee required pursuant to this subsection shall be
22 remitted at the same time and subject to a single registration
23 period. Upon receipt of a physically disabled license plate, the
24 standard issue license plate must be surrendered to the Oklahoma Tax

1 Commission or motor license agent. The physically disabled license
2 plate must be properly displayed as required for a standard issue
3 license plate and will be the sole license plate issued and assigned
4 to the vehicle. The Oklahoma Tax Commission shall determine, by
5 rule, a method for making required fee adjustments when a physically
6 disabled license plate is obtained during a twelve-month period for
7 which a registration fee has already been remitted pursuant to this
8 subsection. The combination of fees in a single remittance shall
9 not alter the apportionment otherwise provided for by law.

10 B. For all-terrain vehicles and motorcycles used exclusively
11 for use off roads or highways purchased on or after July 1, 2005,
12 and for all-terrain vehicles and motorcycles used exclusively for
13 use off roads or highways purchased prior to July 1, 2005, which the
14 owner chooses to register pursuant to the provisions of Section
15 1115.3 of this title, an initial and nonrecurring registration fee
16 of Eleven Dollars (\$11.00) shall be assessed at the time of initial
17 registration by the owner. Nine Dollars (\$9.00) of the registration
18 fee shall be deposited in the Oklahoma Tax Commission Reimbursement
19 Fund. Two Dollars (\$2.00) of the registration fee shall be retained
20 by the motor license agent. The fees required by subsection A of
21 this section shall not be required for all-terrain vehicles or
22 motorcycles used exclusively off roads and highways.

23 C. For utility vehicles used exclusively for use off roads or
24 highways purchased on or after July 1, 2008, and for utility

1 vehicles used exclusively for use off roads or highways purchased
2 prior to July 1, 2008, which the owner chooses to register pursuant
3 to the provisions of Section 1115.3 of this title, an initial and
4 nonrecurring registration fee of Eleven Dollars (\$11.00) shall be
5 assessed at the time of initial registration by the owner. Nine
6 Dollars (\$9.00) of the registration fee shall be deposited in the
7 Oklahoma Tax Commission Reimbursement Fund. Two Dollars (\$2.00) of
8 the registration fee shall be retained by the motor license agent.
9 The fees required by subsection A of this section shall not be
10 required for utility vehicles used exclusively off roads and
11 highways.

12 D. There shall be a credit allowed with respect to the fee for
13 registration of a new vehicle which is a replacement for:

14 1. A new original vehicle which is stolen from the
15 purchaser/registrant within ninety (90) days of the date of purchase
16 of the original vehicle as certified by a police report or other
17 documentation as required by the Oklahoma Tax Commission; or

18 2. A defective new original vehicle returned by the
19 purchaser/registrant to the seller within six (6) months of the date
20 of purchase of the defective new original vehicle as certified by
21 the manufacturer.

22 The credit shall be in the amount of the fee for registration
23 which was paid for the new original vehicle and shall be applied to
24

1 the registration fee for the replacement vehicle. In no event will
2 the credit be refunded.

3 E. Upon every transfer or change of ownership of a vehicle, the
4 new owner shall obtain title for and, except in the case of salvage
5 vehicles and manufactured homes, register the vehicle within thirty
6 (30) days of change of ownership and pay a transfer fee of Fifteen
7 Dollars (\$15.00) in addition to any other fees provided for in ~~this~~
8 ~~act~~ the Oklahoma Vehicle License and Registration Act. No new decal
9 shall be issued to the registrant. Thereafter, the owner shall
10 register the vehicle annually on the anniversary date of its initial
11 registration in this state and shall pay the fees provided in
12 subsection A of this section and receive a decal evidencing such
13 payment. Provided, used motor vehicle dealers shall be exempt from
14 the provisions of this section.

15 F. In the event a new or used vehicle is not registered, titled
16 and tagged within thirty (30) days from the date of transfer of
17 ownership, the penalty for the failure of the owner of the vehicle
18 to register the vehicle within thirty (30) days shall be One Dollar
19 (\$1.00) per day, provided that in no event shall the penalty exceed
20 One Hundred Dollars (\$100.00). No penalty shall be waived by the
21 Oklahoma Tax Commission or any motor license agent except as
22 provided in subsection C of Section 1127 of this title. Of each
23 dollar penalty collected pursuant to this subsection:

24

1 1. Twenty-one cents (\$0.21) shall be apportioned as provided in
2 Section 1104 of this title;

3 2. Twenty-one cents (\$0.21) shall be retained by the motor
4 license agent; and

5 3. Fifty-eight cents (\$0.58) shall be deposited in the General
6 Revenue Fund.

7 SECTION 3. AMENDATORY 47 O.S. 2011, Section 1135.1, as
8 amended by Section 1, Chapter 26, O.S.L. 2016 (47 O.S. Supp. 2020,
9 Section 1135.1), is amended to read as follows:

10 Section 1135.1 A. The Oklahoma Tax Commission is hereby
11 authorized to design and issue appropriate official special license
12 plates to persons as provided by this section.

13 Special license plates shall not be transferred to any other
14 person but shall be removed from the vehicle upon transfer of
15 ownership and retained. The special license plate may then be used
16 on another vehicle but only after such other vehicle has been
17 registered for the current year.

18 Except as provided in subsection B of this section, special
19 license plates shall be renewed each year by the Tax Commission or a
20 motor license agent. The Tax Commission shall annually notify by
21 mail all persons issued special license plates. The notice shall
22 contain all necessary information and shall contain instructions for
23 the renewal procedure upon presentation to a motor license agent or
24 the Tax Commission. The license plates shall be issued on a

1 staggered system. The motor license agent fees shall be paid out of
2 the Oklahoma Tax Commission Reimbursement Fund.

3 On and after January 1, 2022, if a physically disabled license
4 plate is issued pursuant to paragraph 3 of subsection B of this
5 section, any registration fee required for such plate pursuant to
6 this section and the fee required pursuant to Section 1132 of this
7 title shall be remitted at the same time and subject to a single
8 registration period. The Oklahoma Tax Commission shall determine,
9 by rule, a method for making required fee and registration period
10 adjustments when a physically disabled license plate is obtained
11 during a twelve-month period for which a registration fee has
12 already been remitted pursuant to Section 1132 of this title. The
13 combination of fees in a single remittance shall not alter the
14 apportionment otherwise provided for in this section.

15 B. The special license plates provided by this section are as
16 follows:

17 1. Political Subdivision Plates - such plates shall be designed
18 for any vehicle owned by any political subdivision of this state
19 having obtained a proper Oklahoma certificate of title. Such
20 political subdivisions shall file an annual report with the Tax
21 Commission stating the agency where such vehicle is located. Such
22 license plates shall be permanent in nature and designed in such a
23 manner as to remain with the vehicle for the duration of the life
24

1 span of the vehicle or until the title is transferred to an owner
2 who is not a political subdivision.

3 The registration fee shall be Eight Dollars (\$8.00) and shall be
4 in addition to all other registration fees provided by law, except
5 the registration fees levied by Section 1132 of this title;

6 2. Tax-Exempt or Nonprofit License Plates - such plates shall
7 be designed for:

- 8 a. any motor bus, manufactured home, or mobile chapel and
9 power unit owned and operated by a religious
10 corporation or society of this state holding a valid
11 exemption from taxation issued pursuant to Section
12 501(a) of the Internal Revenue Code, 26 U.S.C.,
13 Section 501(a), and listed as an exempt organization
14 in Section 501(c)(3) of the Internal Revenue Code, as
15 amended, 26 U.S.C., Section 501(c)(3), and that is
16 used by the corporation or society solely for the
17 furtherance of its religious functions,
- 18 b. any vehicle owned and operated only by nonprofit
19 organizations devoted exclusively to youth programs
20 including, but not limited to, the Girl Scouts and Boy
21 Scouts of America,
- 22 c. any vehicle, except passenger automobiles, owned or
23 operated by nonprofit organizations actually involved
24 in programs for the employment of the handicapped and

1 used exclusively in the transportation of goods or
2 materials for such organization,

3 d. any vehicle owned and operated by a nonprofit
4 organization that provides older persons
5 transportation to and from medical, dental and
6 religious services and relief from business and social
7 isolation,

8 e. any vehicle owned and operated by a private nonprofit
9 organization that:

10 (1) warehouses and distributes surplus foods to other
11 nonprofit agencies and organizations, and

12 (2) holds a valid exemption from taxation issued
13 pursuant to Section 501(c) of the Internal
14 Revenue Code, as amended, 26 U.S.C., Section
15 501(c), and listed as an exempt organization in
16 Section 501(c)(3) of the Internal Revenue Code,
17 as amended, and

18 (3) uses such vehicle exclusively for the
19 transportation of such surplus foods,

20 f. any vehicle which:

21 (1) is owned and operated by a private, nonprofit
22 organization which is exempt from taxation
23 pursuant to the provisions of Section 501(c)(3)
24 of the Internal Revenue Code, 26 U.S.C., Section

1 501(c)(3), and which is primarily funded by a
2 fraternal or civic service organization with at
3 least one hundred local chapters or clubs, and
4 (2) is designed and used to provide mobile health
5 screening services to the general public at no
6 cost to the recipient, and for which no
7 reimbursement of any kind is received from any
8 health insurance provider, health maintenance
9 organization or governmental program, or

10 g. any vehicle owned and operated by the Civil Air
11 Patrol, a congressionally chartered corporation that
12 also serves an auxiliary of the United States Air
13 Force and which is exempt from taxation pursuant to
14 the provisions of Section 501(c)(3) of the Internal
15 Revenue Code, 26 U.S.C., Section 501(c)(3), and is
16 used exclusively for its corporate missions of
17 aerospace education, cadet programs and emergency
18 services. Such license plates shall be permanent in
19 nature and designed in such a manner as to remain with
20 the vehicle for the duration of the life span of the
21 vehicle or until the title to such vehicle is
22 transferred to an owner who is not subject to this
23 exemption. Such vehicles shall be exempt from the
24 registration fees levied under Section 1132 of this

1 title, except that an initial registration fee of
2 Twenty-five Dollars (\$25.00) shall apply to each
3 vehicle.

4 Any person claiming to be eligible for a tax-exempt or nonprofit
5 license plate under the provisions of this paragraph must have the
6 name of the tax-exempt or nonprofit organization prominently
7 displayed upon the outside of the vehicle, except those vehicles
8 registered pursuant to the provisions of subparagraph b of this
9 paragraph, unless such display is prohibited by federal or state law
10 or by state agency rules. No vehicle shall be licensed as a tax-
11 exempt or nonprofit vehicle unless the vehicle has affixed on each
12 side thereof, in letters not less than two (2) inches high and two
13 (2) inches wide, the name of the tax-exempt or nonprofit
14 organization or the insignia or other symbol of such organization
15 which shall be of sufficient size, shape and color as to be readily
16 legible during daylight hours from a distance of fifty (50) feet
17 while the vehicle is not in motion.

18 Except as provided in subparagraph g of this paragraph, the
19 registration fee shall be Eight Dollars (\$8.00) and shall be in
20 addition to all other registration fees provided by law, except the
21 registration fees levied by Section 1132 of this title;

22 3. Physically Disabled License Plates - such plates shall be
23 designed for persons who are eligible for a physically disabled
24 placard under the provisions of Section 15-112 of this title. It

1 shall prominently display the international accessibility symbol,
2 which is a stylized human figure in a wheelchair. The Tax
3 Commission shall also design physically disabled license plates for
4 motorcycles owned by persons who are eligible for a physically
5 disabled placard pursuant to the provisions of Section 15-112 of
6 this title. Upon the death of the physically disabled person, the
7 disabled license plate shall be returned to the Tax Commission.
8 There shall be no fee for such plate in addition to the rate
9 provided by the Oklahoma Vehicle License and Registration Act for
10 the registration of the vehicle. For an additional fee of Ten
11 Dollars (\$10.00), a person eligible for a physically disabled
12 license plate shall have the option of purchasing a duplicate
13 physically disabled special license plate which shall be securely
14 attached to the front of the vehicle. The original physically
15 disabled special license plate shall be securely attached to the
16 rear of the vehicle at all times.

17 Any person who is eligible for a physically disabled license
18 plate and whose vehicle has had modifications because of the
19 physical disability of the owner or of a family member within the
20 second degree of consanguinity of the owner, may register the
21 vehicle for a flat fee of Twenty-five Dollars (\$25.00). This fee
22 shall be in lieu of all other registration fees provided by the
23 Oklahoma Vehicle License and Registration Act;

24

1 4. Indian Tribal License Plates - such plates shall be designed
2 for any vehicle of a native American Indian Tribal Association
3 exempted in Sections 201 through 204 of Public Law 97-473 and used
4 by the tribal association exclusively for the furtherance of its
5 tribal functions.

6 The registration fee shall be Eight Dollars (\$8.00) and shall be
7 in addition to all other registration fees provided by law, except
8 the registration fees levied by Section 1132 of this title;

9 5. Hearing Impaired License Plates - such plates shall be
10 designed for persons who are hearing impaired. Such persons may
11 apply for a hearing-impaired license plate for each vehicle with a
12 rated carrying capacity of one (1) ton or less upon the presentment
13 of an application on a form furnished by the Tax Commission and
14 certified by a physician holding a valid license to practice
15 pursuant to the licensing provisions of Title 59 of the Oklahoma
16 Statutes, attesting that the person is hearing impaired. The
17 license plate shall be designed so that such persons may be readily
18 identified as being hearing impaired. There shall be no additional
19 fee for the plate, but all other registration fees provided by the
20 Oklahoma Vehicle License and Registration Act shall apply;

21 6. Antique or Classic Vehicles License Plates - such plates
22 shall be designed and issued for any vehicle twenty-five (25) years
23 of age or older, based upon the date of manufacture thereof and
24

1 which travels on the highways of this state primarily incidental to
2 historical or exhibition purposes only.

3 The registration fee shall be Eight Dollars (\$8.00) and shall be
4 in addition to all other registration fees provided by law, except
5 the registration fees levied by Section 1132 of this title. Any
6 person registering an antique or classic vehicle may elect to have
7 the vehicle registered for a ten-year period. The registration fee
8 for the elected ten-year registration shall be Seventy-five Dollars
9 (\$75.00). The motor license agent registering the antique or
10 classic vehicle for a ten-year period shall receive one hundred
11 percent (100%) of the fees the motor license agent would have
12 otherwise received pursuant to subsection A of Section 1141.1 of
13 this title if the antique or classic vehicle had been registered on
14 an annual basis; and

15 7. Honorary Consul License Plates - such plates shall be
16 designed to include the words "Honorary Consul" and issued to
17 persons who are honorary consuls authorized by the United States to
18 perform consular duties. Persons applying for such license plates
19 must show proof of standing as an honorary consul. The fee for such
20 plate shall be Eight Dollars (\$8.00) and shall be in addition to all
21 other registration fees required by the Oklahoma Vehicle License and
22 Registration Act. The owner of the vehicle that possesses such
23 license plates shall return the special license plates to the
24 Oklahoma Tax Commission if the owner disposes of the vehicle during

1 the registration year or ceases to be authorized to perform consular
2 duties.

3 C. Special license plates provided by this section shall be
4 designed in such a manner as to identify the use or ownership of the
5 vehicle. Use of any vehicle possessing a special license plate
6 provided by this section for any purpose not specified herein shall
7 be grounds for revocation of the special license plate and
8 registration certificate.

9 D. The fees provided by this section shall be deposited in the
10 Oklahoma Tax Commission Reimbursement Fund.

11 SECTION 4. AMENDATORY 47 O.S. 2011, Section 1135.2, as
12 last amended by Section 1, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
13 2020, Section 1135.2), is amended to read as follows:

14 Section 1135.2 A. The Oklahoma Tax Commission is hereby
15 authorized to design and issue appropriate official special license
16 plates to persons in recognition of their service or awards as
17 provided by this section.

18 Special license plates shall not be transferred to any other
19 person but shall be removed from the vehicle upon transfer of
20 ownership and retained. The special license plate may then be used
21 on another vehicle but only after such other vehicle has been
22 registered for the current year.

23 Special license plates shall be renewed each year by the Tax
24 Commission or a motor license agent. The Tax Commission shall

1 annually notify by mail all persons issued special license plates.
2 The notice shall contain all necessary information and shall contain
3 instructions for the renewal procedure upon presentation to a motor
4 license agent or the Tax Commission. The license plates shall be
5 issued on a staggered system except for legislative plates and
6 amateur radio operator license plates.

7 The Tax Commission is hereby directed to develop and implement a
8 system whereby motor license agents are permitted to accept
9 applications for special license plates authorized under this
10 section. The motor license agent shall confirm the applicant's
11 eligibility, if applicable, collect and deposit any amount
12 specifically authorized by law, accept and process the necessary
13 information directly into such system and generate a receipt
14 accordingly. For performance of these duties, motor license agents
15 shall retain the fee provided in Section 1141.1 of this title for
16 registration of a motor vehicle. The motor license agent fees for
17 acceptance of applications and renewals shall be paid out of the
18 Oklahoma Tax Commission Reimbursement Fund.

19 B. The special license plates provided by this section are as
20 follows:

21 1. Prisoner of War License Plates - such plates shall be
22 designed for honorably discharged or present members of the United
23 States Armed Forces and civilians who were former prisoners of war
24 held by a foreign country and who can provide proper certification

1 of that status. Such persons may apply for a prisoner of war
2 license plate for no more than two vehicles with each vehicle having
3 a rated carrying capacity of one (1) ton or less. The surviving
4 spouse of any deceased former prisoner of war, if the spouse has not
5 since remarried, or if remarried, the remarriage is terminated by
6 death, divorce, or annulment, may apply for a prisoner of war
7 license plate for one vehicle with a rated carrying capacity of one
8 (1) ton or less. The fee provided by this section for the special
9 license plate authorized by this paragraph shall be in addition to
10 all other registration fees provided by law, except the registration
11 fees levied by Section 1132 of this title;

12 2. National Guard License Plates - such plates shall be
13 designed for active or retired members of the Oklahoma National
14 Guard. Retirees who are eligible for such plates shall provide
15 proof of eligibility upon initial application, but shall not be
16 required to provide proof of eligibility annually;

17 3. Air National Guard License Plates - such plates shall be
18 designed for active or retired members of the Oklahoma Air National
19 Guard. Retirees who are eligible for such plates shall provide
20 proof of eligibility upon initial application, but shall not be
21 required to provide proof of eligibility annually;

22 4. United States Armed Forces License Plates - such plates
23 shall be designed for active, retired, former or reserve members of
24 the United States Armed Forces, and shall identify which branch of

1 service, and carry the emblem and name of either the Army, Navy, Air
2 Force, Marines or Coast Guard, according to the branch of service to
3 which the member belongs or did belong. Former members who have
4 been dishonorably discharged shall not be eligible for such plates.
5 Persons applying for such license plate must show proof of present
6 or past military service by presenting a valid Uniformed Services
7 Identity Card or the United States Department of Defense Form
8 (DD)214. Retired or former members who are eligible for such plates
9 shall provide proof of eligibility upon initial application, but
10 shall not be required to provide proof of eligibility annually;

11 5. Congressional Medal of Honor Recipient License Plates - such
12 plates shall be designed for any resident of this state who has been
13 awarded the Congressional Medal of Honor. Such persons may apply
14 for a Congressional Medal of Honor recipient license plate for each
15 vehicle with a rated carrying capacity of one (1) ton or less.
16 There shall be no registration fee for the issuance of this plate;

17 6. Missing In Action License Plates - such plates shall be
18 designed to honor members of the United States Armed Forces who are
19 missing in action. The spouse of such missing person, if the spouse
20 has not since remarried, or if remarried, the remarriage is
21 terminated by death, divorce, or annulment, and each parent of the
22 missing person may apply for a missing in action license plate upon
23 presenting proper certification that the person is missing in action
24 and that the person making the application is the qualifying spouse

1 or the parent of the missing person. The qualifying spouse and each
2 parent of the missing person may each apply for the missing in
3 action license plate for each vehicle with a rated carrying capacity
4 of one (1) ton or less;

5 7. Purple Heart Recipient License Plates - such plates shall be
6 designed for any resident of this state presenting proper
7 certification from the United States Department of Veterans Affairs
8 or the Armed Forces of the United States certifying that such
9 resident has been awarded the Purple Heart military decoration.
10 Such persons may apply for a Purple Heart recipient license plate
11 for vehicles having a rated carrying capacity of one (1) ton or
12 less. The surviving spouse of any deceased veteran who has been
13 awarded the Purple Heart military decoration, if such spouse has not
14 since remarried, or if remarried, the remarriage has been terminated
15 by death, divorce or annulment, may apply for such plate for one
16 vehicle with a rated carrying capacity of one (1) ton or less. The
17 license plate created by this paragraph shall be exempt from the fee
18 provided by this section for special license plates;

19 8. Pearl Harbor Survivor License Plates - such plates shall be
20 designed for any resident of this state who can be verified by the
21 United States Department of Veterans Affairs or the Armed Forces of
22 the United States as being:

23 a. a member of the United States Armed Forces on December
24 7, 1941,

1 b. stationed on December 7, 1941, during the hours of
2 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,
3 the island of Oahu, or offshore at a distance not to
4 exceed three (3) miles, and

5 c. a recipient of an honorable discharge from the United
6 States Armed Forces.

7 Such person may apply for a Pearl Harbor Survivor license plate
8 for each vehicle with a rated carrying capacity of one (1) ton or
9 less;

10 9. Iwo Jima License Plates - such plates shall be designed for
11 any resident of this state who can be verified by the United States
12 Department of Veterans Affairs or the Armed Forces of the United
13 States as being:

14 a. a member of the United States Armed Forces in February
15 of 1945,

16 b. stationed in February of 1945 on or in the immediate
17 vicinity of the island of Iwo Jima, and

18 c. a recipient of an honorable discharge from the United
19 States Armed Forces.

20 Such person may apply for an Iwo Jima license plate for each
21 vehicle with a rated carrying capacity of one (1) ton or less.

22 Such license plate shall have the legend "Oklahoma OK" and shall
23 contain three letters and three numbers. Between the letters and
24 numbers shall be a logo of the flag-raising at Iwo Jima. Below the

1 letters, logo and numbers, the plate shall contain the words "FEB."
2 at the left, "Iwo Jima" in the center and "1945" at the right. Such
3 plates shall not be subject to the design requirements of any other
4 license plates prescribed by law other than the space for the
5 placement of the yearly decals for each succeeding year of
6 registration after the initial issue;

7 10. D-Day Survivor License Plates - such plates shall be
8 designed for any resident of this state who can be verified by the
9 United States Department of Veterans Affairs or the Armed Forces of
10 the United States as being:

- 11 a. a member of the United States Armed Forces on June 6,
12 1944,
- 13 b. a participant in the Allied invasion of the coast of
14 Normandy on June 6, 1944; provided, if such
15 participation cannot be verified by the United States
16 Department of Veterans Affairs or the Armed Forces of
17 the United States, the Tax Commission may, in its
18 discretion, accept evidence of such participation from
19 the person applying for the license plate, and
- 20 c. a recipient of an honorable discharge from the United
21 States Armed Forces.

22 Such person may apply for a D-Day Survivor license plate for
23 each vehicle with a rated carrying capacity of one (1) ton or less;

24

1 11. Killed in Action License Plates - such plates shall be
2 designed to honor members of the United States Armed Forces who were
3 killed in action. The spouse of the deceased person, if the spouse
4 has not remarried, or if remarried, the remarriage is terminated by
5 death, divorce, or annulment, may apply for a killed in action
6 license plate upon presenting proper certification that the person
7 was killed in action and that the person making the application is
8 the qualifying spouse of the deceased person. The qualifying spouse
9 may apply for a killed in action license plate for no more than two
10 vehicles with each vehicle with a rated carrying capacity of one (1)
11 ton or less. The fee provided by this section for the special
12 license plate authorized by this paragraph shall be in addition to
13 all other registration fees provided by law, except the registration
14 fees levied by Section 1132 of this title. Beginning on the
15 effective date of this section of this act, the killed in action
16 license plate shall be designed to honor members of the United
17 States Armed Forces who were killed in action while engaged in
18 combat with a hostile force. The parents, siblings, half-siblings,
19 grandparents or spouse of the deceased person, if the spouse has not
20 remarried, or if remarried, the remarriage is terminated by death,
21 divorce or annulment, may apply for a killed in action license plate
22 upon presenting proper certification that the person was killed in
23 action and that the person making the application is the qualifying
24 spouse or family member of the deceased person. The qualifying

1 spouse or family member may apply for a killed in action license
2 plate for no more than two vehicles with each vehicle with a rated
3 carrying capacity of one (1) ton or less. The license plate shall
4 have a white background and the legend "Killed in Action" and shall
5 contain any combination of numbers and letters from one to a maximum
6 of seven in black, as for personalized license plates. To the left
7 of the numbers and letters shall be the Battlefield Cross in gold.
8 The killed in action license plate shall be exempt from any minimum
9 issuance criteria related to license plate applications;

10 12. Gold Star ~~Parents~~ Families License Plates - such plates
11 shall be designed to honor members of the United States Armed Forces
12 who were killed ~~during a war~~ while on active duty. The parents,
13 siblings, half-siblings or grandparents of the deceased person may
14 apply for a gold star license plate upon presenting proper
15 certification that the person was killed ~~during a war~~ while on
16 active duty and that the person making the application is the
17 parent, sibling, half-sibling or grandparent of the deceased person.
18 The ~~parent~~ family member may apply for a gold star ~~parent~~ families
19 license plate for no more than two vehicles with each vehicle having
20 a rated carrying capacity of one (1) ton or less. The fee provided
21 by this section for the special license plate authorized by this
22 paragraph shall be in addition to all other registration fees
23 provided by law, except the registration fees levied by Section 1132
24 of this title;

1 13. Military Decoration License Plates - such plates shall be
2 designed for any resident of this state who has been awarded the
3 Distinguished Service Medal, the Distinguished Service Cross, the
4 Distinguished Flying Cross, the Bronze Star military decoration or
5 the Silver Star military decoration. Such persons may apply for a
6 military decoration license plate for each vehicle with a rated
7 carrying capacity of one (1) ton or less;

8 14. Vietnam Veteran License Plates - such plates shall be
9 designed for honorably discharged or present members of the United
10 States Armed Forces who served in the Vietnam Conflict. Such
11 persons may apply for a Vietnam veteran license plate for each
12 vehicle with a rated carrying capacity of one (1) ton or less;

13 15. Police Officer License Plates - such plates shall be
14 designed for any currently employed, reserve or retired municipal
15 police officer or full-time, reserve or retired university police
16 officer certified by the Council on Law Enforcement Education and
17 Training or common education police officer certified by the Council
18 on Law Enforcement Education and Training. Police officers may
19 apply for police officer license plates for vehicles with a rated
20 capacity of one (1) ton or less or for a motorcycle upon proof of
21 employment by or retirement from a municipal, university or common
22 education police department by either an identification card or
23 letter from the chief of the police department or the Oklahoma
24 Police Pension and Retirement Board. Retirees who are eligible for

1 such plates shall provide proof of eligibility upon initial
2 application, but shall not be required to provide proof of
3 eligibility annually. The license plates shall be designed in
4 consultation with municipal police departments of this state;
5 provided, the license plate for motorcycles may be of similar design
6 to the license plate for motor vehicles or may be a new design in
7 order to meet space requirements for a motorcycle license plate;

8 16. World War II Veteran License Plates - such plates shall be
9 designed to honor honorably discharged former members of the United
10 States Armed Forces who are residents of this state and who can be
11 verified by the Oklahoma Military Department, the Department of
12 Veterans Affairs or the Armed Forces of the United States as having
13 served on federal active duty anytime during the period from
14 September 16, 1940, to December 7, 1945. The former members may
15 apply for a World War II Veteran license plate for vehicles with a
16 rated carrying capacity of one (1) ton or less.

17 The license plate shall have the legend "Oklahoma" and shall
18 contain, in the center of the plate, either the Thunderbird Insignia
19 of the 45th Infantry Division in the prescribed red and gold
20 coloring or the emblem of the Army, Navy, U.S. Army Air Corps,
21 Marines or Coast Guard according to the branch of service to which
22 the member belonged. For the purpose of license plate
23 identification, the plate shall contain four digits, two digits at
24 the left and two digits at the right of the insignia or emblem.

1 Centered on the bottom of the license plate shall be the words
2 "WORLD WAR II";

3 17. Korean War Veteran License Plates - such plates shall be
4 designed to honor honorably discharged former members of the United
5 States Armed Forces who are residents of this state and who can be
6 verified by the Oklahoma Military Department, the Department of
7 Veterans Affairs or the Armed Forces of the United States as having
8 served on federal active duty anytime during the period from June
9 27, 1950, to January 31, 1955, both dates inclusive. The former
10 members may apply for a Korean War Veteran license plate for
11 vehicles with a rated carrying capacity of one (1) ton or less.

12 The license plate shall have the legend "OKLAHOMA" and shall
13 contain, in the center of the plate, either the Thunderbird Insignia
14 of the 45th Infantry Division in the prescribed red and gold
15 coloring or the emblem of the Army, Navy, Air Force, Marines or
16 Coast Guard according to the branch of service to which the member
17 belonged. For the purpose of license plate identification, the
18 plate shall contain four digits, two digits at the left and two
19 digits at the right of the insignia or emblem. Centered on the
20 bottom of the license plate shall be the word "KOREA";

21 18. Municipal Official License Plates - such plates shall be
22 designed for persons elected to a municipal office in this state and
23 shall designate the name of the municipality and the district or
24

1 ward in which the municipal official serves. The plates shall only
2 be produced upon application;

3 19. Red Cross Volunteer License Plates - such plates shall be
4 designed to honor American Red Cross volunteers and staff who are
5 residents of this state. Such persons must present an
6 identification card issued by the American Red Cross and bearing a
7 photograph of the person. The license plate shall be designed with
8 the assistance of the American Red Cross and shall have the legend
9 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
10 symbol of the American Red Cross and no more than three letters and
11 three numbers shall be in the color Pantone 186C Red. Below the
12 symbol and letters and numbers shall be the words "American Red
13 Cross" in black. The plates shall not be subject to the design
14 requirements of any other license plates prescribed by law other
15 than the space for the placement of the yearly decals for each
16 succeeding year of registration after the initial issue;

17 20. Desert Storm License Plates - such plates shall be designed
18 and issued to any honorably discharged or present member of the
19 United States Armed Forces who served in the Persian Gulf Crisis and
20 the Desert Storm operation. Such persons may apply for a Desert
21 Storm license plate for each vehicle with a rated carrying capacity
22 of one (1) ton or less;

23 21. Military Reserve Unit License Plates - such plates shall be
24 designed and issued to any honorably discharged or present member of

1 a reserve unit of the United States Armed Forces. Such persons may
2 apply for a Military Reserve Unit license plate for each vehicle
3 with a rated carrying capacity of one (1) ton or less;

4 22. Oklahoma City Bombing Victims and Survivors License Plates
5 - such plates shall be designed and issued to any victim or survivor
6 of the bombing attack on the Alfred P. Murrah Federal Building in
7 downtown Oklahoma City on April 19, 1995;

8 23. Civil Air Patrol License Plates - such plates shall be
9 designed and issued to any person who is a member of the Civil Air
10 Patrol. Such persons may apply for a Civil Air Patrol license plate
11 for each vehicle with a rated carrying capacity of one (1) ton or
12 less upon proof of membership in the Civil Air Patrol. The license
13 plate shall be designed in consultation with the Civil Air Patrol;

14 24. Ninety-Nines License Plates - such plates shall be designed
15 and issued to members of the Ninety-Nines. Persons applying for
16 such license plate must show proof of membership in the Ninety-
17 Nines. The license plates shall be designed in consultation with
18 the Ninety-Nines;

19 25. Combat Infantryman Badge License Plates - such plates shall
20 be designed to honor recipients of the Combat Infantryman Badge.
21 The plate shall have the legend "Oklahoma OK". Below the legend
22 shall be the Combat Infantryman Badge and three numbers. Below the
23 badge and the numbers shall be the words "Combat Infantryman Badge".
24 Such persons may apply for a Combat Infantryman Badge license plate

1 for each vehicle with a rated carrying capacity of one (1) ton or
2 less;

3 26. Somalia Combat Veterans License Plates - such plates shall
4 be designed and issued to any honorably discharged or present member
5 of the United States Armed Forces who saw combat in the United
6 Nations relief effort. Such persons may apply for a Somalia Combat
7 Veteran license plate for each vehicle with a rated carrying
8 capacity of one (1) ton or less;

9 27. Police Chaplain License Plates - such plates shall be
10 designed and issued to members of the International Conference of
11 Police Chaplains (ICPC) who have completed the ICPC requirements for
12 basic certification as a police chaplain. The license plates shall
13 be designed in consultation with the ICPC;

14 28. Joint Service Commendation Medal License Plates - such
15 plates shall be designed and issued to any resident of this state
16 who has been awarded the Joint Service Commendation Medal by the
17 United States Secretary of Defense;

18 29. Merchant Marine License Plates - such plates shall be
19 designed, subject to criteria to be presented to the Tax Commission
20 by the Oklahoma Department of Veterans Affairs, and issued to any
21 person who during combat was a member of the Merchant Marines as
22 certified by the Oklahoma Department of Veterans Affairs. Such
23 license plate may be issued for each vehicle with a rated carrying
24 capacity of one (1) ton or less;

1 30. Legislative License Plates - such plates shall be designed
2 for persons elected to the Oklahoma Legislature and shall designate
3 the house of the Legislature in which the legislator serves and the
4 district number;

5 31. Disabled Veterans License Plates - such plates shall be
6 designed for persons presenting proper certification from the United
7 States Department of Veterans Affairs or the Armed Forces of the
8 United States certifying such veteran has a service-connected
9 disability rating of fifty percent (50%) or more, regardless which
10 agency pays the disability benefits, or that such veteran has been
11 awarded a vehicle by the United States government or receives a
12 grant from the United States Department of Veterans Affairs for the
13 purchase of an automobile due to a service-connected disability
14 rating or due to the loss of use of a limb or an eye. Such persons
15 may apply to the Tax Commission for a disabled veterans license
16 plate or to a motor license agent for a regular license plate for no
17 more than two vehicles with each vehicle having a rated carrying
18 capacity of one (1) ton or less. The surviving spouse of any
19 deceased disabled veteran, if the spouse has not since remarried, or
20 if remarried, the remarriage is terminated by death, divorce, or
21 annulment, or a surviving spouse in receipt of Dependency and
22 Indemnity Compensation from the United States Department of Veterans
23 Affairs, may apply for a disabled veterans license plate for one
24 vehicle with a rated carrying capacity of one (1) ton or less. The

1 fee provided by this section for the special license plate
2 authorized by this paragraph shall be in addition to all other
3 registration fees provided by law, except the registration fees
4 levied by Section 1132 of this title. The total expense of this
5 license plate shall not exceed Five Dollars (\$5.00).

6 If the person qualifies for a disabled veterans license plate
7 and is also eligible for a physically disabled placard under the
8 provisions of Section 15-112 of this title, the person shall be
9 eligible to receive a disabled veterans license plate that also
10 displays the international accessibility symbol, which is a stylized
11 human figure in a wheelchair. Upon the death of the disabled
12 veteran with a disabled veterans license plate with the
13 international accessibility symbol, the plate shall be returned to
14 the Tax Commission;

15 32. United States Air Force Association License Plates - such
16 plates shall be designed for members of the United States Air Force
17 Association. Persons applying for such license plate must show
18 proof of membership in the Association. The license plates shall be
19 designed in consultation with the Association;

20 33. Oklahoma Military Academy Alumni License Plates - such
21 plates shall be designed and issued to any resident of this state
22 who is an alumnus of the Oklahoma Military Academy. Such persons
23 may apply for an Oklahoma Military Academy Alumnus license plate for
24 each vehicle with a rated carrying capacity of one (1) ton or less.

1 The license plates shall be designed in consultation with the
2 Oklahoma Military Academy and shall contain the shield of the
3 Academy;

4 34. Amateur Radio Operator License Plates - such plates shall
5 be designed and issued to any person, holding a valid operator's
6 license, technician class or better, issued by the Federal
7 Communications Commission, and who is also the owner of a motor
8 vehicle currently registered in Oklahoma, in which has been
9 installed amateur mobile transmitting and receiving equipment.
10 Eligible persons shall be entitled to two special vehicle
11 identification plates as herein provided. Application for such
12 identification plates shall be on a form prescribed by the Tax
13 Commission and the plates issued to such applicant shall have
14 stamped thereon the word "Oklahoma" and bear the official call
15 letters of the radio station assigned by the Federal Communications
16 Commission to the individual amateur operator thereof. All
17 applications for such plates must be made to the Tax Commission on
18 or before the first day of October of any year for such plates for
19 the following calendar year and must be accompanied by the fee
20 required in this section together with a certificate, or such other
21 evidence as the Tax Commission may require, of proof that applicant
22 has a valid technician class or better amateur operator's license
23 and proof of applicant's ownership of a vehicle in which radio
24 receiving and transmitting equipment is installed. Applicants shall

1 only be entitled to one set of special identification plates in any
2 one (1) year, and such calendar year shall be stamped thereon. The
3 right to such special identification plates herein provided for
4 shall continue until the amateur radio operator's license of the
5 person to whom such plates are issued expires or is revoked;

6 35. American Legion License Plates - such plates shall be
7 designed for members of the American Legion. Persons applying for
8 such license plate must show proof of membership. The license
9 plates shall be designed in consultation with the American Legion of
10 Oklahoma;

11 36. Deputy Sheriff License Plates - such plates shall be
12 designed for any currently employed or retired county sheriff or
13 deputy sheriff. County sheriffs or deputy sheriffs may apply for
14 such plates for vehicles with a rated capacity of one (1) ton or
15 less upon proof of employment by or retirement from a county
16 sheriff's office by either an identification card or letter from the
17 county sheriff or a government-sponsored retirement board from which
18 the county sheriff or deputy sheriff may be receiving a pension.
19 Retirees who are eligible for such plates shall provide proof of
20 eligibility upon initial application, but shall not be required to
21 provide proof of eligibility annually. The license plates shall be
22 designed in consultation with the county sheriff offices of this
23 state;

24

1 37. Gold Star Surviving Spouse License Plates - such plates
2 shall be designed to honor the surviving spouses and children of
3 qualified veterans. As used in this paragraph, "qualified veteran"
4 shall mean:

5 a. any person honorably discharged from any branch of the
6 United States Armed Forces or as a member of the
7 Oklahoma National Guard, who died as a direct result
8 of the performance of duties for any branch of the
9 United States Armed Forces or Oklahoma National Guard
10 while on active military duty, or

11 b. any person honorably discharged from any branch of the
12 United States Armed Forces or as a member of the
13 Oklahoma National Guard, who died as a result of
14 injury, illness or disease caused by the performance
15 of such duties while on active duty, whether the death
16 occurred while on active duty or after the honorable
17 discharge of such person.

18 The fee provided by this section for the special license plate
19 authorized by this paragraph shall be in addition to all other
20 registration fees provided by law, except the registration fees
21 levied by Section 1132 of this title;

22 38. Korea Defense Service Medal License Plates - such plates
23 shall be designed and issued to any resident of this state who has
24 been awarded the Korea Defense Service Medal by the United States

1 Secretary of Defense. Such persons may apply for a Korea Defense
2 Service Medal license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less;

4 39. 180th Infantry License Plates - such plates shall be
5 designed for members and prior members of the 180th Infantry.
6 Persons applying for such license plate must obtain and provide
7 proof of their membership from the 180th Infantry Association. The
8 license plates shall be designed in consultation with the 180th
9 Infantry;

10 40. Operation Iraqi Freedom Veteran License Plates - such
11 plates shall be designed and issued to any honorably discharged or
12 present member of the United States Armed Forces who served in
13 Operation Iraqi Freedom. Such person may apply for an Operation
14 Iraqi Freedom Veteran license plate for each vehicle with a rated
15 carrying capacity of one (1) ton or less, or for a motorcycle;
16 provided, the license plate for motorcycles may be of similar design
17 to the license plate for motor vehicles or may be a new design in
18 order to meet space requirements for a motorcycle license plate;

19 41. United States Air Force Academy Alumni License Plates -
20 such plates shall be designed and issued to any resident of this
21 state who is an alumnus of the United States Air Force Academy.
22 Such persons may apply for a United States Air Force Academy Alumnus
23 license plate for each vehicle with a rated carrying capacity of one
24 (1) ton or less;

1 42. Operation Enduring Freedom Veteran License Plate - such
2 plates shall be designed and issued to any honorably discharged or
3 present member of the United States Armed Forces who served in
4 Operation Enduring Freedom on or after September 11, 2001. The
5 license plate shall be designed in consultation with the Military
6 Department of the State of Oklahoma. Such person may apply for an
7 Operation Enduring Freedom Veteran license plate for each vehicle
8 with a rated carrying capacity of one (1) ton or less, or for a
9 motorcycle; provided, the license plate for motorcycles may be of
10 similar design to the license plate for motor vehicles or may be a
11 new design in order to meet space requirements for a motorcycle
12 license plate;

13 43. Military Multi-Decoration License Plate - such plates shall
14 be designed and issued to any honorably discharged or present member
15 of the United States Armed Forces who qualifies for more than one
16 military decoration license plate pursuant to the provisions of this
17 section. The Tax Commission shall develop and implement a system
18 whereby the designs of the eligible license plates can be included
19 together on a single license plate. Such person may apply for a
20 Military Multi-Decoration license plate for each vehicle with a
21 rated carrying capacity of one (1) ton or less;

22 44. Global War on Terror Expeditionary License Plate - such
23 plates shall be designed and issued to any honorably discharged or
24 present member of the United States Armed Forces who has earned a

1 Global War on Terror Expeditionary decoration. The license plate
2 shall be designed in consultation with the United States Institute
3 of Heraldry and the Military Department of the State of Oklahoma.
4 Such person may apply for a Global War on Terror Expeditionary
5 license plate for each vehicle with a rated carrying capacity of one
6 (1) ton or less;

7 45. Legion of Merit Medal Recipient License Plates - such
8 plates shall be designed for any resident of this state presenting
9 proper certification from the United States Department of Veterans
10 Affairs or the Armed Forces of the United States certifying that
11 such resident has been awarded the Legion of Merit military
12 decoration. Such persons may apply for a Legion of Merit recipient
13 license plate for vehicles having a rated carrying capacity of one
14 (1) ton or less. The license plate shall be designed in
15 consultation with the Military Department of the State of Oklahoma;

16 46. 1-179th License Plates - such plates shall be designed for
17 members, prior members and members of the household of a member or
18 former member of the 1-179th Infantry. Persons applying for such
19 license plate must obtain and provide proof of their membership
20 association with the 1-179th Infantry Association. The license
21 plate shall be designed in consultation with the 1-179th Infantry;

22 47. 2-179th License Plates - such plates shall be designed for
23 members, prior members and members of the household of a member or
24 former member of the 2-179th Infantry. Persons applying for such

1 license plate must obtain and provide proof of their membership
2 association with the 2-179th Infantry Association. The license
3 plate shall be designed in consultation with the 2-179th Infantry;

4 48. Combat Action Ribbon Recipient License Plates - such plates
5 shall be designed to honor recipients of the Combat Action Ribbon
6 who present proper certification from the United States Department
7 of the Navy. The license plate shall include the Combat Action
8 Ribbon earned by the recipient. Such persons may apply for a Combat
9 Action Ribbon Recipient license plate for vehicles having a rated
10 carrying capacity of one (1) ton or less;

11 49. Oklahoma Submarine Veterans License Plate - such plates
12 shall be designed for any resident of this state who is a United
13 States submarine veteran and presents either a Department of Defense
14 form 214 or other documentation certifying such service. Such
15 persons may apply for an Oklahoma Submarine Veterans license plate
16 for vehicles having a rated capacity of one (1) ton or less. The
17 license plate design shall include both gold and silver dolphins to
18 represent both officer and enlisted service members;

19 50. United States Navy Seabees and Civil Engineer Corps License
20 Plate - such plates shall be designed and issued to any honorably
21 discharged or present member of the United States Navy Seabees or
22 Civil Engineer Corps. Such persons may apply for a United States
23 Navy Seabees and Civil Engineer Corps license plate for vehicles
24 having a rated carrying capacity of one (1) ton or less. The

1 license plate shall be designed in consultation with the Military
2 Department of the State of Oklahoma;

3 51. Combat Action Badge Recipient License Plate - such plates
4 shall be designed to honor recipients of the Combat Action Badge who
5 present proper certification from the United States Army. The
6 license plate shall include the Combat Action Badge earned by the
7 recipient. Such persons may apply for a Combat Action Badge
8 Recipient license plate for vehicles having a rated carrying
9 capacity of one (1) ton or less, or for a motorcycle; provided, the
10 license plate for motorcycles may be of similar design to the
11 license plate for motor vehicles or may be a new design in order to
12 meet space requirements for a motorcycle license plate;

13 52. Iraq Combat Veteran License Plate - such plates shall be
14 designed and issued to any honorably discharged or present member of
15 the United States Armed Forces who saw combat in Operation Iraqi
16 Freedom. Such persons may apply for an Iraq Combat Veteran license
17 plate for each vehicle with a rated carrying capacity of one (1) ton
18 or less, or for a motorcycle; provided, the license plate for
19 motorcycles may be of similar design to the license plate for motor
20 vehicles or may be a new design in order to meet space requirements
21 for a motorcycle license plate;

22 53. Afghanistan Combat Veteran License Plate - such plates
23 shall be designed and issued to any honorably discharged or present
24 member of the United States Armed Forces who saw combat in Operation

1 Enduring Freedom. Such persons may apply for an Afghanistan Combat
2 Veteran license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less, or for a motorcycle; provided, the
4 license plate for motorcycles may be of similar design to the
5 license plate for motor vehicles or may be a new design in order to
6 meet space requirements for a motorcycle license plate; and

7 54. Special Forces Association License Plates - such plates
8 shall be designed and issued to any honorably discharged or present
9 member of the Army Special Forces qualified and authorized to wear
10 upon the person's United States military uniform the Army Special
11 Forces Tab. Persons applying for the Special Forces Association
12 license plate must provide a copy of the orders awarding the Special
13 Forces Tab or authorizing its wear upon a United States military
14 uniform. The license plate shall be designed in consultation with
15 the Special Forces Association, Chapter 32-50. The Tax Commission
16 shall produce up to two distinct designs for the Special Forces
17 Association license plate. Qualified persons may select one design
18 at the time of application. The plates shall be issued to any
19 qualified person in any combination of numbers and letters from one
20 to a maximum of seven, as for personalized license plates;

21 55. Veterans of the United States Armed Forces License Plates -
22 such plates shall be designed for veterans of the United States
23 Armed Forces, and shall identify the branch of service, carry the
24 emblem and name of either the Army, Navy, Air Force, Marines or

1 Coast Guard, according to the branch of service to which the member
2 belonged, and shall reflect veteran status. Former members who have
3 been dishonorably discharged shall not be eligible for such plates.
4 Persons applying for such license plates must show proof of past
5 military service by presenting a valid United States Department of
6 Defense Form (DD)214 upon initial application but shall not be
7 required to provide proof of eligibility annually; and

8 56. Navy Chief License Plates - such plates shall be designed
9 and issued to any resident of this state who has achieved the rank
10 of E7 through E9 in the United States Navy and presents proper
11 certification that the resident has achieved such rank and was
12 either honorably discharged or is an active or retired member of the
13 United States Navy. Such persons may apply for a Navy Chief license
14 plate for vehicles having a rated carrying capacity of one (1) ton
15 or less, or for a motorcycle; provided, the license plate for
16 motorcycles may be of similar design to the license plate for motor
17 vehicles or may be a new design in order to meet space requirements
18 for a motorcycle license plate.

19 C. Unless otherwise provided by this section, the fee for such
20 plates shall be Eight Dollars (\$8.00) and shall be in addition to
21 all other registration fees provided by the Oklahoma Vehicle License
22 and Registration Act. Such fees shall be deposited in the Oklahoma
23 Tax Commission Reimbursement Fund to be used for the administration
24 of the Oklahoma Vehicle License and Registration Act.

1 SECTION 5. AMENDATORY 47 O.S. 2011, Section 1135.3, as
2 last amended by Section 2, Chapter 434, O.S.L. 2019 (47 O.S. Supp.
3 2020, Section 1135.3), is amended to read as follows:

4 Section 1135.3 A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support, interest, or
7 membership to or for an organization, occupation, cause or other
8 subject as provided by this section.

9 Special license plates shall not be transferred to any other
10 person but shall be removed from the vehicle upon transfer of
11 ownership and retained. The special license plate may then be used
12 on another vehicle but only after such other vehicle has been
13 registered for the current year.

14 Special license plates shall be renewed each year by the Tax
15 Commission or a motor license agent, unless authorized by the Tax
16 Commission to be renewed for a period greater than one (1) year.
17 The Tax Commission shall notify by mail all persons issued special
18 license plates. The notice shall contain all necessary information
19 and shall contain instructions for the renewal procedure upon
20 presentation to a motor license agent or the Tax Commission. The
21 license plates shall be issued on a staggered system.

22 The Tax Commission is hereby directed to develop and implement a
23 system whereby motor license agents are permitted to accept
24 applications for special license plates authorized under this

1 section. The motor license agent shall confirm the applicant's
2 eligibility, if applicable, collect and deposit any amount
3 specifically authorized by law, accept and process the necessary
4 information directly into such system and generate a receipt
5 accordingly. For performance of these duties, motor license agents
6 shall retain the fee provided in Section 1141.1 of this title for
7 registration of a motor vehicle. The motor license agent fees for
8 acceptance of applications and renewals shall be paid out of the
9 Oklahoma Tax Commission Reimbursement Fund.

10 If fewer than one hundred of any type of special license plates
11 authorized prior to January 1, 2004, are issued prior to January 1,
12 2006, the Tax Commission shall discontinue issuance and renewal of
13 that type of special license plate. Any such authorized special
14 license plate registrant shall be allowed to display the license
15 plate upon the designated vehicle until the registration expiration
16 date. After such time the expired special license plate shall be
17 removed from the vehicle.

18 Except as otherwise provided in law, for special license plates
19 authorized on or after July 1, 2004, no special license plates shall
20 be developed or issued by the Tax Commission until the Commission
21 receives one hundred (100) prepaid applications therefor. The
22 prepaid applications must be received by the Tax Commission within
23 one hundred eighty (180) days of the effective date of the
24 authorization or the authority to issue shall be null and void. In

1 the event one hundred (100) prepaid applications are not received by
2 the Tax Commission within such prescribed time period any payment so
3 received shall be refunded accordingly.

4 B. The special license plates provided by this section are as
5 follows:

6 1. Round and Square Dance License Plate - such plates shall be
7 designed and issued to any person wishing to demonstrate support for
8 round and square dancing;

9 2. National Association for the Advancement of Colored People
10 License Plate - such plates shall be designed, subject to the
11 criteria to be presented to the Tax Commission by the NAACP, and
12 issued to any person wishing to demonstrate support for the NAACP;

13 3. National Rifle Association License Plate - such plates shall
14 be designed, subject to the criteria to be presented to the Tax
15 Commission by the National Rifle Association, and issued to any
16 person wishing to demonstrate support for the National Rifle
17 Association;

18 4. Masonic Fraternity License Plate - such plates shall be
19 designed and issued to any resident of this state who is a member of
20 a Masonic Fraternity of Oklahoma. Such persons may apply for a
21 Masonic Fraternity license plate for each vehicle with a rated
22 carrying capacity of one (1) ton or less upon proof of a Masonic
23 Fraternity membership or upon the presentment of an application for
24 a Masonic Fraternity license plate authorized and approved by the

1 Grand Lodge of Oklahoma. The license plates shall be designed in
2 consultation with the Masonic Fraternities of Oklahoma and shall
3 contain the Masonic emblem;

4 5. Shriner's Hospitals for Burned and Crippled Children License
5 Plate - such plates shall be designed to demonstrate support for
6 Shriner's Hospitals for Burned and Crippled Children and shall be
7 issued to any resident of this state who is a member of a Shriner's
8 Temple in Oklahoma. The license plate shall be designed in
9 consultation with the Shriner's Temples in Oklahoma and shall
10 contain the Shriner's emblem;

11 6. Balloonists License Plate - such plates shall be designed
12 and issued to any person wishing to demonstrate support for hot air
13 ballooning in this state;

14 7. Order of the Eastern Star License Plate - such plates shall
15 be designed and issued to any resident of this state who is a member
16 of an Order of the Eastern Star. Such persons may apply for an
17 Order of the Eastern Star license plate for each vehicle with a
18 rated carrying capacity of one (1) ton or less upon proof of an
19 Order of the Eastern Star membership or upon the presentment of an
20 application for an Order of the Eastern Star license plate
21 authorized and approved by the organization. The license plate
22 shall be designed in consultation with the Order of the Eastern Star
23 and shall contain the Order of the Eastern Star emblem;

24

1 8. Knights of Columbus License Plate - such plates shall be
2 designed and issued to any resident of this state who is a member of
3 the Knights of Columbus. Such persons may apply for a Knights of
4 Columbus license plate for each vehicle with a rated carrying
5 capacity of one (1) ton or less upon proof of a Knights of Columbus
6 membership or upon the presentment of an application for a Knights
7 of Columbus license plate authorized and approved by the
8 organization. The license plate shall be designed in consultation
9 with the Knights of Columbus and shall contain the Knights of
10 Columbus emblem;

11 9. Jaycees License Plate - such plates shall be designed and
12 issued to members of the Jaycees. Persons applying for such license
13 plate must show proof of membership in the Jaycees. The license
14 plates shall be designed in consultation with the Jaycees;

15 10. Kiwanis International License Plate - such plates shall be
16 designed and issued to members of Kiwanis International. Persons
17 applying for such license plate must show proof of membership in
18 Kiwanis International. The license plates shall be designed in
19 consultation with Kiwanis International;

20 11. Certified Public Accountants License Plate - such plates
21 shall be designed and issued to any resident of this state who is a
22 Certified Public Accountant. Such persons may apply for a Certified
23 Public Accountant license plate for each vehicle with a rated
24 carrying capacity of one (1) ton or less upon proof of status as a

1 Certified Public Accountant. The license plates shall be designed
2 in consultation with the Oklahoma Society of Certified Public
3 Accountants;

4 12. Civil Emergency Management License Plate - such plates
5 shall be designed and issued to persons wishing to demonstrate
6 support for the state civil emergency management system. Persons
7 applying for such license plate must show proof of official
8 affiliation by presenting a nonexpired proof of employment,
9 affiliation or retirement in the form of an identification card or
10 letter on official letterhead from a municipal, county or state
11 emergency management department head;

12 13. Civilian Conservation Corps License Plate - such plates
13 shall be designed, subject to criteria to be presented to the Tax
14 Commission, by the Civilian Conservation Corps Association, and
15 issued to any person wishing to demonstrate support of the Civilian
16 Conservation Corps;

17 14. Rotarian License Plate - such plates shall be designed and
18 issued to any resident of this state who is a member of a Rotarian
19 Club of Oklahoma. Such persons may apply for a Rotarian license
20 plate for each vehicle with a rated carrying capacity of one (1) ton
21 or less upon proof of a Rotarian Club membership or upon the
22 presentment of an application for a Rotarian license plate
23 authorized and approved by a Rotarian Club of Oklahoma. The license
24

1 plates shall be designed in consultation with the five Rotarian
2 District Governors and shall contain the Rotarian emblem;

3 15. Benevolent Protective Order of Elks License Plate - such
4 plates shall be designed, subject to criteria to be presented to the
5 Tax Commission, by the Benevolent Protective Order of Elks, and
6 issued to any resident of this state who is a member of the
7 Benevolent Protective Order of Elks;

8 16. Humane Society License Plate - such plates shall be
9 designed and issued to any person wishing to demonstrate support for
10 the Humane Society of the United States. The plates shall be issued
11 to any person in any combination of numbers and letters from one to
12 a maximum of seven, as for personalized license plates. The plate
13 shall contain the official Humane Society logo;

14 17. Oklahoma Mustang Club License Plate - such plates shall be
15 designed, subject to criteria to be presented to the Tax Commission,
16 by the Oklahoma Mustang Club, and issued to any resident of this
17 state who is a member of the Oklahoma Mustang Club. Such persons
18 may apply for an Oklahoma Mustang Club license plate upon
19 presentment of proof of membership in the Oklahoma Mustang Club.
20 The plates shall be issued to any person in any combination of
21 numbers and letters from one to a maximum of seven, as for
22 personalized license plates;

23 18. American Business Clubs (AMBUCS) License Plate - such
24 plates shall be designed and issued to members of American Business

1 Clubs. Persons applying for such license plate must show proof of
2 membership in AMBUCS. The license plates shall be designed in
3 consultation with American Business Clubs;

4 19. West Point 200th Anniversary License Plate - such plates
5 shall be designed and issued to any person wishing to commemorate
6 the Two Hundredth Anniversary of the founding of the United States
7 Military Academy at West Point, New York. The license plates shall
8 be designed in consultation with the West Point Society of Central
9 Oklahoma;

10 20. Oklahoma Aquarium License Plate - such plates shall be
11 designed and issued to persons wishing to demonstrate support for
12 the Oklahoma Aquarium. The license plates shall be designed in
13 consultation with the Oklahoma Aquarium. Subject to the provisions
14 of subsection A of this section, the Oklahoma Aquarium license plate
15 is hereby reauthorized effective November 1, 2021;

16 21. The Pride of Broken Arrow License Plate - such plates shall
17 be designed and issued to any person wishing to demonstrate support
18 for The Pride of Broken Arrow marching band. The plates shall be
19 designed in consultation with the Broken Arrow Public School System;

20 22. Fellowship of Christian Athletes License Plate - such
21 plates shall be designed in consultation with the Fellowship of
22 Christian Athletes and issued to members and supporters of the
23 Fellowship of Christian Athletes;

24

1 23. Parrothead Club License Plate - such plates shall be
2 designed and issued to members and supporters of the Parrothead
3 Club. The license plate shall be issued to any person in any
4 combination of numbers and letters from one to a maximum of seven as
5 for personalized license plates;

6 24. Oklahoma Bicycling Coalition License Plate - such plates
7 shall be designed and issued to any person who is a member of the
8 Oklahoma Bicycling Coalition. The license plates shall be designed
9 in consultation with the Oklahoma Bicycling Coalition;

10 25. Electric Lineman License Plate - such plates shall be
11 designed and issued to persons wishing to demonstrate support for
12 Oklahoma's electric linemen. The license plates shall be designed
13 in consultation with the Oklahoma Electric Superintendent's
14 Association;

15 26. Alpha Kappa Alpha License Plate - such plates shall be
16 designed and issued to any person who is a member of Alpha Kappa
17 Alpha Sorority. The license plates shall be designed in
18 consultation with the Oklahoma Chapter of Alpha Kappa Alpha
19 Sorority;

20 27. The National Pan-Hellenic Council Incorporated License
21 Plate - such plates shall be designed and issued to any person
22 wishing to demonstrate support to any of the nine sororities and
23 fraternities recognized by the National Pan-Hellenic Council
24 Incorporated. The license plates shall be designed in consultation

1 with the Oklahoma Chapter of the National Pan-Hellenic Council
2 Incorporated;

3 28. Organ, Eye and Tissue License Plate - such plates shall be
4 designed and issued to persons wishing to demonstrate support and
5 increase awareness for organ, eye and tissue donation. The license
6 plates shall be designed in consultation with the State Department
7 of Health;

8 29. Central Oklahoma Habitat for Humanity License Plate - such
9 plates shall be designed and issued to persons wishing to
10 demonstrate support and increase awareness for Habitat for Humanity.
11 The license plate shall be designed in consultation with Central

14 License Plate - such plates shall be designed and issued to persons

1 Subject to the provisions of subsection A of this section, the Sigma
2 Gamma Rho License Plate is hereby reauthorized effective November 1,

5 designed and issued to persons wishing to demonstrate support for
6 and increase awareness of multiple sclerosis. The license plates
7 shall be designed in consultation with the Oklahoma Chapter of the
8 National Multiple Sclerosis Society;

9 38. Frederick Douglass High School License Plate - such plates
10 shall be designed and issued to any person wishing to demonstrate

13 and shall contain instructions for the renewal procedure upon
14 presentation to a motor license agent or the Tax Commission. The
15 license plates shall be issued on a staggered system.

16 The Tax Commission is hereby directed to develop and implement a
17 system whereby motor license agents are permitted to accept
18 applications for special license plates authorized under this
19 section. The motor license agent shall confirm the applicant's
20 eligibility, if applicable, collect and deposit any amount
21 specifically authorized by law, accept and process the necessary
22 information directly into such system and generate a receipt
23 accordingly. For performance of these duties, motor license agents
24 shall retain the fee provided in Section 1141.1 of this title for

1 registration of a motor vehicle. The motor license agent fees for
2 acceptance of applications and renewals shall be paid out of the
3 Oklahoma Tax Commission Reimbursement Fund.

4 If fewer than one hundred of any type of special license plates
5 authorized prior to January 1, 2004, are issued prior to January 1,
6 2006, the Tax Commission shall discontinue issuance and renewal of
7 that type of special license plate. Any such authorized special
8 license plate registrant shall be allowed to display the license
9 plate upon the designated vehicle until the registration expiration
10 date. After such time the expired special license plate shall be
11 removed from the vehicle.

15 an Environmental Awareness License Plate upon payment of the fee

21 Commission shall be authorized, if necessary, to enter into a
22 licensing agreement with the Boy Scouts of America for any licensing
23 fees which may be required in order to use the Boy Scouts of America
24 logo or design. The licensing agreement shall provide for a payment

1 to the Boy Scouts of America of not more than Twenty Dollars
2 (\$20.00) for each license plate issued;

2 be required in order to use the organization's logo or design. The
3 licensing agreement shall provide for a payment to the Oklahoma
4 Veterans of Foreign Wars Auxiliary organization of not more than
5 Twenty Dollars (\$20.00) for each license plate issued;

6 100. Transportation to Transportation License Plate - such
7 plates shall be designed and issued to persons wishing to support
8 county roads and bridges. The license plates shall be designed in
9 consultation with the Association of County Commissioners of
10 Oklahoma. Twenty Dollars (\$20.00) of the fee collected shall be
11 paid to the county treasurer for the county in which the license
12 plate was purchased to be credited to the County Highway Fund
13 created pursuant to Section 1503 of Title 69 of the Oklahoma
14 Statutes;

15 101. Blue Star Mothers License Plate - such plates shall be
16 designed and issued to any person showing proof of membership in an
17 Oklahoma Chapter of Blue Star Mothers of America, Inc. The license
18 plates shall be designed in consultation with Blue Star Mothers of
19 America, Inc., Oklahoma Chapter One. The Tax Commission shall be
20 authorized to enter into a licensing agreement with Blue Star
21 Mothers of America, Inc., Oklahoma Chapter One for any licensing
22 fees which may be required in order to use the Blue Star Mothers of
23 America logo or design. The licensing agreement shall provide for a
24 payment to Blue Star Mothers of America, Inc., Oklahoma Chapter One

1 of not more than Twenty Dollars (\$20.00) for each license plate
2 issued;

3 102. Stillwater Public Schools License Plate - such plates
4 shall be designed and issued to any person wishing to demonstrate
5 support for the Stillwater School District. The license plates
6 shall be designed in consultation with the administration of the
7 Stillwater School District. The Tax Commission shall be authorized
8 to enter into a licensing agreement with the Stillwater School
9 District for any licensing fees which may be required in order to
10 use the school district's logo or design. The licensing agreement
11 shall provide for a payment to the Stillwater School District of not
12 more than Twenty Dollars (\$20.00) for each license plate issued;

13 103. Oklahoma Golf License Plate - such plates shall be
14 designed and issued to any person wishing to demonstrate support for
15 the sport of golf in Oklahoma. The license plates shall be designed
16 in consultation with the South Central Section of the Professional
17 Golfers' Association of America and issued to any person wishing to
18 demonstrate support for the sport of golf in Oklahoma. The Tax
19 Commission shall be authorized to enter into a licensing agreement
20 with the South Central Section of the Professional Golfers'
21 Association of America for any licensing fees which may be required
22 in order to use the organization's logo or design. The licensing
23 agreement shall provide for a payment to the South Central Section
24

1 of the Professional Golfers' Association of America of not more than
2 Twenty Dollars (\$20.00) for each license plate issued;

3 104. Paramedic License Plate - such plates shall be designed
4 and issued to any person who is a paramedic. Such persons may apply
5 for a paramedic license plate for each vehicle with a rated carrying
6 capacity of one (1) ton or less upon proof of a paramedic license.

7 The license plates shall be designed in consultation with the
8 Oklahoma State University-Oklahoma City Paramedicine Program and the
9 Oklahoma Emergency Medical Technicians Association. The Tax

10 Commission shall be authorized to enter into a licensing agreement
11 with the Oklahoma Emergency Medical Technicians Association for any
12 licensing fees which may be required in order to use the

13 Association's logo or design. The licensing agreement shall provide
14 for deposit to the Emergency Medical Personnel Death Benefit
15 Revolving Fund created in Section 1-2505.2 of Title 63 of the
16 Oklahoma Statutes of not more than Twenty Dollars (\$20.00) for each
17 license plate issued;

18 105. National Defense Service Medal License Plate - such plates
19 shall be designed and issued to those persons who have received the
20 National Defense Service Medal and wish to demonstrate support for
21 the Oklahoma Department of Veterans Affairs. The license plates
22 shall be designed in consultation with the Oklahoma Department of
23 Veterans Affairs. The Tax Commission shall be authorized to enter
24 into a licensing agreement with the Oklahoma Department of Veterans

1 Affairs for any licensing fees which may be required in order to use
2 the Department's logo or design. The licensing agreement shall
3 provide for a payment to the Oklahoma Department of Veterans Affairs
4 of not more than Twenty Dollars (\$20.00) for each license plate
5 issued;

6 106. University of Oklahoma RUF/NEKS License Plate - such
7 plates shall be designed and issued to any past or present member of
8 the University of Oklahoma RUF/NEKS upon providing proof of
9 membership in the organization as may be required by the Tax
10 Commission. The license plates shall be designed in consultation
11 with the University of Oklahoma RUF/NEKS. The Tax Commission shall
12 be authorized to enter into a licensing agreement with the
13 University of Oklahoma RUF/NEKS for any licensing fees which may be
14 required in order to use the organization's logo or design. The
15 licensing agreement shall provide for a payment to the University of
16 Oklahoma RUF/NEKS Scholarship Fund of not more than Twenty Dollars
17 (\$20.00) for each license plate issued;

18 107. Tulsa Community College License Plate - such plates shall
19 be issued to persons wishing to support Tulsa Community College.
20 The plates shall be designed in consultation with Tulsa Community
21 College. The Tax Commission shall be authorized to enter into a
22 licensing agreement with Tulsa Community College for any licensing
23 fees which may be required in order to use the organization's logo
24 or design. The licensing agreement shall provide for a payment to

1 Tulsa Community College of not more than Twenty Dollars (\$20.00) for
2 each license plate issued;

3 108. Guthrie Street Kings License Plate - such plates shall be
4 designed and issued to any person wishing to demonstrate support for
5 the Guthrie Street Kings. The license plates shall be designed in
6 consultation with the Guthrie Street Kings. The Tax Commission
7 shall be authorized to enter into a licensing agreement with the
8 Guthrie Street Kings for any licensing fees which may be required in
9 order to use the organization's logo or design. The licensing
10 agreement shall provide for a payment to the Guthrie Street Kings of
11 not more than Twenty Dollars (\$20.00) for each license plate issued;

12 109. Epilepsy Foundation License Plate - such plates shall be
13 designed and issued to any person wishing to demonstrate support for
14 the Epilepsy Foundation. The license plates shall be designed in
15 consultation with the Epilepsy Foundation of Oklahoma. The Tax
16 Commission shall be authorized to enter into licensing agreements
17 with the Epilepsy Foundation for any licensing fees which may be
18 required in order to use the organization's logo or design. The
19 licensing agreement shall provide for a payment to the Epilepsy
20 Foundation of not more than Twenty Dollars (\$20.00) for each license
21 plate issued; and

22 110. America First License Plate - such plates shall be
23 designed and issued to any person wishing to demonstrate support for
24 the proclamation of "America First". The license plates shall be

1 designed in consultation with Warriors for Freedom and the Honoring
2 America's Warriors Foundations. The Tax Commission shall be
3 authorized to enter into licensing agreements with the Warriors for
4 Freedom and Honoring America's Warriors Foundations for any
5 licensing fees which may be required in order to use the
6 Foundations' logos or designs. The licensing agreements shall
7 provide for a payment to the Honoring America's Warriors Foundation
8 of not more than Ten Dollars (\$10.00) and a payment to the Warriors
9 for Freedom Foundation of not more than Ten Dollars (\$10.00) for
10 each license plate issued.

11 C. The fee for such plates shall be Thirty-five Dollars
12 (\$35.00) per year of renewal and shall be in addition to all other
13 registration fees provided by the Oklahoma Vehicle License and
14 Registration Act. The fee shall be apportioned as follows:

15 1. Twenty Dollars (\$20.00) per year of renewal or any other
16 amount as provided in this title of the fee shall be apportioned as
17 provided or deposited in a fund as specified within the paragraph
18 authorizing the special license plate;

19 2. Eight Dollars (\$8.00) per year of renewal of the fee shall
20 be deposited in the Oklahoma Tax Commission Reimbursement Fund to be
21 used for the administration of the Oklahoma Vehicle License and
22 Registration Act; and

23 3. Any remaining amounts of the fee shall be apportioned as
24 provided in Section 1104 of this title.

1 SECTION 7. AMENDATORY 47 O.S. 2011, Section 1135.7, as
2 amended by Section 5, Chapter 69, O.S.L. 2018 (47 O.S. Supp. 2020,
3 Section 1135.7), is amended to read as follows:

4 Section 1135.7 A. The Oklahoma Tax Commission or private
5 vendor with whom the Commission has contracted is authorized to
6 design and issue special license plates to any person that applies
7 to the Tax Commission or private vendor for the creation of a
8 special license plate and meets the minimum standards and
9 qualifications specified in this section.

10 B. If the following standards and guidelines are satisfied, the
11 Tax Commission shall authorize the issuance of a special license
12 plate to the person making application for the special license
13 plate:

14 1. The license plate is to:

15 a. show membership in or affiliation with an
16 organization, or

17 b. demonstrate support for an organization, group or
18 cause;

19 2. The license plate does not advertise or endorse a product,
20 brand, or service that is provided for sale;

21 3. The license plate does not promote any philosophy based on
22 prejudice or that is contrary to state civil rights laws; and

23 4. Two hundred prepaid applications for the special license
24 plate are received by the Tax Commission or private vendor.

1 C. The fee for special license plates shall be determined in
2 accordance with Section ~~1 of this act~~ 1135.9 of this title. If the
3 special license plate does not provide financial assistance the fee
4 shall be no less than Fifteen Dollars (\$15.00) per year of renewal
5 and shall be in addition to all other registration fees provided by
6 the Oklahoma Vehicle License and Registration Act. Unless otherwise
7 provided in this section, Fifteen Dollars (\$15.00) of the fee shall
8 be apportioned as follows: Eight Dollars (\$8.00) of the special
9 license plate fee shall be deposited in the Oklahoma Tax Commission
10 Reimbursement Fund to be used for the administration of the Oklahoma
11 Vehicle License and Registration Act and the remaining amounts of
12 the special license plate fee shall be apportioned as provided in
13 Section 1104 of this title.

14 D. For special license plates that provide financial assistance
15 created pursuant to the provisions of this section, the Tax
16 Commission shall be authorized to enter into a licensing agreement
17 with an organization for any licensing fees that may be required to
18 use the organization's logo or design.

19 E. The fee for special license plates that provide financial
20 assistance shall be determined in accordance with Section ~~1 of this~~
21 ~~act~~ 1135.9 of this title. Provided, the fee shall be no less than
22 Thirty-five Dollars (\$35.00) and shall be in addition to all other
23 registration fees provided by the Oklahoma Vehicle License and

1 Registration Act. Thirty-five Dollars (\$35.00) per year of renewal
2 of the fee shall be apportioned as follows:

3 1. a. Twenty Dollars (\$20.00) of the fee shall be
4 apportioned to the License Plate Special Program
5 Assistance Revolving Fund created in Section 1135.8 of
6 this title to be used in the manner detailed in the
7 application for the special license plate~~r~~, except as
8 provided in subparagraph b of this paragraph.

9 b. If the Tax Commission has entered into a licensing
10 agreement with an organization for the use of its
11 design or logo pursuant to Chapter 74 of this title,
12 an amount to be determined in the licensing agreement,
13 but not to exceed Twenty Dollars (\$20.00) per license
14 plate issued, shall be transferred monthly to that
15 organization as payment of licensing fees and no fee
16 shall be apportioned to the License Plate Special
17 Program Assistance Revolving Fund.

18 2. Eight Dollars (\$8.00) of the fee shall be deposited in the
19 Oklahoma Tax Commission Reimbursement Fund to be used for the
20 administration of the Oklahoma Vehicle License and Registration Act;
21 and

22 3. Any remaining amounts of the fee shall be apportioned as
23 provided in Section 1104 of this title.

1 ~~E.~~ F. Except as otherwise provided in subsection D and
2 subparagraph b of paragraph 1 of subsection E of this section, if a
3 person applies for a special license plate that provides financial
4 assistance, the application shall designate a state agency to be
5 responsible for expending the funds generated by the special license
6 plate and the application shall designate a specific public purpose
7 for which the funds are to be used. The application shall include
8 an acknowledgment from the designated state agency of their
9 agreement with acceptance of the designated funds.

10 ~~F.~~ G. Special license plates shall not be transferred to any
11 other person but shall be removed from the vehicle upon transfer of
12 ownership and retained. The special license plate may then be used
13 on another vehicle but only after such other vehicle has been
14 registered for the current year.

15 Special license plates shall be renewed each year by the Tax
16 Commission or a motor license agent, unless authorized by the Tax
17 Commission to be renewed for a period greater than one (1) year.
18 The Tax Commission shall notify all persons issued special license
19 plates of the renewal procedures prior to the expiration of the
20 special license plate. The notice shall contain all necessary
21 information and shall contain instructions for the renewal procedure
22 upon presentation to a motor license agent or the Tax Commission.
23 The license plates shall be issued on a staggered system.

1 The Tax Commission is hereby directed to develop and implement a
2 system whereby motor license agents are permitted to accept
3 applications for special license plates authorized under this
4 section. The motor license agent shall confirm the applicant's
5 eligibility, if applicable, collect and deposit any amount
6 specifically authorized by law, accept and process the necessary
7 information directly into such system and generate a receipt
8 accordingly. For performance of these duties, motor license agents
9 shall retain the fee provided in Section 1141.1 of this title for
10 registration of a motor vehicle. The motor license agent fees for
11 acceptance of applications and renewals shall be paid out of the
12 Oklahoma Tax Commission Reimbursement Fund.

13 ~~G.~~ H. All special plates issued by the Tax Commission prior to
14 ~~the effective date of this act~~ November 1, 2005, shall not be
15 subject to the requirements and qualifications outlined in this
16 section.

17 ~~H.~~ I. As used in this section, "person" includes an individual,
18 group, organization or not-for-profit corporation that is recognized
19 as such by the Internal Revenue Service.

20 SECTION 8. AMENDATORY Section 4, Chapter 434, O.S.L.
21 2019 (68 O.S. Supp. 2020, Section 2368.32), is amended to read as
22 follows:

23 Section 2368.32 There is hereby created in the State Treasury a
24 revolving fund to be designated the "Historic Greenwood

1 District/Juneteenth Festival Revolving Fund" and administered by the
2 Oklahoma Department of Commerce. The fund shall be a continuing
3 fund, not subject to fiscal year limitations, and shall consist of
4 all the monies received by the Oklahoma Department of Commerce
5 pursuant to the provisions related to the Historic Greenwood
6 District License Plate in Section 1135.5 of Title 47 of the Oklahoma
7 Statutes. All monies accruing to the credit of the fund are
8 appropriated and may be budgeted and expended by the Oklahoma
9 Department of Commerce at the beginning of each fiscal year for the
10 purpose of providing grants to support and promote the Historic
11 Greenwood District Juneteenth Festival in the Historic Greenwood
12 District in Tulsa, Oklahoma. Expenditures from the fund shall be
13 made upon warrants issued by the State Treasurer against claims
14 filed as prescribed by law with the Director of the Office of
15 Management and Enterprise Services for approval and payment and in
16 consultation with the Black Wall Street Chamber of Commerce. Upon
17 the effective date of Section 6 of this act, the Oklahoma Department
18 of Commerce shall transfer all the existing unencumbered monies
19 contained in the Historic Greenwood District/Juneteenth Festival
20 Revolving Fund to the Historic Greenwood District Juneteenth
21 Festival. For ninety (90) days following the effective date of
22 Section 6 of this act, the fund shall be monitored for the accrual
23 of funds. If any other monies accrue to the fund in the said ninety
24 (90) days, those funds shall be transferred to the Historic

1 Greenwood District Festival as they accrue. At the end of the
2 ninety-day term, the provisions of this section shall cease to have
3 the force and effect of law and this fund shall cease to exist.

4 SECTION 9. REPEALER Section 4, Chapter 434, O.S.L. 2019
5 (68 O.S. Supp. 2020, Section 2368.32), as last amended by Section 8
6 of this act, is hereby repealed.

7 SECTION 10. Sections 1, 2, 3, 4, 5 and 7 of this act shall
8 become effective November 1, 2021.

9 SECTION 11. Section 9 of this act shall become effective ninety
10 (90) days following the date as of which Section 6 of this act
11 becomes effective as law.

12 SECTION 12. It being immediately necessary for the preservation
13 of the public peace, health or safety, an emergency is hereby
14 declared to exist, by reason whereof Sections 6 and 8 of this act
15 shall take effect and be in full force from and after its passage
16 and approval.
