8                   An Act relating to general appropriations for the  
9                   expenses of various agencies of the executive,  
10                  legislative and judicial departments of the state;  
11                  repealing Sections 1 through 170, Chapter 371, O.S.L.  
12                  2017, which relate to appropriations; making  
13                  appropriations to the Oklahoma Education Lottery  
14                  Trust Fund, State Board of Education, the Oklahoma  
15                  Arts Council, the State Board of Career and  
16                  Technology Education, the Office of Educational  
17                  Quality and Accountability, the Oklahoma Educational

16 Recreation Department, the Oklahoma Water Resources  
17 Board, the Alcoholic Beverage Laws Enforcement  
18 Commission, the Oklahoma Department of Corrections,  
19 the Oklahoma State Bureau of Investigation, the  
20 Council on Law Enforcement Education and Training,  
21 the Board of Medicolegal Investigations, the Oklahoma  
22 State Bureau of Narcotics and Dangerous Drugs  
23 Control, the Department of Public Safety, the Court  
24 of Criminal Appeals, district attorneys and the  
District Attorneys Council, the Supreme Court, the  
Oklahoma Indigent Defense System and the Pardon and  
Parole Board; stating amounts of the appropriations;  
stating purposes and restrictions; authorizing  
certain expenditures; authorizing certain transfers;  
and providing for effect of prior allocations and  
expenditures.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER Sections 1 through 170, Chapter 371,  
O.S.L. 2017, are hereby repealed.

#### EDUCATION

SECTION 2. There is hereby appropriated to the Oklahoma  
Education Lottery Trust Fund from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury, the

5 SECTION 3. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 General Revenue Fund of the State Treasury for the fiscal year  
8 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
9 much thereof as may be necessary for the financial support of public  
10 schools.

11 SECTION 4. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Education Reform Revolving Fund created in Section 34.89 of Title 62  
14 of the Oklahoma Statutes, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
15 much thereof as may be necessary for the financial support of public  
16 schools.

17 SECTION 5. The State Board of Education is hereby authorized to  
18 expend during the fiscal year ending June 30, 2018, from the Common  
19 Education Technology Revolving Fund of the State Treasury, the sum  
20 of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be  
21 necessary for the financial support of public schools.

22 SECTION 6. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 Mineral Leasing Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
2 much thereof as may be necessary for the financial support of public  
3 schools.

4 SECTION 7. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 Mineral Leasing Fund of the State Treasury for the fiscal year  
7 ending June 30, 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
8 much thereof as may be necessary for the financial support of public  
9 schools.

10 SECTION 8. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
13 fiscal year ending June 30, 2018, the sum of \_\_\_\_\_ Dollars  
14 (\$0.00) or so much thereof as may be necessary for the financial  
15 support of public schools.

16 SECTION 9. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
19 fiscal year ending June 30, 2016, the sum of \_\_\_\_\_ Dollars  
20 (\$0.00) or so much thereof as may be necessary for the financial  
21 support of public schools.

22 SECTION 10. Notwithstanding any other provision of law, the  
23 State Board of Education is hereby authorized to expend during the  
24 fiscal year ending June 30, 2018, from the School Consolidation

1 Assistance Fund (260 Fund), the sum of \_\_\_\_\_ Dollars (\$0.00) or  
2 so much thereof as may be necessary for the financial support of  
3 public schools.

4 SECTION 11. There is hereby appropriated to the State Board of  
5 Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
8 much thereof as may be necessary for the support of public schools  
9 activities.

10 SECTION 12. There is hereby appropriated to the State Board of  
11 Education from any monies not otherwise appropriated from the  
12 General Revenue Fund of the State Treasury for the fiscal year  
13 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) or  
14 so much thereof as may be necessary for the Certified Employee  
15 Health Benefit Allowance.

16 SECTION 13. There is hereby appropriated to the State Board of  
17 Education from any monies not otherwise appropriated from the  
18 General Revenue Fund of the State Treasury for the fiscal year  
19 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars  
20 (\$0.00) so much thereof as may be necessary for the Support  
21 Personnel Health Benefit Allowance.

22 SECTION 14. There is hereby appropriated to the State Board of

3 SECTION 22. There is hereby appropriated to the State Board of  
4 Career and Technology Education from any monies not otherwise  
5 appropriated from the Oklahoma Education Lottery Trust Fund of the  
6 State Treasury for the fiscal year ending June 30, 2016, the sum of  
7 \_\_\_\_\_ Dollars (\$0.00) pursuant to paragraph 2 of subsection C  
8 of Section 713 of Title 3A of the Oklahoma Statutes for allocation  
9 by the State Board of Career and Technology Education for the  
10 education and general operating budgets of the institutions and for  
11 other programs, construction, renovations or repairs administered by  
12 the State Board of Career and Technology Education.

13 SECTION 23. Notwithstanding any other provision of law, the  
14 State Board of Career and Technology Education is hereby authorized  
15 to expend during the fiscal year ending June 30, 2018, from the  
16 State Board of Career and Technology Education Revolving Fund (200  
17 Fund), the sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof  
18 as may be necessary to perform the duties imposed upon the State  
19 Board of Career and Technology Education by law.

20 SECTION 24. There is hereby appropriated to the Office of  
21 Educational Quality and Accountability from any monies not otherwise  
22 appropriated from the General Revenue Fund of the State Treasury for  
23 the fiscal year ending June 30, 2018, the sum of \_\_\_\_\_  
24 Dollars (\$0.00) or so much thereof as may be necessary to perform



1 the duties imposed upon the Office of Educational Quality and  
2 Accountability by law.

3 SECTION 25. There is hereby appropriated to the Office of  
4 Educational Quality and Accountability from any monies not otherwise  
5 appropriated from the Special Cash Fund of the State Treasury the  
6 sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be  
7 necessary to perform the duties imposed upon the Office of  
8 Educational Quality and Accountability by law.

9 SECTION 26. There is hereby appropriated to the Oklahoma  
10 Educational Television Authority from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury for

14 the duties imposed upon the Oklahoma Educational Television  
15 Authority by law.

16 SECTION 27. There is hereby appropriated to the Oklahoma State

18 appropriated from the General Revenue Fund of the State Treasury for  
19 the fiscal year ending June 30, 2018, the sum of \_\_\_\_\_  
20 Dollars (\$0.00) or so much thereof as may be necessary for  
21 allocation by the Oklahoma State Regents for Higher Education  
22 pursuant to the provisions of Article XIII-A of the Oklahoma  
23 Constitution for the education and general operating budgets of the  
24 institutions and for other programs, construction, renovations or

1 repairs administered by the Oklahoma State Regents for Higher  
2 Education. Of those funds appropriated, the sum of \_\_\_\_\_  
3 Dollars (\$0.00) shall be transferred to the Oklahoma Tuition  
4 Equalization Grant Trust Fund to implement the provisions of the  
5 Oklahoma Tuition Equalization Grant Act.

6 SECTION 28. The Oklahoma State Regents for Higher Education are  
7 hereby authorized to expend during the fiscal year ending June 30,  
8 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) from the Higher  
9 Education Capital Revolving Fund of the State Treasury for  
10 allocation by the Oklahoma State Regents for Higher Education  
11 pursuant to the provisions of Article XIII-A of the Oklahoma  
12 Constitution for the education and general operating budgets of the  
13 institutions and for other programs, construction, renovations or  
14 repairs administered by the Oklahoma State Regents for Higher  
15 Education.

16 SECTION 29. The Oklahoma State Regents for Higher Education are  
17 hereby authorized to expend during the fiscal year ending June 30,  
18 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) from the Oklahoma  
19 Student Aid Revolving Fund of the State Treasury for allocation by  
20 the Oklahoma State Regents for Higher Education pursuant to the  
21 provisions of Article XIII-A of the Oklahoma Constitution for the  
22 education and general operating budgets of the institutions and for  
23 other programs, construction, renovations or repairs administered by  
24 the Oklahoma State Regents for Higher Education.

1 SECTION 30. There is hereby appropriated to the Oklahoma State  
2 Regents for Higher Education from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury for  
4 the fiscal year ending June 30, 2018, the sum of \_\_\_\_\_ Dollars  
5 (\$0.00) or so much thereof as may be necessary for expenditures for  
6 concurrent enrollment pursuant to Section 628.13 of Title 70 of the  
7 Oklahoma Statutes.

10 appropriated from the General Revenue Fund of the State Treasury for

13 general operating budget of the Administrative Offices of the  
14 Oklahoma State Regents for Higher Education.

15 SECTION 34. There is hereby appropriated to the Commissioners  
16 of the Land Office from any monies not otherwise appropriated from  
17 the Commissioners of the Land Office Fund of the State Treasury for  
18 the fiscal year ending June 30, 2018, the sum of \_\_\_\_\_  
19 Dollars (\$0.00) or so much thereof as may be necessary to perform  
20 the duties imposed upon the Commissioners of the Land Office by law.

21 SECTION 35. There is hereby appropriated to the Oklahoma  
22 Department of Libraries from any monies not otherwise appropriated  
23 from the General Revenue Fund of the State Treasury for the fiscal  
24 year ending June 30, 2018, the sum of \_\_\_\_\_ Dollars

1 (\$0.00) or so much thereof as may be necessary to perform the duties  
2 imposed upon the Oklahoma Department of Libraries by law.

3 SECTION 36. There is hereby appropriated to the Physician

5 appropriated from the General Revenue Fund of the State Treasury for

23 SECTION 39. There is hereby appropriated to the Oklahoma Center  
24 for the Advancement of Science and Technology from any monies not

1 otherwise appropriated from the General Revenue Fund of the State  
2 Treasury for the fiscal year ending June 30, 2018, the sum of  
3 \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be necessary  
4 to perform the duties imposed upon the Oklahoma Center for the  
5 Advancement of Science and Technology by law. Of those funds  
6 appropriated, the sum of \_\_\_\_\_ Dollars (\$0.00) shall be  
7 deposited in the Research Support Revolving Fund, created pursuant  
8 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those  
9 funds appropriated, the sum of \_\_\_\_\_ Dollars (\$0.00) shall be  
10 deposited in the Seed-Capital Revolving Fund, created pursuant to  
11 Section 5060.21 of Title 74 of the Oklahoma Statutes.

12 GENERAL GOVERNMENT AND TRANSPORTATION

13 SECTION 40. There is hereby appropriated to the Office of the  
14 Attorney General from any monies not otherwise appropriated from the  
15 General Revenue Fund of the State Treasury for the fiscal year  
16 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) or so  
17 much thereof as may be necessary to perform the duties imposed upon  
18 the Office of the Attorney General by law.

19 SECTION 41. There is hereby appropriated to the Office of the  
20 Attorney General from any monies not otherwise appropriated from the  
21 General Revenue Fund of the State Treasury for the fiscal year  
22 ending June 30, 2018, the sum of \_\_\_\_\_ Dollars (\$0.00) to  
23 transfer to the Legal Services Revolving Fund, created pursuant to  
24 subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

1           SECTION 42.           REAPPROPRIATION AND REDESIGNATION           The amount  
2 of \_\_\_\_\_ Dollars (\$0.00)) of the original appropriation of  
3 \_\_\_\_\_ Dollars (\$0.00), appropriated to the Office of the  
4 Attorney General by Section 154, Chapter 311, O.S.L. 2012, from any  
5 monies not otherwise appropriated from the Special Cash Fund of the  
6 State Treasury, for the prosecution and defense of claims related to  
7 water and water rights in Oklahoma, is hereby reappropriated and  
8 redesignated to perform the duties imposed upon the Office of the  
9 Attorney General by law. If, on the date this act is approved, any  
10 of the amount originally appropriated, as adjusted by expenditures,  
11 encumbrances and transfers, results in an unencumbered balance less  
12 than the reappropriated and redesignated amount, that reappropriated  
13 and redesignated amount is reduced to the unencumbered amount.

2 imposed upon the Office of the State Auditor and Inspector by law.

3 SECTION 45. There is hereby appropriated to the Office of the  
4 State Auditor and Inspector from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2018, the sum of \_\_\_\_\_ Dollars  
7 (\$0.00) or so much thereof as may be necessary to perform the duties  
8 imposed upon the Commission on County Government Personnel Education  
9 and Training. The appropriation made in this section shall be  
10 expended exclusively for the purpose so stated and shall not be  
11 transferable.

12 SECTION 46. Notwithstanding any other provision of law, the  
13 Office of the State Auditor and Inspector is hereby authorized to  
14 expend during the fiscal year ending June 30, 2018, from the State
