21	agency shall submit to the State Purchasing Director by November 1
22	of each year a report listing all acquisitions exceeding Fifty
23	Thousand Dollars (\$50,000.00) but not exceeding One Hundred Thousand

1 Dollars (\$100,000.00) of the state agency for the preceding fiscal 2 year which will include the following information: Professional services contracts; 3 1. 4 2. Nonprofessional services contracts; and 5 3. Contracts for the leasing of property including real property contracts and any lease agreements for products or 6 7 equipment. в. The report shall contain: 8 9 1. The name of the supplier; 10 2. A description of each acquisition; The purchase price of the acquisition; and 11 3. 12 The total amount expended to date for the preceding fiscal 4. 13 year for the acquisition. 14 C. The report shall specifically identify sole source and sole 15 brand acquisitions. 16 The state agency shall submit the report, in written or D. 17 electronic format, to the State Auditor and Inspector and to the 18 Office of Management and Enterprise Services. The state agency 19 shall submit the report, in written or electronic format, to any 20 member of the Appropriations and Budget Committee of the House of 21 Representatives or Appropriations Committee of the Senate if a 22 member so requests. 23 24
