5 AS INTRODUCED

6 An Act relating to marriage; creating the
7 Preservation of Sovereignty and Marriage Act;
8 prohibiting public funds for any activity licensing
9 or supporting same-sex marriage; prohibiting public
10 employees from recognizing same-sex marriage
11 licenses; prohibiting spending public funds to
12 enforce certain court orders; directing state courts
13 to dismiss challenges to the act; providing for
14 payment of costs and attorney fees; prohibiting
15 interference with implementation of the act;
16 requiring removal of office for any judge violating
17 the act; stating effectiveness of act against federal
18 court rulings; providing for severability; providing
19 for codification; and declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 21 of Title 43, unless there is
23 created a duplication in numbering, reads as follows:

24 A. This section shall be known and may be cited as the
"Preservation of Sovereignty and Marriage Act".

B. No taxpayer funds or governmental salaries shall be paid for
any activity that includes the licensing or support of same-sex
marriage. No employee of this state and no employee of any local

1 governmental entity shall officially recognize, grant or enforce a
2 same-sex marriage license and continue to receive a salary, pension
3 or other employee benefit at the expense of taxpayers of this state.
4 No taxes or public funds of this state shall be spent enforcing any
5 court order requiring the issuance or recognition of a same-sex
6 marriage license.

7 C. The courts of this state shall dismiss any challenge to any
8 portion of the Preservation of Sovereignty and Marriage Act, with an
9 award of costs and attorney fees to defendants. No employee of this
10 state and no employee of any local governmental entity shall violate
11 or interfere with the implementation of this act and continue to
12 receive a salary, pension or other employee benefit at the expense
13 of taxpayers of this state.

14 D. If a judge violates this act, the judge shall be removed
15 from office pursuant to Section 1 of Article VIIA of the Oklahoma
16 Constitution.

17 E. The Preservation of Sovereignty and Marriage Act shall be
18 fully effective, based on the Eleventh Amendment to the Constitution
19 of the United States and the structure of the United States
20 Constitution, against any contrary federal court ruling.

21 F. Each provision in the Preservation of Sovereignty and
22 Marriage Act is severable from the remainder of the act, such that
23 the lack of enforceability of any provision shall not affect the
24 enforceability of other provisions.

1 SECTION 2. It being immediately necessary for the preservation
2 of the public peace, health and safety, an emergency is hereby
3 declared to exist, by reason whereof this act shall take effect and
4 be in full force from and after its passage and approval.
