7 AS INTRODUCED

8 An Act relating to crimes and punishments; amending
9 21 O.S. 2021, Section 13.1, which relates to required
10 minimum sentences; adding criminal offense to list of
11 crimes; expanding scope of sentencing requirement to
12 include attempts, conspiracies, or solicitations; and
13 providing an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 21 O.S. 2021, Section 13.1, is
16 amended to read as follows:

17 Section 13.1 Persons convicted of:

18 1. First degree murder, as defined in Section 701.7 of this
19 title;

20 2. Second degree murder, as defined by Section 701.8 of this
21 title;

22 3. Manslaughter in the first degree, as defined by Section 711
23 of this title;

1 4. Poisoning with intent to kill, as defined by Section 651 of
2 this title;

3 5. Shooting with intent to kill, use of a vehicle to facilitate
4 use of a firearm, crossbow or other weapon, assault, battery, or
5 assault and battery with a deadly weapon or by other means likely to
6 produce death or great bodily harm, as provided for in Section 652
7 of this title;

8 6. Assault with intent to kill, as provided for in Section 653
9 of this title;

10 7. Conjoint robbery, as defined by Section 800 of this title;

11 8. Robbery with a dangerous weapon, as defined in Section 801
12 of this title;

13 9. First degree robbery, as defined in Section 797 of this
14 title;

15 10. First degree rape, as provided for in Section 1111, 1114 or
16 1115 of this title;

17 11. First degree arson, as defined in Section 1401 of this
18 title;

19 12. First degree burglary, as provided for in Section 1436 of
20 this title;

21 13. Bombing, as defined in Section 1767.1 of this title;

22 14. Any crime against a child, as provided for in Section 843.5
23 of this title;

24 15. Forcible sodomy, as defined in Section 888 of this title;

1 16. Child pornography or aggravated child pornography, as
2 defined in Section 1021.2, 1021.3, 1024.1, 1024.2 or 1040.12a of
3 this title;

4 17. Child prostitution, as defined in Section 1030 of this
5 title;

6 18. Lewd molestation of a child, as defined in Section 1123 of
7 this title;

8 19. Abuse of a vulnerable adult, as defined in Section 10-103
9 of Title 43A of the Oklahoma Statutes;

10 20. Aggravated trafficking, as provided for in subsection C of
11 Section 2-415 of Title 63 of the Oklahoma Statutes;

12 21. Aggravated assault and battery upon any person defending
13 another person from assault and battery; ~~or~~

14 22. Human trafficking, as provided for in Section 748 of this
15 title; or

16 23. Shooting into a dwelling or a building used for public or
17 business purposes, as provided for in Section 1289.17A of this
18 title,

19 or any attempt, conspiracy, or solicitation thereof, shall be
20 required to serve not less than eighty-five percent (85%) of any
21 sentence of imprisonment imposed by the judicial system prior to
22 becoming eligible for consideration for parole. Persons convicted
23 of these offenses shall not be eligible for earned credits or any
24 other type of credits which have the effect of reducing the length

1 of the sentence to less than eighty-five percent (85%) of the
2 sentence imposed.

3 SECTION 2. This act shall become effective November 1, 2023.
