7 An Act relating to schools; amending Section 2,
8 Chapter 13, O.S.L. 2016 (70 O.S. Supp. 2016, Section
9 822.2), which relates to the prohibition of persons
10 from giving money or a thing of value to a student-
11 athlete or family member for certain purposes;
12 removing requirement that high schools advise certain
13 students of certain information; providing an
14 effective date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY Section 2, Chapter 13, O.S.L. 2016
17 (70 O.S. Supp. 2016, Section 822.2), is amended to read as follows:

18 Section 822.2 A. Except as provided for in subsection C of
19 this section, no person shall give, offer, promise or attempt to
20 give any money or other thing of value to a student-athlete or
21 member of the immediate family of a student-athlete:

22 1. To induce, encourage or reward the application, enrollment
23 or attendance of the student-athlete at a public or private
24 institution of postsecondary education in order to have the student-
athlete participate in intercollegiate sporting events, contests,
exhibitions or programs at that institution; or

1 2. To induce, encourage or reward the participation in an
2 intercollegiate sporting event, contest, exhibition or program by
3 the student-athlete.

4 B. No person shall enter into or solicit directly or through an
5 agent a transaction with a student-athlete if the person has, or
6 could be reasonably expected to have, knowledge that the transaction
7 would likely cause the student-athlete to permanently or temporarily
8 lose athletic scholarship eligibility, the ability to participate on
9 an intercollegiate athletic team or the ability to participate in
10 one or more intercollegiate sporting competitions as sanctioned by:

11 1. A national association for the promotion and regulation of
12 intercollegiate athletics;

13 2. An athletic conference or other sanctioning body; or

14 3. The institution of postsecondary education itself as a
15 reasonable self-imposed disciplinary action taken by the institution
16 to mitigate sanctions likely to be imposed by an organization as a
17 result of the transaction or as a violation of the rules of the
18 institution.

19 C. This section shall not apply to:

20 1. Any public or private institution of postsecondary education
21 or to any officer or employee of the institution when the
22 institution or the officer or employee of the institution is acting
23 in accordance with an official written policy of the institution
24

1 which is in compliance with the bylaws of the National Collegiate
2 Athletic Association;

3 2. Any intercollegiate athletic award approved or administered
4 by the public or private institution of postsecondary education;

5 3. Grants-in-aid or other full or partial scholarships awarded
6 to a student-athlete or administered by a public or private
7 institution of postsecondary education;

8 4. Members of the immediate family of the student-athlete; and

9 5. Money or things of value given by a person to a student-
10 athlete or the immediate family of a student-athlete that do not
11 exceed One Hundred Dollars (\$100.00) in value in the aggregate on an
12 annual basis.

13 D. Any person who violates the provisions of this section shall
14 be guilty of a misdemeanor and, upon conviction, shall be subject to
15 a fine of not less than One Thousand Dollars (\$1,000.00) and not
16 more than Five Thousand Dollars (\$5,000.00), or by imprisonment not
17 to exceed one (1) year, or by both such fine and imprisonment.

18 ~~E. Each public and private high school in this state shall at
19 the beginning of each sports season advise in writing each student
20 who participates in any athletic program sponsored by the school of
21 the provisions of this section and shall provide each student with
22 information concerning the effect of receiving money or other things
23 of value on the future eligibility of the student to participate in~~
