L5	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
L 6	SECTION 1. AMENDATORY 21 O.S. 2011, Section 1952, is
L7	amended to read as follows:
18	Section 1952. As used in the Oklahoma Computer Crimes Act:
L 9	1. "Access" means to approach, gain entry to, instruct,
20	communicate with, store data in, retrieve data from or otherwise use
21	the logical, arithmetical, memory or other resources of a computer,
22	computer system or computer network;
23	2. "Computer" means an electronic device which performs work

using programmed instruction having one or more of the capabilities

- of storage, logic, arithmetic or communication. The term includes
  input, output, processing, storage, software and communication
  facilities which are connected or related to a device in a system or
  network;
  - 3. "Computer network" means the wired or wireless physical or logical interconnection of terminals by communication modes with a one or more computers or computer, or a complex consisting of two or more interconnected computers systems to each other, or to other computer networks, for the purpose of transmitting or receiving computer programs, computer software or data;
  - 4. "Computer program" means a set or series of instructions or statements and related data which when executed in actual or modified form directs or is intended to direct the functioning of a computer system in a manner designed to perform certain operations;
  - 5. "Computer software" means one or more computer programs, procedures and associated documentation used in the operation of a computer system;
  - 6. "Computer system" means a set of related, connected or unconnected, computer equipment, devices including support devices, one or more of which contain computer programs, electronic instructions, input data, and output data, that performs functions including, but not limited to, logic, arithmetic, data storage and retrieval, communication, and control and software. "Computer system" The term does not include calculators which are not

- programmable and are not capable of being connected to or used to access other computers, computer networks, computer systems or support devices;
- 7. "Data" means a representation of information, knowledge,

  facts, concepts, computer software, computer programs or

  instructions. Data may be in any form, in storage media, or as

  stored in the memory of the computer or in transit or presented on a

  display device;
- 9 8. "Malicious computer program" means any computer program that is created, executed, modified or distributed with the intent to 10 11 disrupt, destroy, deny access to, redirect, defraud, deceive, exceed 12 or gain unauthorized access to any computer, computer system, computer network or data. Malicious computer program includes, but 13 is not limited to, viruses, Trojan horses, spyware, worms, rootkits, 14 15 backdoors, ransomware and other malicious computer instructions, 16 whether part of or independent of broader computer software or computer systems; 17
  - 9. "Property" means any tangible or intangible item of value and includes, but is not limited to, financial instruments, geophysical data or the interpretation of that data, information, computer software, computer programs, electronically-produced data and computer-produced or stored data, supporting documentation, computer software in either machine or human readable form, electronic impulses, confidential, copyrighted or proprietary

- 20 | SECTION 2. AMENDATORY 21 O.S. 2011, Section 1953, as
- 21 amended by Section 1, Chapter 66, O.S.L. 2013 (21 O.S. Supp. 2020,
- 22 | Section 1953), is amended to read as follows:
- 23 Section 1953. A. It shall be unlawful to:

1. Willfully, and without authorization, gain or attempt to gain access to and damage, modify, alter, delete, destroy, copy, make use of, use malicious computer programs on, disclose or take possession of a computer, computer system, computer network, data or any other property;

- 2. Use a computer, computer system, computer network or any other property as hereinbefore defined for the purpose of devising or executing a scheme or artifice with the intent to defraud, deceive, extort or for the purpose of controlling or obtaining money, property, data, services or other thing of value by means of a false or fraudulent pretense or representation;
- 3. Willfully exceed the limits of authorization and damage, modify, alter, destroy, copy, delete, disclose or take possession of a computer, computer system, computer network, data or any other property;
- 4. Willfully and without authorization, gain or attempt to gain access to a computer, computer system, computer network, data or any other property;
- 5. Willfully and without authorization use or cause to be used computer services;
- 6. Willfully and without authorization disrupt or cause the disruption of computer services or deny or cause the denial of access or other computer services to an authorized user of a computer, computer system or computer network, other than an

- authorized entity acting for a legitimate business purpose without the effective consent of the owner;
- 7. Willfully and without authorization provide or assist in providing a means of accessing a computer, computer system, data or computer network in violation of this section;
- 8. Willfully use a computer, computer system, or computer network to annoy, abuse, threaten, or harass another person; and
- 9. Willfully use a computer, computer system, or computer network to put another person in fear of physical harm or death; and
- 10. Willfully solicit another, regardless of any financial consideration or exchange of property, of any acts described in paragraphs 1 through 9 of this subsection.
- B. Any person convicted of violating paragraph 1, 2, 3, 6, 7 or 0 or 10 of subsection A of this section shall be guilty of a felony punishable as provided in Section 1955 of this title.
- C. Any person convicted of violating paragraph 4, 5 or 8 of subsection A of this section shall be guilty of a misdemeanor.
- D. Nothing in the Oklahoma Computer Crimes Act shall be construed to prohibit the monitoring of computer usage of, or the denial of computer or Internet access to, a child by a parent, legal guardian, legal custodian, or foster parent. As used in this subsection, "child" shall mean any person less than eighteen (18) years of age.

1	E. Nothing in the Oklahoma Computer Crimes Act shall be
2	construed to prohibit testing by an authorized entity, the purpose
3	of which is to provide to the owner or operator of the computer,
4	computer system or computer network an evaluation of the security of
5	the computer, computer system or computer network against real or
6	imagined threats or harms.
7	SECTION 3. This act shall become effective November 1, 2021.
