Supp. 2022, 16 Section 2-8-224), is amended to read as follows: 17 Section 2-8-224. A. It is unlawful for a person who is under 18 twenty-one (21) years of age to purchase, receive, or have in his or 19 her possession a tobacco product, nicotine product or vapor product, 20 or to present or offer to any person any purported proof of age 21 which is false or fraudulent, for the purpose of purchasing or 22 receiving any tobacco product, nicotine product or vapor product. 23 It shall not be unlawful for an employee under twenty-one (21) years 24

- of age to handle tobacco products, nicotine products or vapor products when required in the performance of the employee's duties.
- B. When a person violates subsection A of this section, the 3 4 Alcoholic Beverage Laws Enforcement (ABLE) Commission shall require 5 the violator to shall complete an education or tobacco use cessation program approved by the State Department of Health court. If the 6 7 violator fails to complete the tobacco use cessation program ordered by the court, a fine may be imposed that shall not exceed Fifty 8 9 Dollars (\$50.00) for a first offense or One Hundred Dollars 10 (\$100.00) for subsequent offenses. The violator may also be 11 required to complete a community service program or other 12 appropriate programs or services as ordered by the court. The court 13 shall have jurisdiction over the violator for twelve (12) months 14 following sentencing to ensure all programs and orders of the court 15 are followed.
 - C. The ABLE Commission shall establish rules to provide for notification to a parent or guardian of any minor cited for a violation of this section.
 - D. Cities and towns may enact and municipal police officers may enforce ordinances prohibiting and penalizing conduct in violation of this section.
- E. For the purposes of this section, the term "vapor products"

 shall have the same meaning as provided in the Prevention of Youth

 Access to Tobacco Act.
