12	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
13	SECTION 1. NEW LAW A new section of law to be codified
14	in the Oklahoma Statutes as Section 1086.7 of Title 82, unless there
15	is created a duplication in numbering, reads as follows:
16	A. The Oklahoma Flood and Drought Management Task Force is
17	hereby established and shall be comprised of two groups, the
18	management group and the advisory group.
19	B. 1. The management group shall be comprised of designees
20	from the following state agencies:
21	a. the Oklahoma Water Resources Board, which shall serve
22	as the lead agency,
23	b. the Oklahoma Department of Emergency Management and
24	Homeland Security,

1	c. the Oklahoma Department of Agriculture, Food, and								
2	Forestry,								
3	d. the State Department of Health,								
4	e. the Department of Environmental Quality,								
5	f. the Oklahoma Conservation Commission,								
6	g. the Department of Wildlife Conservation,								
7	h. the Oklahoma Climatological Survey, and								
8	i. the Oklahoma Military Department.								
9	2. The advisory group shall be comprised of designees of the								
10	following state associations and entities:								
11	a. Association of County Commissioners of Oklahoma,								
12	b. Oklahoma Rural Water Association, and								
13	c. Oklahoma Municipal League.								
14	The advisory group shall also include the resources of all								
15	remaining state agencies and departments available to provide advice								
16	and assistance to the Oklahoma Flood and Drought Management Task								
17	Force, including the Oklahoma State Regents for Higher Education.								
18	C. The Oklahoma Water Resources Board shall formally coordinate								
19	with the following federal agencies:								
20	1. Federal Emergency Management Agency (FEMA);								
21	2. U.S. Army Corps of Engineers;								
22	3. U.S. Forest Service;								
23	4. The United States Geological Survey;								
24	5. Bureau of Reclamation;

U.S. Department of Housing and Urban Development; 6 7 12. United States Environmental Protection Agency; and 13. Any other federal agency available to provide advice and 8 9 assistance. 10 The Oklahoma Flood and Drought Management Task Force shall D. have the following duties: 11 12 1. Developing and recommending state drought and flood 13 response, recovery, and mitigation initiatives for conditions 14 determined to be detrimental to the state economy and public health; 15 2. Identifying drought and flood management areas in the state; 16 3. Providing coordination and communication among federal, 17 state, and local entities as deemed appropriate for drought and 18 flood assistance programs, education, and information; and 19 Performing such other drought- and flood-related assessments 4. 20 and response functions as deemed necessary. 21 Ε. Beginning in 2025, and every ten (10) years thereafter, in 22 conjunction with the update of the Oklahoma Comprehensive Water Plan 23 and State Flood Plan, the Oklahoma Water Resources Board shall 24
