9   AS INTRODUCED

10                           An Act relating to public finance; creating the State  
11                           Revenue Apportionment Evaluation Commission;  
12                           providing for membership; providing for service by  
13                           appointed members and removal with or without cause;  
14                           requiring organizational meeting; providing for  
15                           selection of chair and vice-chair; providing for  
16                           applicability of Open Meeting Act and Open Records  
17                           Act; providing for staff assistance; imposing duties;  
18                           requiring analysis of certain state revenue  
19                           apportionments; providing for content of analysis and  
20                           report; requiring submission of report by date  
21                           certain; providing for codification; providing an  
22                           effective date; and declaring an emergency.

23 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

24                           SECTION 1.           NEW LAW           A new section of law to be codified  
  in the Oklahoma Statutes as Section 46.5 of Title 62, unless there  
  is created a duplication in numbering, reads as follows:

1           A. There is hereby created the "State Revenue Apportionment  
2 Evaluation Commission".

3           B. The Commission shall consist of nine (9) members to be  
4 appointed or selected as follows:

5           1. Two persons appointed by the Governor;

6           2. Two persons to be appointed by the Speaker of the Oklahoma  
7 House of Representatives;

8           3. Two persons to be appointed by the President Pro Tempore of  
9 the Oklahoma State Senate;

10          4. The Executive Director of the Oklahoma Tax Commission or a  
11 designee;

12          5. The Director of the Office of Management and Enterprise  
13 Services or a designee; and

14          6. The State Treasurer or a designee.

15          C. Any person appointed to the Commission pursuant to  
16 subsection B of this section shall serve at the pleasure of the  
17 appointing authority and may be removed by such appointing authority  
18 without cause.

19          D. The Commission shall hold an organizational meeting not  
20 later than sixty (60) days after the effective date of this act and  
21 shall select from among its membership a chair and vice-chair.

22          E. The Commission shall be subject to the provisions of the  
23 Oklahoma Open Meeting Act and the Oklahoma Open Records Act.

1 F. The Commission shall be authorized to meet as often as  
2 required in order to perform the duties imposed upon it by law.

3 G. Staff assistance to the Commission shall be provided by the  
4 Oklahoma House of Representatives, the Oklahoma State Senate, the  
5 Office of Management and Enterprise Services and the Oklahoma Tax  
6 Commission.

7 H. The Commission shall analyze the state revenue system with  
8 special emphasis on the amount of revenue which is apportioned for  
9 purposes other than expenditures from the General Revenue Fund of  
10 the State Treasury. The Commission shall prepare a summary, within  
11 one hundred twenty (120) days after the end of each fiscal year, of  
12 the revenue sources which are apportioned to destinations other than  
13 the General Revenue Fund, the amount of revenue apportioned to those  
14 sources or purposes and the tax or other revenue system from which  
15 the apportionment is derived, the total amount of revenue from the  
16 state tax and revenue structure that is apportioned for purposes  
17 other than expenditures from the General Revenue Fund, a summary of  
18 any changes to apportionments enacted during the immediately  
19 preceding regular session of the Legislature and any other  
20 information which the Commission determines to be necessary for a  
21 complete analysis of the topic of apportioned revenues.

22 I. The annual report required by subsection H of this section  
23 shall be delivered to the Governor, the Speaker of the Oklahoma  
24 House of Representatives and the President Pro Tempore of the State

1 Senate by the deadline prescribed in subsection H of this section.  
2 The annual report shall also be posted to the Internet website of  
3 the Oklahoma Tax Commission.

4 SECTION 2. This act shall become effective July 1, 2019.

5 SECTION 3. It being immediately necessary for the preservation  
6 of the public peace, health or safety, an emergency is hereby  
7 declared to exist, by reason whereof this act shall take effect and  
8 be in full force from and after its passage and approval.
