8 Oklahoma Commercial Motor Carrier (CMC) Safety  
9 Enhancement Act - transferring certain size and

21 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

22 SECTION 1. NEW LAW A new section of law to be codified  
23 in the Oklahoma Statutes as Section 1-140.2 of Title 47, unless  
24 there is created a duplication in numbering, reads as follows:

1 For purposes of this title, "over-dimension" means any type of  
2 vehicle that exceeds the legal height, weight or length dimensions  
3 as specified in this title.

4 SECTION 2. NEW LAW A new section of law to be codified  
5 in the Oklahoma Statutes as Section 230.50 of Title 47, unless there  
6 is created a duplication in numbering, reads as follows:

7 Sections 2 through 6 of this act shall be known and may be cited  
8 as the "Oklahoma Commercial Motor Carrier (CMC) Safety Enhancement  
9 Act".

10 SECTION 3. NEW LAW A new section of law to be codified  
11 in the Oklahoma Statutes as Section 230.51 of Title 47, unless there  
12 is created a duplication in numbering, reads as follows:

13 The purpose of the Oklahoma Commercial Motor Carrier (CMC)  
14 Safety Enhancement Act is to consolidate operations of state  
15 agencies relating to enforcement of federal and state laws and rules  
16 regarding motor carriers, commercial motor vehicles and drivers of  
17 commercial motor vehicles by transferring the commercial motor  
18 vehicle inspection duties and responsibilities of the Department of  
19 Public Safety (Department) Size and Weight Enforcement Section  
20 (Troop S) of the Oklahoma Highway Patrol to the Oklahoma Corporation  
21 Commission (Commission). Department of Oklahoma Highway Patrol  
22 troopers assigned to Troop S, and their equipment, shall remain with  
23 the Department in order to assist with Highway Patrol officer  
24 shortages. Department port of entry officers and the vehicles,

1 computers and all other equipment assigned to them shall be  
2 transferred to the Commission effective January 1, 2020.

3 SECTION 4. NEW LAW A new section of law to be codified  
4 in the Oklahoma Statutes as Section 230.52 of Title 47, unless there  
5 is created a duplication in numbering, reads as follows:

6 The Oklahoma Commercial Motor Carrier (CMC) Safety Enhancement  
7 Act shall be implemented in two phases:

8 1. Phase I shall begin upon the effective date of this act and  
9 be completed by October 1, 2019. Phase I shall include, at a  
10 minimum:

- 11 a. the Oklahoma Corporation Commission and the Department  
12 of Public Safety developing a transfer plan,
- 13 b. the Department training and certifying Commission-  
14 designated officers to perform all levels of North  
15 American Standard Inspection (NASI),
- 16 c. the Commission and the Department coordinating with  
17 the Federal Motor Carrier Safety Administration to  
18 execute a transfer of Motor Carrier Safety Assistance  
19 Program (MCSAP) grant funds to the Commission on or  
20 before January 1, 2020,
- 21 d. the Department providing a listing of the personnel,  
22 salary, benefits, vehicles, computers and all other  
23 equipment of the Department's port of entry officers  
24 as of the effective date of this act,

1 e. the Department providing a list of its records,  
2 equipment and administrative rules associated with the  
3 NASI/MCSAP and the Federal Highway Administration  
4 (FHWA) State Enforcement Plan encompassing over-  
5 dimension commercial motor vehicles (CMVs). Portable  
6 scales assigned to the Department's Oklahoma Highway  
7 Patrol officers as of the effective date of this act  
8 may be retained by the Department for use in roadside  
9 enforcement, and

10 f. any other needs or requirements identified by the  
11 Commission or the Department; and

12 2. Phase II becomes effective January 1, 2020, at which time:

13 a. the primary duty and responsibility to perform NASI of  
14 motor carrier and commercial motor vehicles and to  
15 administer the MCSAP shall be vested with the Oklahoma  
16 Corporation Commission,

17 b. the primary duty and responsibility to cooperate with  
18 the FHWA on the State Enforcement Plan encompassing  
19 over-dimension CMVs shall be vested with the Oklahoma  
20 Corporation Commission. The Department shall supply  
21 required information to the Commission for inclusion  
22 in the State Enforcement Plan. The Commission shall  
23 enforce federal and state commercial motor vehicle  
24

1 size and weight requirements (hereinafter referred to  
2 as over-dimension),

3 c. all records associated with the NASI/MCSAP and the  
4 over-dimension program, and all vehicles and equipment  
5 assigned to the Department's port of entry officers  
6 shall transfer from the Department to the Commission,

7 d. all administrative rules promulgated by the Department  
8 related to the administration of the NASI/MCSAP  
9 program and the over-dimension program shall be  
10 transferred to and become a part of the administrative  
11 rules of the Commission. The Office of Administrative  
12 Rules in the Secretary of State's office shall provide  
13 adequate notice in the Oklahoma Register of the  
14 transfer of rules and shall place the transferred  
15 rules under the Oklahoma Corporation Commission. From  
16 and after January 1, 2020, any amendment, repeal or  
17 addition to the transferred rules shall be under the  
18 jurisdiction of the Corporation Commission,

19 e. funds sufficient to exercise the transferred duties,  
20 responsibilities and personnel shall be appropriated  
21 or allocated to the Commission for fiscal year 2020  
22 and beyond. Such funds shall not be subject to  
23 budgetary limitations. The Office of Management and  
24 Enterprise Services (OMES) is hereby authorized to

1 transfer such funds as may be necessary to effect such  
2 allocations,

3 f. personnel transferred pursuant to the provisions of  
4 this section shall not be required to accept a lesser  
5 salary than presently received; provided, the  
6 provisions of this section shall not prohibit the  
7 Commission or the Department from imposing furloughs  
8 or reductions-in-force with respect to such personnel  
9 as allowed by law. Personnel transferred shall be  
10 placed within the classification level in which they  
11 meet qualifications. All such persons shall retain  
12 seniority, sick and annual time and retirement  
13 benefits which have accrued with their tenure with the  
14 Department. The transfer of personnel shall be  
15 coordinated with OMES, and

16 g. all enforcement matters pending as of January 1, 2020,  
17 relating to the NASI or over-dimension program shall  
18 remain with the Department.

19 SECTION 5. NEW LAW A new section of law to be codified  
20 in the Oklahoma Statutes as Section 230.53 of Title 47, unless there  
21 is created a duplication in numbering, reads as follows:

22 The Department of Public Safety shall retain certified North  
23 American Standard Inspection inspectors to investigate commercial  
24 motor vehicle (CMV) accidents. An interagency cooperative agreement

1 between the Oklahoma Corporation Commission and the Department to  
2 identify the Department's commercial motor vehicle accident  
3 investigation allowable reimbursable expenses under the Motor  
4 Carrier Safety Assistance Program (MCSAP), and for the Commission to  
5 provide assistance to the Department, as needed, may be executed.  
6 The Commission is not obligated to reimburse the Department any  
7 allowable expenses in excess of those obtained under the MCSAP  
8 grant. The Department may request assistance from the Commission  
9 when investigating CMV accidents.

10 SECTION 6. NEW LAW A new section of law to be codified  
11 in the Oklahoma Statutes as Section 230.54 of Title 47, unless there  
12 is created a duplication in numbering, reads as follows:

13 A. The Oklahoma Corporation Commission is hereby authorized to  
14 promulgate rules to establish the amounts of fines or penalties  
15 associated with the Oklahoma Commercial Motor Carrier Safety  
16 Enhancement Act.

17 B. The Commission shall adjudicate civil enforcement actions  
18 initiated by Commission personnel.

19 C. There is hereby created in the State Treasury a revolving  
20 fund to be known and designated as the "Safety Enhancement Act  
21 Fund". All funds derived from fines and penalties collected, funds  
22 received by the Commission pursuant to the provisions of the  
23 Oklahoma Commercial Motor Carrier (CMC) Safety Enhancement Act shall  
24 be deposited in the fund. The fund shall be a continuing fund not

1 subject to fiscal year limitations. All monies accruing to the  
2 credit of the fund are hereby appropriated and may be budgeted and  
3 expended by the Commission. Expenditures from the fund shall be  
4 made upon warrants issued by the State Treasurer against claims  
5 filed as prescribed by law with the Director of the Office of  
6 Management and Enterprise Services for approval and payment.

7 SECTION 7. AMENDATORY 47 O.S. 2011, Section 2-105.4A, as  
8 amended by Section 1, Chapter 99, O.S.L. 2015 (47 O.S. Supp. 2018,  
9 Section 2-105.4A), is amended to read as follows:

10 Section 2-105.4A ~~There is hereby created within the Oklahoma~~  
11 ~~Highway Patrol Division the Size and Weight Enforcement Section.~~  
12 ~~The Commissioner of Public Safety shall employ a minimum of twenty-~~  
13 ~~five additional members of the Oklahoma Highway Patrol, one Captain~~  
14 ~~and eight Lieutenants and shall assign the twenty-five members of~~  
15 ~~the Oklahoma Highway Patrol, one Captain and eight Lieutenants to~~  
16 ~~the Size and Weight Enforcement Section. The Size and Weight~~  
17 ~~Enforcement Section~~ Motor Carrier/Vehicle Enforcement Section of the  
18 Oklahoma Corporation Commission's Transportation Division shall have  
19 the primary duty of the enforcement of the provisions of Section 14-  
20 101 et seq. of this title.

21 ~~Said Commissioner~~ The Commission shall purchase and maintain the  
22 necessary motor vehicle equipment, portable scales and other items  
23 of equipment and supplies and shall provide proper training  
24 necessary for the enforcement of the provisions of Section 14-101 et



1 seq. of this title. At the discretion of the Commissioner of Public  
2 Safety, the Department of Public Safety may assign duties to an  
3 Oklahoma Highway Patrol Trooper relating to size and weight  
4 enforcement and may purchase and maintain the necessary motor  
5 vehicle equipment, portable scales and other items of equipment and  
6 supplies and provide proper training necessary for the supplemental  
7 enforcement of the provisions of Section 14-101 et seq. of this  
8 title. The Department shall ensure that any such supplemental  
9 enforcement by the Department is consistent with enforcement by the  
10 Commission.

11 SECTION 8. AMENDATORY 47 O.S. 2011, Section 2-124, as  
12 amended by Section 165, Chapter 304, O.S.L. 2012 (47 O.S. Supp.  
13 2018, Section 2-124), is amended to read as follows:

14 Section 2-124. A. There is hereby created within the  
15 Department of Public Safety an Oklahoma Law Enforcement  
16 Telecommunication Systems Division.

17 B. The Division shall:

18 1. Operate and maintain an ~~on-line, real-time~~ online, real-time  
19 computer system and a statewide law enforcement data communication  
20 network;

21 2. Utilize and distribute information on vehicle registration,  
22 driver records, criminals and the commission of crimes;

23

1           3. Be responsible for the coordination of user agencies with  
2 the National Crime Information Center in Washington, D.C., and the  
3 National Law Enforcement Telecommunication System, or its successor;

4           4. Be the central access and control point for Oklahoma's  
5 input, retrieval and exchange of law enforcement information in the  
6 National Crime Information Center and the National Law Enforcement  
7 Telecommunication System; and

8           5. Provide user agencies a data communication network, in order  
9 to exchange and distribute law enforcement data rapidly, and  
10 training in the use of the Oklahoma Law Enforcement  
11 Telecommunication Systems.

12           C. The statewide law enforcement data communications network  
13 shall be a part of the Oklahoma Government Telecommunications  
14 Network (OGTN) created in Section 34.23 of Title 62 of the Oklahoma  
15 Statutes; provided, however, the Department of Public Safety may  
16 continue to operate, maintain and enhance the statewide law  
17 enforcement data communications network; provided, however, the  
18 Department of Public Safety shall submit all plans for the  
19 enhancement of the statewide law enforcement communications network  
20 to the Office of Management and Enterprise Services for review and  
21 approval. The Department of Public Safety shall participate with  
22 the Office of Management and Enterprise Services in joint efforts to  
23 provide services for the OGTN.

1 D. All criminal justice agencies disseminating criminal history  
2 information derived from the National Crime Information Center's  
3 criminal history file shall maintain a record of dissemination in  
4 accordance with federal law as well as rules promulgated by the  
5 National Crime Information Center and the Commissioner of Public  
6 Safety.

7 E. North American Standard Inspection-certified motor carrier  
8 enforcement officers (MCEOs) and certified enforcement managers  
9 employed by the Oklahoma Corporation Commission shall be granted  
10 access to the National Law Enforcement Telecommunication System to  
11 perform functions required as a result of statutory duties related  
12 to motor carriers, commercial motor vehicles, trailers and drivers  
13 of commercial motor vehicles.

14 F. The Oklahoma Law Enforcement Telecommunication Systems  
15 Division shall have the authority to audit state and local law  
16 enforcement and criminal justice agencies to ensure compliance with  
17 federal laws as well as rules of the Department of Public Safety  
18 which pertain to the Oklahoma Law Enforcement Telecommunication  
19 Systems.

20 SECTION 9. AMENDATORY 47 O.S. 2011, Section 14-111, as  
21 amended by Section 2, Chapter 249, O.S.L. 2012 (47 O.S. Supp. 2018,  
22 Section 14-111), is amended to read as follows:

23 Section 14-111. A. Any officer of the Department of Public  
24 Safety, the Oklahoma Corporation Commission, any sheriff, or any

1 | salaried deputy sheriff is authorized to stop any vehicle upon any  
2 | road or highway in order to weigh such vehicle by means of portable  
3 | or stationary scales, or cause the same to be weighed by any  
4 | official weigher, or upon any privately owned scales and may require  
5 | that such vehicles be driven to the nearest or most convenient  
6 | available scales for the purpose of weighing. Any officer weighing  
7 | a vehicle pursuant to this section by means of portable scales shall  
8 | allow the driver of the vehicle to move the vehicle to the most  
9 | level weighing area available within two (2) miles of the stop. In  
10 | the event that any axle weight or the gross weight of any such  
11 | vehicle be found to exceed the maximum weight authorized by law, or  
12 | by permit issued therefor, the officer may require, in the case of  
13 | separable loads, the driver, operator or owner thereof to unload at  
14 | the site such portion of the load as may be necessary to decrease  
15 | the weight of such vehicle to the maximum weight authorized by law.  
16 | Provided, however, that if such load consists of livestock,  
17 | perishable merchandise, or merchandise that may be destroyed by the  
18 | weather, then the driver shall be permitted to proceed to the  
19 | nearest practical unloading point in the direction of destination  
20 | before discharging such excess cargo. All material so unloaded  
21 | shall be cared for by the owner or operator of such vehicle at the  
22 | risk of such owner or operator.

23 |       B. The operator of any truck or other vehicle transporting farm  
24 | products for hire or other merchandise for hire shall have in his or

1 her possession a certificate carrying the following information:  
2 name of the operator; driver license number; vehicle registration  
3 number; Corporation Commission permit number; and statement of owner  
4 authorizing transportation of the products by above named operator.  
5 For the purposes of this section "certificate" includes electronic  
6 manifests and other similar documents that include all of the  
7 information required pursuant to this section.

8       Should the vehicle be loaded with livestock, the certificate or  
9 a bill of lading shall accompany the load and shall include the  
10 number of animals, and should the livestock be the property of more  
11 than one person, a certificate signed by each owner carrying the  
12 above information including the number of animals owned by each  
13 owner shall be carried by the operator. Should the operator be the  
14 owner of the merchandise or livestock, the merchandise or livestock  
15 having just been purchased, the operator shall have in his or her  
16 possession a bill of sale for such merchandise or livestock. Should  
17 the operator be the owner of livestock or other farm products  
18 produced by the operator, the operator shall be required to show  
19 satisfactory identification and ownership of the vehicle. Any  
20 officer as outlined in this chapter shall have the authority to stop  
21 any vehicle loaded with livestock, merchandise or other farm  
22 products and investigate as to the ownership of the merchandise,  
23 livestock or other farm products. Should the operator of any  
24 vehicle be unable to establish to the satisfaction of the officer

1 the ownership of the merchandise, livestock or other products, or  
2 shall not have the certificate as specified in this section for the  
3 transportation of such merchandise, livestock or other farm  
4 products, the merchandise, livestock or other farm products and the  
5 vehicle in which they are being transported shall be impounded by  
6 the officer and any expense as to the care of any livestock shall be  
7 the responsibility of the owner or operator of the vehicle, and any  
8 loss or damage of the merchandise, livestock or other farm products  
9 shall be the responsibility of the operator or owner, or both.

10 The provisions of this subsection shall not apply to a person  
11 who is transporting horses or livestock; provided, the person shall  
12 not have been hired to transport the horses or livestock.

13 SECTION 10. AMENDATORY 47 O.S. 2011, Section 14-113, is  
14 amended to read as follows:

15 Section 14-113. The Director of the Department of  
16 Transportation with respect to highways on the state highway system,  
17 or local authorities with respect to highways under their  
18 jurisdiction, as defined in Title 69 of the Oklahoma Statutes, may  
19 prohibit the operation of vehicles on any such highways, or impose  
20 restrictions as to the weights of vehicles to be operated upon any  
21 state or federal highway or any detour established for such  
22 highways, or for any bridge located upon such highways or detours,  
23 whenever any such highway, detour or bridge by reason of  
24 deterioration, rain, snow or other climatic conditions will be

1 seriously damaged or destroyed unless the use of vehicles thereon is  
2 prohibited or the permissible weight reduced. Such restrictions  
3 shall be effective when signs giving notice thereof are erected upon  
4 the highway, detour, bridge, or portion thereof affected by such  
5 action, and the Department of Public Safety ~~has~~ and the Oklahoma  
6 Corporation Commission have been notified. The purpose of this  
7 provision with respect to local authorities is to give such  
8 authorities an opportunity to prevent or minimize an immediate  
9 threat of serious harm or destruction to any highway, detour or  
10 bridge under their jurisdiction due to rain, snow or other climatic  
11 conditions. Nothing stated herein shall be construed to grant local  
12 authorities the right to issue permits designed to regulate the use  
13 of overweight vehicles upon highways subject to their jurisdiction,  
14 and the issuance of such permits is expressly prohibited.

15 SECTION 11. AMENDATORY 47 O.S. 2011, Section 14-116, as  
16 last amended by Section 3, Chapter 373, O.S.L. 2016 (47 O.S. Supp.  
17 2018, Section 14-116), is amended to read as follows:

18 Section 14-116. A. The Commissioner of Public Safety shall  
19 charge a minimum permit fee of Forty Dollars (\$40.00) for any permit  
20 issued pursuant to the provisions of Section 14-101 et seq. of this  
21 title. In addition to the permit fee, the Commissioner shall charge  
22 a fee of Ten Dollars (\$10.00) for each thousand pounds in excess of  
23 the legal load limit. The Commissioner of Public Safety shall  
24 establish any necessary rules for collecting the fees.

1 B. The Department of Public Safety is authorized to establish  
2 an escrow account system for the payment of permit fees. Authorized  
3 motor carriers meeting established credit requirements may  
4 participate in the escrow account system for permits purchased from  
5 all size and weight permit offices in this state. Carriers not  
6 choosing to participate in the escrow account system shall be  
7 required to make payment of the required fee or fees upon purchase  
8 of each permit as required by law. All monies collected through the  
9 escrow account system shall be deposited to a special account of the  
10 Department of Public Safety and placed in the custody of the State  
11 Treasurer. Proceeds from permits purchased using the escrow account  
12 system shall be distributed as provided for in subsection H of this  
13 section. However, fees collected through such accounts for the  
14 electronic transmission, transfer or delivery of permits, as  
15 provided for in Section 14-118 of this title, shall be credited to  
16 the Department of Public Safety Restricted Revolving Fund.

17 C. 1. Application for permits shall be made a reasonable time  
18 in advance of the expected time of movement of such vehicles. For  
19 emergencies affecting the health or safety of persons or a  
20 community, permits may be issued for immediate movement.

21 2. Size and weight permit offices in all districts where  
22 applicable shall issue permits to authorize carriers by telephone  
23 during weekdays.

24



1 D. No overweight permit shall be valid until all license taxes  
2 due the State of Oklahoma have been paid.

3 E. No permit violation shall be deemed to have occurred when an  
4 oversize or overweight movement is made pursuant to a permit whose  
5 stated weight or size exceeds the actual load.

6 F. Any permit issued for a truck or truck-tractor operating in  
7 combination with a trailer or a semitrailer shall contain only the  
8 license plate number for the truck or truck-tractor if the permittee  
9 provides to the Department a list containing the license plate  
10 number, and such other information as the Department may prescribe  
11 by rule, for each trailer or semitrailer which may be used for  
12 movement with the permit. When the permittee provides the list  
13 described in this subsection, the license plate number for any  
14 trailer or semitrailer to be moved with the permit shall not be  
15 included on the permit; provided, a trailer or semitrailer which is  
16 not on the list shall not be authorized to be used for movement with  
17 the permit. It shall be the responsibility of the permittee to  
18 ensure the list provided to the Department is maintained and updated  
19 with any fleet changes. The Department shall adopt any rules deemed  
20 necessary to administer the provisions of this subsection.

21 G. The first deliverer of motor vehicles designated truck  
22 carriers or well service carriers manufactured in Oklahoma shall not  
23 be required to purchase an overweight permit when being delivered to  
24 the first purchaser.

1 H. Except as provided in Section 14-122 of this title, the  
2 first One Million Two Hundred Sixteen Thousand Dollars  
3 (\$1,216,000.00) of proceeds from both the permit fees and the  
4 overweight permit fees imposed pursuant to subsection A of this  
5 section collected monthly shall be apportioned as provided in  
6 Section 1104 of this title. For the fiscal year beginning July 1,  
7 ~~2016~~ 2019, and ~~ending June 30, 2017,~~ the next ~~Two Million One~~  
8 ~~Hundred Fifty Thousand Dollars (\$2,150,000.00)~~ Seven Hundred Fifty  
9 Thousand Dollars (\$750,000.00) of proceeds from both the permit fees  
10 and the overweight permit fees imposed pursuant to subsection A of  
11 this section collected monthly shall be remitted to the ~~Department~~  
12 ~~of Public Safety~~ Enhancement Act Fund for the purpose of ~~training~~  
13 ~~the Department of Public Safety~~ Oklahoma Corporation Commission  
14 staffing and equipping the port of entry ~~officers whose powers and~~  
15 ~~duties shall be specified by the Department of Public Safety through~~  
16 ~~the promulgation of rules~~ weigh stations with North American  
17 Standard Inspection-certified motor carrier enforcement officers,  
18 which begins January 1, 2020. For the fiscal year beginning July 1,  
19 ~~2017~~ 2020, and all subsequent years, the next One Million Five  
20 Hundred Thousand Dollars (\$1,500,000.00) of proceeds from both the  
21 permit fees and the overweight permit fees imposed pursuant to  
22 subsection A of this section collected monthly shall be remitted to  
23 the ~~Department of Public Safety~~ Enhancement Act Fund for the purpose  
24 of the Oklahoma Corporation Commission staffing and equipping the

1 port of entry weigh stations with ~~Department of Public Safety port~~  
2 ~~of entry~~ North American Standard Inspection-certified motor carrier  
3 enforcement officers ~~whose powers and duties shall be specified by~~  
4 ~~the Department of Public Safety through the promulgation of rules.~~

5 For the fiscal year beginning July 1, ~~2016~~ 2019, and ending June 30,  
6 ~~2017~~ 2020, all proceeds collected from both the permit fees and the  
7 overweight permit fees imposed pursuant to subsection A of this  
8 section in excess of ~~Three Million Three Hundred Sixty-six Thousand~~  
9 ~~Dollars (\$3,366,000.00)~~ One Million Nine Hundred Sixty-six Thousand  
10 Dollars (\$1,966,000.00) shall be deposited in the Weigh Station  
11 Improvement Revolving Fund as provided in Section 1167 of this title  
12 for the purpose set forth in that section and may be used for motor  
13 carrier permitting systems and motor carrier safety and enforcement.

14 For the fiscal year beginning July 1, ~~2017~~ 2020, and all subsequent  
15 years, all proceeds collected from both the permit fees and the  
16 overweight permit fees imposed pursuant to subsection A of this  
17 section in excess of Two Million Seven Hundred Sixteen Thousand

15 promulgated on April 28, 2003, by the United States Department of

6 classification of inspection being conducted.

7       F. To process motor carriers and commercial motor vehicles  
8 Automatic License Plate Readers may be used in electronic screening  
9 operations for the purpose of credential checks, public safety and  
10 protection of infrastructure.

11       G. Data collected or retained through the use of an ALPR  
12 system:

13       1. Is confidential and not subject to disclosure under the  
14 Oklahoma Open Records Act, Section 24A.1 et seq. of Title 51 of the  
15 Oklahoma Statutes;

16       2. Is available for use only by the Department, the Authority  
17 or the Commission in carrying out its functions or by a law  
18 enforcement agency conducting North American Standard Inspections or  
19 criminal investigations;

20       3. May be published and released as public information using  
21 aggregate data that does not reveal the activities or identify  
22 specific commercial motor vehicles or specific motor carriers; and

23       4. May be shared with the Federal Motor Carrier Safety  
24 Administration for regulatory compliance purposes.
