7 An Act relating to school employee pay; amending 70
8 O.S. 2011, Sections 6-206 and 6-206.1, as amended by
9 Section 603, Chapter 304, O.S.L. 2012 (70 O.S. Supp.
10 2017, Section 6-206.1), which relate to the annual
11 salary bonus for school psychologists, speech-
12 language pathologists and audiologists; deleting
13 funding contingency language; deleting obsolete
14 language; changing name of certain fund; providing an
15 effective date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 70 O.S. 2011, Section 6-206, is
amended to read as follows:

A. ~~Subject to the availability of funds, the~~ The State Board of
Education shall provide an annual salary bonus in the amount of Five
Thousand Dollars (\$5,000.00) no later than January 31 of each year
to the following employees of public school districts:

1. Any school psychologist who has been designated as a
Nationally Certified School Psychologist by the National School
Psychology Certification Board; and

1 2. Any speech-language pathologist or audiologist who holds a
2 Certificate of Clinical Competence awarded by the American Speech-
3 Language Hearing Association.

4 B. The State Board of Education shall adopt rules for the
5 provision of the bonus pursuant to this section to include, but not
6 be limited to, a process by which a nationally certified school
7 psychologist, speech-language pathologist and audiologist may verify
8 that:

9 1. The individual is still employed by a school district;

10 2. The certification required in subsection A of this section
11 has been attained and has not lapsed; and

12 3. The individual is licensed to practice in this state.

13 C. An individual who qualifies for the bonus pursuant to this
14 section and who is employed by a school district on less than a
15 full-time basis, shall receive a pro-rated bonus based on the
16 proportionate equivalency to full-time employment.

17 D. No school or school district shall be liable for payment of
18 bonuses pursuant to this section. The bonus shall not be included
19 in the calculation of salary for purposes of meeting the district or
20 statutory minimum salary schedule or for purposes of calculating
21 Teachers' Retirement System of Oklahoma contributions or benefits.

3 SECTION 2. AMENDATORY 70 O.S. 2011, Section 6-206.1, as
4 amended by Section 603, Chapter 304, O.S.L. 2012 (70 O.S. Supp.
5 2017, Section 6-206.1), is amended to read as follows:

6 Section 6-206.1 There is hereby created in the State Treasury a
7 revolving fund for the State Board of Education to be designated the
8 "Oklahoma School Psychologist, Speech-Language Pathologist, and
9 Audiologist National Certification Revolving Fund". The fund shall
10 be a continuing fund, not subject to fiscal year limitations, and
11 shall consist of all monies appropriated or transferred to the fund
12 by the Legislature. All monies accruing to the credit of the fund
13 are hereby appropriated and may be budgeted and expended by the
14 State Board of Education to provide an annual bonus for individuals
15 meeting the requirements of Section 6-206 of this title.
16 Expenditures from the fund shall be made upon warrants issued by the
17 State Treasurer against claims filed as prescribed by law with the
18 Director of the Office of Management and Enterprise Services for
19 approval and payment.

20 SECTION 3. This act shall become effective July 1, 2018.

21 SECTION 4. It being immediately necessary for the preservation
22 of the public peace, health or safety, an emergency is hereby

2 be in full force from and after its passage and approval.
