6	<u>AS INTRODUCED</u>
7	An Act relating to schools; creating the Humanity of the Unborn Child Act; affirming public policy of the
8	state; creating certain revolving fund; requiring funds to be expended by State Board of Education for
9 10	certain purpose; requiring State Department of Education to operate certain program to educate
11	<pre>public and students in certain grades; requiring Department to develop certain programs that contain certain criteria; requiring medical providers and</pre>
12	hospitals to inform pregnant patient of certain programs; requiring public schools operating at grade
13	nine to provide certain instruction; requiring public schools to inform parent prior to presentation of
14	certain instruction; providing for codification; providing for noncodification;
15	effective date.

17	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
18	SECTION 1. NEW LAW A new section of law to be codified
19	in the Oklahoma Statutes as Section 11-112 of Title 70, unless there
20	is created a duplication in numbering, reads as follows:
21	This act shall be known and may be cited as the "Humanity of the
22	Unborn Child Act".
23	SECTION 2. NEW LAW A new section of law not to be
24	codified in the Oklahoma Statutes reads as follows:

Pursuant to the United States Supreme Court Case Maher v. Roe, which held that the U.S. Constitution imposes "no limitation on the authority of a state to make a value judgment favoring childbirth over abortion, and to implement that judgment by the allocation of public funds", 432 U.S. 464, 474 (1977), the Legislature hereby affirms that it is the public policy of the State of Oklahoma to make a value judgment favoring childbirth over abortion, and to implement that judgment by the allocation of public funds.

SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 11-112.1 of Title 70, unless there is created a duplication in numbering, reads as follows:

There is hereby created in the State Treasury a revolving fund for the State Board of Education to be designated as the "Public Education on the Humanity of the Unborn Child Fund". The fund shall be a continuing fund, not subject to fiscal year limitations, and shall consist of all monies deposited to the credit of the fund by law. All monies accruing to the credit of said fund shall be budgeted and expended by the Board for the establishment of the public information programs established in Section 4 of this act. Expenditures from said fund shall be made upon warrants issued by the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.

SECTION 4. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 11-112.2 of Title 70, unless there is created a duplication in numbering, reads as follows:

- A. Contingent on the provision of appropriated funds or revolving funds designated for the State Board of Education for such purpose, the State Department of Education shall establish, operate and maintain a public information program or programs for the purpose of educating the public about the humanity of a child in utero. The fund shall not be available to any organization or affiliate of an organization which provides or promotes abortions or refers for abortion. Expenditures shall be drawn from the Public Education on the Humanity of the Unborn Child Fund.
- B. The Department shall establish, operate and maintain a program to educate students in grades nine through twelve about the humanity of a child in utero. The Department shall conduct the programs and activities in paragraphs 1 through 10 of this subsection to the extent possible pursuant to the funds appropriated for the program, and may utilize information from the State Department of Health and the State Board of Medical Licensure and Supervision which complies with the purposes of the Humanity of the Unborn Child Act. The Department shall:
- 1. Develop and make available materials designed to provide accurate, scientifically verifiable information concerning the probable anatomical and physiological characteristics of the unborn

child at two-week gestational intervals. The Department may utilize as a resource the material created pursuant to Section 1-738.2 of

Title 63 of the Oklahoma Statutes and as located on the website,

www.awomansright.org;

- 2. Develop, update annually and maintain information concerning public and private agencies and services available to assist a woman through pregnancy, upon childbirth and while the child is dependent, which shall include a comprehensive list of the agencies available, including adoption agencies, a description of the services they offer and a description of the manner, including telephone numbers and email addresses, by which they might be contacted. The Department shall index this information geographically and shall make it readily accessible on the Department's website. The website shall include the following statement:
 - "There are many public and private agencies willing and able to help you to carry your child to term and to assist you and your child after your child is born, whether you choose to keep your child or to place him or her for adoption. The State of Oklahoma strongly urges you to contact them if you are pregnant.";
- 3. Develop and distribute educational and informational materials, including audiovisual materials, to provide public information through public service announcements, media and otherwise for the purpose of achieving an abortion-free society.

- Such materials shall be developed from the most readily available,

 accurate and up-to-date information and shall clearly and

 consistently teach that abortion kills a living human being and is

 against public policy;
 - 4. Develop and conduct training programs concerning unborn child humanity education and abortion prevention for teachers, counselors, other educational personnel, parents, public service personnel and community leaders;

- 5. Provide technical assistance to help community-based organizations in the planning and implementation of abortion prevention, alternatives to abortion referral and unborn child humanity education programs;
- 6. Provide outreach, consultation, training and alternatives to abortion referral services to schools, organizations and members of the community;
- 7. Develop, identify, publicize the availability of and widely disseminate the most readily available, accurate and up-to-date secondary school unborn child humanity education and abortion prevention curricula and materials, including audiovisual materials which clearly and consistently teach that abortion is against public policy;
- 8. Facilitate the use of appropriate means of communicating to students about the humanity of the unborn child, especially

involving the participation of entertainment personalities and athletes who are recognizable role models for many young people;

- 9. Develop and distribute educational and informational material concerning maternal behavior during pregnancy which is helpful to a human child in utero, including avoidance of tobacco, alcohol and other drugs; proper nutrition and prenatal vitamins; and utilization of and resources available for prenatal medical and wellness care; and
- 10. Other programs of unborn child humanity education and abortion prevention consistent with the purposes of the Humanity of the Unborn Child Act.
- SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 11-112.3 of Title 70, unless there is created a duplication in numbering, reads as follows:
- A. Each medical provider licensed in this state and each hospital licensed in this state shall inform each pregnant patient under the care of the physician or hospital, not later than five (5) days from the determination that the patient is pregnant, of the public information programs developed pursuant to Section 4 of this act.
- B. Contingent on the provision of appropriated funds or revolving funds designated for the Public Education on the Humanity of the Unborn Child Fund, each public school operating at grade level nine in Oklahoma shall provide a unit of instruction during

        SECTION 6. This act shall become effective November 1, 2016.
