15	amended by Section 1, Chapter 128, O.S.L. 2022 (59 O.S. Supp. 2022,
16	Section 6001), is amended to read as follows:
17	Section 6001. A. 1. There is hereby re-created the State
18	Board of Behavioral Health Licensure to continue until July 1, <del>2023</del>
19	2025, in accordance with the provisions of the Oklahoma Sunset Law.
20	2. Members of the Board shall serve at the pleasure of and may
21	be removed from office by the appointing authority. Members shall
22	continue to serve until their successors are appointed. Any vacancy
23	shall be filled in the same manner as the original appointments.
24	Four members shall constitute a quorum.

A majority of the Board shall constitute a quorum for the
 transaction of business.

The members of the Board from each professional area of 3 3. behavioral health counseling shall comprise separate committees and 4 5 shall consult on professional issues within their respective areas of behavioral health counseling. Each committee shall recommend to 6 the Board approval or disapproval of all licenses to be issued 7 within its specialty. Each committee shall be authorized to 8 9 recommend approval or disapproval of the examination requirements 10 for all applicants for licensure in the respective area of behavioral health counseling, provide grading standards for 11 12 examinations, and provide for other matters relating to licensure in that area of behavioral health counseling. Each committee may 13 create advisory committees to consult on professional duties and 14 responsibilities pursuant to the provisions of this section. 15

4. Any and all recommendations, approvals, or disapprovals made
by a committee pursuant to the provisions of this section shall not
become effective without the approval of a majority of members of
the Board.

5. The jurisdictional areas of the Board shall include
 professional counseling licensing and practice issues, marital and
 family therapist licensing and practice issues, behavioral
 practitioner licensing and practice issues and such other areas as
 authorized by the Licensed Professional Counselors Act.

 all applicable requirements of the Administrative Procedures Act
 have been followed including but not limited to notice, rule impact
 statements and rule-making hearings.

5 D. Members of the Board shall serve without compensation but 6 may be reimbursed for expenses incurred in the performance of their 7 duties, as provided in the State Travel Reimbursement Act. The 8 Board is authorized to utilize the conference rooms of and obtain 9 administrative assistance from the State Board of Medical Licensure 10 and Supervision as required.

11 E. The Board is authorized and empowered to:

Establish and maintain a system of licensure and
 certification pursuant to the provisions of the Licensed
 Professional Counselors Act;

Adopt and enforce standards governing the professional
 conduct of persons licensed pursuant to the provisions of the

Lease office space for the purpose of operating and
 maintaining a state office, and pay rent thereon; provided, however,
 such state office shall not be located in or directly adjacent to
 the office of any person licensed pursuant to the provisions of the

5. Employ such office personnel as may be necessary, and fix
 and pay their salaries or wages;

Contract with state agencies for the purposes of 3 investigating written complaints regarding the conduct of persons 4 5 licensed pursuant to the provisions of the Licensed Professional 6 Counselors Act and obtaining administrative assistance as deemed necessary by the Executive Director; and 7 7. Make such other expenditures as may be necessary in the 8 9 performance of its duties. The Board shall employ an Executive Director. The Executive 10 F. Director shall be authorized to: 11 12 1. Employ and maintain an office staff; 13 2. Enter into contracts on behalf of the Board; and 3. Perform other duties on behalf of the Board as needed or 14 directed. 15 G.
