10 COMMITTEE SUBSTITUTE

11 An Act relating to the Oklahoma Department of
12 Agriculture, Food, and Forestry; requiring that
13 portions of certain appropriated funds be used for
14 certain purposes; providing procedures; providing
15 lapse dates; and requiring and prohibiting certain
16 budget procedures.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. From the funds appropriated to the Oklahoma
19 Department of Agriculture, Food, and Forestry in Enrolled House Bill
20 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
21 sum of Three Million Dollars (\$3,000,000.00) shall, under the
22 direction of the Commissioner of Agriculture, be allocated to the
23 Oklahoma State University College of Veterinary Medicine.

24 SECTION 2. From the funds appropriated to the Oklahoma
Department of Agriculture, Food, and Forestry in Enrolled House Bill

1 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
2 sum of Two Million Dollars (\$2,000,000.00) shall, under the
3 direction of the Commissioner of Agriculture, be allocated to the
4 extension offices that are affiliated with the Oklahoma State
5 University Agricultural Extension Service.

6 SECTION 3. From the funds appropriated to the Oklahoma
7 Department of Agriculture, Food, and Forestry in Enrolled House Bill
8 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
9 sum of One Million Dollars (\$1,000,000.00) shall, under the
10 direction of the Commissioner of Agriculture, be allocated to the
11 research centers that are affiliated with the Oklahoma State
12 University Agriculture Experiment Stations.

13 SECTION 4. From the funds appropriated to the Oklahoma
14 Department of Agriculture, Food, and Forestry in Enrolled House Bill
15 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
16 sum of One Hundred Fifty Thousand Dollars (\$150,000.00) shall, under
17 the direction of the Commissioner of Agriculture, be allocated for
18 facility improvements needed for cattle stock shows.

19 SECTION 5. From the funds appropriated to the Oklahoma
20 Department of Agriculture, Food, and Forestry in Enrolled House Bill
21 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
22 sum of Three Hundred Thousand Dollars (\$300,000.00) shall, under the
23 direction of the Commission of Agriculture, be allocated to hire
24 additional full-time meat inspectors.

1 SECTION 6. Appropriations made by Enrolled House Bill No. 2900
2 of the 1st Session of the 58th Oklahoma Legislature, not including
3 appropriations made for capital outlay purposes, may be budgeted for
4 the fiscal year ending June 30, 2022 (hereafter FY-22) or may be
5 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23).
6 Funds budgeted for FY-22 may be encumbered only through June 30,
7 2022, and must be expended by November 15, 2022. Any funds
8 remaining after November 15, 2022, and not budgeted for FY-23, shall
9 lapse to the credit of the proper fund for the then current fiscal
10 year. Funds budgeted for FY-23 may be encumbered only through June
11 30, 2023. Any funds remaining after November 15, 2023, shall lapse
12 to the credit of the proper fund for the then current fiscal year.
13 These appropriations may not be budgeted in both fiscal years
14 simultaneously. Funds budgeted in FY-22, and not required to pay
15 obligations for that fiscal year, may be budgeted for FY-23, after
16 the agency to which the funds have been appropriated has prepared
17 and submitted a budget work program revision removing these funds
18 from the FY-22 budget work program and after such revision has been
19 approved by the Office of Management and Enterprise Services.
