16	BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:
17	SECTION 1. From the funds appropriated to the Oklahoma
18	Department of Agriculture, Food, and Forestry in Enrolled House Bill
19	No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the
20	sum of Three Million Dollars (\$3,000,000.00) shall, under the
21	direction of the Commissioner of Agriculture, be allocated to the
22	Oklahoma State University College of Veterinary Medicine.
23	SECTION 2. From the funds appropriated to the Oklahoma
24	Department of Agriculture, Food, and Forestry in Enrolled House Bill

No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the sum of Two Million Dollars (\$2,000,000.00) shall, under the direction of the Commissioner of Agriculture, be allocated to the extension offices that are affiliated with the Oklahoma State University Agricultural Extension Service.

6 SECTION 3. From the funds appropriated to the Oklahoma 7 Department of Agriculture, Food, and Forestry in Enrolled House Bill 8 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the 9 sum of One Million Dollars (\$1,000,000.00) shall, under the 10 direction of the Commissioner of Agriculture, be allocated to the 11 research centers that are affiliated with the Oklahoma State 12 University Agriculture Experiment Stations.

SECTION 4. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) shall, under the direction of the Commissioner of Agriculture, be allocated for facility improvements needed for cattle stock shows.

SECTION 5. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the sum of Three Hundred Thousand Dollars (\$300,000.00) shall, under the direction of the Commission of Agriculture, be allocated to hire additional full-time meat inspectors.

1 SECTION 6. Appropriations made by Enrolled House Bill No. 2900 2 of the 1st Session of the 58th Oklahoma Legislature, not including appropriations made for capital outlay purposes, may be budgeted for 3 4 the fiscal year ending June 30, 2022 (hereafter FY-22) or may be 5 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23). 6 Funds budgeted for FY-22 may be encumbered only through June 30, 7 2022, and must be expended by November 15, 2022. Any funds 8 remaining after November 15, 2022, and not budgeted for FY-23, shall 9 lapse to the credit of the proper fund for the then current fiscal 10 year. Funds budgeted for FY-23 may be encumbered only through June 11 30, 2023. Any funds remaining after November 15, 2023, shall lapse 12 to the credit of the proper fund for the then current fiscal year. 13 These appropriations may not be budgeted in both fiscal years 14 simultaneously. Funds budgeted in FY-22, and not required to pay 15 obligations for that fiscal year, may be budgeted for FY-23, after 16 the agency to which the funds have been appropriated has prepared 17 and submitted a budget work program revision removing these funds 18 from the FY-22 budget work program and after such revision has been 19 approved by the Office of Management and Enterprise Services. 20 21 58-1-8328 JM 05/17/21
