8 An Act relating to the Oklahoma Department of  
9 Agriculture, Food, and Forestry; requiring that  
10 portions of certain appropriated funds be used for  
11 certain purposes; providing procedures; providing  
12 lapse dates; and requiring and prohibiting certain  
13 budget procedures.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. From the funds appropriated to the Oklahoma  
16 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
17 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the  
18 sum of Three Million Dollars (\$3,000,000.00) shall, under the  
19 direction of the Commissioner of Agriculture, be allocated to the  
20 Oklahoma State University College of Veterinary Medicine.

21 SECTION 2. From the funds appropriated to the Oklahoma  
22 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
23 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the  
24 sum of Two Million Dollars (\$2,000,000.00) shall, under the  
direction of the Commissioner of Agriculture, be allocated to the

1 extension offices that are affiliated with the Oklahoma State  
2 University Agricultural Extension Service.

3 SECTION 3. From the funds appropriated to the Oklahoma  
4 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
5 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the  
6 sum of One Million Dollars (\$1,000,000.00) shall, under the  
7 direction of the Commissioner of Agriculture, be allocated to the  
8 research centers that are affiliated with the Oklahoma State  
9 University Agriculture Experiment Stations.

10 SECTION 4. From the funds appropriated to the Oklahoma  
11 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
12 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the  
13 sum of One Hundred Fifty Thousand Dollars (\$150,000.00) shall, under  
14 the direction of the Commissioner of Agriculture, be allocated for  
15 facility improvements needed for cattle stock shows.

16 SECTION 5. From the funds appropriated to the Oklahoma  
17 Department of Agriculture, Food, and Forestry in Enrolled House Bill  
18 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the  
19 sum of Three Hundred Thousand Dollars (\$300,000.00) shall, under the  
20 direction of the Commission of Agriculture, be allocated to hire  
21 additional full-time meat inspectors.

22 SECTION 6. Appropriations made by Enrolled House Bill No. 2900  
23 of the 1st Session of the 58th Oklahoma Legislature, not including  
24 appropriations made for capital outlay purposes, may be budgeted for

1 the fiscal year ending June 30, 2022 (hereafter FY-22) or may be  
2 budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23).  
3 Funds budgeted for FY-22 may be encumbered only through June 30,  
4 2022, and must be expended by November 15, 2022. Any funds  
5 remaining after November 15, 2022, and not budgeted for FY-23, shall  
6 lapse to the credit of the proper fund for the then current fiscal  
7 year. Funds budgeted for FY-23 may be encumbered only through June  
8 30, 2023. Any funds remaining after November 15, 2023, shall lapse  
9 to the credit of the proper fund for the then current fiscal year.  
10 These appropriations may not be budgeted in both fiscal years  
11 simultaneously. Funds budgeted in FY-22, and not required to pay  
12 obligations for that fiscal year, may be budgeted for FY-23, after  
13 the agency to which the funds have been appropriated has prepared  
14 and submitted a budget work program revision removing these funds  
15 from the FY-22 budget work program and after such revision has been  
16 approved by the Office of Management and Enterprise Services.
