From the funds appropriated to the Oklahoma 4 Department of Agriculture, Food, and Forestry in Enrolled House Bill 5 No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the 6 sum of One Million Dollars (\$1,000,000.00) shall, under the 7 direction of the Commissioner of Agriculture, be allocated to the 8 research centers that are affiliated with the Oklahoma State 9 University Agriculture Experiment Stations.

SECTION 4. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the sum of One Hundred Fifty Thousand Dollars (\$150,000.00) shall, under the direction of the Commissioner of Agriculture, be allocated for facility improvements needed for cattle stock shows.

SECTION 5. From the funds appropriated to the Oklahoma Department of Agriculture, Food, and Forestry in Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, the sum of Three Hundred Thousand Dollars (\$300,000.00) shall, under the direction of the Commission of Agriculture, be allocated to hire additional full-time meat inspectors.

SECTION 6. Appropriations made by Enrolled House Bill No. 2900 of the 1st Session of the 58th Oklahoma Legislature, not including appropriations made for capital outlay purposes, may be budgeted for

1 the fiscal year ending June 30, 2022 (hereafter FY-22) or may be budgeted for the fiscal year ending June 30, 2023 (hereafter FY-23). 2 Funds budgeted for FY-22 may be encumbered only through June 30, 3 4 2022, and must be expended by November 15, 2022. Any funds remaining after November 15, 2022, and not budgeted for FY-23, shall 5 lapse to the credit of the proper fund for the then current fiscal 6 7 year. Funds budgeted for FY-23 may be encumbered only through June 30, 2023. Any funds remaining after November 15, 2023, shall lapse 8 9 to the credit of the proper fund for the then current fiscal year. 10 These appropriations may not be budgeted in both fiscal years 11 simultaneously.
