HOUSE BILL 3101

AS INTRODUCED

An Act relating to professions and occupations; amending 59 O.S. 2011, Section 199.14, as last amended by Section 4, Chapter 62, O.S.L. 2018 (59 O.S. Supp. 2019, Section 199.14), which relate to the State Board of Cosmetology and Barbering; modifying fee schedule; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 59 O.S. 2011, Section 199.14, as last amended by Section 4, Chapter 62, O.S.L. 2018 (59 O.S. Supp. 2019, Section 199.14), is amended to read as follows:

Section 199.14 A. The following fees shall be charged by the State Board of Cosmetology and Barbering:

2        B. In addition to the fees specified in subsection A of this  
3 section, the Board shall charge a total penalty of Ten Dollars  
4 (\$10.00), as provided for in Section 199.10 of this title.

5        C. Any person licensed as an advanced operator prior to July 1,  
6 1985, may renew the advanced cosmetologist license annually by  
7 payment of the fee required by this section and by being in  
8 compliance with the rules promulgated by the State Board of  
9 Cosmetology and Barbering.

10       SECTION 2. This act shall become effective November 1, 2020.
