11 An Act relating to school district boards of
12 education; amending 26 O.S. 2011, Section 13A-110, as
13 amended by Section 8, Chapter 380, O.S.L. 2015 (26
14 O.S. Supp. 2015, Section 13A-110), which relates to
15 vacancies on boards of education; providing for the
16 filling of certain vacancies on the board of
17 education by appointment; allowing the appointment of
18 persons who do not reside in certain districts;
19 requiring appointed persons to reside in the school
20 district and meet other eligibility qualifications;
21 limiting service; amending 70 O.S. 2011, Sections 5-
22 110, as last amended by Section 1, Chapter 17, O.S.L.
23 2013, 5-110.1, as amended by Section 2, Chapter 192,
24 O.S.L. 2012 and 5-110.2 (70 O.S. Supp. 2015, Sections
5-110 and 5-110.2), which relate to instructional
requirements for school district board of education
members; requiring school district boards of
education to declare certain seats vacant within
certain time period; adding prohibition to hold
certain seat in certain circumstances; modifying
certain permanent record; requiring a school district
board of education to declare the seat of certain
members vacant within certain time period; and
directing the State Board of Education to provide
certain notification.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY 26 O.S. 2011, Section 13A-110, as
3 amended by Section 8, Chapter 380, O.S.L. 2015 (26 O.S. Supp. 2015,
4 Section 13A-110), is amended to read as follows:

5 Section 13A-110. A. Vacancies for members of the board of
6 education of every school district or technology center school
7 district shall be filled by appointment by the board. ~~Persons~~

8 B. Except as provided for in subsection D of this section,
9 persons appointed to fill such vacancies in the first half of the
10 term of office for the board position shall serve only until the
11 next succeeding election, at which time the office which they hold
12 shall be placed on the ballot for the balance of the unexpired term.
13 Vacancies filled by appointment following the delivery of the
14 resolution calling for regular elections to the secretary of the
15 county election board shall be filled until the regular elections
16 the following year. Persons elected to fill unexpired terms shall
17 begin those terms at the next regular meeting of the board of
18 education following the election. Persons appointed to fill such
19 vacancies after the first half of the term of office for the board
20 position shall serve for the balance of the unexpired term. ~~No~~

21 C. Except as provided for in subsection D of this section, no
22 person shall be appointed to a board of education who does not meet
23 the eligibility qualifications needed to be a candidate for such
24 position as provided for in ~~Sections~~ Section 13A-106 of this title

1 and Sections 5-110, 5-110.1 and 5-113 of Title 70 of the Oklahoma
2 Statutes.

3 B. D. If after the filing period is closed no candidate for an
4 open position on a board of education of a school district has filed
5 and therefore a vacancy is created, the vacancy shall be filled by
6 appointment by the board. Persons appointed to fill such vacancies
7 shall not be required to reside in the board or election district
8 but shall be required to reside in the school district and to meet
9 the other eligibility qualifications needed to be a candidate for
10 the position as provided for in Section 13A-106 of this title and
11 Sections 5-110, 5-110.1 and 5-113 of Title 70 of the Oklahoma
12 Statutes. Persons appointed to fill vacancies as provided for in
13 this subsection shall be eligible to serve only for the balance of
14 the term.

15 E. If the board of education does not fill the vacancy by
16 appointment within sixty (60) days of the date the board declared
17 the seat vacant, the board of education shall call a special
18 election to fill the vacancy for the unexpired term. The special
19 election shall be called on a date established by subsection B of
20 Section 3-101 of this title, and the special filing period shall be
21 scheduled as required in subsection D of Section 13A-109 of this
22 title.

1 SECTION 2. AMENDATORY 70 O.S. 2011, Section 5-110, as
2 last amended by Section 1, Chapter 17, O.S.L. 2013 (70 O.S. Supp.
3 2015, Section 5-110), is amended to read as follows:

4 Section 5-110. A. A school district elector who is elected or
5 appointed to be a member of a school district board of education
6 prior to January 1, 2014, shall obtain instruction on education
7 issues in accordance with rules promulgated by the State Board of
8 Education. Except as provided in subsection B of this section, at
9 the time a school district elector files a notification and
10 declaration of candidacy for the office of school district board of
11 education membership or is appointed to be a member of a school
12 district board of education on or after January 1, 2014, the elector
13 shall agree and pledge in writing that, within fifteen (15) months
14 of election or appointment as a member of the district board of
15 education, the member will complete at least twelve (12) hours of
16 instruction on education issues in the following areas: school
17 finance; legal issues, which include but are not limited to
18 employment, due process, new laws, the Oklahoma Open Records Act and
19 the Oklahoma Open Meeting Act; and duties and responsibilities,
20 which include but are not limited to special education and ethics,
21 of district board of education members. Each elector shall agree
22 and pledge in writing to complete at least one (1) hour of
23 instruction in school finance, one (1) hour of instruction in the
24 Oklahoma Open Records Act and the Oklahoma Open Meeting Act and one

1 (1) hour of instruction in ethics. The remaining hours may be
2 satisfied by attending a two-day workshop to be held within the
3 state by the State Department of Education, by the Oklahoma
4 Department of Career and Technology Education, or by attending
5 workshops, seminars or classes which address the above-mentioned
6 subject matter, and which are sponsored by any organization approved
7 by the State Board of Education, including but not limited to
8 institutions of higher education. The State Board of Education
9 shall promulgate rules by which an organization or particular
10 courses offered by an organization may be approved for purposes of
11 fulfilling the instructional requirements set out in this section.

12 B. When an incumbent of a district board of education files a
13 notification and declaration of candidacy for reelection to the
14 district board of education, the member shall be required to agree
15 and pledge in writing that upon reelection the member will complete
16 six (6) hours of instruction, within fifteen (15) months of
17 election, including one (1) hour of instruction in school finance,
18 one (1) hour of instruction in the Oklahoma Open Records Act and the
19 Oklahoma Open Meeting Act and one (1) hour of instruction in ethics.
20 The remaining hours may be satisfied by attending a workshop, class
21 or seminar addressing the education issues set forth in subsection A
22 of this section.

23 C. The State Department of Education shall, immediately after
24 the annual elections of various district board of education members,

1 determine the members of the district boards of education pledged to
2 complete the instructional requirements established in subsections A
3 and B of this section, and shall notify the members of the time and
4 place where workshops, classes and seminars are to be conducted.
5 Upon completion of the instructional requirements, the certificate
6 of completion shall be included in the public records of the school
7 board's minutes. Each school board member, except for an incumbent
8 member, shall be required within fifteen (15) months following or
9 preceding election to complete the workshop established by
10 subsection A of this section or to attend twelve (12) hours of other
11 state workshops, classes or seminars conducted as instruction on the
12 subjects of school finance, legal issues, and the ethics, duties and
13 responsibilities of district board of education members, including
14 at least one (1) hour of instruction in school finance, one (1) hour
15 of instruction in the Oklahoma Open Records Act and the Oklahoma
16 Open Meeting Act and one (1) hour of instruction in ethics.

17 D. If a school board member, including an incumbent member, has
18 not satisfied the instructional requirements as set forth in this
19 section within fifteen (15) months of election, reelection or
20 appointment, the district board of education shall declare the seat
21 of the member vacant within thirty (30) days of the date of receipt
22 of notice that the member has not completed the requirements as
23 provided for pursuant to Section 5-110.2 of this title and shall
24 fill the vacancy according to law. A school board member who is

1 required to vacate a school board seat pursuant to this subsection
2 shall be ineligible to be reappointed ~~or to,~~ to run for reelection
3 to or to hold that respective board seat on the school district
4 board of education or to run for election to or to hold any other
5 board seat on the board of education for a three-year period for
6 three-member boards, for a four-year period for seven-member boards
7 or for a five-year period for five-member boards.

8 E. All government departments, agencies and institutions of
9 this state are directed to lend assistance as may be required by the
10 State Department of Education for the proper conduct and
11 administration of the workshops as authorized in subsection A of
12 this section. The State Department of Education shall maintain a
13 permanent record of the instructional hours and continuing education
14 hours earned for each district board of education member ~~who~~
15 ~~successfully completes a workshop and shall issue a certificate of~~
16 ~~completion to the member.~~

17 F. The State Department of Education, the Oklahoma Department
18 of Career and Technology Education, and, upon approval of the State
19 Board of Education, any organization or association representing
20 district boards of education in this state are authorized to charge
21 persons pledged to attend a workshop, class or seminar for purposes
22 of meeting the instructional requirements of this section, a
23 registration fee sufficient to defray the estimated costs of
24

1 presenting the workshop, class or seminar and to collect the fees at
2 the time of registration.

3 G. Any member of a district board of education or any
4 individual elected, certified as the elected member by the county
5 election board, but not sworn in and seated as a member of a
6 district board of education at the time of a workshop, class or
7 seminar presented by the State Board of Education, the Oklahoma
8 Department of Career and Technology Education, or an organization or
9 association representing district boards of education within the
10 state who attends and successfully completes a workshop, class or
11 seminar as required by subsection A or B of this section shall be
12 reimbursed by the school district in accordance with the travel
13 reimbursement policy of the district.

14 SECTION 3. AMENDATORY 70 O.S. 2011, Section 5-110.1, as
15 amended by Section 2, Chapter 192, O.S.L. 2012 (70 O.S. Supp. 2015,
16 Section 5-110.1), is amended to read as follows:

17 Section 5-110.1 A. In addition to the requirements of Section
18 5-110 of this title, every member of a school district board of
19 education elected to a full term of office of five (5) years or more
20 shall be required to attend a minimum of fifteen (15) hours of
21 continuing education, each member elected to a full four-year term
22 of office shall be required to attend a minimum of twelve (12) hours
23 of continuing education, and each member elected to a full three-
24 year term of office shall be required to attend a minimum of nine

1 (9) hours of continuing education, prior to the date set for filing
2 for reelection to that respective board seat. The continuing
3 education courses, workshops, seminars, conferences, and conventions
4 which shall satisfy the continuing education requirement shall be
5 approved jointly by the State Department of Education and the
6 Oklahoma Department of Career and Technology Education.

7 B. Local and state continuing education programs conducted
8 pursuant to the provisions of this section shall be held in all
9 regions of the state at institutions of higher learning, area
10 technology centers or other approved sites. Notice of such courses
11 and seminars shall be provided to all school board members and to
12 the public schools.

13 C. This section shall not apply to those school board members
14 who file for reelection prior to July 1, 1991.

15 D. If a school board member has not satisfied the continuing
16 education requirements of this section, the school district board of
17 education shall declare the seat of the member vacant within thirty
18 (30) days of the date of receipt of notice that the member has not
19 completed the requirements as provided for pursuant to Section 5-
20 110.2 of this title and shall fill the vacancy according to law.
21 Failure by a board member to satisfy the continuing education
22 requirements of this section shall result in the ineligibility of
23 the member to be reappointed ~~or~~ to, run for reelection to or to hold
24 that respective board seat on the school district board of education

1 or to run for election to or to hold any other board seat on the
2 board of education for a three-year period for three-member boards,
3 for a four-year period for seven-member boards or for a five-year
4 period for five-member boards

5 E. The State Department of Education, the Oklahoma Department
6 of Career and Technology Education, and any organization approved by
7 the State Board of Education, including but not limited to
8 institutions of higher education, may charge persons attending
9 continuing education courses a registration fee sufficient to defray
10 the estimated costs of presenting the course. The registration fees
11 for each course shall be announced prior to the date of such course.

12 F. Any member of a school district board of education who
13 attends and completes a course which satisfies in part or in full
14 the requirements of this section shall be reimbursed by the school
15 district for expenses incurred. In addition, a school district
16 board of education may reimburse members of the board of education
17 for expenses incurred in registering and attending board member
18 training programs or activities approved by the board which are in
19 addition to the minimum school board training requirements
20 established by law.

21 SECTION 4. AMENDATORY 70 O.S. 2011, Section 5-110.2, is
22 amended to read as follows:

23 Section 5-110.2 The State Board of Education shall maintain
24 records of attendance by school board members at continuing

1 education events required pursuant to Sections 5-110 and 5-110.1 of
2 this title and prior to the final opportunity for each school board
3 member who has not completed the continuing education requirements
4 to complete the same, shall notify the school board member by mail
5 before March 1 of each year of any final opportunity to complete
6 these requirements. Upon determining that a school board member did
7 not complete the continuing education requirements of Sections 5-110
8 or 5-110.1 within the respective period of time, the Board shall
9 immediately notify by certified mail the school district board of
10 education and the school district superintendent that the school
11 board member did not complete the requirements and that the school
12 district board of education is required to declare the seat of that
13 member vacant.
